

**TYENDINAGA MOHAWK COUNCIL MINUTES  
AUGUST 22, 2012**

WHEREAS, the Mohawks of the Bay of Quinte are eligible for funding under Feddev Ontario's Community Infrastructure Improvement Fund (CIIF) to submit application for cost incurred between April 1, 2012 and completion; and

WHEREAS, the total estimated amount required to complete the upgrade totals \$1,417,700.00 with Feddev contributing \$708,850.00 and MBQ contributing \$708,850.00

THEREFORE BE IT RESOLVED that the Tyendinaga Mohawk Council agrees to support the application to Feddev Ontario's Community Infrastructure Improvement Fund (CIIF) for costs incurred between April 1, 2012 to completion.

AND FURTHERMORE BE IT RESOLVED that the Tyendinaga Mohawk Council approves to commit \$708,850.00 with CIIF committing the remaining \$708,850.00.
