WHEREAS our community is stronger when all members become aware of child abuse and neglect prevention and become involved in supporting parents to raise their children in a safe, nurturing environment; and

WHEREAS Mohawks of the Bay of Quinte members celebrate children, our community's greatest resource and the community leaders of tomorrow;

THEREFORE, we, the Tyendinaga Mohawk Council, do hereby proclaim the month of October 2012 as

CHILD ABUSE PREVENTION MONTH

in the community of the Mohawks of the Bay of Quinte and commend this observance of the members of this Territory.

WHEREAS the lives of many members of the Mohawks of the Bay of Quinte have been directly or indirectly impacted by the high numbers of children in care; and

WHEREAS foster parents are individuals or couples with a genuine interest in children and a sense of community responsibility; and

WHEREAS 247 foster parents in Hastings and Northumberland counties provide a caring and safe environment for children in care; and

WHEREAS foster parents of the two Societies provided approximately 95,080 days of care to foster children last year; and

WHEREAS the number of children who received in care service in Hastings and Northumberland counties for the year 2011/2012 was 729;

THEREFORE BE IT RESOLVED that members of the Mohawks of the Bay of Quinte are encouraged to support and embrace the community of foster parents during this special week; and

THEREFORE BE IT FURTHER RESOLVED that the Mohawks of the Bay of Quinte declares the week of October 21–27, 2012 to be Canadian Foster Family Week;

MOTION #12: Moved by Roy C. Maracle, seconded by Carl E. (Ted) Maracle that Every Child Deserves to be a Kid. They also deserve to be loved, nurtured and have a permanent family. Unfortunately, abused and neglected children enter the care of Highland Shores Children's Aid and are waiting for such a home. These children are not the newborns most people picture when they think of adoption. Generally they are older boys and girls and sibling groups as well as children with emotional and behavioural challenges.

Adoption gives them a brighter future and brings great joy to the adoptive parents. It offers permanency and security to children and gives them the opportunity to develop healthy, nurturing relationships in a family setting.

WHEREAS to date, 11 children in Hastings and Northumberland counties combined, who are not yet matched with an adoptive family and the continuing need is for families who will adopt older children and sibling groups; and

WHEREAS many of these children have special needs, which may include medically fragile infants or children with emotional, physical, social and/or educational challenges; and

WHEREAS many school age children and in some cases sibling groups become available for adoption; and

WHEREAS these children require extra patience and support to help them overcome previous hardships; and

WHEREAS in 2011/12 32 children from Hastings and Northumberland counties and 2 additional children from other Societies were placed into adoptive families in our communities; and

WHEREAS families are able and willing to adopt children who have emotional and behavioural challenges, are older children or belong to a sibling group; and

WHEREAS, it is important to stress that people regardless of income and marital status, or not owning a home do not disqualify individuals from adopting; and

WHEREAS, children waiting for adoptive parents and families who have adopted these children require and deserve community and Society support;

THEREFORE BE IT RESOLVED, we, the Tyendinaga Mohawk Council, do hereby proclaim

NOVEMBER 2012 as ADOPTION AWARENESS MONTH
in the community of Mohawks of the Bay of Quinte

In honour of this event, we encourage community agencies, religious organizations, businesses and others to celebrate adoption, honour families that grow through adoption, further an awareness of the challenges and issues in adoption, and focus attention on those children who live in the shadow of an uncertain future while they await permanent families.
