

TYENDINAGA MOHAWK COUNCIL MINUTES
MARCH 26, 2013

A special meeting of the Tyendinaga Mohawk Council was held on Wednesday, March 26, 2014 at 10:10 a.m. in the Council Chambers to discuss the Iroquois Caucus.

Chief Maracle opened the meeting with a Prayer.

MOTION #1: Moved by Douglas E. Maracle, seconded by Sandra J. Lewis-den Otter that the Tyendinaga Mohawk council approves the 2014-2015 funding submission to the Professional & Institutional Development Program (P&ID). In this submission the Mohawks of the Bay of Quinte (MBQ) propose to complete the following three projects in the 2014-2015 fiscal:

Project 1: Replacement of Network Equipment - \$41,360

Project 2: Virtualization of MBQ Servers - \$35,200

Project 3: Document Management System - \$128,180

MBQ's proposal includes a 20/80 cost share of the total \$204,740 with MBQ paying \$40,948 of the total and P&ID funding covering the remaining \$163,792.

The Tyendinaga Mohawk Council are also committed to informing and engaging the members of the Mohawks of the Bay of Quinte in the governance development initiative. M.C.R. #2013/14-123.

MOTION #2: Moved by Douglas E. Maracle, seconded by Sandra J. Lewis-den Otter that Council approve to draft a letter to go to Prime Minister Harper regarding Bill C10 – communities are in discussions with Ontario – bill is prejudicial to those discussions; raise constitutional issue; and failure or willing to negotiate; withdraw bill to see what comes out of provincial discussions.

MOTION #3: Moved by Douglas E. Maracle, seconded by Sandra J. Lewis-den Otter that Council approve to draft a Letter to go to Premier Wynne – meeting with Ann Bird was requested and she declined; discuss another marker to make legal; did not accommodate request of Iroquois Caucus to attend standing committee; constitutional factor and UNDRIP.

MOTION #4: Moved by Sandra J. Lewis-den Otter, seconded by Douglas E. Maracle that Council approve the letter to Hiawatha Institute for Indigenous Knowledge, Syracuse University regarding the transfer of land at Kahon:ios/Cohoes Falls from Brookfield Renewable Power to the Hiawatha Institute for Indigenous Knowledge.

Carried.

MOTION #5: Moved by Barry Brant, seconded by Douglas E. Maracle that this meeting be adjourned. (1:25 p.m.)
