WHEREAS, the First Nation Information Governance Centre (FNIGC) is funded by the Government of Canada to conduct the RHS, together with its regional partners, including the Chiefs of Ontario. Chief of Ontario maintains accountability to First Nations through its membership, which includes all 133 Ontario First Nations as represented by their respective Chiefs. FNIGC maintains accountability to First Nations through its membership, which includes all participating Regional Organizations; and

WHEREAS, in its conduct and stewardship over the First Nations Regional Health Survey 1 and 2 (RHS 1 and 2), the FNIGC, working together with the Regions, has an established reputation and infrastructure that maintains direct accountability to First Nations leadership, respect for First Nations' principals of OCAP, while providing a security and privacy framework that meets the highest standards; and

WHEREAS, the Regional Health Survey 3 was developed to respect and uphold rights of the First Nations and the jurisdiction of their representative bodies, and to gather First Nations data to be used by First Nations to improve the quality of life of their citizens, communities, and tribal and regional entities;

THEREFORE BE IT RESOLVED, that the Tyendinaga Mohawk Council consents to the participation of the Tyendinaga First Nation in the First Nations Regional Health Survey 3 (RHS 3) and the
