- Replace the 4" forcemain that serves the Huron Brant Pumping Station,
- The engineering services to extend the waterline to the Bell's Road,
- The purchase of equipment to replace the existing water meters with new remote meters; and
- The installation of a new potable water holding tank, and septic tank and field at the Busing and Public Works Hangar

Whereas, the total amount for this application is \$314,389.00 with MBQ covering the remaining \$96,757.00

Therefore be it resolved that the Tyendinaga Mohawk Council agrees to support the application to the Clean Water and Wastewater Fund for the above projects.

Further be it resolved that the Tyendinaga Mohawk Council hereby approves MBQ's financial contribution of \$96,757.00.
