AND WHEREAS by purporting to enter into and failing to terminate the Turton Penn Lease the Crown has breached its fiduciary and treaty obligations to the MBQ;

AND WHEREAS the Crown in right of Canada is in law responsible for the breaches of the fiduciary and treaty obligations of the Crown to MBQ relating to the Turton Penn Lease;

AND WHEREAS the MBQ have prepared a Statement of Claim asserting a specific claim against the Crown in right of Canada within the meaning of Canada's Specific Claims Policy and the Specific Claims Tribunal Act;

THEREFORE BE IT RESOLVED that the Tyendinaga Mohawk Council approve to submit the Turton Penn Loss of Use Claim to Minister Carolyn Bennett and the Specific Claims Branch of the Department of Indigenous and Northern Affairs.
