

**TYENDINAGA MOHAWK COUNCIL MINUTES**  
**MARCH 18, 2015**

A meeting of the Tyendinaga Mohawk Council was held on Wednesday, March 18, 2015 at 9:00 a.m. in the Council Chambers.

Chief Maracle opened the meeting with a Prayer.

The Council met with several representatives from the Ontario Ministry of Natural Resources and Forestry Colin Lake, Management Biologist, Lake Ontario Management Unit (Glenora), Andy Todd, Manager, Lake Ontario Management Unit (Glenora), Jon Averill, Resource Liaison, Peterborough District, Jim Hoyle, Bay of Quinte Assessment Biologist, Lake Ontario Management Unit (Glenora), Alastair Mathers, Assessment Supervisor, Lake Ontario Management (Glenora), MBQ Staff Lisa Maracle, Director of Community Services and Nicole Storms, Environmental Coordinator regarding the status of the fishery of Lake Ontario, Bay of Quinte and part of the St. Lawrence River system. MNRF presentation included general information, a PowerPoint presentation on the proposed fish species restocking plan, and addressed questions from Council members. Andy Todd made the presentation and stated the overall condition of the fishery for Lake Ontario and Bay of Quinte is good and steadily improving. MNR have studied netting in the Bay of Quinte since the 1950s.

MNRF has completed a restocking analysis for the fishery and Walleye. The Stocking Plan is reviewed for compliance under an environmental assessment plan.

A slide presentation was made on the status of the fishery, the harvest for recreational and commercial fisheries, and the quantity of the landed value of the fish harvest and overall estimated economic benefit to the region. The presentation included information on Walleye, Yellow Perch, Bass, Pike, Sturgeon, and other species.

The Walleye population in the Bay of Quinte is doing well. Although the Walleye population declined rather abruptly in the early 1990s, they have recovered well. In 2014, it was estimated there was 15,000 Walleye in the Bay of Quinte. The recreational fisheries accounts for 80% of the harvest of Walleye.

There are no commercial fisheries licences in the Bay of Quinte for Walleye. The commercial fisheries on Lake Ontario are highly regulated by the Department of Fisheries and Oceans. There are approximately 160 commercial fishery licences for Lake Ontario and part of the St. Lawrence River system. The fishery is done by trap netting and hoop netting.

MNRF advised there is a small aircraft that monitors the number of fishery ice huts on the Bay of Quinte for survey purposes. Creole surveys are completed in the winter months. An average of 500 fish huts / 200,000 angler hours occurred in the year 2014 for the entire Bay of Quinte.

Commercially, an estimated 28,000 pounds of Walleye was harvested from Lake Ontario and outside of Bay of Quinte in 2014 – valued at \$64,000. The Crown received a 3.3% royalty, approximately \$10,000, on the landed value. The commercial value of all the commercial fisheries for Lake Ontario and part of the St. Lawrence River is 30 million with an overall economic estimated impact of 200 million for the region. Most of the fish harvested in Lake Ontario under commercial fishery licenses are processed at fish processing plant in the Lake Erie area.

The recreational harvest of fish species is 80% and commercial harvest 20%.

The Sturgeon, American Eel, and several turtles are endangered species in this area.

Zebra Mussels remain in the Bay of Quinte, but has not depleted the fishery – contributed to the decline of some species, but has not depleted any. The federal government continues to regulate ships from foreign countries and the exchange of ballast water in salt water as a zebra mussel control plan.

Approximately 6.5 million fish are restocked in all of Lake Ontario annually. 214 million were restocked in 2014. MNRF's overall lake-wide stocking target of Walleye summer fry is 100,000. The Bay of Quinte is not restocked because it is self-sustaining. The restocking program in Lake Ontario will eventually migrate to the Bay of Quinte. Most of the restocking of Lake Ontario occurs in the western parts.

Whitefish were impacted by the Zebra Mussel invasion and have significantly declined. There remains to be a lot of Zebra Mussel, but is has not depleted the fisheries. MNRF carefully analyzes the predator-prey balance for certain fish species. The harvest pressure and ecology are in balance.
