Chief opened the meeting with a Prayer

MOTION #1: Moved by Douglas E. Maracle, seconded by Roy C. Maracle that Council approve sending the letter to Mark Bain regarding the Ernestown Wind Project.

MOTION #6: Moved by Roy C. Maracle, seconded by Douglas E. Maracle that WHEREAS the lives of many members of the Mohawks of the Bay of Quinte have been directly or indirectly impacted by the high numbers of children in care; and

WHEREAS foster, customary care and kin in care parents are individuals or couples with a genuine interest in children and a sense of community responsibility; and

WHEREAS 200 foster, customary care and kin in care parents in Hastings, Northumberland and Prince Edward counties provide a caring and safe environment for children in care; and

WHEREAS foster, customary care and kin in care parents of Highland Shores Children's Aid provided over 87,000 days of care to foster children last year; and

WHEREAS the number of children who received in care service in Hastings, Northumberland and Prince Edward counties for the year 2012/2013 was 795;

THEREFORE BE IT RESOLVED that members of the Mohawks of the Bay of Quinte are encouraged to support and embrace the community of foster, customary care and kin in care parents during this special week; and

THEREFORE BE IT FURTHER RESOLVED that the Mohawks of the Bay of Quinte declares the week of October 20–26, 2013 to be National Foster Family Week;

MOTION #7:

Moved by Roy C. Maracle, seconded by Douglas E. Maracle that WHEREAS child abuse is a complex and ongoing problem in society, affecting many children; and

WHEREAS every child is entitled to be loved, cared for, nurtured and secure and to be free from neglect, as well as verbal, emotional, sexual and physical abuse; and

WHEREAS the Mohawks of the Bay of Quinte sees a need to support community-based programs to prevent child abuse and neglect; and

WHEREAS it is the responsibility of every adult who comes in contact with a child to protect that child's unconditional right to a safe, nurturing childhood; and

WHEREAS the Mohawks of the Bay of Quinte has dedicated individuals and organizations who work daily to counter the problem of child abuse and neglect and to help parents obtain the assistance they need; and

WHEREAS our community is stronger when all members become aware of child abuse and neglect prevention and become involved in supporting parents to raise their children in a safe, nurturing environment; and

WHEREAS Mohawks of the Bay of Quinte members celebrate children, our community's greatest resource and the community leaders of tomorrow;

THEREFORE, we, the Tyendinaga Mohawk Council, do hereby proclaim the month of October 2013 as

CHILD ABUSE PREVENTION MONTH

in the community of the Mohawks of the Bay of Quinte and commend this observance of the members of this Territory. M.C.R. #2013/14-056.

**MOTION #8:** Moved by Roy C. Maracle, seconded by Douglas E. Maracle that Every Child Deserves to be loved, nurtured and have a permanent family. Sadly, some children in care of Highland Shores Children's Aid are waiting for such a home. These children are not the newborns most people picture when they think of adoption. Generally they are older boys and girls and sibling groups as well as children with emotional and behavioural challenges.

Adoption gives these young people a brighter future and brings great joy to the adoptive parents. It offers permanency and security to children and gives them the opportunity to develop healthy, nurturing relationships in a family setting.

WHEREAS of June 30, 2013 there were 26 children in Hastings, Northumberland and Prince Edward counties combined, who were either being transitioned into their adoptive home or were waiting to have an adoptive home found for them; and

WHEREAS Highland Shores Children's Aid has a continuing need for families who will adopt older children and sibling groups; and

WHEREAS some of these children may include medically fragile infants, children or youth with emotional, physical, social and/or educational challenges; and

WHEREAS in fiscal 2012/13, 16 children and youth from Hastings, Northumberland and Prince Edward counties and 2 additional children, who were in the care of other Societies were adopted by families within our community; and

WHEREAS, it is important to stress that low income, being single, or not owning a home does not disqualify individuals from adopting; and

WHEREAS, children waiting for adoptive parents and families who have adopted these children require and deserve community and Society support;

THEREFORE BE IT RESOLVED, we, the Tyendinaga Mohawk Council, do hereby proclaim

NOVEMBER 2013 as ADOPTION AWARENESS MONTH  
in the community of Mohawks of the Bay of Quinte

In honour of this event, we encourage community agencies, religious organizations, businesses and others to celebrate adoption, honour families that grow through adoption, further an awareness of the challenges and issues in adoption, and focus attention on those children who live in the shadow of an uncertain future while they await permanent families.
