**APRIL 6, 2011**

A meeting of the Tyendinaga Mohawk Council was held on Wednesday, April 6, 2011 at 9:00 a.m. in the Council Chambers.

Mike Brant attended Council to discuss the upcoming Federal Election on May 2, 2011.

MOTION #1: Moved by Roy C. Maracle, seconded by Keith A. Sero that Council supports the community member's right to vote in the Federal Elections at a polling station on the Tyendinaga Mohawk Territory if they wish to do so.

Sero that Council approve for the Roads Department to put a quantity of 40 loads 3" minus gravel approx. 480 tonnes and grade the estimated cost is \$3,426.00 on a one-time basis only at Great Oak Lane owner Jackie Maracle on a cost recovery basis; Jackie Maracle is to sign a waiver that there is no liability to the Mohawks of the Bay of Quinte and no guarantee of the work since the existing road base is inadequate.
