Steve Kotack stated Measurement Canada was contacted in response to a consumer complaint. The complaint was about the visibility of the display of the measuring device.

Scott Maracle, Fire Chief was seeking advice from Measurement Canada as per motion #15 dated April 4, 2001 and Motion #20 dated January 13, 2010.

Within the first two years devices must be checked to ensure it measures accurately.
