TYENDINAGA MOHAWK COUNCIL MINUTES JULY 8, 2011

A special meeting of the Tyendinaga Mohawk Council was held on Friday, July 8, 2011 at 10:00 a.m. in the Council Chambers to discuss the enforcement of the Electricity Act and Electrical Safety Code.

There are electrical safety laws and regulations.

Contractors may face charges for jobs done that are non-compliant with the code.

Modifications to the electrical systems require permits that cost approximately \$70.00. The Federal Government uses the authority of jurisdiction in place of the Province. There are situations where permits and inspections are not being done.

Section 88 of the Indian Act already incorporates all laws of general application making these laws applicable to the reserves and these include the Ontario Electrical Safety Code.

Be it therefore resolved, that all electrical installations and or alterations residential, industrial and commercial be in compliance with the Electrical Safety Code which includes permits and inspections. M.C.R. #2011/12-031

Council also received information on the Continue Safety Services. Todd Kring is the contact for Electrical Safety in the workplace.
