The Home and Community Care Case Manager will remain directly accountable to the Mohawks of the Bay of Quinte Senior Administration and ultimately to the Tyendinaga Mohawk Council;

Section 46 of the Ontario Works Act reads:

"Delegation of administrator's power and duties 46.(1) An administrator may, in writing, authorize a person or class of persons employed by the delivery agent for the purpose to exercise any of his or her powers and duties under his or her supervision and direction.

(2) A decision made by a person exercising the administrator's power or duties under this section shall be deemed to be a decision of the administrator. 1997, c.25, Sched. A, s. 46"

Therefore for be it resolved that the Tyendinaga Mohawk Council support the designation of responsibility to the Home and Community Care Case Manager as having full administrative responsibility of the HNSA program and requirements associated with reporting to the Ministry of Health and Long-Term Care for the Mohawks of the Bay of Quinte.
