MOTION #1:	Moved by Velma Hill-Dracup, seconded by Douglas E. Maracle that Council acknowledge the Band Advisory Services Program Report dated September 14, 2011 and forward to Aboriginal Affairs and Northern Development Canada. Carried.

	Whereas, the Mohawks of the Bay of Quinte are eligible for funding under Aboriginal Affairs and Northern Development Canada's 2011-12 Public Buildings Fire Deficiencies Remediation Call for Proposals to rehabilitate the Community Centre, Fire Hall, Sustainable Development Office, Aboriginal Headstart, and the 59ers Hall: and

Whereas, the total estimated amount required to repair the deficiencies totals \$34,900 with HRSDC contributing \$17,450 and MBQ contributing \$17,450;

> Whereas, the total estimated amount required to repair the deficiencies totals \$334,000 with AANDC contributing \$167,000 and MBQ contributing \$167,000;

Therefore be it resolved that the Tyendinaga Mohawk Council agrees to support the application to AANDC 2011-12 Public Buildings Fire Deficiencies Remediation Call for Proposals to rehabilitate the Mohawk Administration Office Building for the total estimated amount of \$334,000.

And furthermore be it resolved that the Tyendinaga Mohawk Council approve to commit \$167,000 with AANDC committing the remaining \$167,000 to complete the deficiencies. M.C.R. #2011/12-063
