

**TYENDINAGA MOHAWK COUNCIL MINUTES  
JULY 26, 2012**

A special meeting of the Tyendinaga Mohawk Council was held on Thursday, July 26, 2012 at 2:30 a.m. in the Council Chambers to review the 2011/2012 Mohawks of the Bay of Quinte Audit as of March 31, 2012.

Jon Tuer presented the audit findings report as at March 31, 2012 and the audit report as at March 31, 2012.

There were no illegal acts. The allowance for doubtful accounts is \$470,099.00 for housing and \$68,678.00 for the general account.

The audit fees for fiscal year 2011/2012 is \$37,228.00.

There is a valuation issue for the Fibre Optics Project for work previously done by the former contractor.

The audit opinion for March 31, 2012 is unqualified.

Contribution from Aboriginal Affairs and Northern Development Canada as of March 31, 2012 was \$9,373,544.00 down from \$9,663,238.00 as of March 31, 2012.

Loans payable for CMHC Housing is \$3,814,037.00 as of March 31, 2012 for 6 different CMHC Housing projects.

The surplus as of March 31, 2012 is \$1,681,290.00 mostly from Casino Rama and Capital projects.

The annual surplus for March 31, 2011 was \$6,478,689.00 mostly from Casino Rama one time litigation settlements of the Ontario First Nations Limited Partnership Inc.

28 Bank of Montreal housing loan guarantees is \$2,017,007.00 and all payments are up to date as of March 31, 2012.

4 Bank of Montreal on reserve Business loan guarantees is \$333,558.00 and all payments are up to date as of March 31, 2012.
