Whereas, the main objective of the Chiefs of Ontario office is to facilitate the discussion, planning implementation and evaluation of all local, regional and national matters affecting the First Nations people of Ontario;

Whereas, members of the Ontario First Nation Fire Chiefs Association would benefit from networking, training initiatives, information sharing and support by Chiefs of Ontario;

Whereas, the cooperative efforts of the Chiefs of Ontario and the Ontario First Nations Fire Chiefs Association could result in more proactive and informed approach in communities' fire protection, fire prevention and emergency planning for safer communities;

Therefore be it resolved, the Tyendinaga Mohawk Council hereby supports the resolution presented at the All Ontario Chiefs Conference and Chief Maracle to second the motion.
