AND WHEREAS as part of the Transaction, MBQ must incorporate two companies: one to act a nominee purchaser (the "**Purchasing Entity**") of the Limited Partnership Interest and another to act as a borrowing entity (the "**Borrowing Entity**") to provide security for future borrowing requirements;

AND WHEREAS MBQ will be the sole shareholder of the Borrowing Entity and the Borrowing Entity will be the sole shareholder of the Purchasing Entity;

THEREFORE BE IT RESOLVED:

- Tyendinaga Mohawk Council on behalf of MBQ hereby agree to incorporate two companies as part of the Transaction: (a) an Ontario corporation to act as the Purchasing Entity; and (b) an Ontario company to act as the Borrowing Entity.
- 2. Tyendinaga Mohawk Council on behalf of MBQ hereby agree to execute and deliver the Framework Agreement with such minor amendments thereto as the Tyendinaga Mohawk Council may approve, the execution by the Chief on behalf of MBQ of the said agreement to be conclusive evidence of such approval herein.
- 3. Tyendinaga Mohawk Council on behalf of MBQ hereby confirms that there is no community ratification or similar process required respecting (a) the incorporation of the Purchasing Entity and Borrowing Entity; and (b) the entering into of the Framework Agreement.
- 4. Tyendinaga Mohawk Council hereby authorize on behalf of and in the name of MBQ, all other acts and things as may be necessary or desirable to give effect to the foregoing. M.C.R. #2013/14-041
