> Whereas, the Mohawks of the Bay of Quinte are eligible for funding the Ontario Trillium Fund (OTF) to submit application to complete the required restoration to the interior of Christ Church; and

> Whereas, the total estimated amount required to complete the upgrade totals \$231,338 with OTF contributing \$150,000, The Christ Church Restoration Committee contributing \$50,000 and MBQ contributing \$25,000 in cash contribution + \$10,082 in project management services as an in-kind contribution.

Therefore be it resolved that the Tyendinaga Mohawk Council agrees to support the application to the OTF to complete the required restoration at the Christ Church for the total estimated amount of \$231,338.

And furthermore be it resolved that the Tyendinaga Mohawk Council approve to commit \$ 25,000 in cash contribution and \$10,082 as an in-kind contribution with the Christ Church Restoration Committee contributing \$50,000 and the OTF contributing remaining \$150,000 to complete the required restoration. M.C.R. #2014/15-030.
