They are looking to partner with a First Nation to build a Museum, Theme Park, Motel, etc. based on the Peace Maker. They are looking to lease 300 to 400 acres of land.

They would hire First Nations people. This is their first venture.

Andrew Clifford Maracle and Bruce Roundpoint would be the main contact for this. Allen stated there was a study completed about a year ago. This is a 2 billion dollar venture.

Triwin would like to introduce the Chinese to the First Nations' cultures. Andrew stated he has land on Eagle Hill.

Triwin is looking to have a joint venture with MBQ, it would be profit sharing and would need to lease land from MBQ.

This partnership would be 51% MBQ and 49% Triwin.

John MacDonald is Legal Counsel for Triwin. Triwin has bought Andrew Clifford Maracle's land on Hwy #2, not the house, and 10 acres.

Allen Yap also stated they would be interested in purchasing Foresters Island.

Council only considers written proposals for any economic venture.

Whereas, the total estimated amount required to complete the upgrade totals \$231,788 with Parks Canada contributing \$25,000, the Ontario Trillium Fund contributing \$150,000, The Christ Church Restoration Committee contributing \$21,706 and MBQ contributing \$25,000 in cash contribution + \$10,082 in project management services as an in-kind contribution.

Therefore be it resolved that the Tyendinaga Mohawk Council agrees to support the application to Parks Canada's National Historic Sites Cost-Share Program to complete the required restoration at the Christ Church for the total estimated amount of \$231,788.

And furthermore be it resolved that the Tyendinaga Mohawk Council reaffirm their commitment of \$25,000 in cash contribution and \$10,082 as an in-kind contribution and the Christ Church Restoration Committee contributing \$50,000. M.C.R. #2014/105-080
