WHEREAS, the total estimated amount of costs required to complete the repairs totals \$47,000.00 with the MTO contributing \$23,500.00 and MBQ contributing \$23,500.00

WHEREAS all work will be completed by March 31, 2015, all unused funds shall be returned to MTO and all overrun costs will be the responsibility of the Mohawks of the Bay of Quinte.

THEREFORE BE IT RESOLVED that the Tyendinaga Mohawk Council agrees to accept the amount of \$23,500.00 from MTO for repairs regarding the settlement of Airport Road.

AND FURTHERMORE BE IT RESOLVED that the Tyendinaga Mohawk Council approves to commit \$23,500.00 to complete the repairs regarding the settlement of Airport Road.
