WHEREAS the Immediate Needs Fund will support First Nation communities in immediate need of multi-units, renovations and additions or lot servicing on reserve. The Tyendinaga Mohawk Council is requesting funding from the following steam:

Immediate Needs Fund:

Number of units funded through the Fund:

- Construction of 4-Plex (4 units)
- Renovation and Additions \$250,000

WHEREAS the Tyendinaga Mohawk Council has informed itself and understands the funding requirements as set out in the parameters and eligible investment categories for the Immediate Needs, and agrees with them.

WHEREAS the Tyendinaga Mohawk Council commits to:

- 1. Complete the projects within timeline as defined in its needs identification form
- 2. Comply with the parameters and eligible investment categories for the Immediate Needs Fund
- 3. Comply with all applicable federal and provincial environmental protection statues and regulations that may apply to the projects
- 4. Have a fair and transparent process to allocate funding towards new construction and renovation to ensure it targets and benefits those in highest needs, particularly vulnerable population groups, such as the elderly, disabled, single parents and their children, families dependent on social assistance.
- 5. Identify revenue sources for ongoing maintenance of new builds and renovated units for which funding has been requested via the Immediate Needs Fund.

- 6. Ensuring that there is no evidence of contamination on the lands on which housing units will be built or renovated that may, upon exposure, constitute an identifiable risk to human health or to the natural environment.
- 7. Certify that all housing units constructed or renovated will be inspected by qualified inspectors who must confirm that they meet or exceed the National Building Code (NBC) standards. The Tyendinaga Mohawk Council agrees that the record of inspection and record of compliance to the NBC standards and other applicable code standards will be kept on file by the Tyendinaga Mohawk Council and provided to the Department as per the eligible investments of the Immediate Needs Fund.

THEREFORE BE IT RESOLVED the commitments made herein are irrevocable. M.C.R. #2016/17-030.
