residences located along the York Road east of Wyman's, Tyendinaga Mohawk Council propose to invite five local construction firms to complete the watermain installation,

Therefore be it Resolved, that Tyendinaga Mohawk Council hereby requests funding from Indigenous and Northern Affairs in the amount of \$636,220 to design, tender and install 800m of 300mm watermain to provide water and fire protection servicing to the Mohawk Community Centre, Firehall, Home Support Building, the Orange Lodge and four (4) residential homes.
