

**TYENDINAGA MOHAWK COUNCIL MINUTES  
APRIL 14, 2021**

A special meeting of the Tyendinaga Mohawk Council was held on Wednesday, April 14, 2021 at 4:20 p.m. in the Council Chambers.

Present: Chief R. Donald Maracle  
Councilors: Carl E. (Ted) Maracle, Lynda Leween and Kelly Maracle  
Josh Hill absent

Staff: David Souliere, CAO; Angela Maracle, Senior Director of Operations; Shelley Bowden, Executive Administrative Assistant and Recording Secretary to Council joined via Microsoft Team Conferencing.

MOTION #1: Moved by Kelly Maracle, seconded by Lynda Leween that WHEREAS, the Tyendinaga Mohawk Council strongly supports and strives to preserve and enhance the Kanyen'keha language and culture revitalization for the Mohawks of the Bay of Quinte.

AND WHEREAS, the Tyendinaga Mohawk Council has worked closely with Tsi Tyonheht Onkwaen:na (TTO), a community-based organization that provides language and cultural programming;

AND WHEREAS, TTO would better be able to deliver cultural activities, language learning and intergenerational knowledge sharing in a larger community cultural space;

THEREFORE, BE IT RESOLVED that the Tyendinaga Mohawk Council approve the application to the Indigenous Community Capital Grant Program (ICCGP) in the amount of \$150,000 to conduct the Detailed Design for a Kenhetke Cultural Centre. M.C.R. #2021/22-003.

MOTION #2: Moved by Lynda Leween, seconded by Carl E. (Ted) Maracle that WHEREAS the Mohawks of the Bay of Quinte are applying to the Indigenous Community Capital Grants (ICCG) Program fund.

WHEREAS the funding application in the total amount of \$442,802.00 will help support the Mohawks of the Bay of Quinte to renovate the building located at 274 Highway 49, Tyendinaga Mohawk Territory, K0K 1X0.

WHEREAS, the Tyendinaga Mohawk Council will contribute 10% (\$44,280.20) towards the project if approved.

THEREFORE BE IT RESOLVED that the Tyendinaga Mohawk Council supports submitting the ICCG Program funding application requesting funding in the amount of \$396,362.20. M.C.R. #2021/22-004.
