- ii. Article 21(2): States shall take effective measures, and where appropriate, special measures to ensure continuing improvement of their economic and social conditions. Particular attention shall be paid to the rights and special needs of Indigenous elders, women, youth, children and persons with disabilities.

AND WHEREAS: The Chiefs in Assembly have supported through Resolution 25/2018 that "the Minister of Employment, Workforce Development be called on to Initiate a parallel process for the full devolution of labour market authority and jurisdiction under the control of First Nations Government".

AND WHEREAS: The devolution process is in effect through the Indigenous Skills and Employment Training Strategy and the Tyendinaga Mohawk Council supports the process of First Nations Government and is ready to assume its own responsibility in regards to the labour market authority.

THEREFORE BE IT RESOLVED That the Tyendinaga Mohawk Council work directly with the Aboriginal Labour Force Development Circle as the Agreement Holder to implement their own agreement with the Aboriginal Labour Force Development Circle asserting jurisdiction of their own labour market strategy.

AND FURTHER BE IT RESOLVED That this process be in effect as of April 1, 2021. MCR #2020/21-025
