A meeting of the Tyendinaga Mohawk Council was held on Tuesday, October 5, 2021.

MOTION #1: Moved by Josh Hill, seconded by Lynda Leween that
WHEREAS: The Tyendinaga Mohawk Council has been informed by the Tyendinaga Police Service that the following person:

Shannon Clara HARTMAN DOB: 1984/06/12

Presents a demonstrated threat to the peace, security and health of the residents of the Mohawks of the Bay of Quinte:

AND WHEREAS: **Shannon Clara HARTMAN DOB: 1984/06/12**, was found during the execution of a judicially authorized Controlled Drugs and Substances Act search warrant within 28 Deserontyon Dr., Tyendinaga Mohawk Territory, which will result in drug possession charges, has an extensive and violent criminal history, including drug trafficking and possession convictions, exhibits an inability to comply with court orders and is not a member of the Mohawks of the Bay of Quinte nor is there evidence she is of indigenous descent.

THEREFORE, BE IT RESOLVED: That **Shannon Clara Hartman DOB: 1984/06/12**, be prohibited from being on the Tyendinaga Mohawk Territory of the Mohawks of the Bay of Quinte for any reason. M.C.R. #2021/22-047.

Sandy Sousa DEOLIVEIRA DOB: 1987/07/30

Presents a demonstrated threat to the peace, security and health of the residents of the Mohawks of the Bay of Quinte:

AND WHEREAS: **Sandy Sousa DEOLIVEIRA DOB: 1987/07/30**, was found during the execution of a judicially authorized Controlled Drugs and Substances Act search warrant within 28 Deserontyon Dr., Tyendinaga Mohawk Territory, which will result in drug possession charges, has a criminal history, including drug trafficking conviction and exhibits an inability to comply with court orders and is not a member of the Mohawks of the Bay of Quinte nor is there evidence she is of indigenous descent.

THEREFORE, BE IT RESOLVED: That **Sandy Sousa DEOLIVEIRA DOB: 1987/07/30**, be prohibited from being on the Tyendinaga Mohawk Territory of the Mohawks of the Bay of Quinte for any reason. M.C.R. #2021/22-048.

Vicardo (a.k.a. Adrian) WADE DOB: 1990/02/28

Presents a demonstrated threat to the peace, security and health of the residents of the Mohawks of the Bay of Quinte:

AND WHEREAS: **Vicardo (a.k.a. Adrian) WADE DOB: 1990/02/28**, was found during the execution of a judicially authorized Controlled Drugs and Substances Act search warrant within 28 Deserontyon Dr., Tyendinaga Mohawk Territory, which will result in drug possession charges and is not a member of the Mohawks of the Bay of Quinte nor is there evidence he is of indigenous descent.

THEREFORE, BE IT RESOLVED: That **Vicardo (a.k.a. Adrian) WADE DOB: 1990/02/28**, be prohibited from being on the Tyendinaga Mohawk Territory of the Mohawks of the Bay of Quinte for any reason. M.C.R. #2021/22-049.
