To Tyendinaga Community Members

The Education Feasibility Study has set out to review the current education system as part of life long learning in the community. The Tyendinaga Education Steering Committee (TESC) is guiding the education study process. As well, MBQ hired the consultant firm Native Management Services, Mary Jamieson and Darrin Jamieson, to conduct the study.

Native Management Services have held focus groups and community meetings and are compiling surveys and conducting research to gather as much data as possible about our education system and its future potential. Community meetings will be held to provide interim reports on the study progress as information becomes available.

The Education Feasibility Study is a major project and the findings will be shared with community members in May 2008. The final report will be provided to community members with information to help them make an informed decision about the future direction of education in Tyendinaga.

Recent feedback from community members has indicated that there is a concern that the consultants' final report will be shared with Indian and Northern Affairs Canada (INAC) and that INAC expects this report and a decision about increased control on March 31, 2008. This is *not* the case. The current project funding timeline ends June 30, 2008. With respect to a decision about increased control, the community will not be asked to make any decision until all the information has been collected.

Another concern brought forward is that community members feel that a decision has already been made about local control of education. However, *no* decision has been made about increasing control over education in the community. This is a community decision to make and it will be community members who make any decision and not the Tyendinaga Mohawk Council.

### Information Update: March 5, 2008

#### Reconsideration of Common Experience Payments Has Begun.

Indian Residential Schools Resolution Canada (IRSRC) is now processing applications for the Common Experience Payment (CEP) Reconsideration Process.

All CEP applicants eligible for reconsideration, who have not already applied, will soon be receiving a letter informing them about the Reconsideration Process. This letter will be from the National Administration Committee (NAC), the multi-party Committee overseeing the administration of the Indian Residential Schools Settlement Agreement.

#### What is the Reconsideration Process?

The Reconsideration Process is a second review by the Government, as Administrator to the court-supervised process, to ensure that the original decision for each applicant is accurate and appropriate. The review will also consider any additional information provided by the applicant.

#### Am I eligible for the Reconsideration Process?

To be eligible for reconsideration, the former student for whom the application is made must:

- Have been a resident at an Indian Residential School(s), not a day student;
- Have resided at a school that is on the list of recognized Indian Residential Schools;
- Have been alive on May 30, 2005;
- or
- Lived at the Mohawk Institute Residential Boarding School in Brantford, Ontario between 1922 and 1969, and been alive on October 5, 1996.

#### When should I apply?

If you are not satisfied with the outcome of your CEP decision, and you have not already applied for the Reconsideration Process, you have **six months** from the date noted at the top of your CEP decision letter or from the date the NAC letter is issued, whichever is later, to apply for the Reconsideration Process.

If you do not apply for the Reconsideration Process, you will not be able to appeal your assessment any further.

#### How do I apply?

It is important to note that applicants do not need to find their records or provide additional information in order to have their file reconsidered. However, we encourage applicants to provide any information they may have that might help researchers to confirm residence and years of residence.

Our objective is to ensure that all eligible former Indian Residential School students are compensated according to the Indian Residential Schools Settlement Agreement.

#### How long will it take to have my CEP reconsidered?

It is important to note that although some requests may be processed in early March, 2008, the majority will be processed within 90 days from now (if you have already submitted a reconsideration request) or up to 90 days after you apply. Some requests will be extremely complex and may take up to 160 days to process.

#### What happens if I'm not satisfied with the reconsideration decision?

After reconsideration, if the applicant still disagrees with the decision that has been made, they have the right to appeal to the NAC. Additional details on the Appeal Process will be provided in writing with the reconsideration letter. Applicants will not be able to appeal to the NAC until they have gone through the Reconsideration Process.

### ATTENTION CANADIAN CITIZENS TRAVELLING TO THE UNITED STATES BY LAND OR WATER

As of **January 31, 2008**, if you travel to the U.S. by land or water, a U.S. law will require you to present:

- A government-issued photo ID, such as a driver's licence; **AND**
- A birth certificate or citizenship card;
- OR**
- A valid passport;
- OR**
- A NEXUS or a Free and Secure Trade (FAST) card;
- OR**
- For those 18 and under, a birth certificate.

Canadian citizens flying to or through the U.S. must present a valid Canadian passport.

In February, Kahniothe Library held a reading of the Minutes of 1800. Over the next few months we will be printing these minutes in the newsletter.

In September 1800 there was a Council Meeting held in the community that spanned 8 days. This meeting was held to try to come to some resolution of the troubles that had been dividing the community at that time.

These minutes were recorded by John Chew, a Secretary for Indian Affairs.

Proceedings of a Council held at the Bay of Quinte beginning on the 2<sup>nd</sup> and ending on the 10<sup>th</sup> of September 1800, in the Mohawk Village

Captain Claus addressed the meeting as follows:

Brothers - The melancholy business which has lately happened here induced your Father, General Hunter, to order me down to meet you, and to inquire into the cause of your disputes, and if possible to bring you together again as friends and relations should always be. The greatest misfortune which can possibly happen to you is that of living in a divided State - you lose all your domestic comforts and all your respectability as a Nation. You not only injure each other individually, but you bring disgrace and sorrow on all connected with you; Nor can I avoid telling you that I feel in a very sensible manner every circumstance that tends to weaken you as a Nation, or to interrupt the harmony and mutual good will of men who should live as one family and who should resolve that no consideration should disunite them. Your father, however, is desirous of knowing the grounds of your disputes which have terminated so unfortunately, and I shall be glad to hear what each party has to say tomorrow morning at 10 o'clock as it is now too late to proceed to business.

September 3<sup>rd</sup>

Captain Isaac spoke as follows:

Brothers - I only want to say a few words: it is to know how you received this bad news and from whom you received it.

Captain Claus answered: That he had heard it as he has always been accustomed to hear news, that is, from the Head of the Village and that he had come down to make a particular enquiry into the business that he might be satisfied of the Truth.

Captain Isaac then said: I will tell you, Brother, the whole business in a very short time.

There was some money brought from Albany, Viz., 500 dollars by Captain Brant and 500 by Captain John for the payment of the Lands sold, to the American Government, on the Mohawk River. When Captain John arrived here, we enquired whether he had sold the Lands and brought the money, and what news he brought with him; Captain John answered, the Americans and us are different people, and are not fond of communicating any news to us, knowing we belonged to a different Country. We then asked John what he had done in the business he went upon and he answered, "it would do very well for a Messenger to be questioned in that manner, which he did not consider himself to be." Captain Isaac says that they had heard what money he had brought and that he had made away with the greatest part of it, which made a great riot in the Village. This was three years ago last spring - sometime after that Captain John went to Montreal and no one knew on what business, until he returned, when he held a Council with the whole Village except Captain Isaac. That Captain John told them, he had assembled them and that it would be for the last time and he hoped they would consider well what he was going to say. He then told them a Chief who had the care of a Village should be a man of sense and good conduct, to lead people in a proper manner and instruct them in what was right. He then desired that all of them should speak their minds freely and not hang down their heads as they had always done, but to speak out and have no secrets among them, and after making this speech he quitted the Council and would have nothing more to say to them.

That two years afterwards the young men of the Village met, and he, Captain Isaac, was with them; and they appointed Chiefs of the Village, at which time Laurence, one of the men who was killed and who was half-Brother to Isaac, said "as they could get no satisfaction from Captain John for the money he got at

Albany, they would take his property and sell it as they were determined to get as much as they could from his property. That every time they met, Laurence was always repeating this, and said further, if Captain John resisted he would settle him as he was a very great thief. That he, Captain Isaac, told Laurence he should not repeat these things so often that it was of bad consequence to threaten in that manner, and that he had better drop the matter, and take no further notice of it as the loss of money was of no consequence, but a life was of great value - this was all that happened at the time.

Last summer he, Captain Isaac, and a part of the Mohawks went down to Lower Canada, and held a Council with the 7 Nations of Canada at LaChine, from whence they went to Sir John Johnson's where they received presents. Laurence was dissatisfied with what he received and applied to Mr. Chew to give him more, which Mr. Chew refused saying he had no authority, tho he notwithstanding gave him some trifle. Laurence was nevertheless dissatisfied, it being so trifling. They then came off from LaChine to return home and they conceived that Laurence was dissatisfied the whole way up. The people of the Village, on the arrival of the party, desired they might meet and hear what had been done in Lower Canada, and they met accordingly, except Laurence who not being satisfied would not appear in the Council.

That the last spring He, Isaac, and his people Appointed a meeting to be held on Easter Sunday for the purpose of erecting a Saw Mill on the Indian Lands. That after the Council, the people staid at his (Isaac's) house that they might be in readiness to go to put up the Mill the next day, and in the morning a Messenger was sent up by Captain John saying if they attempted to build a mill, it would not be good, as he was going to build a mill there himself. That when they received that message, they said they would drop it as it would occasion confusion among them; and as there were two rapids, they would take the upper one as they did not wish to make any disturbance.

That on the 4<sup>th</sup> of June He, Capt. Isaac, assembled his people and Capt. John assembled also his people, at different places and made themselves merry. That on the next day John Mircle and Seth went into the plain to Hunt up Horses and met Laurence; that Laurence struck Mircle severely with a stick three times. That on the 9<sup>th</sup> June he, Isaac, met Laurence's son, Thomas, and desired him to tell his father not to make a practice of beating people when he met them in the woods, for that was not their ancient custom & desired him also to tell his father if he made a practice of beating people he might repent it; and that Laurence sent him back an answer the same day that it was very wise, that was what he wished for. That He, Isaac, sent his negro boy the same day for some seed corn to Seth's house and desired him to avoid Laurence for fear of accident. That notwithstanding this precaution the negro boy and Laurence met and Laurence desired him to tell his master, Isaac, to appoint any place he thought proper and he, Laurence, would meet him. Laurence added "If you do not tell your master then, I will kill you the first time I see you, and if he does not send me a message back I certainly will kill him, and if he does not point out a place where we are to meet, I will do it for him the first time I see him". Capt. Isaac says further that Laurence was not drunk and that if Mircle had not run away when Laurence struck him, it was his design to have killed him upon the spot. That when the negro boy delivered him the Message to appoint a place to meet Laurence, he was much affected and after considering some time and that it was a matter of great consequence and that he was a man, he took his sword in his hand.

That very early in the morning of the 10<sup>th</sup> June last, he, Captain Isaac, sent his Black boy to Laurence to inform him he had appointed a place of meeting which was half-way between their two houses - and that soon after the negro boy returned with an answer from Laurence saying he was ready. That he, Capt. Isaac, then got up and went to meet him, three others with him. When they came to the place appointed no one was there, but in the course of a little time Laurence and two others appeared, and did not appear to be armed. Capt. Isaac then told his men, about 5 minutes before Laurence arrived, that they were not to interfere in the matter at all, that he and Laurence would decide the matter themselves and that they, by no means, were to interfere in the business. That when he, Capt. Isaac & Laurence met, they mutually saluted each other and said good Morning. He, Capt. Isaac, then asked Laurence if he had received the message he had sent him - Laurence said he had - and told Capt. Isaac he was always abusing his sons and immediately came up with a stick and knocked Capt. Isaac down, so that the sword he had was of no use to him. He, Capt. Isaac, says that he hoped to have settled their differences by speaking to Laurence, but he was struck down so suddenly, he had not an opportunity. That after laying sometime, he got up and was knocked down again with the same stick and also a third time in the same manner, after which he was incapable of getting up, but when he recovered and looked round him he saw the ground Bloody, not knowing in what manner it came there.

Adjourned till tomorrow at 10 o'Clock. Captain John wishing at that time to prepare himself to speak.

### WATERSHED CONDITIONS BULLETIN

Quinte Conservation is advising local municipalities and watershed residents regarding changing conditions in local watersheds.

Warming temperatures, precipitation and snow melt will cause water levels on local rivers, lakes and streams to increase steadily during the coming week throughout the Moira, Salmon and Napanee watersheds and in Prince Edward County.

Water levels are currently slightly below normal and rising. Most of the river ice cover is gone but ice remains on larger lakes. The risk of ice jamming is low.

Quinte Conservation personnel are monitoring watershed conditions closely and any changes in the conditions will be updated later this week.

Quinte Conservation staff monitor water levels and weather forecasts carefully as part of the agency's flood forecasting and warning program. Information on water levels and information bulletins are available at [www.quinteconservation.ca](http://www.quinteconservation.ca). Quinte Conservation's area of concern includes the drainage basins of the Moira, Salmon and Napanee Rivers and their tributaries, and all of Prince Edward County.

A watershed conditions bulletin is issued to raise awareness about a change or potential change in conditions on local waterways. An update to this bulletin may be issued if conditions warrant.

### A FRIENDLY REMINDER!

The Water Sampling Program will continue throughout the year. I wanted to notify community members that I will be around to each of your homes as quickly and, sufficiently as I can.

It's important to have your water tested at **least three times per year**, with one of those samples taken in the spring.

If you do not wish to have any samples taken at your house please call to have your named removed from the list. This also ensures that other homes that wish to be sampled receive earlier service.

### Helpful Water Hints

( TO HELP MAINTAIN POTABLE WATER)

**FAQ:** Bacteria such as e.coli and total coliform can grow inside your screened taps. To prevent bacteria growth, soak your aerators in javex and remove all debris from the inside of the screen.

**FAQ:** Water storage tanks/cisterns can become contaminated. You should have your water tested to ensure its safety. Instructions can be provided to help you clean your tanks/cisterns if required.

**FAQ:** Used or soiled dish clothes can contain bacteria. You should never wrap a used dish cloth around your tap or have it near the aerator. This can cause the bacteria to spread into your tap.

**FAQ:** Animals that have access to drink the water directly from the taps can also cause bacteria growth in a faucet. Never allow an animal to drink directly from taps or sinks.

**FAQ:** If you are reusing drinking water containers, disinfection is essential. Bacteria could potentially build up if containers are not cleaned frequently with pure javex.

**FAQ:** Water coolers should also be cleaned with javex at least twice a year to prevent bacteria growth. Instructions can be mailed to you if requested.

Chief Maracle opened the meeting with prayer.

Trustee Report for March 2008.

A major concern for all Boards of Education in Ontario is the implementation of Bill 212 which is an Act to Amend the Education Act in respect of Behavior, Discipline and Safety and Regulations and Policy/Program Memoranda. The new Safe Schools Act comes into effect February 1, 2008. School Boards are now required to: - Provide programs to students who have been expelled or are on a long-term suspension to allow them to continue their education and access services such as anger management or career counseling

- Treat bullying as an infraction for which suspension must be considered
- Consider mitigating and other factors before students are suspended or expelled
- Respond to all inappropriate behaviours in the most appropriate way instead of automatic suspensions and expulsions (in most cases). This could include a range of consequences such as meetings with parents, referral to a community agency, suspension or expulsion.

On the topic of the Self Identification Process, representatives of Band Council, Administration and Education along with HPEDSB director Kathy Soule and Elizabeth Bigwin from the Toronto Native Education Office continue to work together to develop the process. 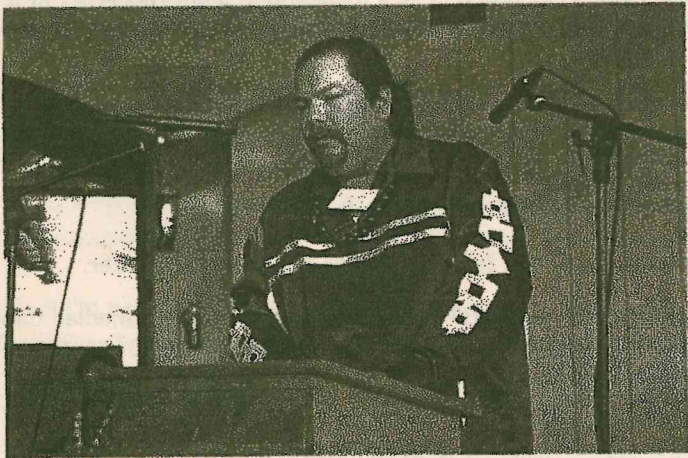

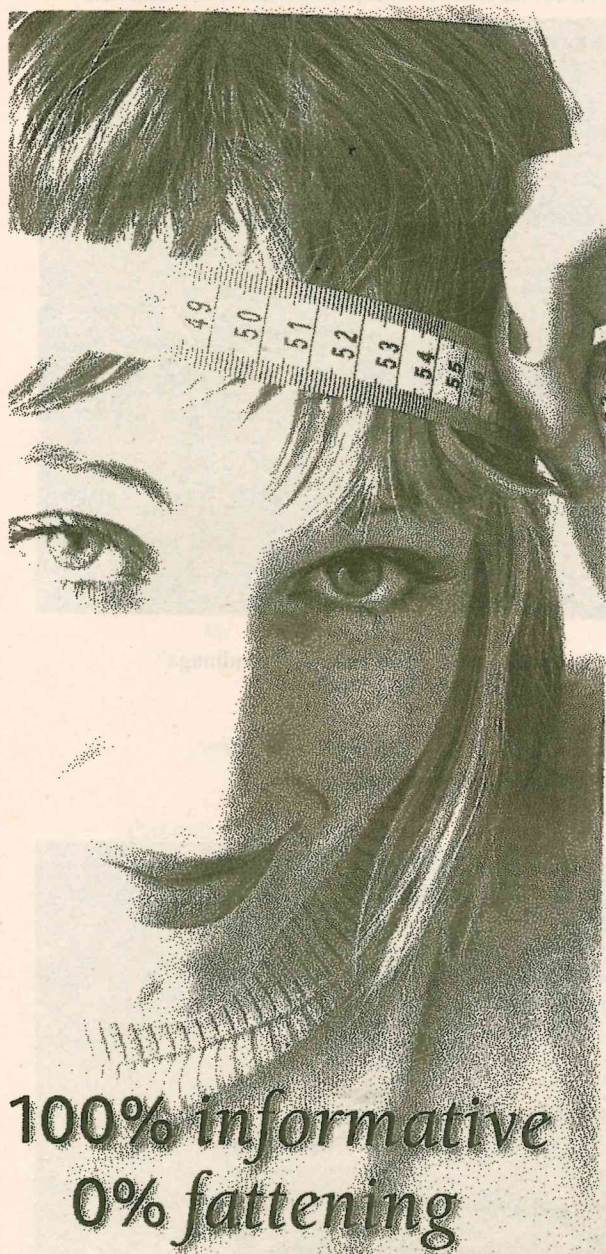

### Colorectal cancer screening saves lives

Colorectal cancer is the third most common cancer in men and women. But, with tests, it can be found early and in some cases, can even be prevented.

“Colorectal cancer is 90 per cent curable when found and treated early. This percentage drops to 10 per cent when found in the later stages of the disease,” says Danielle Paterson, senior manager, prevention at the Canadian Cancer Society, Ontario.

Colorectal cancer was much less common among Aboriginal people in the 1960s and 1970s. But since then, it has risen to the same levels as the rest of Ontario. Colorectal cancer shares some of the same risks as diabetes – which is rising among Aboriginal people. The risks are obesity, lack of exercise or physical activity and poor diet. Smoking is also a risk factor for colorectal cancer.

Thanks in part to the Canadian Cancer Society's work, the Ontario government has started a province-wide colorectal cancer screening program – the first in North America – that will save lives. The program is rolling out over five years and is aimed at all Ontario men and women 50 years old and over. It recommends a fecal occult blood test (FOBT) every two years for those at average risk and a colonoscopy for those at higher risk. The FOBT is a simple test that looks for blood in the stool (poop) that can't be seen by the naked eye. You can get a test from a doctor or healthcare worker.

People usually only need a colonoscopy as a follow-up to a positive FOBT or if they are at higher risk of getting colorectal cancer because another member of their family has had the disease

Speak to your doctor or healthcare worker about a plan for you if you have:

- a first-degree relative (such as parent, sister or brother) who has had colorectal cancer
- another bowel problem
- small growths (polyps) on the inner wall of your colon

Also, if you don't know your risk, talk to a doctor or healthcare worker.

In Ontario, about 7,800 people were diagnosed with colorectal cancer in 2007 and another 3,250 died of the disease.

“Colorectal cancer screening should be part of a lifelong strategy for healthy living for both men and women 50 and over,” says Paterson.

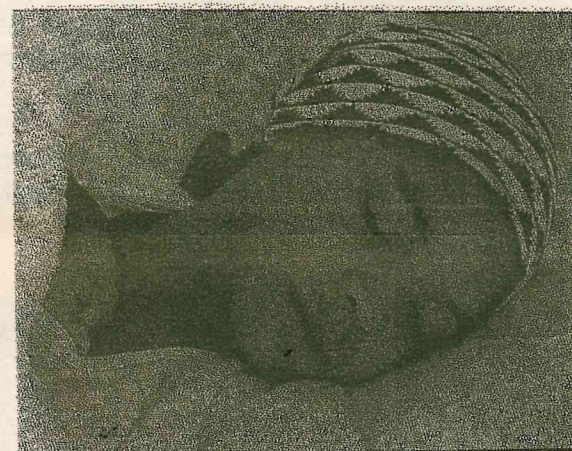

#### What is Kangaroo Care?

Kangaroo care is a way of nurturing a baby to enhance skin-to-skin contact between baby and parent. The term *kangaroo care* is used because the method is similar to how a baby kangaroo is nurtured by its mother - from the safe environment of the womb to the safe environment of the pouch where the baby continues to mature. Skin-to-skin contact creates a very special bond, and offers comfort to fussy or colicky babies. Although kangaroo care has been shown to enhance milk supply and breastfeeding, *kangaroo care is for all newborn babies*. Whether or not you are breastfeeding, we encourage you to call for information and help to kangaroo your precious little one. Comfortable kangaroo wraps are available for loan. 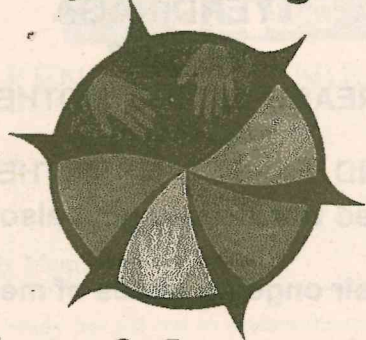

## RED CEDARS & RECREATION

### What is Stalking?

Stalking is a form of abuse. The purpose of stalking is to intimidate, threaten and control the victim. Stalking is against the law and is legally termed *Criminal Harassment*. The offence of Criminal Harassment appears in Section 264 of the Criminal Code of Canada.

Criminal Harassment can include a variety of behaviours and action, and is usually a pattern of behaviour rather than a single incident. Stalking is intended to intimidate the victim – behaviours that are simply annoying would not likely be considered Criminal Harassment (unless coupled with other harassing behaviours, listed below), and it is unlikely that the police would be able to intervene.

#### Stalking includes:

- Repeated phone calls, phone messages, text messages or emails that aggravate or threaten the recipient
- Repeatedly sending unwanted or unsolicited items to the recipient
- Following the victim, or people associated with the victim, such as children, parents, friends
- Taking or tampering with mail
- Trying to obtain private information about the victim from other people
- Entering your residence when you are not there or forced entry into your residence
- Vandalism to property that belongs to the victim or to people associated to the victim
- Threats or assaults against the victim or their pets

#### Who is the Stalker?

Typically, stalkers fall into one of three general categories: intimate, delusional or vengeful.

- Intimate stalkers are those who just can't let that certain someone "go". They usually have had an intimate relationship with that person that is now ended.
- The **delusional** stalker is one that has had little or no contact with the victim but somehow feels connected to them despite this. The stalker believes that a relationship exists between him and the victim when there isn't one. "Obsessive" is a word that would describe this type of stalking.
- The **vengeful** stalker is someone that has had an altercation with the victim or feels that the victim has somehow slighted or insulted them. "Getting even" is the purpose of this type of stalking.

#### Statistics:

- 88% of stalkers are men
- 80% of victims are women
- 57% of stalkers are former partners of the victim
- 28% are co-workers or friends or acquaintances

#### DO's and DON'T for protecting yourself:

- DO avoid all contact with your stalker once you have told him NO.
- DO tell people what is happening to you and the danger you feel.
- DO tell others the importance of keeping your personal information private.
- DO keep everything your stalker sends you and document anything that happens.
- DO consider reporting the harassment to police.
- DO find a women's program that can offer guidance and support.
- DON'T ignore the stalkers actions or keep it a secret.
- DON'T underestimate the danger you may be in.
- DON'T try to deal with your stalker by yourself.

It is important to have a safety plan that allows you to be prepared in case of an emergency. You will want to have a safe place to go and people to contact (emergency supports). Be sure to bring any documentation that supports your concerns.

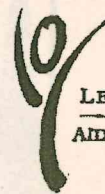

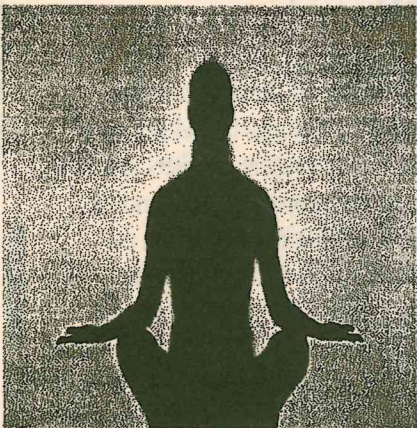

### How to Make Mealtime Enjoyable

### Attention to all Indigenous Peoples: Inuit, Metis, & First Nations!!

A call for quilt blocks acknowledging and honouring our pain and horror, BUT  
MOVING ON TO HEALING, TO LIVING A GOOD LIFE.

As a result of all the news and information, Stories and Truths about the horrible and hideous experiences lived by people of Indigenous Heritage of this great and sacred Turtle Island in the residential schools, and all the scary undesirable effects resulting from all that, there are several paths that have been taken to help us to heal from that atrocity. One of those ways is the setting up of The Truth and Reconciliation Commission (TRC) which works towards developing, as much as is possible, a fair and lasting resolution of the damning legacy of Indian residential schools. The TRC, "an official body that investigates a pattern of abuses over a period of time in order to create an accurate and public historical record of the past" will function for 5 years, so The People will be able "to share their individual experiences in a safe and culturally appropriate manner through statement taking or truth-sharing". At the end of it all, a final report on the research and historic findings, and recommendations will be produced and distributed widely. So that it will be accessible to all, a National Research Centre will be established.

As part of my efforts to help us along on our personal healing journeys, I am putting out a call for quilt blocks. Each square should be 13" x 13". The design is yours; the colours are yours; the embellishments are yours; the materials you use are your choice. Just make sure the blocks can be added and used in the quilt. You can even paint on canvas or stiff paper, or use photos or pictures, because I can get these things transferred onto fabric - which can then be used in the quilt. If you have any questions about what media you can use, please get a hold of me. The project is to create a quilt made up of the squares sent in to me by Indigenous Peoples who contribute a square depicting the theme. Each block is to be about what you want to express regarding residential schools. It can be about what you experienced, or it can be about how you have compassion for what others of Our Peoples went thru - whatever it is YOU want to share or express. The quilt will hang at the National Research Centre on residential schools when it is established. All the blocks have to be in my hands by Aboriginal Day, June 21, 2008.

When you send your block in to me, Please include:

1. A long or short story telling what your square is about,
2. Your name and address
3. Your email address (if you have one) and
4. Your phone #. I may need to ask you something about your square and I would like to keep you informed about the progress of the quilt and maybe even be able to send you a picture of the completed quilt.
