A Mohawk Law to recognize FNTI – Update – March 19<sup>th</sup>, 2009

A community meeting was held on February 10<sup>th</sup>, 2009 as part of the process for establishing a by-law in Tyendinaga. Unfortunately, attendance of community members at the meeting was very low. In the normal process for establishing a by-law, the next step would be to pass a Band Council Resolution and submit the draft by-law to Indian and Northern Affairs for the ministers' approval. Since there was a low number of attendees at the meeting, TMC will postpone the submission to INAC and offer another opportunity for community input.

Questions asked at the meeting

**How will FNTI ensure graduates are able to gain employment in the community?**

FNTI is an education and training institute, developing and delivering courses and programs to meet community needs (all Aboriginal communities), other than the 40 + jobs at FNTI, there is no mandate to create employment.

**What is the success of FNTI?**

An independent consulting firm hired in 2005 to perform an operational review noted FNTI boasts a 90% + graduation and employment rate, considerably higher than mainstream colleges and universities which have typically have 50%-60%.

**What mechanisms are in place to ensure 3<sup>rd</sup> party objectivity?**

The proposed by-law does not affect the current operations of FNTI. The policies currently in place to deal with complaints, appeals and evaluations will be maintained.

**How much funding comes from Mohawks of the Bay of Quinte for FNTI?**

MBQ does not provide regular operational funding to FNTI; however, student tuition funding does get paid to FNTI for students enrolled at FNTI.

**How will FNTI ensure quality education?**

The proposed by-law does not affect the current operations of FNTI. Existing quality assurance mechanisms such as student evaluations, program evaluations, curriculum development guidelines, etc. will continue.

**The MBQ education feasibility study in 2007/2008 indicated the community was NOT ready to take control of education, why would we pass a by-law to recognize FNTI?**

MBQ (community) has been in control of FNTI since inception in 1985 through an independent board of directors supported by Tyendinaga Mohawk Council.

The proposed by-law has little to do with FNTI operations. FNTI has existed for 24 years in its current status as an Aboriginal post-secondary institute developing and delivering courses and programs with accreditation through mainstream college and university partners.

The proposed by-law is more of an exercise in jurisdiction. The provincial government under the constitution of Canada has the jurisdiction for education. Unfortunately, the province of Ontario refuses to grant FNTI accreditation status because it is situated on reserve, which is the jurisdiction of the Federal government. Since both levels of government refuse to deal with the jurisdictional question and since TMC has provisions under the Indian Act to create by-laws, the council proposes the development of this by-law in an effort to exercise jurisdictional authority to grant FNTI charter status in order to grant academic credentials (certificates, diplomas, degrees) to its students.

AND WHEREAS, the outstanding principal balance of this existing loan will be refinanced for which loan, the Mohawks of the Bay of Quinte Band is a party to a Project Operating Agreement for the receipt of operating subsidies under Section 95 of the National Housing Act.

AND WHEREAS, Project operating subsidies under Section 95 of the National Housing Act will be available to assist with the rental housing project's financial viability while the Band is in compliance with the Section 95 Project Operating Agreement

AND WHEREAS, The Band is responsible for the management of the project under the terms of the Section 95 Operating Agreement as long as the loan is in effect.

AND WHEREAS, Financing shall be as follows:

Outstanding Principal Balance

Of Loan at Renewal \$595,597.83  
AND WHEREAS, The loan is to be amortized over a period of 14 years, 9 months at an interest rate and term maturity to be determined by the Bank of Montreal as lender, and pursuant to the provision of the National Housing Act. AND WHEREAS, Monthly payments on the loan will be the responsibility of the Band.

AND WHEREAS, The rental housing project shall remain the property of the Band while the loan is in effect. THEREFORE BE IT RESOLVED, Property insurance shall be provided as required under the terms and conditions of the project countersigned Offer to Lend for a loan under Section 15.1(1) of the National Housing Act.

AND BE IT FURTHER RESOLVED The Minister of Indian Affairs and Northern Development is hereby authorized to direct the transfer of Indian monies of the Band to the extent that such monies are or may become available, for the purpose of reimbursing Her Majesty the Queen in right of Canada as represented by the Minister of Indian Affairs and Northern Development for any payment made by her Majesty to the Bank of Montreal as lender at any time in the future in respect of repayment of the loan requested by this resolution. Repayment of which we hereby request the Minister to guarantee. The authority conferred herein is irrevocable. M.C.R. #2008/09-130



M.C.R. #2008/09-132

#### Recognizing an Unhealthy Relationship

*How do I know if my relationship with my partner is not healthy?*

There are many signs of a hurtful, unhealthy relationship.

- Get very jealous when I am around other people?
- Make fun of me in front of friends and family?
- Destroy or threaten to destroy my things?
- Ask me not to spend any time with my family or friends?
- Put me down or blame me when things go wrong?
- Call me names and threaten to hurt me?
- Threaten to take the children from me?
- Push me around or hit me?
- Take away control of all of the money?

*I feel I'm to blame. Maybe if I try harder to please my partner, things would be different.*

You are not to blame for your partner's behaviour or actions. No one has the right to hit you or constantly put you down. If your partner acts or behaves like this, you may feel:

- Alone and isolated from family and friends
- Anxious because you have to do everything just right...or else
- Depressed, unhappy, unwell and unable to get to sleep
- Afraid to say what you think because of your partner's reactions or anger
- Scared to break up or leave your partner
- Embarrassed to tell people how your partner treats you
- Sure that nobody will believe you if you tell
- That you are the only one who is treated like this

*What should I do if these things are happening to me?*

Talk to somebody you trust. Find out about your options and make some plans for getting help and getting to safety if necessary. You should have a safety plan even if you stay. Know what you will do if your partner becomes violent. Be prepared to leave quickly. Make a list of things you should take. Have a small suitcase packed with a few clothes, medications, and important papers, like your bankbook, ID and so on. You should also have a safety plan for work to tell the people who work with you how to protect you from unwanted contact from your partner.

Consider making a safety plan with your children so they know who to call or where to go if your partner is hurting you. Check out the last section in this booklet about help. It offers suggestions on who to turn to for support.

## Raising Your Grandchildren

#### What You Might Be Seeing:

Children living with their grandparents will face some unique challenges:

- They may act out or challenge you
- They may feel insecure and unsure that you will take care of them
- They may be anxious or depressed
- They may seem young or act too old for their ages
- They will miss their parents

#### What You Can Do To Help the Children

It will take time for your grandchildren to feel safe and secure in their new home with you. You can help by encouraging these good feelings in a number of ways:

- Set up daily routines such as: mealtime, bedtime, and other daily activities.
- Create a space just for your grandchildren to help them feel more at home such as their own bedroom.
- Making sure to keep daily communication with your grandchildren.
- Set up a few rules and explain your expectations. Then enforce the rules consistently.
- Making sure to reward positive behaviour. When children make mistakes, focus on teaching rather than punishing.
- Being involved in their schooling and encouraging the children to participate in school events and activities.

No matter why or how your grandchildren came to live with you, your grandchildren will benefit from being in your home. When children are unable to live with their parents, living with a grandparent may provide the follow:

- A chance to stay with siblings
- More contact with their parents, depending on the situation
- The comfort of a familiar language and culture
- Fewer moves from place to place

Parenting the second time around brings special challenges and special joys. Do not hesitate to ask for help or seek services in your community for yourself and your grandchildren.

## Trustee Report for March 2009

The last couple of month's have been busy for HPEDSB with budgetary preparations for next school year being required by the Ministry of Education. Each spring district school boards are required to establish a school year calendar for the next school year in accordance with Regulation 304 "School Year Calendar". This regulation sets the beginning and end dates for the school year; stipulates school holidays; and prescribes the minimum number of instructional days (194) and the maximum number of professional activity days (6), examination days (10) and the board designated holidays (2).

In establishing its annual School Calendar, it is the practice of the Board to consult many of its stake holders and neighboring school boards in order to insure the optimum use of school time and to minimize transportation costs. After much deliberation a decision was made by the Board of Trustees to have a September

1st start to the school year in order to get the required instructional days (194) into the school year for 2009/2010.

This was a difficult decision to make but in regards to the late Labour Day date this year, the majority of School Boards across Ontario have gone to the early start date.

## SIMCOE DEED ALSO KNOWN AS TREATY 3 ½

J. GRAVES SIMCOE.

GEORGE THE THIRD by the Grace of God of Great Britain, France and Ireland, King, Defender of the Faith and so forth.

Know ye that Whereas the Attachment and Fidelity of the Chief Warriors and People of the Six Nations to us and our Government, have been made manifest on divers occasions by their spirited and zealous exertions and by the bravery of their conduct; And We being desirous of shewing Our approbation of the same, and in recompense of the losses they may have sustained of providing a convenient Tract of Land under Our protection for a safe and comfortable retreat for them and their posterity Have, of Our special Grace, certain knowledge and mere motion, Given and by these presents Do give and grant unto the Chiefs, Warriors, Women and People of the said Six nations and their Heirs for ever all that District or Territory of Land being parcel of a certain District lately purchased by us of the Mississague Nation lying and being and limited and bounded as follows (that is to say) the Tract will then be bounded in front by the Bay of Quinte between the mouths of the River Shannon and Bowen's Creek about Twelve Miles Westerly by a Line running, North Sixteen Degrees West from the West side of the Mouth of the River Shannon, and Easterly by a Line running north Sixteen Degrees West from the Mouth of Bowen's Creek, and Northerly by a Line running East Sixteen Degrees North and West Sixteen Degrees, South at the distance of about Thirteen Miles back from the Bay of Quinte, measured on the Western Boundary aforesaid, to the North East Angle of the Township of Thurlow. To Have and to Hold the said District or Territory of Land of us Our Heirs and Successors to them the Chiefs, Warriors, Women and People of the said Six Nations and to and for the sole use and behoof of them and their Heirs for ever freely and clearly of and from all and all manner of Rents, Fines or Services whatsoever to be rendered by them the said Chiefe, Warriors, Women and people of the said Six Nations to us or our successors for the same and of and from all conditions, stipulations and agreements whatever except as hereinafter by us expressed and declared. Giving and granting and by these presents confirming to the said Chiefs, Warriors, Women and People of the said Six Nations, and their Heirs, the full and entire possession, Use benefit and advantage of the said District or Territory of Land to be held and enjoyed by them in the most free and ample manner and according to the several Customs and usages by them the said Chiefs, Warriors, Women and People of the Six Nations. Provided always, and be it understood to be the true intent and meaning of these Presents; that for the purpose of assuring the said Lands as aforesaid to the said Chiefs, Warriors, Women and People of the Six Nations and their Heirs and of securing to them the free and undisturbed possession and enjoyment of the same. It is Our Royal Will and Pleasure that no Transfer, Alienation, Conveyance, Sale, Gift, Exchange, Lease, Property, or Possession shall at any time be had, made, or

given of the said District or Territory or any part or parcel thereof by any of the said Chiefs, Warriors, Women and people of the said Six Nations to any other Nation or Body of People, Person or persons whatsoever other than among themselves the said Chiefs, Warriors, Women and People of the said Six Nations but that any such Transfer, Alienation, Conveyance, Sale, Gift, Exchange, Lease, or Possession shall be null and void and of no effect whatever. And that no Person or Persons shall possess or occupy the said District or Territory, or any part or parcel thereof by or under pretence of any such alienation or Conveyance as aforesaid, or by or under any pretence whatever under pain of our severe displeasure. And that in case any Person or Persons other than the said Chiefs, Warriors, Women and People of the said Six Nations shall under pretence of any such Title as aforesaid, presume to possess or occupy the said District or Territory or any part or parcel thereof that it shall and may be lawful for Us, our Heirs and Successors at any time hereafter to enter upon the Lands so occupied and possessed by any other Person or Persons other than the said Chiefs, Warriors, Women and People of the said Six Nations and them the said Intruders thereof and therefrom wholly to dispossess and evict and to resume the same to Ourselves, Our Heirs and Successors. Provided always nevertheless that if at any time the said Chiefs, Warriors, Women and People of the said Six Nations should be inclined to dispose of and Surrender their Use and Interest in the said District or Territory, the same shall be purchased only for Us in our name at some Public Meeting or Assembly of Chiefs, Warriors and People of the said Six Nations to be held for that purpose by the Governor, Lieutenant Governor or Person Administering Our Government in Our Province of Upper Canada.

IN TESTIMONY WHEREOF We have caused these Our Letters to be made Patent and in the Great Seal of Our said province to be hereunto affixed; Witness His Excellency John Graves Simcoe, Esquire, Lieutnenat Governor and Colonel Commanding Our Forces in Our said Province, Given at Our Government House at Navy Hall this First Day of April in the Year of Our Lord One Thousand Seven Hundred and Ninety Three in the Thirty Third Year of Our Reign.

### **\*BOIL WATER REMINDER\***

As a reminder, in February 2008 Health Canada recommended the Tyendinaga Mohawk Council place a precautionary boil water advisory on all the ground water fed wells in the Tyendinaga Mohawk Territory.

Should your bacteriological water sample indicate a safe or adverse result please ensure the water is **boiled or disinfected and filtered**. The water sample may contain water borne parasites such as Giardia or Cryptosporidium without proper filtration. **Please do not consume or serve the water to the public.**

For information on obtaining a water treatment system for your household, business or service building please contact a licensed plumber as each water supply varies. Ensure your plumber is aware that you must have filtration for water borne parasites.

**\*Please note: the municipal water supply is monitored through the water treatment plant in Deseronto and is considered safe for consumption. This supply is available at the Bayshore Park for bottle fills, please remember to disinfect your containers\***

### GIRLS: SUGAR AND SPICE?

#### A Peek at Social Bullying

'Social bullying', sometimes referred to as 'relational bullying' or 'social aggression' is the most difficult type of bullying to detect from the outside. This is partly because we have been focused on the more obvious forms of hurtful behaviour; physical aggression and violence. Social bullying is "the systematic diminishment of a bullied child's sense of self through ignoring, isolating, excluding or shunning" (Bully, Bullied and Bystander: Coloroso 17:2002).

#### WHAT IT IS

To gain acceptance and security during the preteen years and throughout their teens, kids not only join groups, they form groups called cliques, which have a commonality of interests, values, abilities, and tastes. This is good. There is also exclusivity and exclusion. This is not good. Social bullying can involve subtle gestures such as; aggressive stares, rolling of eyes, sighs, frowns, sneers or snickers. It can also include; gossip, rumours, harassing, backhanded compliments and hostile body language. The intent of relational bullying is to alienate and reject a peer or purposefully ruin friendships. Recent studies show that up to 70% of girls report that they have been involved in this kind of behaviour, as a perpetrator, a target or a witness.

#### WHO IT AFFECTS

While social bullying can be found in the behaviours of both males and females, for the purposes of this article we will focus on girls, since this is the most common form of bullying among girls. Social bullying can be the most powerful ruler of girls' relationships. With girls, they are keenly aware that they are not permitted to throw a punch; they are not allowed to wrestle each other to the ground. The aggression will come out in other ways. Instead of using their fists as a weapon, they will use their relationships as weapons.

While it can begin as early as grade three, relational bullying is at its most powerful in the middle years, with the onset of adolescence and the accompanying physical, mental, emotional and sexual changes. It is a time when young teens are trying to figure out who they are and trying to fit in with their peers. Intentionally excluding a child from sleepovers, birthday parties and playground games is often overlooked as a form of bullying because it is not as readily identifiable as name-calling or a fist in the face (verbal or physical). The results are not as obvious as a black eye or a torn jacket and the pain it causes is usually hidden or when expressed, dismissed.

#### WHY IT IS SO PAINFUL: EFFECTS

We know from a wide variety of sources that girls and women intensely value relationships. So for girls, when a relationship is threatened, it might be particularly painful since that is a method in which girls identify themselves and their social goals.

Young women are much more likely to experience depression, negative self-concept, poor body image and eating disorders compared to young men. This relates to the tendency for young females to internalize distress and problems, whereas young males exhibit these problems in externalizing, disruptive behaviour. A girls' self confidence is affected, along with her school work. She may experience migraines or anxiety attacks. She may wish to avoid school or change schools altogether.

Sadly, girls do not always grow out of this behaviour. They become women who pack up their childhood baggage and bring it to the workplace. New research in social aggression indicates that females of any age are probably very adept at waging psychological warfare against each other.

#### WHY DO GIRLS DO IT?

Girls who are engaged in social bullying are searching for dominance, power and leadership. For them, power is about being able to get other people to do what they want. It is about being able to with-hold comments, praise, being able to pull some people in and push other people out. Social bullying is an

extremely covert and terrifying way to obtain this 'power'. However, all girls who engage in this type of behaviour are experiencing some underlying fear and insecurity.

#### WHAT TO DO ABOUT IT

Consider teaching or reminding children about the Great Law of Peace and its principles: Peace, power and righteousness, and thus; the true meaning of power. It is said that there is a sacred relationship not only among humans or between human beings and the physical world, but among all creatures and elements extending to the realm of the spirit. True justice is the achievement of balance in all these relationships and the demonstration in both action and thought of respect for the dignity of each element. We must remind our girls and women of their value to our society. For example; traditionally, women served as spiritual, political and military leaders.

Girls respond differently to interventions compared to boys. Female students relate best to strong and assertive female teachers who have had similar experiences in adolescence. Likewise, successful approaches for boys employ sensitive male teachers who can help unravel masculinity and its connection to toughness, aggression and the code of silence around expressing emotions.

- Learn and practise healthy ways to resolve conflict
- Say sorry (If you mean it. An apology has to be done in a way where it actually helps, where it does not make the other person feel worse. **Remember, justice for Haudenosaunee people is not about punishment, it is about working to achieve respectful co-existence by restoring harmony to the network of relationships)**
- Talk it out to learn each others' feelings
- Discuss what real power is
- Speak up about mean behaviour. Help children to discern what is and is not acceptable behaviour
- Develop boundaries
- Practise developing empathy in early years
- Cultivate and reward kindness
- Parents and educators need to practise positive role modelling

*"One of the most difficult things to do as a parent is to look in the mirror, but that is exactly what should be done if we are going to change this behaviour. Adults foster this development by not intervening. I believe that adults contribute to children learning these behaviours by modeling them for them. Whenever a girl or boy watches a Mother be overtly nice to someone then hang up the phone and malign them or when they observe their Mothers be nice to someone's face, than say negative things about them behind their backs. Learn to appreciate how their behaviour affects others. Practise positive role modelling in your own relationships".*
