### **Attention All Business Owners:**

The current Policy For The Issuance Of Business Registrations On The Tyendinaga Mohawk Territory is included in this edition of the newsletter. A copy of the application is included as an insert for your convenience. Please note that all current business registrations are only valid until September 30, 2006. If you have a business operating on the Territory please ensure it is registered with the Administration Office.

All sections of the application need to be filled out completely, including the Preliminary Environmental Screening section. Applications need to be sent to the Technical Department at the Administration Office, before being forwarded to the Economic Development Officer. Policy for the Issuance of Business Registrations on the Tyendinaga Mohawk Territory

PURPOSE

- The purpose of the Policy is the registration of businesses, callings, trades and occupations located and operated within the boundaries of the Tyendinaga Mohawk Territory.
- All Businesses based on Tyendinaga Mohawk Territory must be registered under this policy in order to be considered legitimate.

**DEFINITIONS** 

a. Act means the Indian Act, RSC. 1985, c I-5.

2.

- b. Business means a calling, trade, occupation, employment or profession, vocation, commercial activity, or an enterprise which habitually busies, occupies or engages the regular time, attention, labour and effort of the registrant or person(s) for the purposes of gain, benefit, advantage, livelihood or profit, or in which the registrant or person(s) show(s) willingness to invest time and capital on a future outcome.
- C. Calling means a business or profession as defined in this policy.
- d. Council means the duly elected officials of the Tyendinaga Mohawk Territory No. 38.
- Member means a person who lawfully possesses a status card and membership with e. the Mohawks of the Bay of Quinte.
- f. Occupation means a business or profession as defined in this policy.

- Person includes not only an individual member as defined in this policy, but also a partnership, syndicate, association, corporation or the agent or trustee of a person.
- Profession means a vocation, occupation or calling requiring special, usually h. advanced, education and skill as defined in this policy.
- Registrant means those persons eligible to apply for and/or possess a business registration as defined in Section 4(a) of this policy.
- Trade means a business as defined in this policy.

- Tyendinaga Administration Office refers to the administrative component of the
- Tyendinaga Mohawk Territory means the current legal description and boundaries of the Tyendinaga Indian Reserve No. 38.

REQUIREMENTS FOR BUSINESS REGISTRATION

- Every business within the Tyendinaga Mohawk Territory that applies for a Wholesal Tobacco Permit shall hold a valid business registration under this policy and b recognized under Schedule 1. Only registered businesses are considered legitimate.
- Any person carrying on more than one business within the Tyendinaga Mohawl b. Territory must obtain a separate business registration for each business.
- Every business registration issued under this policy is valid and permits the registran to carry on the business in a lawful manner.
- The registrant or person in charge or control of the premises where the business is conducted shall at all times keep the business registration prominently displayed in ar area visible to the general public.
- The registrant must notify the Council or its representative of any change in:
  - the mailing or business address
  - ii. the type of business (as per Schedule 1)
  - iii. the area of the premises
  - any substantial physical alteration to the premises in which the business is iv.
- Upon the closing of the business, the registrant shall surrender the business registration to the Council.

APPLICATION

- Only members of the Mohawks of the Bay of Quinte who wish to conduct business shall apply in writing to the Tyendinaga Mohawk Council for the issuance of a business registration. Applications are available at the Tyendinaga Administration Office, Tyendinaga Mohawk Territory, Ontario, K0K 1X0. Application for Business Registrations must be completed in their entirety.
- Every person applying for a business registration under this policy that is governed or requires registration by any federal statute or self-regulating professional body, must supply proof of his or her qualifications and of the qualifications of the employees to carry on such a business.
- Where the applicant is a corporation or partnership with one or more Status member(s) of MBQ, proof of incorporation or partnership (including ownership division) must be provided. Status members of MBQ must hold a majority ownership of the business.
- Where the applicant is a corporation or partnership or an individual(s) with NO Status member(s) of MBQ as owner of the proposed business, a special application to the Tyendinaga Mohawk Council may be submitted with their application outlining how their business will make a positive impact on the Tyendinaga Mohawk Community. IF THIS BUSINESS IS GRANTED A BUSINESS REGISTRATION, IT WILL NOT BE ELIGIBLE TO RECEIVE A TOBACCO QUOTA.
- The proposed business must be within the defined boundaries of the Tyendinaga Mohawk Territory.
- Applications must be signed and completed in its entirety stating: f.
  - Applicant's Name
  - ü. Applicant's Band Number
  - iii. Applicant's Residential Civic Address
  - Applicant's Residential Phone Number
  - V. Name of Business
  - vi. Address of Business
  - vii. Phone/Fax Number/E-Mail Address of Business
  - VIII. Type/Nature of Business (as per schedule 1)
  - Seasonality of Business and Duration of Season; ix.
  - Days and Hours of Operation;

xi. New/Renewal Application;

xii. Proof of Registration Pursuant to Federal Statute or Self-Regulating Professional Body

xiii. Proof of Incorporation, Partnership, Syndication or Association

xiv Preliminary Environmental Screening Section

#### ISSUANCE OF BUSINESS REGISTRATIONS

- a. The Tyendinaga Mohawk Council is responsible for the issuance of business registrations; the distribution of tobacco quotas is the responsibility of the Ministry of Revenue, Motor Fuels and Tobacco Tax Branch.
- b. The Tyendinaga Mohawk Council, in an effort to protect the environment, has incorporated the requirement to provide preliminary project information to determine potential adverse environmental effects. The Preliminary Environmental Screening Section must be signed by MBQ's Technical Department, The applicant may also be required to submit an Environmental Assessment completed by a qualified person submitted with the completed registration form.
- c. Only one (1) registration will be allowed for each business. Business Registrations must be placed in the name of the individual and shall be deemed a personal registration to the registrant. The holder of registration must also be majority owner/shareholder/partner of the business.
- d. The registration will be issued for two (2) years and registration holders must renew application. It shall be the responsibility of the registrant to apply for a business registration renewal.
- e. The registration of a business does not give business special powers. Should a business require special licenses, permits or certification, this business registration does not exempt a business from obtaining the necessary documents.
- f. Unincorporated businesses are deemed to be the personal property of the registrant and, as such, qualifies for all applicable protection and benefits afforded under the *Indian Act* in the same manner as its owner(s).
- g. Upon a business registration applicant meeting the provisions for the issuance under section 5(g) and Schedule 1 of this policy a business registration shall be issued to the applicant.
- Any application for license under this policy shall be made to the Economic Development Office using Form A, enclosing necessary certificates of compliance in relation to Schedule 1 requirements.
- i. The Council shall, upon receiving an application (and recommendation from the Economic Development Officer) for a business registration, promptly issue by delivering or mailing a business registration to the applicant at the address shown in the application provided:
  - i. The Council is satisfied that the applicant's business complies with all provisions in any of the other Mohawks of the Bay of Quinte's By-law(s) and/or policies; and
  - The Council is satisfied in respect to a business involved in the sale of food or drink, or where food is handled or stored, the applicant has a certificate confirmation from an authorized Health Officer as determined by Tyendinaga Mohawk Council.
  - The Council is satisfied in respect to a business involved in the sale or storage of bulk petroleum products that the business be in compliance with all Technical Standards and Safety Authority Regulations. Tyendinaga Mohawk Council recognizes the TSSA as the knowledgeable authority in the safe handling of bulk petroleum and fuel products
  - iv. The Council is satisfied that the applicants business complies with all the requirements under Schedule 1.
  - v. the application complies with this policy; and
  - vi. the applicant has disclosed all required information in the application form; and
  - vii. the applicant's business would not be detrimental to the health, welfare, safety, morality and environment of the inhabitants of the Tyendinaga Mohawk Territory; and
  - viii. the Council's investigations do not disclose any reason to believe that the carrying on of the said business may result in a breach of the law, or may be in any way adverse to the public interest.

j. If the applicant or registrant fails to comply with or the Council is not satisfied with information received from the applicant or registrant under section 5(h) of this policy and Schedule 1 of this policy, the Council shall forthwith (on the recommendation of the Economic Development Officer) serve the applicant notice of the refusal to issue the business registration, stating the reason(s) for refusal and said notice will be served personally or by registered mail to the applicant at the address shown in the business registration application.

#### REVOCATION AND ENFORCEMENT OF BUSINESS REGISTRATIONS

6.

7.

- a. Tyendinaga Mohawk Council reserves the right to revoke Business Registrations (on the recommendation of the Economic Development Officer) if:
  - i. After issuance of a Business Registration, a business fails to comply with 5(h),
     Schedule 1 or any other parts of the Policy.
  - ii. The business being conducted is not that as is described in the application for business registration.
- b. If an application for a business licence is denied or a licence is revoked, Tyendinaga Mohawk Council reserves the right to contact known suppliers to advise them of nonregistration.
- c. All registered legitimate businesses will have Mohawks of The Bay of Quinte Business registration displayed publicly.

#### APPEALS

- Appeals must be made in writing within sixty (60) days of the initial notice. Copies of the appeal notice must be sent to the Tyendinaga Administration Office.
- b. The Council must notify the appellant of the date, time and place of hearing within thirty (30) days of receipt of notice to appeal. All documents relevant to the appeal must be presented to the pertinent parties within ten (10) days.
- c. At the appeal hearing, the onus will be upon the appellant to show just cause why the business registration applied for should be granted or that revocation was done in error.
- d. If the appellant agrees at the review hearing to accept conditions upon the registration, Council may render a decision granting the appellant the registration applied for upon such conditions as it considers fair and appropriate.
- e. Council will give its decision in writing to the appellant as soon as reasonably possible.
  - f. If Council renders a decision granting the appellant the registration applied for, the registration will be issued upon the appellant complying with this policy.
  - g. If Council renders a decision declining the appellant the registration applied for and should circumstances change, the appellant may re-apply for a registration.
  - h. All decisions of the Tyendinaga Mohawk Council are final.

#### TRANSFER OF BUSINESS REGISTRATIONS

a. Business Registrations are not transferable and must be surrendered to the Economic Development Office upon the sale, dissolution, termination or winding up of the business, the business ceases to operate or if the type or nature of the business substantially changes.

#### REGULATIONS OF BUSINESS

- a. Businesses must have a permanent location on the Tyendinaga Mohawk Territory.
- b. Businesses must comply with Schedule 1 of the Policy in regards to additional regulations that must be met. Schedule 1 may change from time to time as authorized by Tyendinaga Mohawk Council Motion. All charges with respect to inspections must be borne by the business.
- c. Representative(s) of the Tyendinaga Mohawk Council will be allowed to inspect the business premises during normal business hours. Where a situation arises compromising the health and safety of citizens of Tyendinaga Mohawk Territory, representatives of the Tyendinaga Mohawk Council or agents of the Tyendinaga Mohawk Council may suspend business operations until such time as the business meets all health and safety standards.
- d. Council may make regulations pursuant to this policy.

# Your Hydro One Electricity Bill GST & Debt Retirement Charge Exemption

Status Indians, Indian Bands and Band Councils are exempt from paying GST and the Del Retirement Charge (DRC) for electricity purchased for use on an Indian Reserve. DRC collected to pay down the stranded debt of the former Ontario Hydro. For most customers i Ontario, the DRC is 0.7 cents per kWh. DRC is calculated based on the amount of electricit used, so it varies from one bill to the next.

Here's information about GST and DRC refunds and how to make a claim.

### How do I claim an exemption?

In order to claim GST and DRC exemption, you'll need to provide us with the following:

- Name on Hydro One account
- 10-digit Hydro One account number
- Account address
- Indian Status card number

#### How will I receive my refund?

We will apply a credit on your bill, once you have demonstrated that you are eligible for GST and DRC exemption.

#### **GST** refund

We can only refund GST for the current calendar year.

For any refunds prior to January 1st, complete the GST form – General Application for Rebate of GST/HST (GST189). To obtain this form, visit the GST office or get it from the Canada Revenue Agency's website at www.cra-arc.gc.ca or call 1-800-959-5525.

#### **DRC** refund

We will refund DRC for the period it was charged in error. We started collecting the DRC when the electricity market opened to competition of May 1, 2002.

# PROCEDURE FOR CONTACTING PIERCE ANIMAL CONTROL SERVICES

Residents can call (613) 966-4483 leave your name and phone number so that they can contact you.

They are available 24 hours for emergencies. An emergency would be a dog that is injured and the owner is unknown, a dog that is harassing livestock, a dog endangering the public or an animal suspected of having rabies. If a resident would like to log a complaint or inform them of a dog running at large they can do so by calling Monday to Friday between the hours of 8:00 a.m. and 4:30 p.m.

They are not available to pick up strays running at large on weekends or statutory holidays. All animals that are picked up are taken to the **Quinte Humane Society** and their hours are 12:00 noon to 5:00 p.m. Monday to Saturday and 1:00 p.m. to 4:00 p.m. Sunday. The Quinte Humane Society is also closed on statutory holidays.

The Quinte Humane Society is located on Avonlough Road which is at the west end of Belleville off of Dundas St. west (Hwy #2). Their number is (613) 968-4673.

#### "WHAT WE HOLD DEAR:" Treasured Memories of **Alderville First Nation**

#### by Ruth Clarke and members of the community.

It is Ruth's fifth book and her second volume of Alderville's history; the first, Before the Silence: Fifty Years in the History of Alderville First Nation 1825:1875, was published in 1999 and depicted life for the Mississauga Ojibway during those fifty years, including their migration from Grape Island in the Bay of Quinte to their settlement in Alderville.

In photos and narrative, WHAT WE HOLD DEAR resumes the story in the late 1800s and continues to present-day life in Alderville. It continues in the style of BEFORE THE SILENCE, written from the point of view of fictional characters.

Two women figure prominently in WHAT WE HOLD DEAR. Aged but spry Kathleen Franklin, or Gate-gan as she is called, and Katie Chase, her greatgranddaughter, narrate the story. The two women are at home alone for a month during the summer when Gate-gan gives a trunk full of what she holds dear: photographs, newspaper clippings, university papers, recipes and memorabilia that she has collected throughout her lifetime, to Katie. As they go through the contents of the trunk their stories and lore become threads that weave a rich textured history of Alderville's past and recent history. Though Gate-gan and Katie are fictional characters, all that the two women discuss throughout the book is factual.

Members of Alderville First Nation share the by-line on this book in which they have either written chapters or provided information or photographs.

In 1953, Mary Jane Muskratte Simpson completed a manuscript, LIFE ON THE LAKE, from which chapters have been excerpted and enhanced with photographs from Peterborough Centennial Museum and Archives of paddleboats, steamers and riverboats that once plied the Kawartha Lakes. Dave Mowat, great-grandson of Fred Simpson, the marathon runner who ran in the 1908 Olympics, wrote an essay celebrating his ancestor's illustrious career. Research that Melody Crowe and Arlene Beaver conducted in 1981 during a summer project appears throughout the book; from the construction of the monument to recollections elders had about gathering wild rice on Rice Lake and other practices and traditions.

#### LANDFILL INFORMATION

#### Background:

In 1999, there was a proposal, to close the Tyendinaga Landfill Site, INAC provided a one time offer of \$222,500.00, but it was conditional on our waste going to the Richmond Landfill Site. Tyendinaga Mohawk Council (TMC), at that time, opposed the Richmond Landfill Site Expansion, so it was evident not to accept the proposal offer. Since 1999, TMC has been lobbying INAC for funding for proper closure, in accordance to the Ontario Regulations, and Guidelines.

In May 2006, TMC passed a motion to close the embankment, and to implement a bin system, in an effort to eliminate a fast growth of an improper landfill. Since that time, we have observed an elevated amount of waste coming in. In comparison with neighbouring communities, Tyendinaga Territory is generating 6 times more garbage.

#### Why close TMT landfill?

As Keepers of the Earth, we have an obligation to ensure our Mother Earth is protected for the Seven Generations. It has been stated that the Tyendinaga landfill is not an appropriate area, because it is located on fractured limestone. has no liner, and is located close to Sucker Creek. Also, because there is an absence of adequate funding for equipment from INAC, there is a possibility of landfill activities negatively impacting the environment.

#### What will happen next?

Currently, there are new initiatives under consideration by the Mohawk Environment Committee and TMC. The current proposal under development for INAC consideration is opting for curbside pickup, for both waste, and recycling, full proper closure of the landfill site, and funding for annual maintaining. An area will still be maintained for Household Hazardous Waste, Scrap Metal, and Tires.



WHY indeed!!! Breastfeeding can be the one life-saving thing that is available immediately, locally, and without interruption during emergencies and disasters. Some very young babies have even survived being buried in rubble for days by nursing from their mother who had passed away beside them. Babies have been nourished in concentration camps by undernourished mothers . . . or fathers! The donation and use of infant formulas may actually increase malnutrition, diarrheal disease and death. Which is why the World Health Organization recommends, "In emergencies, breastfeeding is the optimal and safest feeding method" and urges "to exercise extreme caution when planning, implementing or supporting emergency relief operations, by protecting, promoting and supporting breastfeeding...".

Dr. Anahit Demirchian reported, in response to the Armenian earthquake, "Our maternity hospitals were flooded with breastmilk substitutes [ie. formula] brought in by humanitarian aid agencies. This nearly destroyed our breastfeeding programs."

Some common myths about breastfeeding may contribute to the perceived "need" for formula use & donation during emergencies. . .

Myth # 1: Malnourished mothers cannot breastfeed

Myth # 2: Stress makes a mother's milk dry up

Myth # 3: Babies with diarrheal disease need water or tea or formula
Myth # 4: Mothers cannot resume breastfeeding if they have stopped
More information on "Myths about breastfeeding in emergencies" is available
online at www.ibfan.org (see Working Groups), and at our local Breastfeeding
Support Group meetings.

In any situations where babies are orphaned, where mothers are too ill or too injured and unable to breastfeed, or choose not to breastfeed, other feeding options in order of preference and safety are:

1) Mothers own expressed breastmilk

2) Wet-nursing, or nursing by another person who is already lactating or willing to bring in a milk supply for the baby

3) Locally available milks suitable for older infants and young children

4) Locally obtained commercial infant formulas may be used if conditions permit safe preparation, use, and storage (often not possible during emergency conditions)

These options and preferences apply to non-emergency situations as well.

In One Magic Minute, We Changed the World: 1999/9/9 9:09 am

In late February of 1999, a small group of burned-out parents, most of whom had never met face-to-face, set out to change the world.

We are parents of children with Fetal Alcohol Spectrum Disorders (FASD), a group of disabilities caused by maternal drinking during pregnancy. FASD is now the leading cause of mental retardation in western civilization, one which could be totally prevented. FASD affects about 1 in 100 people in North America. (There are about 3 million people with FASD in the U.S., and 300,000 in Canada, most undiagnosed.) In Eastern Europe and countries of the former Soviet Union, the rate of undiagnosed FASD may be higher.

Our original volunteers were mainly adoptive and foster parents, plus a small but committed number of mothers in recovery, who have been working hard to inform and support other women with substance abuse problems. All of us lived daily with children whose prenatal damage caused mental retardation or learning disabilities, plus severe acting-out behavior that disrupted our lives and their classrooms, and often physical problems requiring much medical attention. For most of us, life revolved around our children's crises: most mothers had been forced to abandon any thought of full-time career.

Frustrated by the lack of public awareness of FASD by both public and professionals, we had sought help for our problems on the online support group, Faslink, for two years or more. And on that February day, we began to wonder:

What if, on the ninth minute of the ninth hour of the ninth day of the ninth month of the year one thousand, nine hundred and ninety-nine, we asked the world to remember that during the nine months of pregnancy, a woman should remain alcohol free? And, what if we also asked the world to remember those millions of people who will never fulfill their genetic potential, because of prenatal alcohol exposure? At this magic minute in history, could we begin to change the world?

And we began to work on it, building alliances, with only the help of the Internet. Our group grew to include about 70 volunteer coordinators in eight countries. Our northernmost volunteers are in Alaska, Yukon and Nunavut, our southernmost in New Zealand. We've had FAS Day proclamations from many cities and towns, and several U.S. states.

FASDay began in Auckland, New Zealand, where "Minute of Reflection" bells rang at 9:09 a.m., at Mt Albert Methodist church. Then it moved to Adelaide, Australia, and then to South Africa, where at 9:09 a.m., Cape Town volunteers gathered to hear the War Memorial Carillon that rang when Nelson Mandela was released from prison. Volunteers in Italy, Germany and Sweden held events – and then FASDay crossed the Atlantic. There were events in every time zone across Canada and the U.S., including ringing of carillons in Toronto, Niagara Falls, Hastings, NE, and Austin & San Antonio, Texas. The westernmost activity was the community breakfast on the tiny island of Kitkatla, B.C., near the Queen Charlotte Islands, where the village bell rang at 9:09 a.m. followed by prayers in the native tongue by village elders.

#### What is Parent Abuse?

#### Defining Parent Abuse

Parent abuse is difficult to define because it is not always clear when certain behaviours are "normal" and when they are "abusive." Conflict becomes abusive when one person uses threats, force or manipulation to gain power over the other. Parent abuse is any act of a child that is intended to cause physical, psychological or financial damage to gain power and control over a parent.

Teenagers normally go through a process of trying to establish their sense of separateness from their parents. This is called "individuating," and may at times include some defiance or resistance toward authority. There is a difference, however, between resistance and aggression, between separating from a parent and trying to take control of a parent, between "normal" teenage behaviour and "parent abuse."

Abusive adolescent behaviour ranges from mild to severe violence. Parents have to examine their teen's behaviour and determine whether it is acceptable or if it has become abusive. Abusive behaviour should not be tolerated. The abuse usually begins with verbal abuse. For most parents, the abuse is a daily occurrence that follows a pattern, usually with the child showing no signs of remorse or guilt.

#### Forms of Parent Abuse

Any behaviour that is deliberately harmful to the parent and used as a form of control may be defined as abuse. The abuse may be physical, psychological (including verbal) or financial. Here are some examples of the various forms of abuse:

#### Physical abuse

- hitting, punching, slapping or kicking
- shoving and pushing
- breaking things and/or punching holes in the walls
- throwing things
- spitting

# Psychological abuse and emotional terrorism

- intimidating the parent, making the parent fearful
- maliciously playing mind games, trying to make the parent think he or she is crazy
- making unrealistic demands on parents
- purposely not telling the parent where they're going or what they're doing
- running away from home or staying out all night
- lying
- threatening to hurt, maim or kill the parent or someone else
- making manipulative threats, such as threatening to run away, commit suicide or otherwise hurt themselves
- degrading the parent or other family members
- withholding affection
- controlling the running of the household

#### Verbal abuse

- yelling
- arguing, challenging ("I don't have to do anything you say!")
- being sarcastic or critical, belittling
- laughing in the parent's face
- name calling
- swearing at the parent

Some adolescent behaviour is more irresponsible and thoughtless than abusive. However, in some cases, adolescents deliberately use psychological means to manipulate, control and hurt their parents.

#### Financial abuse

- stealing money or parent's belongings
- selling possessions, their own or the parents'
- destroying the home or parents' belongings
- demanding parents buy things they don't feel they can afford
   incurring debts the parents must cover (e.g. as a result of damage to or theft of others' property)

#### Who is the abused Parent?

Parental abuse can occur in any family and is not associated with social class, ethnic background, or sexual orientation. Although fathers are also susceptible, mothers are the most frequent victims of parent abuse. One of the reasons is that women are the primary caregivers. Often abused mothers are single parents. Elderly parents and parents with disabilities may be particularly

vulnerable to abuse by their teenage children. Teenagers who abuse their parents may also abuse their younger siblings and/or family pets.

#### Profile of the Teen

Some abusive teens participate in socially deviant activities such as drug or alcohol use or criminal activities (shoplifting, fraud, break and enter, theft, violent crime and/or prostitution). When teens become involved in drugs or alcohol, parents sometimes notice a sudden, drastic change in their school work, relationships and behaviour. Sometimes youth who are abusive toward their parents have themselves been the victims of physical, sexual and/or emotional abuse. Some teens may not have been the direct victims of violence but may have witnessed it in their homes. It is recognized that children who witness violence, compared to children who have not witnessed violence are at a greater risk of developing behaviour problems, such as aggression with peers, noncompliance with adults, destructive behaviour, and conflict with the law.

#### The Effects

Most parents have difficulty accepting that their teenager is abusive and may deny the problem. They often feel depressed, anxious, and ashamed. They may also feel guilty for pressing charges against the child for the assault. Abusive behaviour also affects other children in the home. Parents may fear for the safety of the other children, as well as their own safety.

#### Breaking the Silence

To help families and stop parent abuse, we have to break the silence that surrounds it. Because parent abuse is still not recognized, it is often considered acceptable behaviour. The first step to ending the abuse is recognizing that it is abuse. After recognizing the abuse, parents need a safe place to talk about what they are experiencing. Talking about the abuse can have a profound impact on parents and can help break the isolation.

Some of the places you can turn to for support include: family and friends, support groups, counselling services, parent resource centers, women's shelter's and resource centers.

On Thursday 29 June, Christ Church, Tyendinaga had a very special visitor. The Reverend Denis Mulliner, Chaplain and Deputy Priest in Ordinary to Her Majesty's Chapel Royal at Hampton Court Palace, was in Canada for the funeral of a friend and made time to visit Her Majesty's Chapel Royal of the Mohawks.

We shared greetings from our respective congregations and then Father Mulliner was given a tour of Christ Church by Gail Clement (Warden), Wilma Maracle (Treasurer and Altar Guild president), the Rev'd Canon Cyril Betts (Priest) and the Rev'd Brad Smith (Deacon-in-Charge). Father Mulliner was especially interested in the historical connections between the Mohawk people and the Crown and was intrigued by the various gifts that illustrate them. For those of you who don't know, Christ Church is home to half of the historic Queen Anne Communion Silver, given in 1711 and divided between Tyendinaga and the Six Nations Reserve in Brantford in 1788; a triptych in the Mohawk language (with the Apostle's Creed, the Ten Commandments and the Lord's Prayer) and a bell given by King George III; a royal coat of arms given by King George V; a Bible given by Queen Victoria and a chalice given by Queen Elizabeth II in 1984 to commemorate the coming of the United Empire Loyalists to Ontario and decorated with the clan symbols of the Mohawks at Tyendinaga.

After the tour and conversation, the parish presented Father Mulliner with two commemorative plates from Tyendinaga. One depicts Christ Church and the other depicts the Queen Anne Silver. He has promised to display them in his Chapel Royal to emphasise our fraternity with the Chapel Royal establishment in the United Kingdom. When this was completed, we drove to All Saints', Tyendinaga to have a quick tour of the Upper Church, which is blessed with a beautiful stained glass light in the vestibule that depicts the Tree of Peace and the Bear, Wolf, and Turtle clan symbols.

It was a delight to visit with Father Mulliner to learn about his experience of working in the Chapel Royal and to reinforce how we are always part of a Church that is much bigger than our local parish. Here, our Chapel Royal is a parish church where the designation comes from loyalty of the Mohawks in the American Revolutionary War. In the United Kingdom, Chapels Royal are where the Royal Family worship. We hope to see him again next summer when he returns for a vacation with his wife.




# Arts Access Tvendinaga





# POSTCARDS FROM THE VISION QUEST by Joseph Brant

I'm coming home!!!! (for the pow wow)

By the time you read this, I'll probably be back here in Nashville. If, by chance, you read this before the pow wow, I'd ask you—in any other circumstance—to just look for the long-haired, overweight Indian, but—in this case—I'm hoping to bump into a couple more than just me. (With that in mind, I'll also ask you not to just walk up to people and say you're looking for "Mr. Brant").

These are the things we get used to when we live off the rez.

We're so special and unique out here in the big, bad world, where the white people forget and think we're just like them, and the black people (don't forget, but) accept us as one of them.

I don't honestly believe I've ever been to the Tyendinaga pow wow. It was only a couple years in existence when I moved away ten-ish years ago. All this reminds me of the fair; I haven't been to the fair since, I think, 1997. Can you believe how long it's been since 1997?! Neither can I.

When I say "the fair" you know I'm talking about the Mohawk Fair, right? I just realized that—I assume we're all on the same page, and in all likelihood, we were.

Well I made it through the two-week trial period for the diet I mentioned last month, so I'm totally part of the study. Even better news: I'm in the group that gets to drink a glass of water before each meal (remember, the other two either drink a glass of grapefruit juice or eat a grapefruit before each meal).

Unfortunately, I'm realizing that drinking grapefruit juice or eating the grapefruit would've made me take the study a little more seriously. Water, as you know, is pretty much everywhere whether you're dieting or not. In years passed, when I tell myself I'm dieting I usually eat very little, exercise and lose 20 or 30 pounds very fast. Then I get tired of eating healthy and exercising so I stop it all—just as much a matter of cold-turkey this time—and gain it all back (plus more) within six months.

So this time I figured I'd do it slowly and...uh, more cognizantly because it's (as they say) a "lifestyle change" and not a diet. My friend Matt owns a bar that I visit once every six months to a year and, every time I walk in, the same ol' bartender—who I barely recognize—says to me, after a few minutes have passed, "you used to work with Matt at the Wildhorse," and I'll think, "until now, I'd forgotten how I know him."

I've been visiting www.MySpace.com a lot recently. (You'll notice I really don't have much to say this month, so I'll just gossip from here on out.) I'm still not convinced My Space is something adults should use; I've always kind of operated under the assumption that it was only for musicians, teenagers and, of course, pederasts.

Still, I have a lot of friends who have My Space "pages" so, it turns out, this is really just an issue of mine and, by the time you read this, I'll probably have my own page. (Please. And my own band? Just as likely.)
