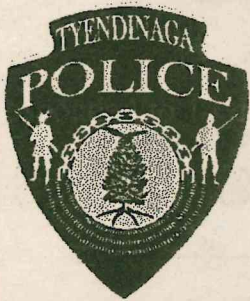

The Mohawk Fire Department has been approached by Keith Maracle owner of Tyendinaga Propane in Shannonville. Keith is very familiar with our fire department partnering with us for propane training and has assisted us fund raising for our Ice Rescue boat and digital camera.

Keith would like to jump start a fund raiser by donating \$500 towards the purchase of a thermal imaging camera worth approximately \$9000.00 and is challenging the community to donate to this worthy cause.

A thermal imaging camera is used by Fire Fighters to find hot spots in structures and is invaluable in locating people in fire and smoke. This tool would take the guess work out of confirming that a fire is completely extinguished and more importantly can instantly locate trapped victims eliminating the need for Fire Fighter to crawl in smoke to locate by feeling their way through a structure.

## TYENDINAGA MOHAWK COUNCIL MINUTES SEPTEMBER 26, 2006

A special meeting of the Tyendinaga Mohawk Council was held on Tuesday, September 26, 2006 at 2:15 p.m. in the Council Chambers.

Present: Chief R. Donald Maracle arrived at 2:50 p.m.; attending a funeral  
Councillors: Trevor Lewis, Barry Brant, Roy C. Maracle and Blaine Loft  
Staff: Rod Jeffries, CAO, and Angela Maracle, AO

MOTION #1: Moved by Roy C. Maracle, seconded by Barry Brant that Blaine Loft act as chair in Chief R. Donald Maracle's absence. Carried.

There will be no Local Business tonight as no one was scheduled as outlined in the Procedures for Local Business.

MOTION #2: Moved by Trevor Lewis, seconded by Barry Brant that this Council appoint Blaine Loft and Roy C. Maracle to sit on the Mohawks of the Bay of Quinte/First Nations Technical Institute Partnership Committee. Carried.

MOTION #3: Moved by Barry Brant, seconded by Roy C. Maracle that this Council approve to send the Memorandum of Understanding between the Mohawks of the Bay of Quinte and Siemens Canada Limited to Alan Pratt for review. Carried.  
Trevor Lewis, negative – concern with amount of legal fees being paid out

MOTION #4: Moved by Trevor Lewis, seconded by Roy C. Maracle that this Council approve the revised Memorandum of Agreement for Aboriginal Diabetes Initiative – Federal for fiscal year 2006-2007 in the amount of \$10,481.06. Carried.

MOTION #5: Moved by Roy C. Maracle, seconded by Trevor Lewis  
WHEREAS Indian and Northern Affairs Canada requires the Ministry of the Environment to issue a Letter of Conformance for water and wastewater treatment facilities located on First Nations Territories; and  
WHEREAS the Tyendinaga Mohawk Council has retained First Nations Engineering Services Ltd. To design the "Interim Wastewater Treatment Project" as approved by Indian and Northern Affairs Canada;  
THEREFORE BE IT RESOLVED that the Tyendinaga Mohawk Council authorizes First Nations Engineering Services Ltd. to make applications on our behalf to the relevant government agencies to obtain regulatory approval for the various components of the "Interim Wastewater Treatment Project" as required. These agencies will consist of, but not be limited to, the Ontario Ministry of the Environment and Health Canada's First Nation and Inuit Health Branch. M.C.R. #2006/07-081 Carried.

Marcel Maracle, Tyendinaga Police Service, called to ask for a written response on whether the Tyendinaga Mohawk Council is the employer of the members of the Tyendinaga Police.

MOTION #6: Moved by Trevor Lewis, seconded by Roy C. Maracle that this Council is the Governance Authority for the Community and are ultimately responsible for public safety and therefore acts as governing authority for the Tyendinaga Police Service until such time as a Police Authority/Police Commission is established. Carried.

MOTION #7: Moved by Trevor Lewis, seconded by Roy C. Maracle that the chair revert back to Chief R. Donald Maracle. (2:55 p.m.) Carried.

MOTION #8: Moved by Blaine Loft, seconded by Trevor Lewis  
WHEREAS INAC has established the Professional and Institutional Development Program to replace the Gathering Strength funding program and is committed to the development of good and effective governance in First Nations communities,  
AND WHEREAS community involvement in governance is crucial to the short and long term strategic planning and development of Tyendinaga Mohawk Territory,  
AND WHEREAS the Mohawks of the Bay of Quinte Chief and Council have determined a governance process to involve the MBQ membership in the development of community authorities/commissions, establishment of an elections code, governance awareness, review and development of youth leadership to support and guide good governance,  
AND WHEREAS the Mohawks of the Bay of Quinte are willing to share the results, upon request, of this Governance Project entitled "Involving Our People in Our Future" with other First Nations and Aboriginal organizations,

THEREFORE BE IT RESOLVED that the Mohawks of the Bay of Quinte Chief and Council fully endorse and support the Capacity Development Proposal submitted to Indian and Northern Affairs Canada with the amount requested of \$89,307.21 and further that the Mohawks of the Bay of Quinte Chief and Council are committed to their contribution of \$23,400.00 for the development of community governance involvement. M.C.R. #2006/07-082 Carried.

Maracle, seconded by Trevor Lewis that this Council direct that a board be put up on the wall in the Council Chambers listing all the minor and major capital, technical and environmental projects along with the status of each project. 

## TYENDINAGA MOHAWK COUNCIL MINUTES NOVEMBER 2, 2006

A meeting of the Tyendinaga Mohawk Council was held on Thursday, November 2, 2006 at 1:00 p.m. in the Council Chambers.

**Present:** Chief R. Donald Maracle  
Councillors: Barry Brant, Roy C. Maracle and Blaine Loft. Trevor Lewis was absent due to work related reasons.  
Staff: Rod Jeffries, CAO, and Angela Maracle, AO

Chief R. Donald Maracle opened the meeting with prayer in Mohawk.

Jackie Maracle, Winston Brant, Deanna Brant, Rick Maracle and Wilson Maracle attended Council regarding Great Oak Lodge laneway.

Jackie requested two things; this is an official request to open the road allowance that connects to where Ron and Deanna Brant have built a house next to MBQ land and Calvin Brant's fence line.

Laneway is not a proper roadway. Built years ago by Stella Brant and local people to help build it up. It is not up to proper standards and difficult to maintain. MBQ Road Staff graded, rolled it and put calcium on it.

Jackie is requesting that the laneway be repaired one more time. Local contractors do not have equipment to grade and roll it again. It has to be done twice a year. Jackie said the residents will pay for all of the costs. The ground is shallow along the right of way with very little soil cover. There are eight homes along the roadway.

Winston Brant said the road is not acceptable for fire, ambulance, health care and police service and oil trucks.

Chief Maracle said a Council motion would be required to authorize the MBQ Road Staff to grade and roll the laneway.

Barry Brant said there are many pressures on the road budget and would be forming a committee to advise on opening of road allowances.

Winston Brant supported an evaluation on the roads and stated the Ridge Road was in poor condition and should be a priority. Barry Brant questioned the liability of repairing the road. Winston suggested that a toll booth should be set up on the York Road since the traffic is 33,000 cars per day.

Jackie stated that he would sign a waiver that the Band would not be liable if there were any accidents on the laneway. Jackie mentioned that Glen Maracle thought it would require \$10,000 to upgrade the road. He stated that he paid \$1,300 last time and he just wanted the road graded and rolled. He did not want gravel or calcium put on the road. He will be back in the spring again to have the road redone.

Winston stated that the pot holes were deep in Jackie Maracle's laneway.

Barry Brant stated that he would approve this time only on a cost recovery basis with liability to MBQ and recommended that Jackie look around for a contractor for the sp maintenance.

Jackie requested that a new culvert be installed about 50 feet off of Ridge Road on the laneway.





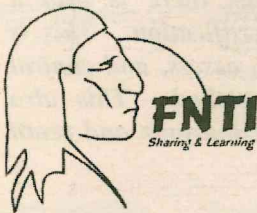

### **1: Introduction to Ventilation systems for First Nations**

#### **2: First Nations Builders Series.**

**Introduction to Ventilation Systems for First Nations (2 full days, in-classroom and on-site, 6-8 participants)**

**Intended Audience:** Renovators, construction or maintenance staff who want to learn how to properly install a Heat Recovery Ventilator (HRV) system, are ready for hands-on installation and want to become HRV installers.

**Course Description:** During the first day, which is in-classroom, participants will learn how a HRV works, the basics of designing a system, how it's cleaned and maintained etc. Day two is strictly for hands-on training and participants visit a home and complete an installation. Those communities that wish to consider this training will have the financial resources to supply the HRV and duct work for the training and have it on site and ready for installation. The community representatives will work with the trainer to determine materials needed, etc.

Day one, the in-classroom day, can accommodate additional participants who are non-technical staff, such as the local nurse, Environmental Health Officer, community health worker who want to learn more about HRVs. These individuals are invited back on the second day to see the completed installations.

### **First Nations Builders Series (3 days, in classroom)**

**Intended Audience:** is contractors, project managers/ site foremen/ carpenters and labourers involved in the production of housing in First Nation communities.

**Course Description:** This workshop is designed to:

- Demonstrate the impact which poor housing design and construction practises have on First Nation communities.
- Introduce and reinforce Healthy Housing principles
- Allow participants to identify typical problems, determine likely causes and recognize the need to change design and construction practises to prevent problems.
- Improve the participants' ability to apply building science principles to prevent problems.
- Introduce new materials, systems and equipment which can improve housing quality in a cost-effective manner.
- Make participants aware that the design and construction of housing can serve as a catalyst to community development.

Workshop Information, Confined Space and JHSC*

**Ontario Safety Group:**

*There has been new legislative requirements effective September 30, 2006 for identifying and entering a Confined Space.*

*Every worker who enters a confined space or performs related work shall be given adequate training for safe work practices for working in confined spaces and for performing related work, including training in the recognition of hazards associated with Confined Spaces.*

*This eight hour course will include information on the following topics: legislation, confined space program, confined space plan, hazard assessment, entry permits, protective equipment, atmospheric testing, rescue and confined space controls.*

*In conjunction with the confined space awareness, there is also a workshop on Joint Health & Safety Committee Certification. This is designed to give participants the ability to recognize, assess, and control workplace hazards using a consistent, accepted method. This also includes the Service sector, office administration, restaurants and retail workers and employers.*

*Legislation also states that a Joint Health and Safety Committee is required: "at a workplace at which twenty or more workers are regularly employed". 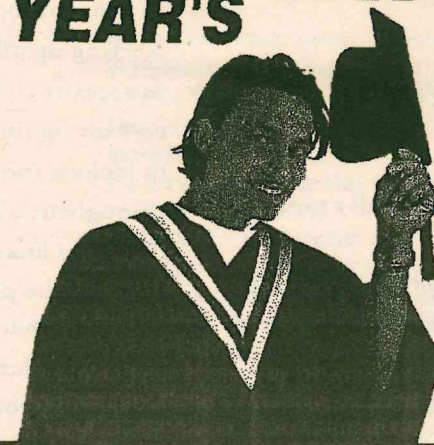

## Ohahase Education Centre Your Future Path to Success!!

### Secondary School Programs

#### Description

Ohahase Education Centre is operated by First Nations Technical Institute to provide programs for students seeking to achieve an Ontario Secondary School Diploma (O.S.S.D.). Ohahase means "new road" in the Mohawk Language and that is why we say it is "Your Future Path to Success"! Ohahase is a Private Secondary School that is inspected and licensed by the Ontario Ministry of Education. Each year our curriculum and guidelines are inspected and the Principal is granted a license to operate and grant credits. Ohahase currently offers two programs; a full-time day program for youth and an adult program of correspondence and night school.

#### Program Mission

#### Ohahase....

Is a centre for excellence, providing holistic and respectful learning rooted in Mohawk language and cultural practices; and

Will facilitate a multigenerational community that fosters belonging through encouragement, motivation and laughter – striving for the goals of self-sufficiency and biculturalism.

### Learning Programs

#### Full-time Day Program for Youth

This program is a Private Secondary School program currently for grade nine and ten students. There is no tuition charge or fees for status Native students or community residents as the school is funded by Indian and Northern Affairs Canada. The program consists of regular semester periods in which students take a maximum of four classes per day in each semester. We offer a unique and challenging curriculum that meets Ontario guidelines and includes aspects of Mohawk language and culture. Students of all ages and levels of ability are welcomed as we are able to provide a small teacher-student ratio. We have been in operation three years and will expand to include grade eleven and twelve in the immediate future.

#### Courses/Program Requirements

Students are required to earn 30 credits to achieve an O.S.S.D. (18 compulsory and 12 optional credits). Our grade 9 and 10 programs in the past have included the following courses:

This program is scheduled during two semesters, starting Semester 1 in September and Semester 2 in February. It is a requirement that students attend classes daily during regular scheduled time slots. Older students are welcome to attend on a part-time basis if they are able to attend the daily scheduled class.

### Adult Education Program

This program is designed as a self-directed learning program with a support system. Adults are offered correspondence courses from the Independent Learning Centre that are approved by the Ministry of Education. Students may work at their own pace and staff at the school, are available to provide assistance when required. The length of the program varies depending on the number of credits required for graduation.

#### Courses/Program Requirements

O.S.S.D (Ontario Secondary School Diploma) requires students to earn 30 credits. Credits may be earned from high school subjects, maturity credits or equivalency credits. At least 4 credits must be senior credits (grade 11 or 12) and a senior English credit must be included.

**Maturity Credits** – the Ministry of education grants up to 12 mature credits to adults returning to school. These credits apply to adult students who started high school in the Province of Ontario before September 1999.

**Equivalency Credits** – some non-post secondary courses that adult students have taken qualify for credits, i.e. apprenticeship training, community college upgrading, etc.

All courses are divided into 20 lessons. Each course is 1 credit unless otherwise stated. Courses are offered at various levels of learning to accommodate educational goals related to work, attending College or University. There is no fee for community members to take a course through correspondence, as the initial registration fees are subsidized by local community service organizations.

Night school is offered periodically and in the past we have offered courses in English, Presentations and Public Speaking Skills, Computers, Math and Mohawk language. Other non-credit workshop courses are available periodically such as leather crafts (moccasins).

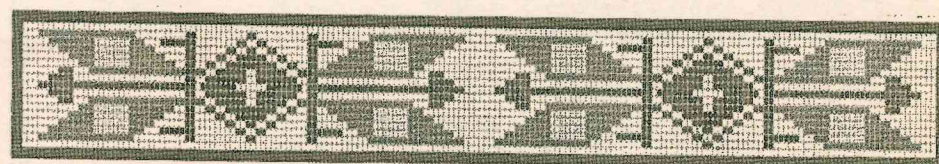

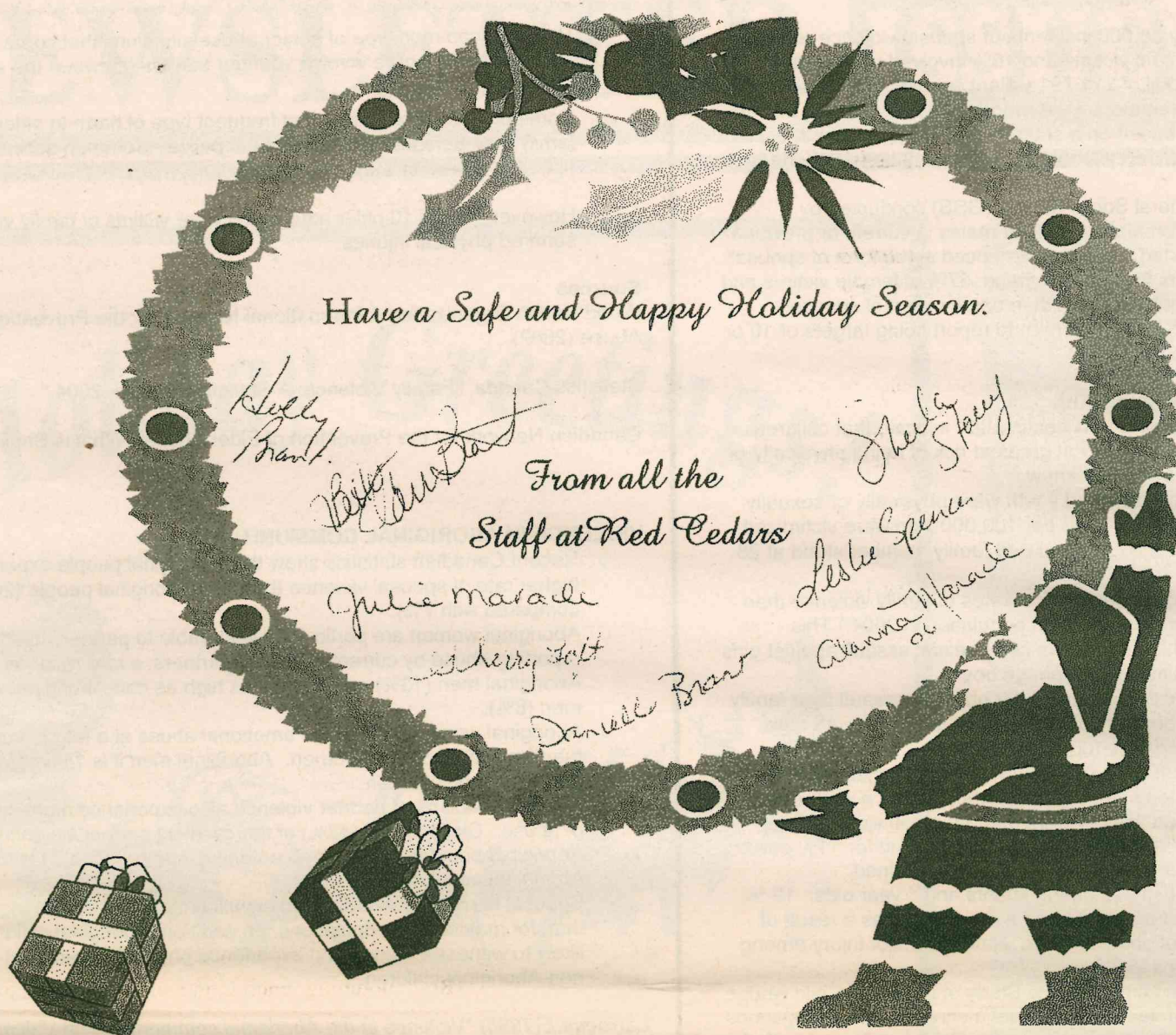

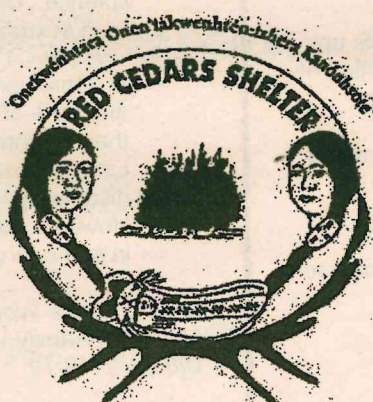

# RED CEDARS

## Domestic Violence Statistics

### Spousal Violence

- In 2004, there were nearly 28,000 incidents of spousal violence reported to police, 84% involved female victims and 16% involved male victims.
- Between 1995 to 2004 a total of 211,791 violent spousal incidents, committed by 172,141 perpetrators were reported to police during this 10 year timeframe. (Data are based on a subset of 119 police departments in 8 provinces across Canada, representing 53% of the national volume or reported crime.
- According to the 2004 General Social Survey (GSS) conducted by Statistics Canada. 7% of females and 6% of males in current or previous spousal relationships reported having experienced some form of spousal violence during the previous 5 years. Of these, 57% of female victims and 49% of male victims experienced more than one incident of spousal abuse. Women were more likely than men to report being targets of 10 or more violent spousal episodes.

### Family violence against children and youth

- Data from a subset of 119 police services in 2004 indicate that children and youth under 18 years of age are at greatest risk of being physically or sexually assaulted by someone they know.
- In 2004, 119 per 100,000 children and youth were physically or sexually assaulted by a parent, compared to 43 per 100,000 who were victimized by a sibling. Rates of assault by an extended family member stood at 28 per 100,000 population.
- Girls under the age of 18 experience higher rates of family violence than boys (242 verses 152 victims per 100,000 population in 2004.) This difference is driven by the higher prevalence of sexual assault against girls and of spousal assault against older teenage boys.
- In 2004, boys aged 14 were at highest risk for physical assault by a family member (183 per 100,000 population) whereas for girls, 16 years olds reported the highest rate (290 per 100,000 population.)
- About 4 in 10 child and youth victims of family violence sustained a physical injury in 2004. Among those against whom either a weapon or physical force had been used, half sustained no physical injury, 37% experienced a minor injury, 1% suffered major injuries and for 11% police were unable to discern whether an injury had been sustained.
- Rates of major injury were highest among infants and 1 year olds. 19 % of infants less than 1 year of age sustained a major injury as a result of family violence, as did 8% of one year olds. Rates of major injury among all other ages ranged from nil to 2%.
- According to the 2003 Canadian Incidence Study of Reported Child Abuse and Neglect (CIS), an estimated 235,315 child maltreatment investigations were conducted by child welfare services across Canada. Almost half of these investigations were substantiated, representing a rate of nearly 19 substantiated investigations per 1,000 children.
- Among substantiated child maltreatment cases, neglect was the most common form of child abuse (30%), followed by exposure to domestic violence (28%), physical abuse (24%), emotional maltreatment (15%), and sexual abuse (3%).
- The rate and type of child maltreatment was similar for boys and girls up to the age of 7, after which differences appear. The greatest proportion of boys abused were between 8 and 11 years of age, while for girls the highest proportion was between the ages of 12 and 15 years.
- Behavioral or emotional problems were among the most commonly noted functioning problems among maltreated children (27%), followed by depression or anxiety (17%), and learning disabilities (15%).

### Elder Abuse

- Canadian research indicates that between 4 and 10% of older adults experience one or more forms of abuse or neglect at some point in their later years from someone they trust or rely on. Under-reporting and inconsistencies in collecting information on abuse suggest that these figures are "the tip of the iceberg."
- Some older adults may be more likely to experience abuse or neglect, including those who are isolated, and those who have mental or physical impairments.
- It is estimated that between 168, 000 and 421, 000 seniors in Canada are experiencing or have experienced abuse or neglect in later in life.
- About 80% of abuse or neglect of older adults is hidden or goes undetected. Only about one in five cases of abuse come to the attention of community agencies or authorities.
- Adult children were involved in 38% of the family assaults against older adults.

- Spouses were involved in 26% of the assaults against older adults.
- Older men were more likely than older women to be victimized by an adult child. Older women were more likely than older men to experience violence at the hands of their spouse.
- The most common type of senior abuse situations that come to the attention of the police involve younger seniors (between the ages of 65 and 69).
- Common assault was the most frequent type of harm to older adults from family members that was reported to police. Common assault may involve hitting or attacking with minor or no injury.
- However, four in 10 older adults who were victims of family violence suffered physical injuries.

### VIOLENCE IN ABORIGINAL COMMUNITIES

- Recent Canadian statistics show that Aboriginal people experience a higher rate of spousal violence than non-Aboriginal people (20% as compared with 7%).
- Aboriginal women are particularly vulnerable to partner violence, with 25% reporting abuse by current or former partners, a rate twice as high as Aboriginal men (13%) and 3 times as high as non-Aboriginal women and men (8%).
- Aboriginal women experience emotional abuse at a rate 8 times greater than for non-Aboriginal women. Aboriginal men it is 18 times greater than for non-Aboriginal men.
- Aboriginal victims of partner violence also experience more severe forms of abuse. Close to half (48%) of the cases of partner violence in the Aboriginal population are life-threatening, compared to 31% for non-Aboriginal populations.
- Spousal homicide rates are also significantly higher for Aboriginal people than for mainstream populations. In addition, Aboriginal children are more likely to witness violence and experience physical and sexual abuse than non-Aboriginal children.

- A 1989 study by the Ontario Native Women's Association found that 8 out of 10 Aboriginal women in Ontario had personally experienced family violence. Of those women, 87% had been injured physically and 57% had been sexually abused.
- In some northern Aboriginal communities, it is believed that between 75% and 90% of women are battered. The study found that 40% of children in these communities had been physically abused by a family member.
- Little is known about the incidence of abuse of older adults, of people with disabilities, and of the homosexual population in Aboriginal communities. However, abuse of older adults has been identified as a serious problem in some Firsts Nation communities.

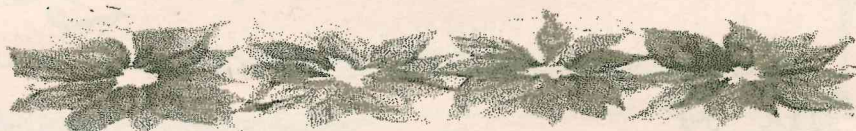

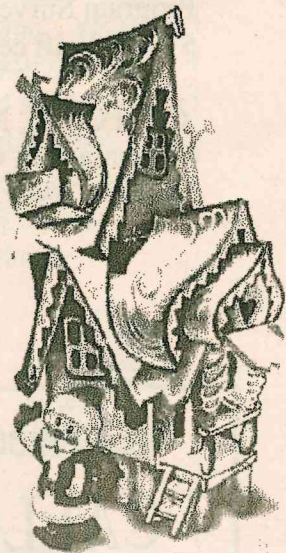

## Aboriginal Youth and HIV/AIDS: The Facts

The Canadian Aboriginal AIDS Network (CAAN) is a national organization which deals with HIV/AIDS in the Aboriginal community. CAAN has a mission to stop the spread of HIV/AIDS and to support those now living with it. HIV/AIDS among Aboriginal young people is rising and this fact sheet will explain how.

### What is HIV/AIDS?

HIV is a virus in North America for over twenty years. It attacks the human immune system, which is what people need to fight off simple things like a cold or flu. HIV stands for Human Immuno-deficiency Virus. AIDS stands for Acquired Immune Deficiency Syndrome.

HIV is believed to cause AIDS. If you have tested HIV-positive, it does not mean you automatically have AIDS. People who test HIV-positive can spread HIV to someone else, even if you feel totally healthy. A blood test is what is used to find out if you have HIV. Unless you have the facts and go for a HIV test you may not know that you have HIV.

Only a doctor can tell someone they have AIDS. You can be infected with HIV for a long time (more than 10 years) before you develop AIDS. AIDS happens when your body cannot fight off infections and your T-cell count goes way down. T-cells are found in your blood system and help fight infections.

### THERE IS NO CURE FOR HIV OR AIDS!

There is no cure for HIV or AIDS, but it is 100% preventable. There are powerful pills that can help people with HIV/AIDS live longer, healthier lives. These medications often make people feel sick from the side effects like upset stomach and diarrhea or worse. The pills are NOT a cure; they only help people live longer.

### Who can get HIV?

Any one can get HIV/AIDS. There are many options to reduce or eliminate the risk of HIV infection. It is not who you are, but what you do that puts you at risk for HIV or other sexually transmitted infections. Here are some ways:

- Blood to blood (like sharing needles to inject drugs.)
- Exchange of body fluids (vaginal or anal intercourse without a condom. Even oral sex can have some risks if there are sores inside the mouth.)

- Mother to child (through breastfeeding or when the mother gives birth.)

Almost one out of every four youth who tests HIV-positive in Canada is Aboriginal. Aboriginal young women; Straight guys and Two-Spirit (Gay/Bisexual/Transgendered) young men who have unprotected sex are becoming infected with HIV more and more.

### What we know for Aboriginal young people under 30 years old!

Among new positive HIV test reports and reported AIDS diagnoses, Aboriginal cases are younger than non-Aboriginal cases. Remember, it takes many years after getting infected with HIV before you develop AIDS. AIDS cases tell us what happened about ten years ago. HIV cases tell us what is happening now.

HIV data from the Centre for Infectious Disease Prevention and Control tells us that 26.5% of new HIV infections are among Aboriginal youth compared to 19% in non-Aboriginal HIV infections. This means Aboriginal youth are being infected more than non-Aboriginal youth.

### REMEMBER!!!!

- HIV is 100% preventable (you can avoid getting HIV/AIDS.)
- Your brain is the body's first defense against HIV/AIDS (you can decide what to do or not to do.)
- Feeling good enough about yourself (like you are worth protecting) can help protect against HIV/AIDS (you are worth it.)
- Find out where to get a blood test for HIV and talk to someone to see if you should take one. Knowledge is Power!
- Know your sexual partner very well before having unprotected sex and talk openly with them.

- **Take care!** It is really important to eat well, exercise regularly, and get enough rest.

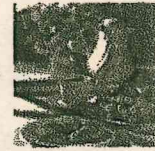
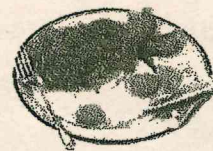

**BREASTFEEDING CIRCLE**

*"If I get an infection, like a cold or flu or diarrhea, will breastfeeding give my baby my illness?"*

No. Viruses cause most infections, and most infections due to viruses are most infectious before the mother has any idea she is sick. By the time the mother has fever, or runny nose, or diarrhea, or cough, or rash, or vomiting etc., she has probably already passed on the infection to the baby, whether she is breastfeeding or not. However, breastfeeding helps the baby fight infection, and the mother should continue breastfeeding in order to protect the baby. If the baby does get sick, which is possible, he is likely to get less sick than if not breastfeeding. You should also continue to breastfeed through bacterial infections, such as "strep throat", for the same reason. Remember to drink plenty of fluids.

*"What if my baby gets sick? I've heard that I should only give clear fluids during diarrhea/vomiting, and that milk shouldn't be given during a respiratory infection."*

Mother's milk is not like other milks, and should not be categorized with milks of other species. Babies get better more quickly while breastfeeding, and rarely need oral rehydration solutions or other forms of fluid replacement (such as IV's). Babies and young children will often refuse other foods or drinks and usually do well with breastfeeding alone in the vast majority of situations. Even when breastmilk is vomited apparently immediately after feeding, some of it has been rapidly absorbed.

There is a belief among some people, including some health professionals, that "milk" should not be given to children during respiratory infections because it produces more mucus. Whether or not this is true, it is definitely not true for breastmilk!

Through breastfeeding, the mother is able to comfort the sick child, and by breastfeeding, the child is also able to comfort the mother. Breastfeeding, not just breastmilk, is good medicine!

The idea for "Dream Catchers" originated in Michigan from participants in a youth group from American Indian Services in Lincoln Park Michigan. The youth group was attending classes at our home, learning paint and body work on street rods and custom cars. The ideas for the car club were inspired from the continued and growing interest from participants from the youth group, as well as some of the parents and the desire to learn how to work on these cars. The involvement in this hobby taught and gave them the skills and knowledge to pursue this as a hobby, and also at the same time, teaching the skills to use as a possible career to use when they enter the job market.

As everyone in the youth group became more involved in working on these cars, so did their interest about street rodding and custom cars. This involvement in the hobby resulted in the idea of starting a street rod and car club, and this decision also drew interest from parents and family members who were also expressing an interest and desire to learn about the car and street rodding hobby. The interest was also about learning how to paint, do body work, and how to put these cars together. Everyone also wanted to own their own cars, but doing their own work on building their own car involving their own kids and family as well this would be accomplished by teaching and helping those interested in the street rodding hobby by teaching others, they in turn will be able to help others also.

Car ownership is not a requirement to being a member, but having an interest, and the interest in learning how to work on these cars is a must.

## POSTCARDS FROM THE VISION QUEST

### Are the winds turning?

I don't know about you but this entire year has just flown by. I'll look at old e-mails or really anything with some kind of date-stamp on it and just do a double-take. It feels like April, May, August was only a few weeks ago.

What were the highlights?

I turned 30 which means I'm a real live adult now. Not that I ever was anything less before. It's funny: I look back now on my youth, especially to when I was a teenager, and it just seems I never really indulged in anything anyone would consider "youthful."

One of the biggest realizations this past while has been my full-on acknowledgment of my need for solitude. I felt so unusual back then because I demanded time alone. Yes, it's strange for a young person to want that, but if you do, how do you stop it? I remember being made to feel strange and odd for—as a necessity—requiring time alone. There are virtues, of course: I'm much more at peace with my thoughts, more available to understand my thoughts when I take the time. It took a long time, I guess is what I'm saying, to accept that this continual rumination is not only okay but an integral part of me just being me. I think what started it was an article I read maybe six months ago. If we were online right now, I'd link to it. Hmm.

For my big bash birthday, I dragged a few friends to a local club to see Carlene Carter. I loved the show; they weren't quite as impressed. I suppose now it may be that part of my delight was to see how age has caught up with Carlene, as well. As recently as seven or eight years ago, she was nothing short of a raging hot mama. It seems, though, that when you take away the drugs, all the weight piles on.

In all my years, I've also learned that drugs make you nice and skinny. I'd be hooked on them today if I weren't so terrified of the downside, or all the negatives, I should say. There's always a tradeoff, you know? The irony, of course, is that people hooked on drugs tend to not care about their waif-like figures; in fact, for the same reason, they probably realize it's an indicator of a problem.

My two favourite albums from this year are "Black Cadillac" by Rosanne Cash and "The Breakthrough" by Mary J. Blige. From top to bottom, start to end, it's always an absolute delight to listen to these two CDs. Rosanne's is mostly about the loss of her parents and dealing with death. Mary Jane's is about love and survival—all the usual female R&B themes—but it all just sounds SO GOOD! I recommend them wholeheartedly.

The best novel/movie combo I've experienced this year is "The Hours." Yes, they're both more than a couple years old. I took a few days earlier this year to read the novel and, immediately after I finished, I watched the movie. Usually novels made into movies suck, but these two complemented each other very well. It was like one filled in the holes left by the other.

I finally got around to reading Joseph Boyden's "Three Day Road," and I enjoyed it very much. It's not so much an Indian novel as it is a World War I novel, what with all the gory details. And you couldn't tear me away from David Treuer's "Native American Fiction: A User's Manual" while I was reading it. It entirely contributes to the better understanding of writing by Boyden and more better known Native writers like Sherman Alexie and Louise Erdrich.

The great big mid-term election was held here in America this year. It's supposed to be such an amazing thing that so many Democrats are in Washington now and all the liberals are so happy. What's strange is that Tennessee contributed nothing to it. "We" elected yet another Republican to the Senate and overwhelmingly endorsed the anti-gay marriage amendment. One can't help but feel a little unwelcome here these days.

I can't recount this past year without acknowledging the passing of my grandparents, Elwood and Eileen. The future will blur their deaths together, I'm afraid. As I said earlier, this year has flown by and, though almost eight months passed between Grandpa in February and Gram in October, that distance will close very fast.

Makes me think about the stories we tell about our lives. Forever, I'm sure, those seven or eight months will seem like nothing but preparation for Gram but, while we lived through that time, we never thought of it as that until it became obvious. And though it was in both February and October, they do seem to adequately bookend the year. At least for me.

Once a major date has passed, it seems nearly impossible to imagine life before it, however tranquil (or not) it was. My mind won't connect the months leading up to September 11, 2001 and that date, for example, in spite of how little it has related to my life. The months, or the weeks and days leading up to my dad's car accident (12 years ago this Dec 21) seem years separated from that day. Because there's no relationship, there's no means for connection.

I've been home three times this year and each visit seemed to pull me back into the details of life at home more than the last. With the passing of my grandparents it seemed there was more time to witness for myself all that has changed. In both cases, we waited a week or so until the day came and with each passing day came to me more memories, more insight into the similarities between the "work of community" that I do in Nashville and what I see happening at home.

I wonder if I've learned enough here; if, after all these wonderful years I've spent alone, there's come time again to re-engage.
