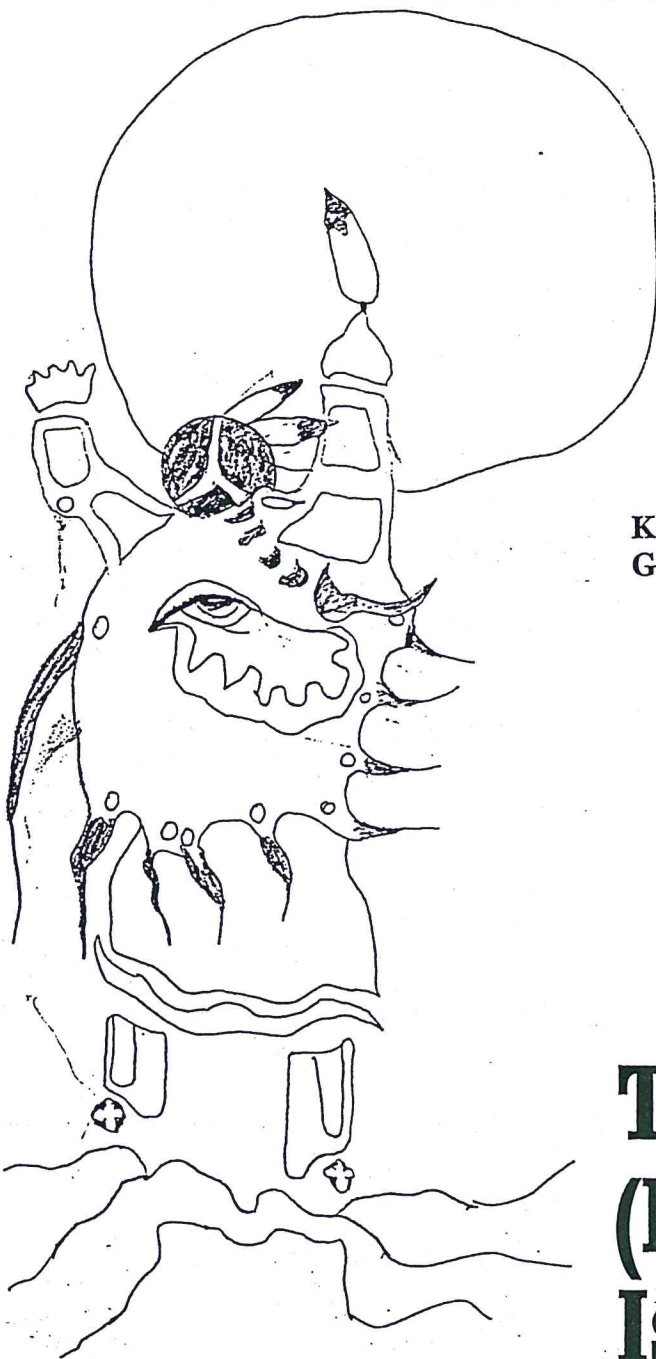

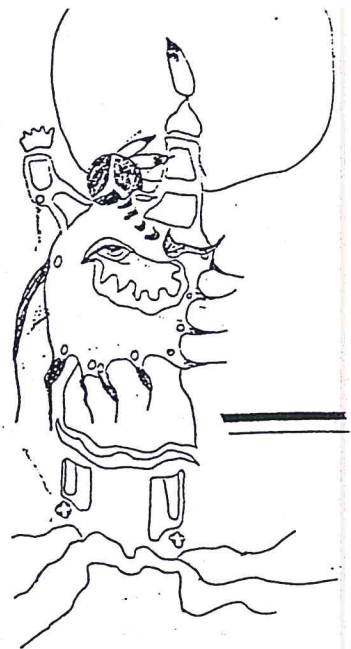

## **RETAILER AGREEMENTS - TOBACCO SALES**

### **BULLETIN**

*This is further to the "Urgent Message to All Chiefs and Councils in Ontario" dated November 12, 1993 and sent to you by Priority Post.*

*Members of the Planning and Priorities Committee met on November 16, 1993 with the Assistant Deputy Minister of the Tax Division of the Ministry of Finance to discuss global concerns with the regulation that imposes a new allocation system for the sale of unmarked tobacco for First Nation consumers.*

*With the passing of Regulation 649/93 the Ontario government has determined a base allocation for each First Nation community using "average" smoking patterns of First Nations people as reported in the census.*

*It was clear from those discussions that the Province is not applying the regulation in the same way in all First Nation communities. The Province is using four different methods of applying the regulation:*

- *Firstly, where a communities' current retail purchases are within*

*the base allocation determined by the province, the Council will not be asked to sign a Retailer Agreement at the present time.*

- *Secondly, in communities where the current retailer purchases are greater than the allocation, retailers will be required to reduce their purchases accordingly and Councils are being asked to sign a Retailer Agreement.*
- *Thirdly, where a community was under the "old" quota system and the allocation will increase under the new allocation, the Council will be asked to sign a Retailer Agreement and have the ability to allocate the increase to the retailers.*
- *Fourthly, where a community was under the "old" quota system and receive an allocation greater than would be available to them under the new formula their allocation will remain the same provided the Council signs a Retailer Agreement.*

Two other items became very clear as a result of the discussions: Ontario, under certain circumstances, is willing to enter into direct negotiations with First Nation communities to reach agreements outside of the regulation, and; in terms of time frames, Ontario realizes that they may not be able to meet the December 1st deadline they have imposed on themselves. It is important to note that this will become impossible if each First Nation community requests separate negotiations to enter agreements outside of the regulation.

To date, activity involving this office has been at the technical level. The next steps will include political meetings and public relations work.

*The advice from the Planning and Priorities Committee has not changed. The Grand Chiefs are firm in their recommendation advising Councils NOT to sign any Retailer Agreements at this time.*

Imposition of the Regulation 649/93 does not meet the tests laid out in the Sparrow decision that requires our involvement. Further, the regulation was developed by the Province without our input and violates the Statement of Political Relationship and

our agreement to conduct business on a government to government basis.

Representatives for the Province report that two Retailer Agreements have been signed and received by the Province, but would not disclose how many communities have written to indicate they will not be signing the Retailer Agreements and will not be involved in allocating or monitoring the provincially established quota.

The Planning and Priorities Committee will be having a conference call to determine further political action. Further Bulletins will be issued as additional information becomes available.

Again as a reminder, I want to repeat the request included in the initial Bulletin. Please keep the retailers in your community informed regarding this issue as the decisions that will be made directly effect their ability to do business.

## **TREATY SIX CHIEFS SET TO TRAVEL TO LONDON, U.K. TO LOBBY FOR PROTECTION OF HISTORIC TREATY RIGHTS**

Today a delegation of fifty-five representatives of the Confederacy of Treaty Six First Nations - Chiefs, Councillors, elders and youths - will be departing for London, U.K. to lobby the British Parliament and international human rights organizations during the period November 20 - 28, 1993. This is the first time since 1981-82 that Treaty Six Chiefs have gone on such a lobbying mission to England to protect their sacred treaty rights.

A basic objective of the latest visit by the First Nations delegation is to inform interested members of the British Parliament of continued failure by the Government of Canada to perform its treaty obligations. There have been literally scores of such violations, and many of them have had the effect of reducing the sovereign authority of the First Nations and their unique bilateral relationship with the British Crown in Right of Canada.

While in London, the First Nations Chiefs will request assistance from British M.P.s and Lords for the setting up of an international monitoring agency that will a) scrutinize treaty violations and, b) monitor the preservation of the right to self-determination of indigenous (First) nations under international law. The Confederacy of Treaty Six First Nations has already made a strong overture to the Commonwealth Heads of Government office in this important respect. The proposed monitoring agency would have the role of safeguarding the inalienable rights of all recognized indigenous peoples in the Commonwealth of Nations.



The First Nations Chiefs will impress upon the British Parliamentarians that the sovereign status of their First Nations that prevailed at the time of treaty signing in 1876 must still remain intact today. The Chiefs will mention the classical Mohegan case that was ruled on by a British Government Privy council Judicial Committee during the pre-revolutionary period in America. In that instance, the nationhood status of the First Nation was clearly recognized and affirmed. The logic is that the same principle should apply to Treaty Six First Nations today.

Confederacy Chiefs and their peoples are firm in their belief that Treaty Six comparable in status to a vast array of international treaties between states around the world. This belief is rooted in the principles of the Royal Proclamation of 1763 which recognized First Nations as sovereign nations and legal custodians of the land they occupied. First Nations Chiefs will seek the political and moral support of the British Government to get a legal opinion from the International Court of Justice at The Hague, Netherlands, affirming that First Nations treaties are of the same order as other international treaties.

An important final objective of the trip to the U.K. will be to invite Her Majesty Queen Elizabeth II to come and visit the indigenous territories in Canada. Some twenty years have passed since Her Majesty was afforded an opportunity for such an official symbolic visit to Alberta. Confederacy of Treaty Six First Nations will give their unequivocal support to the Queen in her struggle to retain her rôle as the monarch of the British Commonwealth of Nations and protector of the treaties of the First Nations, regardless of sporadic rumblings to undercut her.

Confederacy Chiefs and their representatives have lobbied for ten years to the United Nations Sub-Commission on Human Rights at Geneva, Switzerland. Great international awareness of the dilemma of First Nations has been generated in the process. It is a logical extension of that effort to gain stronger support from the British Parliament and the Queen in exerting pressure on Canada to honour its legal treaty obligations to the Treaty Six First Nations.

To put the objectives of this lobbying expedition into proper perspective, it is essential to tie it to the past history of the Treaty Six Nations. One-hundred-seventeen years have passed since the Chiefs and Headman of First Nations became signatorie to Treaty Six (1876) through involvement with Commissioners sent by Queen Victoria. This bilateral (nation-to-nation) agreement has been scrupulously adhered to by people of the Treaty Six First Nations; regrettably,



the Government of Canada has reneged on many of the obligations committed to by the Queens representatives. First Nation leaders have long demanded that the "spirit and intent" of their treaty be honoured to the fullest extent possible.

Why does this dilemma exist today as the end of this century is approached? The virtual reality is that the Government of Canada has been implementing a definite policy of coercive assimilation from the very start of Confederation.

In 1981-82, at the height of the repatriation of the British North America Act (Constitution of Canada) proceedings, some of these same First Nations leaders were in London to ensure that adequate treaty protection provisions were part of the new instrument of national law. At that time, in a last ditch effort to control the situation, the Indian Association of Alberta (which included all the Treaty Chiefs in Alberta), with the support of the Union of Nova Scotia Indians and the Union of New Brunswick Indians, contested the repatriation of the British North America Act without their consent and without the insertion of legally binding treaty protection clauses in it, by taking their case to the British High Court. In a landmark ruling on January 18, 1982, Justice Lord Denning made astute, wise statements in support of the First Nations from Canada. At the time of his momentous decision, the Justice stipulated that if, after a ten year trial, the First Nations still felt their rights were in jeopardy, they should return to London for the purpose of laying their grievances before the British Government. Now that crucially important option is being exercised.

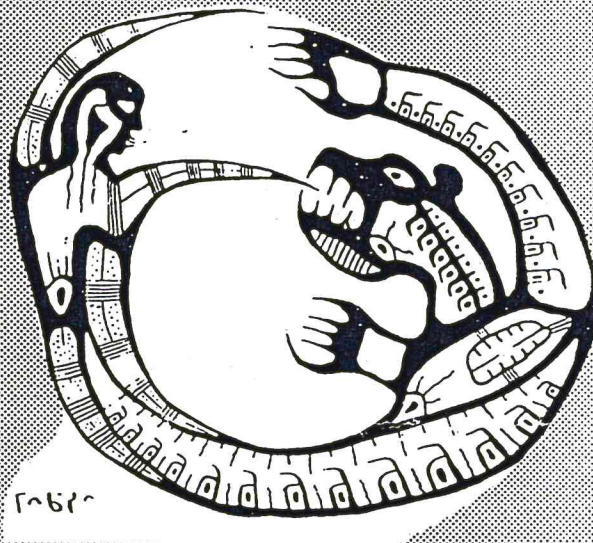

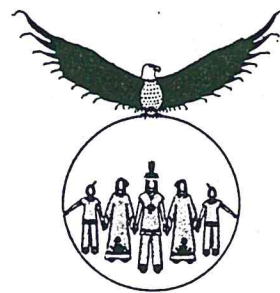

## FULL-TIME NATIVE JP TO BE SWORN IN

**KENORA** -- After four years as a part-time native justice of the peace for Fort Frances, Joe Morrison has returned home to Kenora.

Mr. Morrison, a member of the Big Island First Nation, will be sworn in as the area's full-time presiding native justice of the peace on Friday, October 29. The ceremony will take place at the Kenora courthouse at 216 Water Street, and will be conducted by Senior Judge Gerald Lapkin, Coordinator of Justices of the Peace.

For almost a year before his full-time appointment, Mr. Morrison had been doing double duty between the two jurisdictions. To temporarily fill a need for services in Kenora and the district, he was given the post of part-time presiding native justice of the peace. In this capacity, Mr. Morrison's duties included conducting provincial offences court and bail hearings. In addition to Kenora and Fort Frances, his jurisdiction included Grassy Narrows, Wabaseemoong, Sandy Lake, Pikangikum, Bearskin Lake, Sachigo Lake, Cat Lake, Weagamow Lake, Red Lake and Sioux Lookout.

Mr. Morrison speaks Ojibway, and, prior to his appointment as a part-time justice of the peace, had extensive experience as an advocate in local, regional, provincial and federal native community organizations. A former accountant and member of Canada's NATO forces in Europe, he has been a spiritual and cultural advisor to the National Association of Friendship Centres. He has served as executive director of Ne-Chee Friendship Centre in Kenora and the United Native Friendship Centre in Fort Frances. He was also president of the Nishnawbe-Gamik Friendship Centre in Sioux Lookout.

His full-time assignment to Kenora was effective July 15. Mr. Morrison underwent a full competition and completed several pre-appointment qualifying training courses before being selected.

The Ontario Native Justice of the Peace program was instituted in 1984 by the Ministry of the Attorney General, as a result of a submission from the Ontario Native Council on Justice. So far, the program has encouraged and enabled more than 30 native persons to play an expanded, decision-making role in the administration of justice as justices of the peace.

"Through the program, native justices of the peace are able to apply their cultural understanding, language skills and life experiences in the exercise of their responsibilities," says Attorney General Marion Boyd. "I would like to emphasize that when native justices of the peace are on duty, they handle *all* matters which come before them, not just duties relating to native persons."

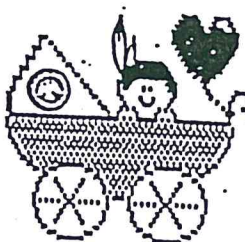

## HOLIDAY SAFETY

Every year, the Christmas Festivities for some are marred by fire tragedy.

Often the cause is related to the Christmas tree or its decorations, overloaded circuits, improper use of the fireplace, and holiday cooking and entertaining.

### IT COULD HAPPEN TO YOU !

- \* Add water daily to keep moisture in the tree
- \* Keep it in a cool place away from heat register, fire place or radiator
- \* Tie or otherwise secure tree so it can't be knocked over by pets or small children
- \* Do not smoke near tree
- \* Before using lights on the tree make sure they are C.S.A. or U.L. listed
- \* Never use more than three strings of lights on 1 circuit
- \* Be able to turn off the tree lights without reaching or crawling under the tree
- \* Do not leave the lights on if you leave the house or when going to bed
- \* If you have an artificial tree, be sure it is flame resistant
- \* Don't burn paper and boxes in the fireplace

If you follow these suggestions you will reduce the chance of Fire in your home over the holidays.

# Exercising the power within

College helps natives solve own problems

DESERONTO, Ont.

Tears come to Rev. Ross Maracle's eyes as he talks of what graduates of his National Native Bible College face on a daily basis:

"One day there's a suicide, another day someone's in a coma after sniffing glue, or somebody's shot."

"This goes on day after day, and the people who work with it are all just bombed out. We don't understand what it's like in those native communities."

Graduates of Maracle's college near Deseronto, 45 kilometres west of Kingston, are all over the North, working as pastors in Baptist, independent and Anglican churches.

Maracle, a Mohawk, started out training men and women to work in evangelical churches, but says the needs are so great on many reserves that some graduates have been drawn into other work as alcohol and drug abuse counsellors or as band chiefs.

That's why he has added extra courses at the college and started training students in substance abuse counselling, grief counselling and administration. He's also training the families of would-be pastors so they too can better handle the pressures that will face them.

Maracle is doing all this on a shoestring. It costs about \$450,000 a year to keep alive the college and his weekly television program for natives, *Spirit Alive*. Most of the money comes from donations, some from the \$2,200 that students pay for each semester.

Raising enough money is a constant struggle, says Maracle. But problems like the smallness of the college's library and the lack of an adequate playground for the 45 children on the campus don't faze students like Benita Manitawabi, an Odawa from Manitoulin Island.

"The college has been like a spiritual healing place for me," says Manitawabi. "My confidence has been built up, and I can see my leadership skills being developed."

Like other students on campus, Manitawabi, 33, believes the Christian message is the only solution for the problems of Canada's native peoples. She says she tried everything to escape the problems in her life — doctors, psychiatrists, native spirituality, the occult.

"My last choice was to try Jesus. I found peace and joy in him."

Others have similar stories. Steve Sliwa, an Ojibway from Curve Lake, near Peterborough, says he started using drugs at 10, and was a drunk for almost 20 years.

"Two years ago, I came to the end of my rope, and I watched *Spirit Alive* and I gave my life to the Lord."

Sliwa, 32, says he's been sober ever since, and spent two years working in a small native church before coming to the college this fall.

Barbara Sutherland, 53, is a Cree. She says she gave up on God after being abused as a child in Catholic residential schools. But in Moose Factory, on James Bay, she started attending a church run by one of the college's graduates.

Now she says, "There are lots of people like me — victims who don't know where they're going. Their children suffer and their grandchildren."

"Maybe I'll be able to go back and counsel wives who have been abused, rape victims."

Maracle, 48, started the college 16 years ago with \$35 and a log cabin at his home on the Tyendinaga reserve. The first students had to do without running water, but 67 men and women have

graduated from the three-year program and another 23 are on campus.

Twenty-seven years ago Maracle was the first native graduate of Eastern Pentecostal Bible College in Peterborough. But he was convinced that non-native colleges just weren't equipped to teach native people to work in a culture and conditions that are quite different from what most bible college students will ever experience.

Maracle says he and other native pastors on the college staff provide role models of people who have succeeded in ministering to the native people.

He believes his students are important to the solution of the problems on native reserves. "Every dismal, desperate statistic says failure. The government's been trying to stem the tide of alcohol abuse and pouring in dollars and experts."

He says native people lead Canada in all the statistics for suicides, murders, rate of imprisonment and alcohol abuse.

"We've had 300 years of failure. Now we have to be given the opportunity to craft our own problems and our own solutions."

"I don't want 'p curse the darkness. I want to find solutions."

For Maracle, that means training

native people to work where there is need, giving them the skills and motivation to persevere in tough circumstances. It also means trying to wake up non-native Canadians through his television programs, speaking engagements and articles written for both Christian and secular publications.

Those efforts were honored this fall by Trinity Western University in Langley, B.C., which gave him an award for what it called his outstanding contributions to the country and his native community.

But Maracle wasn't always devoted to the native people.

"People think I'm always been Mr. Native, but I turned my back on my people after graduating from bible college."

Maracle's father, Rev. Andrew

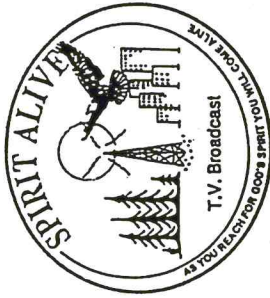
Maracle, was a Mohawk, and Maracle grew up on the Tyendinaga reserve; his mother was non-native. So his first church was a non-native Pentecostal church, and he went on to become a travelling evangelist.

Then, 16 years ago, he says God spoke to him, telling him to go back and work with the native people, starting with a bible college for native pastors.

Maracle is just part of one of the country's best-known native families. His father, now 80, founded many native churches and still travels as an evangelist. His brother, Jonathan, has won awards as one of Canada's top Christian recording artists, while brothers Thomas and David are well-known native sculptors.



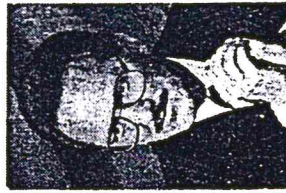

## BREAKTHROUGH FAITH

*And when they had uncovered the roof where He (Jesus) was: and " ... had broken it up, they let down the bed wherein the sick of the palsy lay. When Jesus saw their faith, He said unto the sick of the palsy, Son thy sins be forgiven thee. ... Arise and take up thy bed ..." (Mark 2:4-5,11)*

The opposite of a breakthrough is a breakdown. A breakdown physically, mentally, or emotionally indicates an inability to cope or to move forward. A breakthrough on the other hand, according to Webster's Dictionary is: "an act of breaking through a hindrance, and obstruction or a restriction".

Do you feel hindered and hemmed in, on the verge of a breakdown? Are you facing troubling situations that seem to be impossible and impregnable?

However, suddenly in their path was a hindrance, "and they could not come nigh unto Him, for the press (the crowd)".

This is what St. Peter describes as a "trial of faith". He tells us that when we face difficulties and disappointments our faith should be found unto "praise and honour". At times like these we are to, "... hold fast the confession of our faith without wavering..." (Heb. 10:23). *He is still a rewarder of them that diligently seek him, (Heb. 11:6).*

Thank God, they (the men's friends) didn't say, "At least we tried".

Somehow, I choose to believe that a motivating factor was also the faith of their palsied friend. In pain, bedridden and no doubt a helpless paralytic, body filled with pain and racked with involuntary tremors, his faith started to come alive. Hope begin to stir. I can hear him say, "Boys, don't give up now, we've come too far to turn back!"

3. Faith that Refuses to be Stopped Praise God, with unwavering faith they climbed up onto the roof, above where Jesus was, "...and when they had broken it up, they let down the bed wherein the sick of the palsy lay" (V.4). They didn't have a breakdown -- they had a breakthrough!

Can you imagine the feelings of those outside of where Jesus was, seeing these men carrying a man on a stretcher and climbing upon the roof. What do you think they said? "Hey, what do you think you're doing? Don't you know your going to interrupt a service and disturb a preacher?"

They would not be deterred! They were determined! St. Paul said, "Above all taking up the shield of faith wherewith ye shall be able to quench all the fiery darts of the wicked" (Eph. 6:16). In faith they

resisted the voices of doubt and ridicule and pressed on.

4. Faith That Receives the Answer to Demonstrate the Victory "When Jesus saw their faith, He said unto the sick of palsy, Son thy sins are forgiven thee..." Jesus dealt with first things first. He dealt with sin, the disease of the soul, and then with the sickness of the body. Then He said, "...Arise and take up thy bed" (V.11).

"And immediately he arose, took up the bed, and went forth before them all; inasmuch that they were all amazed, and glorified God saying, We never saw it on this fashion."

(V.12) What a sight! The bed had carried the man. Now the man carried the bed! What a testimony to the determination of faith and to the

Whatever force has paralyzed your life can be overcome. There is healing available to you from Jesus, "Who healeth all thy diseases". May we in churches, homes and our personal lives see it in this fashion, and then we will see people running unto Jesus amazed and glorifying God.

My prayer is, that we also may have courageous roof breaking, and live changing faith! Often, I have been challenged by the phrase that Jesus used frequently, "According to your faith so be it unto you!"

I sense in my spirit that even as Christ, "sent His word, and healed people ..."
