AFN CONFEDERACY OF NATIONS MEETING - OTTAWA, DECEMBER 9 - 11.2003

VOTING PRIVILEGES

After the opening exercises and National Chief Fontaine's speech, there was a rigorous debate about whether to allow all the Chiefs who registered at the conference a vote on issues. The motion was introduced by a Chief from British Columbia requesting the voting rules that the voting rules of the AFN Charter be enforced.

For more than a decade, the AFN Confederacy of Chiefs have allowed all Chiefs registered, to vote on issues. Section 11 of the AFN Charter sets out the rules for regional representation for the AFN Confederacy meetings. The Ontario region for example, would be limited to 16 votes and British Columbia would have 13 votes. This is based on 1 vote for every 10,000 people.

Many Chiefs opposed the request stating that they were invited to the AFN Assembly by letter dated November 21, 2003 and had paid the registration fee and incurred expenses to attend the conference. Many Chiefs cited that they had always voted at the conferences and questioned the motive for enforcing the rules of the Assembly now. For more than nearly fifteen years, the voting rules of the Assembly were not followed. The Chiefs now expect that any registered Chief should have a vote as has been the convention of the Assembly. The National Chief was quick to point out that it was not his office nor the AFN Executive who made this an issue.

The matter was referred to the AFN legal advisor, Roger Jones, who recommended to adopt the status quo for this meeting and apply the custom and tradition of the Assembly to allow any registered Chief to vote. The Chairperson stated that for the next meeting, the implementation of the Charter Rules will have to happen.

here were 174 registered voting delegates at the Assembly. The Chiefs passed a motion based on the lawyers advice, to allow all the registered delegates to vote. A total of 109 Chiefs were in favor, 14 were opposed and there were 2 Abstentions.

Section 11 of the AFN Charter will have to be amended to provide for a more inclusive Assembly,

AFN 2003 PRE-BUDGET SUBMISSION

There was discussion about the AFN 2003 pre-budget submission to the House of Commons Finance Committee for an increase of 1.7 billion dollars in new funding outlined in The Getting Results Submission.

The following represent the history of the pre-budget submissions by the AFN to the Finance Committee.

1999 This marked the first AFN Pre-Budget Submission. In this submission, the AFN pointed out that the First Nations were left out of increased provincial transfers for Health and Education. This Pre-Budget Submission would become the blueprint for all future submissions, based on three themes. These themes reflect arguments originally made in the Royal Commission on Aboriginal Peoples (RCAP) Report. First, our poverty is costing all governments billions of dollars every year. Second, we are the youngest population in Canada. The federal government has to invest to raise the productivity of our youth or there will be fewer resources to support Canada's elderly. Third, the best way to reduce our poverty is to implement First nation governments as a third order of government. The first Pre-Budget Submission also requested resources for First Nation communities to improve services, build economies, enable individuals, settle land claims and implement First Nation governments. The total request was for 1.6 billion.

2000 This Pre-budget Submission focused on creating healthy First Nation communities. The AFN pointed out that improving the health of First Nations and First Nation economies will improve Canadian productivity, living standards and ensure social justice. The AFN repeated the main themes from the first submission. This was the first year of large federal surpluses. The AFN requested \$4.55 billion in resources to restore First Nations implement our governments and build institutions. The AFN Pre-Budget Submission strategy began to work. The federal throne speech from January 2001 began to use some of the language and ideas contained in the 1999 Pre-Budget Submission.

- 200** This Pre-Budget Submission was delivered in October 2001 – one month after September 11th. Naturally, this Pre-Budget Submission focused on the issue of National Security. The *AFN* pointed out to the federal government that our continued poverty had to be addressed as part of the security strategy. Owing to continued large federal surpluses, the *AFN* requested **\$4.13** billion to build our nations, implement First Nation governments and build institutions.
- 2002** The theme of this Pre-Budget Submission was implementing the Throne Speech of 2001, providing a Legacy opportunity for Jean Chretien and responding to the proposed First Nation Governance Act. Federal surpluses remained high so a request for **\$4.6** billion was made to restore nations and implement First Nations governments.
- 2003** The Pre-Budget Submission strategy began to yield results. The federal government committed significant resources (about \$2 billion) to First Nation programs and enhanced services in 2003. The rationale for these commitments matched those presented in past *AFN* Pre-Budget Submissions. The 2003 submission focused on improving productivity. Owing to a much smaller federal surplus and in recognition of committed resources, the *AFN* requested \$1.7 billion.

I am enclosing a copy of the “Estimation Explanations” and “What It Could Mean for Communities” for your perusal.

CANADA'S FORESTRY INDUSTRY

The United States Government has collected 2 billion dollars in tariffs. The *AFN* reported that 1 billion dollars will be returned to Canada which will be returned to the Forest Industry. Some of the BC Chiefs were required to file writs seeking compensation by December 10, 2003 since the timber was harvested in BC First Nations traditional lands.

GULL BAY HOUSING

The Gull Bay Council declared an emergency situation since 50 out of 100 homes have mould problems and are unfit for habitation.

The National Chief responded by stating that *AF* used the numbers in the Auditor General's report for the housing component of **The Getting Results** agenda presented to the House of Commons Finance Committee. Many Chiefs stated that the *AFN* had underestimated the finances required to address sub-standard housing in First Nations communities.

National Chief Phil Fontaine assured the Chiefs that the Paul Martin Government will prioritize housing and is committed to provide housing dollars.

AFN RENEWAL PROCESS

Joe Miskokomon and Wendy Grant will be the co-chairs for the *AFN* renewal process.

OTHER AFN MATTERS

There was a presentation on indigenous languages, the privacy protection authorization form for the health consent initiative, the firearms legislation, USA military recruitment of Native People and health care as a treaty right.

INTERNATIONAL HUMAN RIGHTS DAY

A special summit will take place on January 12, 2004 in Mexico to discuss social and economic issues with world leaders. There will be an indigenous summit in 2005 in Argentina.

AFN GENDER EQUITY OFFICE

National Chief Phil Fontaine announced that the Gender Equality Office and the Women's Secretariat will be reinstated at the *AFN*.

AFN CHIEF EXECUTIVE OFFICER

Effective January 13, 2004, the *AFN* Executive Officer will be Richard Jock from Akwesasne.

ABORIGINAL ACCESS TO FISH AND WILDLIFE AND NATURAL RESOURCES

The legislature in New Brunswick has introduced a Bill entitled “*An Act to Amend the Fish and Wildlife Act*”

This Bill will amend the *Fish and Wildlife Act* to give authority under the *Act*, for the Minister to issue or cause to be issued licenses or enter into agreements to accommodate an Aboriginal or Treaty right to enter upon Crown land to harvest fish and wildlife. In order to have an orderly and managed approach to a sustainable fish and wildlife population, it is necessary for the Minister to have authority to work together with all users of those resources. The *Act*, does not currently contain sufficient authority for the Minister to issue or cause to be issued licenses or to enter into agreements to accommodate an Aboriginal or Treaty Right to harvest fish and wildlife.

The Province of New Brunswick also intends to amend the Forest Act and the Crown Lands Act.

Regional Chief Len Tomah is having meetings with the New Brunswick Provincial Minister responsible for Natural Resources. Len Tomah reported that some of the First Nations hunting camps were burned down due to racism and the stand taken by New Brunswick Natives in exercising aboriginal rights,

The province of Alberta has also introduced similar legislation. We expect that other provinces will consider enacting similar legislation. This places the provincial Ministers in a position of control and conflict with the exercise of Aboriginal rights to hunt fish and gather.

The AFN will be watching this process closely since it impacts on Aboriginal Rights.

The C	Request	Amount (\$millions)	Proposed Additional Resources for Fiscal Year 2004/05
Restoring Nations	Expediting Land Claims	\$300	These are the required resources to reduce the backlog of claims by about 25% over the next three years. It is assumed that the average cost of settling a land claim is \$10 million. The current average cost is about \$7 million.
	Building Land Management Capacity	\$200	These are the resources required to build a comprehensive land and resource management system over the next two years in 200 First Nation communities based on broad estimates by members of Lands Advisory Board.
	Economic Infrastructure	\$200	The federal government has estimated it will cost \$800 million to bring water and sewer systems up to standard. They committed \$600 this year.
	Economic Partnership Development	\$100	The federal government committed over \$4 billion to new economy initiatives in 2000 and 2001 but did not include a First Nation component. This is the estimated cost of that First Nation component adjusting for inflation.
	Jobs and Youth Strategy	\$20	This is the cost to bring the programming costs for Unemployed First Nation youth up to the levels of unemployed Canadian youths.
	Restoring Language and Culture	\$60	The Chiefs Committee on Languages received a commitment for a \$500 million languages foundation in 2002. This was not implemented. This is the cost over the next ten years, a commitment in current dollars.
	Revenue Sharing	\$15	These are the costs for 8 First Nation-provincial-federal negotiations on costs in the Yukon, BC and Saskatchewan
	Total	\$895	
Expanding Resources for First Nation Government	Renew and Strengthen the AFN	\$15	These are the costs to restore the AFN to its 2000 funding levels. Detailed proposals are available.
	Creating Options for First Nation Government	\$50	These are the costs for 50 negotiation processes for First Nation jurisdictions based on the costs associated with self-government and treaty processes.
	Housing	\$200	This is the cost for each of the next three years to build an additional 3000 homes and renovate an additional 3000 homes.
	Child Welfare and Social	\$20	The federal government has committed an additional \$80 million in the next year to enhanced social services. It was estimated in the 2001 AFN PBS that enhanced social service programs would cost \$100 million. This is the additional \$20 million to enhance these programs.
	Education	\$500	It will cost an additional \$400 million to reduce the backlog of First Nation post secondary student and an additional \$100 million to build 20 schools.
	Justice	\$20	It is estimated that it will cost \$5 million to develop a national First Nation justice strategy based on the Aboriginal Justice Inquiry in Manitoba. It was estimated in 2002 by the AFN that between 12 and 15 million was needed to enhance First Nation policing.
	Health	\$30	This is the cost to equalize health expenditures for on-reserve population to the 2001 increases in the CHST. \$1.4 billion in new First Nation health care spending was committed in 2003.



Health Related Contribution Policy/Guidelines

PURPOSE

a Mohawks of the Bay of Quinte Health Related Contribution Service is a path of last resort that may provide assistance to qualified low-income community members and/or families of Tyendinaga Mohawk Territory who have no other financial means to support essential health related matters. Program funding is at a fixed amount and will offer assistance until the funds are exhausted for the current fiscal year.

APPLICATION PROCESS

a The application process is to determine eligibility of a community member and/or families to receive full or partial financial assistance for essential health related matters, and will consist of an intake by a designated worker of the Mohawks of the Bay of Quinte. All intakes will be placed in written format with all pertinent information attached. (Application Form, Appendix "A")

b All intakes will receive written notice of their eligibility or ineligibility upon review by the Mohawks of the Bay of Quinte Council or their designate

CRITERIA

a Must be a registered Band member of the Mohawks of the Bay of Quinte First Nation

b The Health related matter must be deemed essential to

- i one's life sustainability
- ii one's maintaining activities of daily living abilities
- iii and in no manner for cosmetic reasons

ELIGIBILITY

a You may be eligible for the Mohawks of the Bay of Quinte Health Related Contribution Service if

- i. Your household income is below the established income funding formula.
- ii Demonstrate through documentation that you have exhausted all other possible financial resources, i.e. family members, Non-Insured-Health-Benefits (NIHB) and their appeal process, and no other Health coverage through your employment or other Health/Social Assistance program
- iii. Your claim includes, however, not limited to: essential dental cutbacks, essential prescription drugs, essential medical testing, life sustaining treatments, and other as deemed eligible by the designated worker and the Mohawks of the Bay of Quinte Council

- Depend on contractors advice – expect good road at end of day
- Chief – letter re: "substandard road (Wymans Road)
- Granular A quantities increased
- Frank – some projects were maintenance, others reconstruction
- Brian – cannot warranty beneath the road, only materials on the road as temporary patch
- Upper Slash – warranty that road will stand up under normal wear and tear (12 month warranty from date of completion of the road)

School bus worse vehicle on the road today – single access loading – good to gage conditions of road by

- Because of errors in calculating quantities – what impact Upper Slash and Norway's – tendered for \$577,000
\$760,000 projected cost now
\$137,000 extra gravel

Upsize culverts (costs)

- \$753,000 costs to date – still need to do surface treatment
69 cents per square meter (30,000sq. meters)
30 cents because of the quantity
impact of estimate errors amount to about 10%
4 kilometers of road – 7 meters each side
Contingency allowance – already used up with over runs
Peter – internal contingency, hydro relocates used up some of the over run too
- Council needs to know bottom line – authority to pay from Casino budgets
- Upper Slash and Norway reconstruction, other – just surface treatment

Frank – may enter into separate negotiations with the subcontractors – because the quotes were higher due to the time of year – since delayed to next year – costs may not be higher
- Chief – not satisfied with quality of work on Lower Slash Road – very very dusty. Is it finished product? Yes, only single surface treatment was called for
High float emulsion – just chip – ½ cost of surface treatment
Takes a little longer for "float" to go away – needs to go through a season (summer heat) and will look like asphalt
Frank – could have problems with pot holes on Beach Road

- Heavy rain after pulverizing – let it dry and it tightened up
Chief apologized for late payments – needed clarification before he signed
- Frank – will make recommendation with respect to hold back
Need certification that road is up to standard. Wants separate billing/ break quantities down to know what was applied – for warranty reasons
- Little work remains – need to wait for hydro relocates to be done
- 85-90% done now
If roads frost heave during winter/spring, will that be extra costs? Frank said he would deal with any sub grade issues
- On paving – contractor will finish next year
- Partially paved shoulders were previously discussed to allow for cyclists on York Road. Frank said "No", just for the Upper Slash Road only?
By Scott Maracle's house on York before Wards gas station, where Jewel did the ditching – 12 foot drop. Will there be guard rails? Liability issue
Guard rails single 16 linear meter – rail ends \$800 each
Steel beam in front of the house on York – pipe and catch basins put in – very deep there
- West side between Glendon's and Wards – needs guard rails
Frank – met engineering standards
Cost over run on seeding and mulching
10 year use – warranty/normal use
- 85-90% done – finish spring
- \$200,000 spent to date
- Frank – wouldn't suggest money to be spent on maintenance work – rather use on reconstruction when funds are available in the future
- Mowbray's - will perform well with what has been done
- Suggestion that CN – recovery of costs to seal pick-up track – closing a rail crossing
- Chief requested Peter looks into who we contact about cost recovery from CN for construction of cul-de-sac
- Frank – need to set date to discuss Ridge Road. Concern that we have time to do property work. Then won't be delayed again
- 20-23 poles hydro may be effected
- Frank – request to lands department for list of all properties we're dealing with. Still waiting for that information
- Chief – make note of where wet spots are – places where ditch is higher than the road

Truths About Domestic Abuse

Community United Against Violence

"He promised he wouldn't do it again. A few months later, there was another explosion and then again a few weeks after that".

DOMESTIC VIOLENCE IS A SERIOUS PROBLEM IN THE GAY/BISEXUAL COMMUNITY.

Domestic abuse occurs in male-male relationships with as much frequency and severity as it does among heterosexuals. Experts believe that severe violence occurs in 15-20 percent of relationships. It may begin in forms difficult to recognize, such as emotional and verbal attacks. It tends to escalate gradually into physical violence that can be life threatening.

DOMESTIC VIOLENCE IN MALE RELATIONSHIPS IS NOT MUTUAL.

It is not simply a "lovers quarrel" or a "fight". Domestic violence involves one man using intimidation and force against his partner. While the victim may defend himself, this does not mean the violence is mutual.

MEN WHO STAY IN ABUSIVE RELATIONSHIPS DO NOT ENJOY VIOLENCE.

Leaving is not simple. Some men are too frightened by their lover's threats to attempt it. Others stay because they hope the abuse will stop. Many men would leave but do not have access to resources or information.

ABUSE CAN BE FOUND IN ALL SEGMENTS OF THE COMMUNITY.

No group, regardless of race, class, gender, sexual identity, age, political stance, or lifestyle, is free from domestic violence. Do not be mistaken: people from any social group can batter or be battered.

VIOLENT BEHAVIOR IS INEXCUSABLE.

Using violence is a choice - there are always alternatives. Substance abuse, stress, illness, and childhood abuse are often used to excuse violent behavior. A batterer, however, is responsible for his violent behavior. He can choose to walk away or seek treatment.

"If a stranger had assaulted me, I would have run, fought back, or called the police. But this was my lover. It wasn't the same. I didn't know what to do or who to tell".

The abusive behaviours depicted in the wheel can be present in ANY intimate relationship, and in both heterosexual and gay and lesbian couples. But lesbian and gay partners are in

DOUBLE JEOPARDY



Using Isolation

- controlling what you do, who you see and talk to, where you go, limiting your outside involvement
- using jealousy to justify actions
- sabotaging new relationships
- not allowing you to be involved in gay/lesbian community
- using social marginalization and invisibility of gays and lesbians to increase your isolation
- benefitting from lack of safe places to be 'out'

MYTHS ABOUT LESBIAN AND GAY DOMESTIC VIOLENCE

- Only heterosexual women get battered. Men are never victims of domestic violence and women do not abuse.
- Domestic violence is more common in heterosexual relationships than it is in lesbian or gay male relationships.
- It isn't really violence when a same-sex couple fights. It is just a lover's quarrel and a fair fight between equals.
- It isn't really violence at all when gay men fight is just boys being boys.
- The batterer will always be hunch, bigger and stronger. The victim will always be femme, smaller and weaker.
- People who are abusive under the influence of drugs or alcohol are not responsible for their actions.
- Gay men's domestic violence has increased as a result of alcoholism, drug abuse and the AIDS epidemic.
- Lesbian and gay domestic violence is sexual behavior, a version of sadomasochism. The victims actually like it.
- The law does not and will not protect victims of lesbian and gay men's domestic violence.
- Lesbian and gay male victims exaggerate the violence that happens to them. If it were real that bad, they could and would just leave.
- It is easier for lesbian or gay victims of domestic violence to leave the abuser than it is for heterosexual battered women.
- Domestic violence primarily occurs among gay men and lesbians who hang out at bars, are poor or are people of color.
- Victims often provoke the violence done to them. They are getting what they deserve.
- Lesbian or gay male victims of domestic violence are co-dependent.

IS LESBIAN BATTERING THE SAME AS STRAIGHT BATTERING?

Similarities:

- No one deserves to be abused.
- Abuse can be physical, sexual, verbal behavior to coerce or humiliate, emotional or psychological.
- Abuse often occurs in a cyclic fashion.
- Abuse can be lethal.
- The purpose of the abuse is to maintain control and power over one's partner.
- The abused feels also, isolated, afraid and usually convinced that the abuse was somehow her fault or could have been avoided if only she had known what to do.

Differences:

- Lesbians who have been abused have much more difficulty in finding appropriate support than straight women.
- The myth prevails that lesbian abuse must be "mutual." No one assumes straight abuse is mutual.
- Utilizing existing services is tantamount to 'coming out' and a major decision.
- Support services and friends often minimize lesbian violence for several reasons--because the lesbian community doesn't want to destroy the myth of a 'lesbian utopia,' because the battered women's movement doesn't want to destroy their myth of 'all violence is caused by men,' because it is easy to fall into the trap of assuming that the size of a person has anything to do with with battering.
- To complain about lesbian abuse is to reinforce the stereotype that lesbians are 'sick.' No one would claim straight relationships in general are mentally because there is sometimes abuse.
- Lesbians have to face not only the sexist culture, but also a homophobic one as well. A woman of color must face sexism, homophobia, AND racism.
- Lesbian survivors may know few or no other lesbians; leaving the abuser could mean total isolation.
- Lesbians usually aren't as tied financially to their partners as are straight women.
- The lesbian community is small, and in all likelihood everyone the survivor knows will soon know of her abuse.

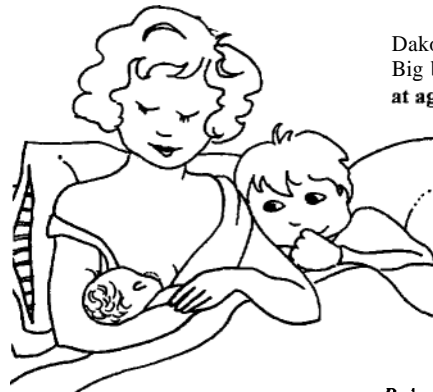

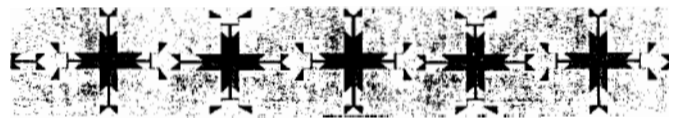

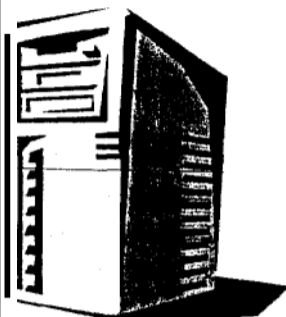

I've Got Two Homes an' I Ain't Ashamed

Christmas is over! The holidays ... over! In spite of it being the first month of the year, a supposed time of renewal filled with resolutions galore, January for me has always been an eventless month.

It is like the extra few minutes you take between turning off the alarm and actually getting out of bed; like the commercials that come on when one TV show has ended and before another begins; that moment when you have to wait for all the cars ahead of you to go – GO!! – after the light has turned green.

It's an in-between time. Christmas, and all the hype surrounding it, has ended. The same people who you so sincerely and wistfully wished happy holidays on that last day of work return to being the Same ol' fools you've always known and, much of the time, can't stand. Only now all of us are wearing clothes that have been washed only once and match virtually nothing else in any of our closets.

In January we fall back into our routine, relax like we promised ourselves we'd do during the holidays and really think about the year ahead. And the one that's passed. (More specific reflections on my visit home next month ... stay tuned!)

Living away from home forces me to often think about what "home" really means. For me, it exists on two levels. Tyendinaga, of course, is capital-h Home. It's where the comfort level spans further than the building where I eat and sleep. It's where I feel, at least, as though I should know everyone around me, where I become shocked to learn Mom orders pizza somewhere other than where she did twenty years ago, and not at all surprised when we pull in to the Same ol' gas station (in spite of the plethora).

Because visits are so short, no matter how lengthy they are, there is always a rush, an urgency to see this cousin and that friend. Inevitably I don't get around to everyone or spend as much time with my mom, brother and grandparents as I'd like. Home, for me, is therefore inherently a place where I relax very little.

That, and Nashville, is the second level of my 'home' definition. One of the great feelings when returning to home – the small-h one, where you sleep, eat and become bored with the routine – is that first sigh and release, the breather of relaxation as soon as I walk through the door. It happens again, the sigh and the breather, when I take off my shoes. And again when I turn on the TV. Later again, when I climb into my own personal comfortable-in-its-own-way bed.

It's that comfort of expectation that makes the small-h home so welcoming. As much as our memories serve us when we are away, Tyendinaga – and everywhere – is always changing, and the people who live there, of course, change right along with it.

By the way, I'm sure by now you've all been to that truck stop outside Napanee. That, to me, is the most heartbreaking, Americanized, turning-me-into-an-anti-NAFTA-radical vision I've seen this side of Canadian Wal-Mart. Even though the big buffet is great (considering what you're paying and, really, what you're expecting), I nearly fell apart when, during my recent visit, I saw white gravy.

Yes, WHITE GRAVY. We don't do white gravy. Or biscuits, though they are good, too. As well I saw big potato wedges (the very reason American KFC sucks) instead of good old fashioned french fries and, gawd help us, no cheese curds – or cheese anything – to make poutine. Just how sad is that?

...perhaps I've digressed a little.

While I am away from home, dividing capital-h qualities of Home with small-h comfort of Nashville, I've found it difficult to plant myself here. I know I'll someday move home, or at least to Canada, and I've seen how difficult it is to share a life with someone who is not from your land.

My parents were lucky in that Christmas Day could easily divide in half. We spent half the day with Mom's family and the rest, just a mile or two down the road, with Dad's. As a young boy I watched as my aunts, uncles and cousins, whose extended families did not live literally two miles apart, spend either one year here and the next there, or only a day here then move on to the next town. It was, in retrospect, an incredible luxury for me, one that I took for granted.

It is hard for me to face the undeniable truth that my future will not be the way my past was. With spouse and children of my own, I will fully understand just how much I took the luxury of community for granted. My seemingly-eternal singledom stands as witness to the fact that I'm avoiding it.

Shortly after Christmas this year, Jodi and I went to Kingston and, during that drive, we found ourselves lost in conversation regarding this very topic. (You know who Jodi is: short, brown-haired Mohawk girl from Shannonville? If you don't know how I'm talking about ... she is my age, grew up on Tyendinaga as well, and moved away too. Now she's returned home.)

Home and the need to plant your seed in your own garden are important to many of us. I think a common misconception about people who've grown up on the rez and moved away is that we've left and intend to never return. Certainly that must be true for many people – and I can name a few people myself – but it doesn't accurately describe all of us.

Many times we may forget that growing up on a reserve – (say this in a big authoritative voice) 'Traditional lands of the Native peoples' – for all of us is just, simply, home. And for many people, be they white or Asian or Jewish, it's okay to leave home. Many of them, because they are no different than us, eventually find themselves back home too.


MBQ Electoral Officer Kelly Maracle tells me that, for this past election, a total of 511 people who do not reside at Tyendinaga voted. Think about the size of our band membership. Five hundred eleven isn't all that many people (neither is the almost 800 or so who voted and live on Tyendinaga, but that's another story).

Of course I don't know who these 511 people are – 510 of them, anyway – but I feel comfortable saying they must be interested in the future of their community, and hopefully, like me, they may very well be creating a small investment – by means of that one vote – in their own future ... one that finds them someday back home again.

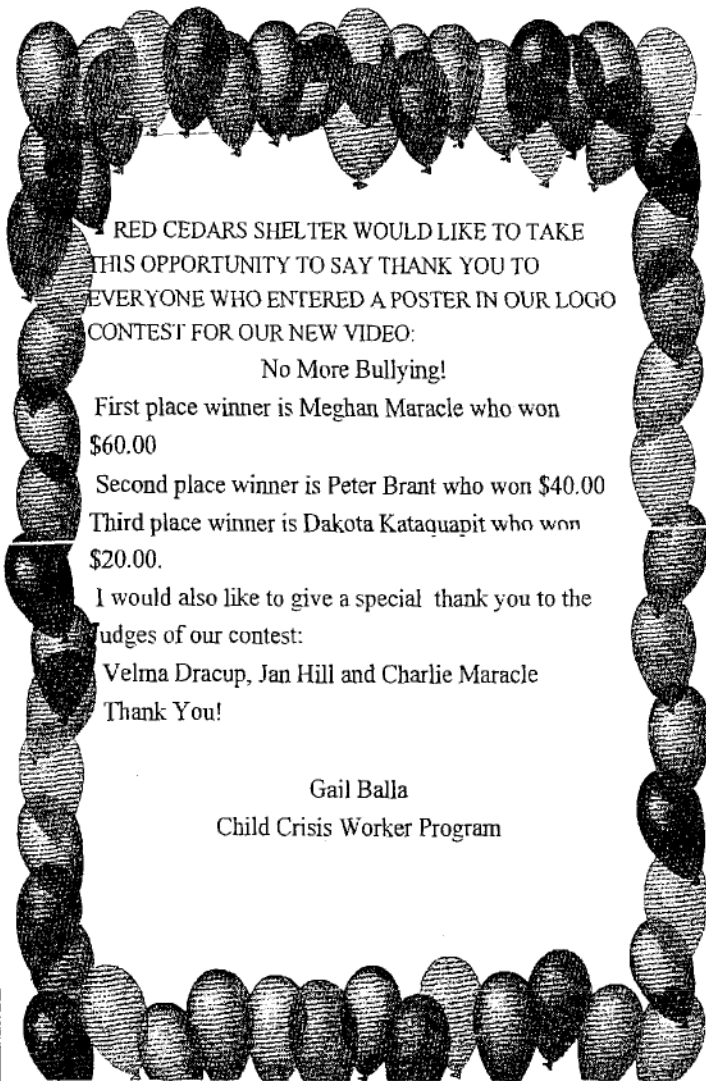

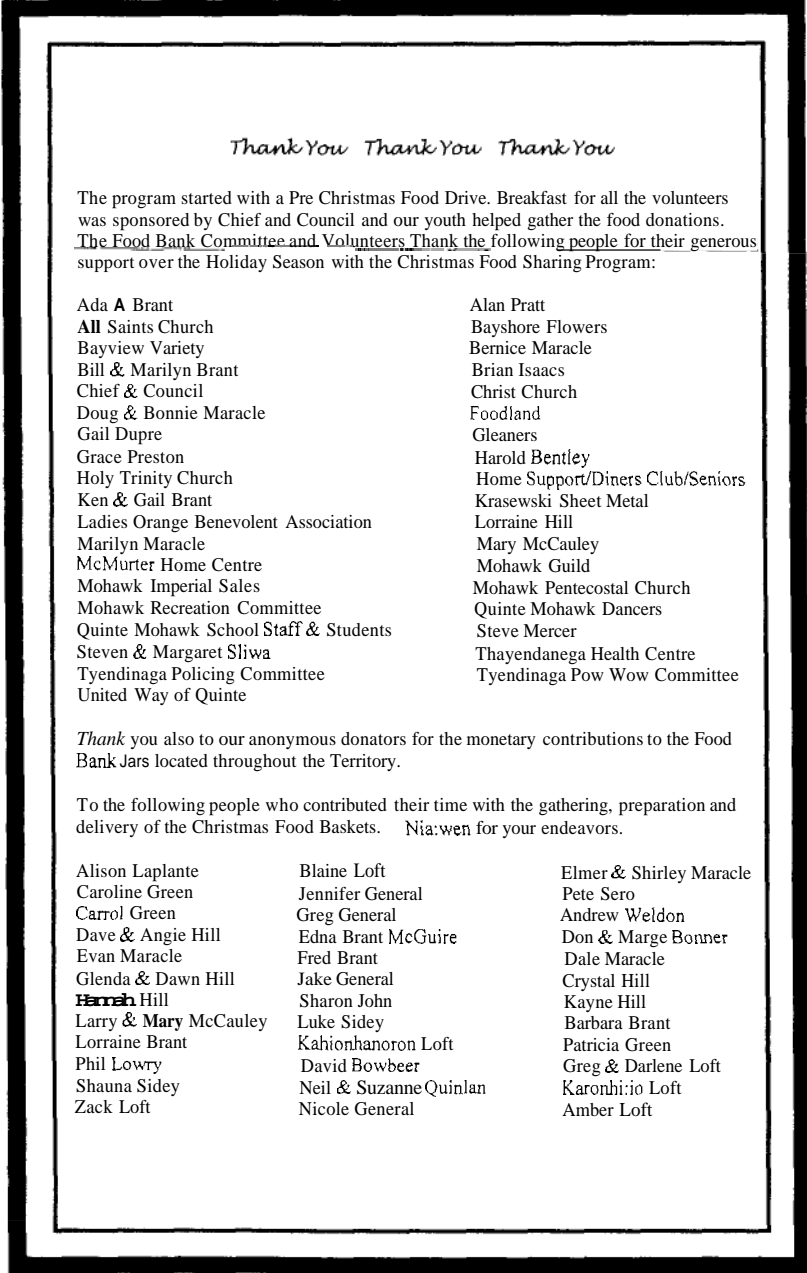

Winter sports safety

Make sure your children are safe when they toboggan and skate.

Children can strangle on a cord or scarf.
Use a neck warmer instead of a scarf.

Take the cords and drawstrings off their clothes.

Safety Tips



Keep children warm. Dress your children in layers.
Make sure their heads and necks are covered by a hat and a neck warmer. Watch for frostbite!

On sunny days, put sunscreen on their skin.

Check your children's equipment to make sure that it fits and is in good condition.

When tobogganing or sledding:

Make sure your children wear a helmet

Choose a hill that is away from roads and parking lots.
There should be no rocks, trees, fences or other dangers in the path.

Teach your children to slide down the middle of the hill, climb up the side and watch up the hill.

Teach them to move out of the way quickly when they get to the bottom.

When skating:

Children should wear a helmet

If you skate on lakes or rivers make sure the ice is smooth and at least 10 centimetres or 4 inches thick.
Never skate near open water.

Children should skate in the same direction and at the same speed as the crowd.

Skaters who cannot keep up with the crowd should move to the side.

When playing hockey, only wear a CSA certified helmet. Replace hockey helmets at least every 5 years.

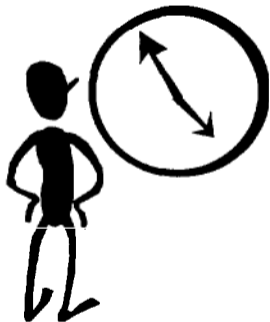

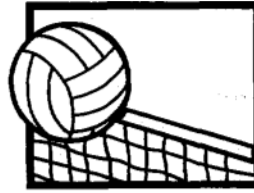

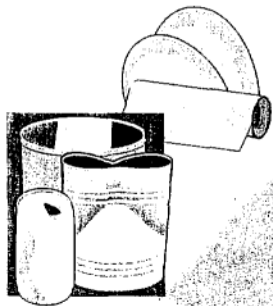
RECYCLING



A Recycling Reminder

Hang this on your wall!

Bring these items to your depot



Metal Cans & Foil

Rinse cans. Place lids in a can, pinch closed and put loose in blue bin. **Do not put aluminum cans inside tin ones.** Include clean aluminum foil and pie plates. *Flattened cans save space!* **No** pots, cigarette or butter wrappers or scrap metal. Avoid putting pop cans inside other cans.



Empty Aerosol and Paint Cans

Make sure metal containers are empty. Take **lids off** the paint cans to let them dry, and place in the blue bin — *don't bag them.* **No** containers with product. paint cans larger than 4 litres (1 gallon), plastic paint cans, propane cylinders or other hazardous waste.



Plastic Containers

Discard tops and rinse containers for soft drinks, detergents, juice, bleach, shampoo, dairy products as well as clear and foam plastic cups, trays and packaging. Flatten soft drink containers and replace lids. All plastics with the numbers 1 to 6 on the bottom are OK. **No** blister or bubblepacks, prescription bottles or toys.



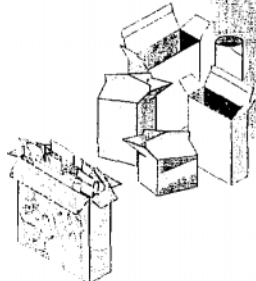
Bottles & Jars

Remove and rinse caps and lids. Metal lids can be recycled with cans. Leave loose in the blue bin. *Don't bag them.* **No** other types of glass such as kitchenware, ceramics, dishes, drinking glasses, window glass, light bulbs or mirrors.

Place in appropriately labelled bins.

Boxboard and Mixed Paper

Bundle junk mail and office paper separately from Boxboard. Flatten and stuff **boxboard** into a large box. **Boxboard** includes cereal boxes as well as milk and shoe and detergent boxes, juice cartons, paper bags, sugar & flour bags, cardboard tubes, books (hardcover & paperback), egg cartons and other clean paper packaging. **No** drink boxes, tissue, paper towel or laminated paper. Do not put paper loose in blue bin.



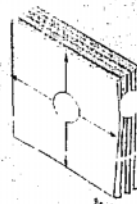
Plastic Bags

Stuff clean, dry plastic bags into a plastic bag and tie handles. Include rinsed milk pouches, grocery, bread, dry cleaning, frozen vegetable and blue newspaper bags as well as outer wrapper from toilet and hand tissues. Remove food residue, stickers and receipts. **No** meat, cheese or stretch wrap, cereal box liners or chip bags.



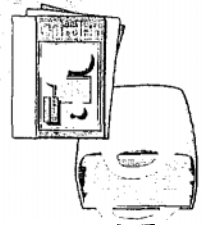
Corrugated Cardboard

Flatten and bundle corrugated cardboard boxes into a maximum size of 30" x 30" x 8" bundles. **Only** broken down and bundled boxes will be collected. **No** waxed boxes, soiled pizza boxes.



Newspapers & Magazines

Place newspapers, inserts, phone books, magazines and catalogues in a plastic bag next to your blue bin. **No** soiled newspapers. Keep boxboard and mixed paper separate, not mixed with newspaper and magazines.
