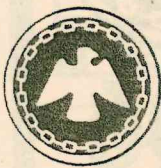

I trust that everyone had a nice Christmas holiday with your relatives and friends and I would like to take this opportunity to wish you all good health, happiness and prosperity in 2006!

#### RESIDENTIAL SCHOOL SETTLEMENT

On November 20, 2005, an Agreement in Principle was reached between the Federal Representatives, the Honourable Frank Iacobucci, and legal counsel for former students, legal counsels for the Churches, the Assembly of First Nations and other Aboriginal organizations. Subject to court approval, the Agreement in Principle proposes a number of elements expected to form the basis of a final settlement package.

##### Common Experience Payment

The agreement in Principle recognizes what was far too often the negative experience for former students of Indian residential schools, and proposes that a Common Experience Payment be made to former students. This Common Experience Payment is a symbol of the Government's desire to heal and repair the relationships damaged by the Indian residential school system.

- Upon application, the Common Experience Payment would be paid to every eligible former Indian residential school student living on May 30, 2005;
- Subject to verification, each eligible former student who applies would receive \$10,000.00 as well as an additional \$3,000.00 for each year of attendance in excess of the first year;
- Eligible former Indian residential school students 65 years of age and older will be able to apply for an advance payment of \$8,000.00;
- Acceptance of the Common Experience Payment would release the Government of Canada and the Churches of all further liability relating to the Indian residential school experience except in cases of sexual abuse and the most serious incidents of physical abuse. Those

claims would be dealt with through a mandatory revised alternative dispute resolution process;

- \$1.9 Billion has been set aside for the direct benefit of former Indian residential school students

##### Independent Assessment Process

An Improved ADR Process call the "Independent Assessment Process" (IAP) will address sexual abuse claims and the most serious incidents of physical abuse.

- Should the Common Experience Payment be accepted by a former student, the new IAP process will become the exclusive vehicle by which that student could pursue a further claim for sexual or serious physical abuse.
- Compensation through the IAP Process would be paid at 100% by the Government in all cases following validation by an independent adjudicator.

##### Truth and Reconciliation

- \$60 Million would be allocated toward the creation of a Truth and Reconciliation process
- The Truth and Reconciliation process is intended to promote public education and awareness about the Indian residential school system and its impacts on the human dignity of former students, as well as provide former students and their family members with an opportunity to share their Indian residential school experiences in a safe and culturally-appropriate environment.

##### Commemoration

- An additional \$10 Million would be invested in the existing Commemoration program.
- The Government will continue funding the commemoration initiatives, events, projects and memorials on a national and community level.

##### Healing

- The Aboriginal Healing Foundation would receive an additional endowment of \$125 Million
- Evaluation of the healing initiatives and programs would be undertaken by the Aboriginal Healing Foundation in the fourth year following court approval, to recommend whether and to what extent funding support should continue.



ADMINISTRATION

- The Church entities involved in the administration of Indian residential schools would make very significant contributions toward healing initiatives.

**ONTARIO HEALTH PREMIUM – RESPONSE FROM THE MINISTER OF FINANCE**

On November 9, 2005 Grand Chief Chris McCormick of the Association of Iroquois and Allied Indians (AIAI) and I met Ministry of Finance officials Sean Mullen, Diana Wright and Simone Boxen regarding the Ontario Health Premium (OHP). The purpose of the meeting was to relay concerns to the Minister that the Ontario Health Premiums should be paid for by the Federal government as done so in the Provinces of British Columbia and Alberta. As a follow-up to that meeting I am providing a copy of the response from Dwight Duncan, Minister of Finance for your perusal.

**ENVIRONMENTAL CONTAMINANTS RESEARCH PROGRAM 2005/2006 – MBQ ENVIRONMENTAL STUDY ON THE RICHMOND LANDFILL SITE**

I am pleased to report the proposal submitted to the 2005/2006 Ontario Regional Environmental Contaminants Program by our Technical Department was approved for funding in the amount of \$119,000.00 to conduct further research into the potential trans-boundary issues surrounding the proposed expansion of the Richmond Landfill Site.

I am providing a copy of the approval letter from Paul Strohack, Regional Environmental Health Manager of Health Canada for your perusal.


**Memorandum**

RE: Ontario Health Premium - Response from Minister of Finance

In follow-up to a meeting held on November 9, 2005 between the Ministry of Finance representatives, Chief R. Donald Maracle and myself we have received the attached response from the Minister of Finance. The purpose of the November 9, 2005 meeting was to further relay our concerns that the Ontario Health Premiums should be paid for by the federal government as done so in the provinces of British Columbia and Alberta.

You will notice in the final paragraph of the attached letter that the Minister of Finance has stated that they are willing to participate in discussions with AIAI and the federal government to see if there is a way that Status Indians in Ontario can have their Health Premiums paid for by the federal government.

I believe we need to research specifically what health services are covered by the Health Premiums in the provinces in Alberta and British Columbia. Once we have our information documented we will be seeking a joint meeting with the federal and provincial representatives. We would be interested in receiving any comments or suggestions that you may have on this matter.

Dear Chiefs McCormick and Maracle:

I am writing as a follow-up to the meeting you had with Sean Mullin, Diana Wright and Simone Boxen on November 9, 2005, regarding your concerns about the Ontario Health Premium (OHP).

Liability for the OHP is created through the provincial *Income Tax Act*, and is based on residency in Ontario and having a taxable income greater than \$20,000. Since the OHP is based on taxable income, income that is exempt from taxation is also exempt from the OHP. Status Indians with income that is greater than \$20,000 and not subject to an exemption would be liable for the OHP.

The Canada Revenue Agency administers the OHP on behalf of the Province under the terms of a Tax Collection Agreement between Ontario and the federal government. The OHP is deducted from pay and pensions of those with taxable earnings or pension income of \$20,000 or more a year, as part of federal and Ontario income tax. The amount deducted, like all payroll deductions, is a best estimate of OHP payable on the income.

While neither pay stubs nor T4s break out the OHP separately, general tax returns include a separate section for taxpayers to calculate OHP for the tax year, based on their taxable income. When employees file their tax returns, their total income tax deducted for the year (including the OHP) is reconciled against their total income tax payable for the year. This determines whether they would get a refund or have a balance owing.



## ADMINISTRATION

The OHP is different in administration and application from the premiums charged in Alberta and British Columbia. In those provinces, all individuals (subject to certain exemptions) who are eligible for coverage under provincial health insurance are liable to pay health premiums. In Alberta, the health premium is administered by the Ministry of Health and Wellness, and in B.C., the Ministry of Small Business and Revenue administers premium billing through Revenue Services of British Columbia.


Liability for the OHP is not connected to eligibility for coverage under the Ontario Health Insurance Plan (OHIP). As a result, no resident would be denied access to Ontario's publicly funded health care services for failing to pay the OHP. Instead, the penalties set out in the Ontario *Income Tax Act* for non-payment of tax would apply to individuals who do not meet their liability to pay the OHP. The OHP is a tax, because liability is not connected to eligibility for health care, and the OHP amounts are unrelated to the cost of receiving health services.

OHIP coverage normally becomes effective three months after the date an individual establishes residency in Ontario. In contrast, liability for provincial income tax depends on being a resident on December 31 of the taxation year. Therefore, liability for the OHP and OHIP coverage do not necessarily coincide.

Although the revenue collected through the OHP goes into the Consolidated Revenue Fund, the government has committed to report publicly where the revenue generated by the OHP is spent. In 2004-05, the OHP raised \$1.7 billion, representing 5.5 per cent of total expenditures in the Ministry of Health and Long-Term Care (MOHLTC). The Public Accounts of Ontario for 2004-05 includes a section detailing the specific health care services that are notionally funded by the OHP, and compares OHP revenue to the increase in MOHLTC operating expenses.

As you indicated, the federal government has refused to pay the OHP for Status Indians. If you decide to engage the federal government in discussions about developing an arrangement whereby the federal government pays the OHP of Status Indians in Ontario, the Ontario Ministry of Finance would be happy to participate in those discussions.

RE: **Bill 36**  
**Local Health System Integration Act, 2005**

Bill 36 was tabled for first reading in the Legislative Assembly on November 24. The Bill is expected to go to Committee after second reading, but it is not known how extensive the Committee process will be, including the possibility of hearings outside of Toronto.

Among other things, Bill 36 sanctions fourteen (14) Local Health Integration Networks (LHINs), with the objective of better managing health care for the residents of the Province. The delegation of authority to the LHINs is subject to the ultimate authority of the Minister of Health and Long-Term Care. First Nations do not have any quarrel in principle with the effort by the Province to re-organize its health care resources. However, First Nations are very concerned that the LHINs legislation will inadvertently undermine existing and future First Nation health care programs and services. Some of these programs and services are funded wholly by the provincial government, and others are funded in whole or in part by the federal government.

In spite of the government-to-government relationship that should apply in dealings between First Nations and the Province, First Nations were not consulted in the development of the legislation. However, at a very late stage, the Ministry of Health did support a First Nations Task Force on LHINs, which is scheduled to report to the government shortly. It is unfortunate that the government did not heed the request to delay the tabling of the legislation until official input from First Nations could be received.


Given this history, it is not surprising that Bill 36 all but ignores First Nations. There is a brief mention of the "role of First Nations" in paragraph (e) of the recitals, right after the French community paragraph. However, there is nothing in the body of the Bill that acknowledges or protects First Nation programs and services. Similar legislation in other provinces is superior in terms of recognizing First Nations.

The current version of the Bill puts First Nation health programs and services at risk. The devoted resources attached to such programs and services may be transferred to LHINs. First Nations are not represented on LHINs and they are not obliged to take First Nation rights and interests into account.

Shortly after the tabling of the Bill, First Nations sent a letter to Health Minister Smitherman recommending two amendments to the Bill. One would exempt existing and future First Nation health programs and services from the scope of LHINs. The other would declare that the legislation cannot prejudice First Nation rights in the health care sector. These two amendments constitute a minimum protective package for First Nations. It is likely that further amendments will be proposed before Committee. The Minister has yet to react to the proposed amendments.

Your support for the First Nation position in this matter would be very much appreciated, including support for specific First Nation amendments to Bill 36. These amendments are meant to protect First Nation rights and interests, and are not intended to otherwise affect the LHINs initiative.

# MEETING MINUTES

## TYENDINAGA MOHAWK COUNCIL MINUTES FEBRUARY 17, 2004

A meeting of the Tyendinaga Mohawk Council held on Tuesday, February 17, 2004 in the Council Chambers for Local Business continued as regular business.

Present: Chief R. Donald Maracle  
Councillors: Willard A. Hill, Blaine Loft and Roy C. Maracle. Velma Hill-Dracup was off recovering from back surgery.  
Staff: Steve Mercer, Chief Administrative Officer

Tyendinaga Concerned Citizens represented by William J. Brant attended Council to discuss Council's Involvement in Church Business.  
William J. & Marilyn Brant, Merle Maracle, Pat Brant, and mother, Wilma Maracle, Gail Clement, Helen Brant, Winston Brant and son, Glenn Hill, Wayne Maracle, Shelley Brant, Audrey Brant, Kurtis Maracle, Joan Brant, Keitha Barberstock, Marylynn St. Amand, Nathan Brinklow, June Morden, Pam Grass, Mildred Maracle and Janet Jung. Christine Claus, Lorna Moses, Dan Whalen, Lois Brant and Mike Brant were also in attendance.

Shelley Brant as spokesperson requested that R. Donald Maracle be declared in conflict of interest as he was a member of the other congregation.

Chief R. Donald Maracle stated that there was no conflict of interest since the Council approved by motion a co-sharing arrangement and that he had communicated this decision to Bishop Bruce in his capacity as Chief.

William J. Brant – we specially asked for this time period to put forward our concerns. Chief Maracle asked the Wardens of Christ Church, Wilma Maracle and Gail Clement, if it was their request to exclude the Anglican Catholics from the meeting with Council and the reply was yes.

MOTION #2: Moved by Roy C. Maracle, seconded by Blaine Loft to respect the wishes of the Tyendinaga Concerned Citizens Group for a closed meeting to discuss their issues.  
Carried.

Chief Maracle asked that it be recorded that the motion is out of order because we are dealing with the use of public property and it is a public matter. No one should be expelled from Council because of their perceived religions.

MOTION #3: Moved by Willard A. Hill, seconded by Roy C. Maracle that the other delegation get full-time afterwards to address Council.  
Carried.

Shelley Brant requested Chief Maracle be declared in conflict of interest due to membership in the congregation. She feels that the Chief has used his position to forward the interest of the congregation.

Bill Brant stated that motion was made by Council to allow this group to be heard in private and asked to respect this group.

The Chief asked Shelley Brant and Wardens Gail Clement and Wilma Maracle if they were asking the Anglican Catholics to leave the meeting. The reply from Shelley Brant and the wardens was yes.

Wanted to have a meeting with no interruption – Wilma Maracle and Gail Clement.

Chief Maracle advised the concerned citizens group and wardens that people who contributed to the Church were being requested to leave the Council meeting.

Chief Maracle as Chair declines motion being out of order, rights is compromised and it represented a human rights violation because members were asked to leave because of their perceived religion.

Chief Maracle left the meeting at 8:30 p.m.

June Morden commented that Bishops and Cardinal is head of the church – do not pay taxes anywhere in the world – no one can intercede in church affairs – the only ones who intercede are the Nazi Germany and Russia and the communists.

MOTION #4: Moved by Roy C. Maracle, seconded by Willard A. Hill that Blaine Loft be Chairperson.  
Carried.

Christine Claus was requested numerous times to leave the meeting, she refused.

A motion was moved by Roy C. Maracle that the police be notified if Christine Claus does not leave, no one seconded the motion.

Council left the room at 10:40 p.m. and returned at 11:20 p.m. Council had no alternative but to close the meeting.

The Church Wardens and the Concerned Citizens Group still wanted to meet with Council, but were concerned if it could be guaranteed to be private.

MOTION #5: Moved by Roy C. Maracle, seconded by Willard A. Hill that this meeting be adjourned. (11:45 p.m.)

- whether there are any hazardous substances or contaminants currently used by the utility on the lands;
- the removal of the hunting provision from the permit;
- changing the archaeological resources and human remains provisions and to specifically require the utility to move its installations at its own expense upon request by the Mohawks of the Bay of Quinte in the event that archaeological resources or human remains are discovered in the permit area;
- ensuring that the utility cannot assign its rights under the permit;
- changing the address for the Mohawks of the Bay of Quinte; and
- other provisions that Carla McGrath as legal counsel for the Mohawks of the Bay of Quinte believes are appropriate.

Carla McGrath will consult with legal counsel for Canada as is necessary to finalize the terms of the draft permits with Bell Canada, Hydro One Networks Inc. and Cogeco Cable.

Once the permit terms are fully developed, the draft permits with Bell Canada, Hydro One Networks Inc. and Cogeco Cable will be presented to the Tyendinaga Mohawk Council for final review and approval.

  - The expansion will enable Cogeco Cable Canada Inc. to provide services to additional members of the Mohawks of the Bay of Quinte; and
  - The expansion does not cause safety concerns.
- Cogeco Cable Canada Inc. must remove its installations at the end of the permit period;
- The minerals provision as it appears in Draft #4 of the s.28(2) permit is acceptable as drafted;
- Council would like the cancellation provision to remain in the permit; however, this provision may be eliminated in exchange for changes to other provisions in negotiating the final permit terms if necessary;
- the issues identified at the Council meeting held on November 17, 2005; and
- other provisions that Carla McGrath as legal counsel for the Mohawks of the Bay of Quinte believes are appropriate.

- Council would prefer that Hydro One Networks Inc. and/or the Ontario Electricity Financial Corporation provide a survey or detailed sketch of the lands currently used by them in order to define a limited permit area; however, should they be unwilling to provide such a survey or detailed sketch, Council approves the use of the footprint of the roadway used in the Highway No. 2 settlement with Ontario, dated for reference November 3, 2005, for the s.35 taking, as the permit area for the s.28(2) permit with Hydro One Networks Inc. and the Ontario Electricity Financial Corporation; and



### EXPIRY DATE ON STATUS CARDS

Our First Nation members have been inquiring why there is an "expiry date" on our status cards. I e-mailed Indian Affairs to inquire about the expiry dates.  
Here is their answer:

Our INAC policy is that the cards need to be renewed every 3 years for children under 18 yrs of age (because their appearances change quite a bit while growing up). For the adults the cards need to be renewed every 5 years as they also change, but not as quickly. These expiry dates are also implemented as they will be keeping in line with other government issued type of documents/cards such as health cards, drivers licenses, passports, etc. Plus once the new card comes into effect (we do not know when yet) these dates will be automatically system generated on the cards. This will help to ensure for INAC and First Nations that there are less fraudulent cards in circulation. My only advice would be to alert the First Nation members to renew their cards before the expiry date, so that they will not experience difficulties when travelling/shopping.

Thank you for voicing your concerns and I will certainly let our headquarters people know the dilemma the expiry date puts on First Nation members.

PLEASE CHECK THE EXPIRY DATE ON YOUR STATUS CARD AND RENEW BEFORE IT EXPIRES.

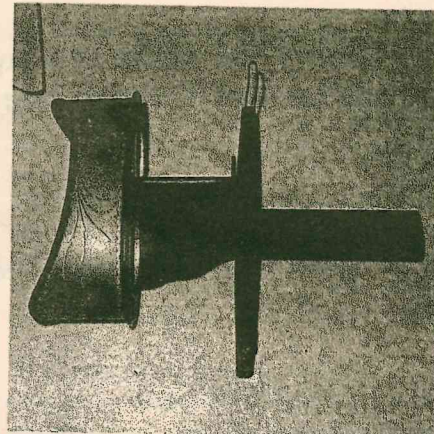

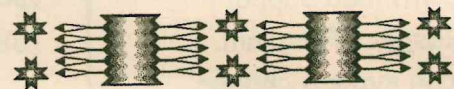


### Stereoscope

## Ohahase Education Centre Your Future Path to Success!!

### Secondary School Programs

#### Description

Ohahase Education Centre is operated by First Nations Technical Institute to provide programs for students seeking to achieve an Ontario Secondary School Diploma (O.S.S.D.). Ohahase means "new road" in the Mohawk Language and that is why we say it is "Your Future Path to Success"! Ohahase is a Private Secondary School that is inspected and licensed by the Ontario Ministry of Education. Each year our curriculum and guidelines are inspected and the Principal is granted a license to operate and grant credits. Ohahase currently offers two programs; a full-time day program for youth and an adult program of correspondence and night school.

#### Program Mission

#### Ohahase....

Is a centre for excellence, providing holistic and respectful learning rooted in Mohawk language and cultural practices; and

Will facilitate a multigenerational community that fosters belonging through encouragement, motivation and laughter – striving for the goals of self-sufficiency and biculturalism.

#### Learning Programs

##### Full-time Day Program for Youth

This program is a Private Secondary School program currently for grade nine and ten students. There is no tuition charge or fees for status Native students or community residents as the school is funded by Indian and Northern Affairs Canada. The program consists of regular semester periods in which students take a maximum of four classes per day in each semester. We offer a unique and challenging curriculum that meets Ontario guidelines and includes aspects of Mohawk language and culture. Students of all ages and levels of ability are welcomed as we are able to provide a small teacher-student ratio. We have been in operation three years and will expand to include grade eleven and twelve in the immediate future.

##### Courses/Program Requirements

Students are required to earn 30 credits to achieve an O.S.S.D. (18 compulsory and 12 optional credits). Our grade 9 and 10 programs in the past have included the following courses:

It is a requirement that students attend classes daily during regular scheduled time slots. Older students are welcome to attend on a part-time basis if they are able to attend the daily scheduled class.

### Adult Education Program

This program is designed as a self-directed learning program with a support system. Adults are offered correspondence courses from the Independent Learning Centre that are approved by the Ministry of Education. Students may work at their own pace and staff at the school, are available to provide assistance when required. The length of the program varies depending on the number of credits required for graduation.

#### Courses/Program Requirements

O.S.S.D (Ontario Secondary School Diploma) requires students to earn 30 credits. Credits may be earned from high school subjects, maturity credits or equivalency credits. At least 4 credits must be senior credits (grade 11 or 12) and a senior English credit must be included. Maturity Credits – the Ministry of education grants up to 12 mature credits to adults returning to school. These credits apply to adult students who started high school in the Province of Ontario before September 1999. Equivalency Credits – some non-post secondary courses that adult students have taken qualify for credits, i.e. apprenticeship training, community college upgrading, etc.

All courses are divided into 20 lessons. Each course is 1 credit unless otherwise stated. Courses are offered at various levels of learning to accommodate educational goals related to work, attending College or University. There is no fee for community members to take a course through correspondence, as the initial registration fees are subsidized by local community service organizations.

Night school is offered periodically and in the past we have offered courses in English, Presentations and Public Speaking Skills, Computers, Math and Mohawk language. Other non-credit workshop courses are available periodically such as leather crafts (moccasins).

### BREASTFEEDING CIRCLE

"What is the Baby Friendly Hospital Initiative? How can I recognize a Baby-Friendly Hospital?  
Are there any local hospitals that are certified Baby-Friendly?"

Mothers often receive confusing, inconsistent breastfeeding information which is not based on evidence. Doctors, nurses and other health care professionals often receive inaccurate breastfeeding information coming only from formula companies, whose interest is in selling formula. The Baby-Friendly Hospital Initiative (BFHI) is a global project started in 1991 by the World Health Organization (WHO) & UNICEF to encourage health care facilities providing care to mothers and babies to adopt policies and practices that are known to be universally helpful and supportive to breastfeeding. The initial project focused on hospitals/maternity centres, but in recent years has been extended to community health facilities. A Baby-Friendly facility, which encourages and helps women to successfully initiate and continue to breastfeed their babies, receives special recognition for doing so by a distinct certificate mounted in the facility where it is easily seen. This can only be received through an assessment process by a specially trained team of objective assessors from outside the facility.

In the 15 years since BFHI was started, over 15,000 hospitals have been certified worldwide, yet Canada has only 3 Baby-Friendly hospitals and 1 Baby-Friendly community health service to date. All are located in Quebec, except St. Joseph's Healthcare in Hamilton, Ont. There are no local hospitals or health centres certified Baby-Friendly yet. In order to achieve designation, every hospital and health facility must practise the "Ten Steps to Successful Breastfeeding" developed by WHO & UNICEF, which are:

- 1) Have a written breastfeeding policy that is routinely communicated to all health care staff.
- 2) Train all health staff in skills necessary to implement this policy.
- 3) Inform all pregnant women about the benefits & management of breastfeeding.
- 4) Help mothers initiate breastfeeding within a half-hour of birth.
- 5) Show mothers how to breastfeed and how to maintain lactation even if they should be separated from their infants.
- 6) Give newborns no food or drink other than breastmilk, unless medically indicated.
- 7) Practise 24-hour rooming-in.
- 8) Encourage breastfeeding on cue.
- 9) Give no artificial teats or pacifiers (also called dummies or soothers) to breastfeeding infants.
- 10) Foster the establishment of breastfeeding support groups & refer mothers to them on discharge from the hospital or clinic.

A Baby-Friendly facility also adheres to the International Code of Breastmilk Substitutes, known as "The Code", which includes these 10 important points:

- 1) No advertising of products under the scope of the Code to the public (ie formula, baby foods, bottles, soothers).
- 2) No free samples.
- 3) No promotion of products in health care facilities, including distribution of free samples.
- 4) No company representatives to advise mothers.
- 5) No gifts or personal samples to health workers.
- 6) No words or pictures idealizing artificial feeding, including no pictures of infants on products.
- 7) Information to health workers should be scientific and factual.
- 8) All information on artificial feeding, including labels, should explain the benefits of breastfeeding and the costs & hazards associated with artificial feeding.
- 9) Unsuitable products such as sweetened condensed milk should not be promoted for babies.
- 10) Products should be of a high quality & take account of the climate & storage conditions of the country where they are used.

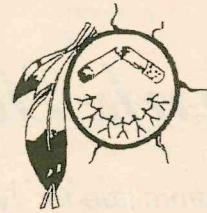

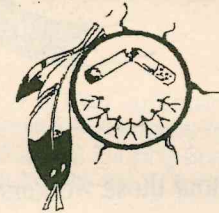

OPP FESTIVE SEASON R.I.D.E. A SUCCESS

(ORILLIA, ONT.) - The Highway Safety Division of the Ontario Provincial Police today released statistics for the fifth and final week of the 2005-2006 Festive Season R.I.D.E. for all OPP jurisdictions in the province of Ontario.

TOTALS WEEK#5

During the fifth and final week (December 23, 2005 – January 2, 2006) of the five-week R.I.D.E. campaign, a total of 139,645 vehicles were stopped at roadside checkpoints. A total of 134 12-hour suspensions were issued and 46 persons were charged with alcohol related Criminal Code driving offences.

FINAL TOTALS (Nov 25-Jan 02)

A total of 576,875 vehicles were checked at roadside checkpoints compared to 450,582 during the same period in 2005. A total of 278 persons were charged with alcohol-related Criminal Code driving offences during the 2005/2006 campaign. Over the same period in 2004/2005, 294 persons were charged with alcohol-related driving charges under the Criminal Code. Also, 671 persons were issued 12-hour suspensions, up from the 2004/2005 total of 664.

During this campaign, 45 people were killed in 37 fatal motor vehicle collisions occurring on OPP patrolled highways. Unfortunately, alcohol related collisions still claimed the lives of 4 people during the 5-week event.

The Ontario Provincial Police reminds motorists that the R.I.D.E. program will continue throughout the year and is not limited to holidays and long weekends. The R.I.D.E. program and other drinking and driving countermeasures are core functions of the Ontario Provincial Police and continue to be a priority. R.I.D.E. checkpoints could be set up at any place and at any time throughout the year.

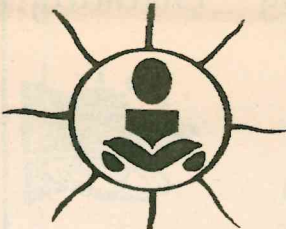

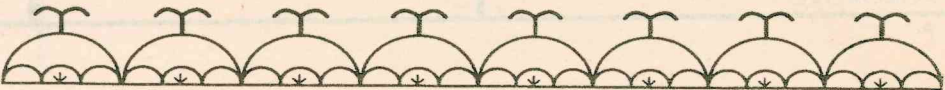

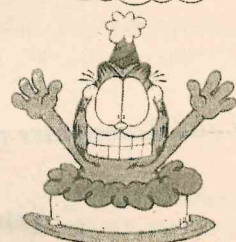

What's more fun then a good old game of "old-timer" hockey, but we have to remember to do regular exercise before racing onto the ice.

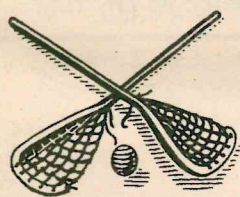
Hockey is a sport of short bursts of high energy and speed – a form of high-intensity exercise that can elevate the heart rate to between 55 and 85 percent of the maximum rate. Sudden on-ice heart attacks among old-timer hockey players are a serious issue.
