

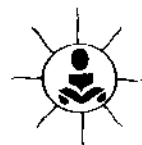

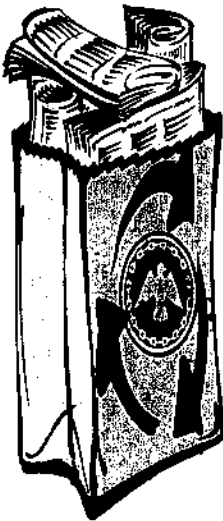


ST. JAMES'S PALACE

The small church of Christ Church, Her Majesty's Royal Chapel of the Mohawks, in the Tyendinaga Mohawk Territory in Ontario, Canada, is one of only six Royal Chapels outside the British Isles. A Gothic structure built by the Mohawks in 1843, Christ Church is a symbol not only of the faith of the Mohawk people but, as a Royal Chapel, it is also a physical symbol of the unique and enduring loyalty of the Mohawk people to the Crown. The Royal gifts displayed in the Royal Chapel include a triptych in the Mohawk language and a bell given to the Mohawks by King George III, a Royal coat of arms given by King George V and a bible given by Queen Victoria. A communion chalice was given by The Queen in 1984 to commemorate the coming of the United Empire Loyalists to Ontario. The communion silver, which was given to the Four Kings by Queen Anne in 1710, is still used on special occasions today.

Sadly, the Royal Chapel, which is such an important part of Canada's cultural heritage, is today in need of urgent repair. A major restoration project is underway. It is an important cause which I am delighted to support. The help of all those who care about special buildings like the Royal Chapel will, I hope, ensure that this important national heritage landmark, which commemorates and celebrates the contribution of the Mohawk people to the historical evolution of Canada, will be preserved for future generations.

A MESSAGE FROM A MEMBER OF COUNCIL
FOR MAY, 1999. SUBMITTED BY WML BRANT

My April message was removed from publication in the Mohawks of the Bay of Quinte newsletter by Chief Maracle for the following reasons to which I am responding:

(This quote is from a memo to the MBQ dated May 5, 1999 from Chief Maracle)

"I have removed Councillor William J. Brant's "Report from Council" from today's newsletter. There are three reasons for doing so:

1. It dealt with personnel matters which were dealt with "in-camera" which may be restricted personal information under the Freedom of Information Act.
2. Council has received legal advice not to publish that report.
3. Some of the facts were incorrect.
4. The report said that it was a "Report from Council" yet neither Councillors Doug Maracle and Colleen Maracle nor myself were consulted prior to the article being given for publication.

This was done to protect the band from suffering additional exposure to civil liability."

The memo was signed by R. Donald Maracle, Chief

#1. With regards to an "in-camera" session it is my understanding that a motion would be made by Council to establish the meeting as an "in camera" session. This was not the case.

#2. To the legal advice that Council received was appended a list of questions and documentation that the lawyer needed "to advise the Band properly." At the time in question this lawyer had no documentation on which to properly advise other than comments from Chief Maracle. Before I decided to submit my newsletter for April, I sought independent legal advice and was advised that "the truth will back you up."

#3. As to the comment "some of the facts were incorrect", indeed the facts were correct but due to my proof-reading error the month of "April" was inserted where it should have read "March" but the day was numbered accurately.

#4. In an effort to please the Chief and some members of Council I have changed the title of my newsletter message to you (which I had previously used for over a year without objection.) My intention and purpose for writing this message is to inform you of the workings of your government.

The information in my letter to you for the month of April 1999 was forwarded without malice toward anyone. It was presented to convey information to you- a practice I have established since becoming a representative on your band council. If indeed there were facts in my April letter to you that were deemed confidential and inappropriate by Chief Maracle, those parts could have been removed and the remainder of the information could have been circulated. Could it not?

I will keep the April 1999 message on file and include items from it in this month's information.

One of the major difficulties that I see in the function of our band council is the fact that there is not a workable set of governance by-laws in place that regulate council proceedings and conduct i.e. (1) meetings are called or cancelled by Chief Maracle with very little notice and can run from 7:00 p.m. to 3:00 a.m. (2) a motion can be moved to adjourn with just cause but the meeting can continue. I will be moving a motion to have governance by-laws established for the Mohawks of the Bay of Quinte Band Council

I attended the 30th General Assembly of the Association of Iroquois and Allied Indians (AIAI) held near Sault Ste. Marie on the territory of Batchewana First Nation on May 28, 1999. The major part of the day was spent on the election of officers. The following persons will form the next AIAI executive:

The right to vote in band elections has been challenged by non-resident band members and as a result and during the AIAI meeting we received a notice of a Supreme Court Ruling made on May 20, 1999 which declares Section 77 (1) of the Indian Act unconstitutional. The memo addressed to all members of the Ojibwas of Batchewana First Nation from Chief and Council, states, and I quote:

"1. What was the issue in this appeal?

The Court was asked to rule whether subsection 77 (1) of the Indian Act, by restricting voting for Chief and Council to members living on reserve, violates the Charter equality rights of members living off-reserve. The subsection says:

(2)

77 (1) A member of a band who has attained the age of eighteen years and is ordinarily resident on the reserve is qualified to vote for a person nominated to be chief of the band and, where the reserve for voting purposes consists of one section, to vote for persons nominated as councillors.

Effectively, the Court was asked to delete the underlined words from the Act because they are unconstitutional

#5. Does the Supreme Court's decision take effect immediately?

Answer: No. While the Court declared the restriction on voting to be unconstitutional, it recognized that putting proper election rules in place will be a complex task involved "new, different, or creative ways of designing such a system". The need for a new system is the Court's recognition that the voting interests of on and off-reserve members are not the same for all purposes. For that reason, it suspended or deferred its judgment for 18 months (to November 2000) so that Parliament could make appropriate changes to the Indian Act."

I feel it will be imperative that MBQ Council meet with officials of the federal government and you to discuss the impact this ruling will have on our community. Your concerns and input will be very important. These meetings need to start as soon as possible

FOR YOUR INFORMATION

MBQ Council has made motions to the following:

1. Increase housing loans to \$60,000.00
2. No longer accepting truck loads of used tires at our dump.
3. To make roads' capital expenditures a priority of budget and to set a time frame and inform community members of the progress (one negative vote was registered).
4. To direct that when staff positions are posted externally that applications be sent to MBQ band members who have graduated in that particular field (using the list of graduates kept with the education department)
5. To upgrade Wyman's side road from where the previous construction ended to Upper Slash Road and west on the Upper Slash for a total of approximately 2.5 Km. This work will be completed by our roads department and will consist of additional gravel and one lift of tar and chips.

A law firm was hired in British Columbia to do work for MBQ band owned companies at the cost of \$107,000.00 in the past year. 1 question:

1. Why MBQ should hire a law firm from out of province?
2. If this firm has a licence from this province and can legally practice law in Ontario?
3. If we really received value for those dollars spent? (I do not think so.)

MOHAWK FIRE DEPARTMENT (MFD)

We received our new pumper fire truck this month and members of Council and others joined with the MFD firefighters in a brief unveiling ceremony on May 21, 1999. This vehicle was a much needed upgrade for the MFD and will greatly enhance our firefighting capabilities. I thank MFD and their helpers for the excellent meal provided after the ceremony.

ROADS

There is an agreement with the Tyendinaga Township Council (TTC) to upgrade Queen Street in Shannonville. We will share 1/3 of the cost which will total \$8,000.00 for MBQ.

Other roads that will be worked on are Bell's sideroad, and the Upper Slash Road west of Milltown Sideroad. It is my understanding that the engineering study for Norway's sideroad is complete and we are waiting for the presentation of this report. This study included the total distance from the Bay of Quinte to the Upper Slash Road.

Direction was given by MBQ to our management staff to investigate the possibility of using loan dollars to complete some of our MBQ capital projects such as the Norway's sideroad project. No action will be taken on borrowing until the total cost of this project is determined, the amortization period established and the funds are identified for the repayment of the loan. Taking this route will speed up the completion of projects rather than having to wait for the government grants to come along.

In closing I would like to state that this time of year (spring) is an extremely busy time for farmers. So if I am unable to return your calls or meet with you immediately, I hope you will understand. I will be in touch as soon as I am able. I am still attempting to work Wednesday's in my office, phone 967-9861. Thank you in advance for your patience.

It has been brought to our attention that the extreme fire conditions occurring in the north have affected several First Nations communities.

Members of the Brunswick House First Nation have been evacuated to the Batchewana First Nation, where a relief effort has been set up in the local arena. Pic Moberg First Nation residents were evacuated to Marathon and returned home today. Approximately 360 residents of the Bearskin Lake First Nation have also been evacuated to the town of Geraldton where they have remained since Tuesday. The Chapleau Cree First Nation is on a Level 1 Alert and if fire conditions worsen, will be evacuated to Garden River First Nation located near Sault Ste. Marie.

We are asking for donations of clothes, toiletries, and food. Any financial assistance that you could provide would be greatly appreciated.

All donations and/or contributions can be sent to the Chiefs of Ontario Toronto Office. They will then be sorted and sent to the communities affected by the fires.

Enclosed for your information is an update on the forest fires provided by the Ontario Ministry of Natural Resources.

West Fire Region Fire Centre - DRYDEN

Forest Fire Update

Date: May 6, 1999

HIGHLIGHTS:

- An Emergency Area Order has been declared for areas extending from the east, west and south shore of Lake Nipigon, and around two large forest fires in that area.
- A Restricted Fire Zone remains in effect across the province
- Six new fires in the West Fire Region May 06

Overview:

Nipigon Fire Number 10 has exceeded 43,300 hectares and is primarily is burning between Black Sturgeon Lake and Lake Nipigon. The south end of the fire received 13.0 mm of rain and 4.0 mm at the north end. There are camps on Frazer Lake, Purdom Lake, MacIver Lake and Elizabeth Lake and some buildings on McIntyre Bay of Lake Nipigon that are threatened by this fire. The enlarged fire is adding to the list of threatened values - namely the Outward Bound Camp, some Lakehead University research plots, a pipeline compressor station, a federal research facility on Nonwatin Lake and other wildlife values. Suppression is being handled from the Thunder Bay Fire Center. Bowater harvest block allocations have been burned, and a 17' recreational trailer, a recreational camp south of Tweed Lake (south of McIntyre Bay), and a bridge across Black Sturgeon River are counted as losses to the fire. However, FireRanger crews saved two Canadian Forestry Service (CFS) Trailers and some expensive Research equipment in the trailers.

The fire is currently smoldering in dead fuels and poor flying weather has hampered attempts to do accurate mapping of the fire perimeter. Global Positioning Systems (GPS) technology will be used May 07 to help map the fire. Additional firefighting resources continue to be deployed to the fire.

The fire team in command of Nipigon Fire Number 12 note that the burnout event carried out May 05 placed a huge margin of safety between the community of Beardmore and the main fire. The fire size has grown in part as a result of the burnout operation and is Not Under Control at 30,070 hectares in size.

Crews continue to establish hose lines on an area of the fire east of Highway 11 and water tanker trucks are providing support by putting out spot fires along the highway. Crews are also establishing homeliness along the TransCanada pipeline between Blackwater River and Highway 580 and northeast from Highway 580 to Sturgeon River.

The Beardmore area started to receive light rain. The Town of Beardmore remains evacuated with most residents staying in Geraldton. Approximately 50 Beardmore residents have remained behind to maintain the town infrastructure and assist with the sprinkler system that had been set up to protect the community. Today's suppression efforts have been concentrated on consolidating the protection buffer that was successfully established around the community of Beardmore, Highway 11, the Ontario Hydro transmission lines, CN Rail and the Trans Canada Pipeline by the burn out that MNR crews carried out yesterday to remove fuel ahead of the eastern flank of the fire. Light winds, higher humidity and a small amount of rain helped the crews prevent any further spread of the fire today. Smoke is beginning to settle tonight and may be a concern for Rocky Bay First Nation and MacDairmid.

With the burn out area and with the opportunity to get a better look at the entire fire today, we have been able to produce an improved map. We are currently estimating the size at 30,070 hectares.

Highway 11 has been closed to traffic since approximately 11:00 am on Tuesday, May 4. This closure will remain in effect until the highway can be safely opened.

Nipigon Fire Number 18, located to the northwest of Eabametoong First Nation (Fort Hope), it is being monitored, but immediate action is not required at this time. It remains at a size of approximately 1800 hectares.

Approximately 360 residents of Bearskin Lake First Nation were evacuated to Geraldton on Tuesday and Wednesday as a large fire burned in the area around their community. Sioux Lookout Fire 16, which is affecting Bearskin Lake, is currently estimated to be 21,000 hectares.

Sioux Lookout Fires 17 and 20 are approximately 2,500 and 900 hectares respectively. They have created concern regarding the hydro supply to Osneburgh First Nation and Pickle Lake and have caused smoke concerns for those two communities.

A Restricted Fire Zone (RFZ) remains in effect for all zones in the Province. This RFZ will be in effect until further notice. We stress that all persons should be extremely careful and under no circumstances should they start a fire for any reason.

There were six new fires today in the Northwest Region with one in Red Lake District, one in Sioux Lookout District and three in the Kenora District. People caused both the Red Lake and Sioux Lookout District fires. No problems were reported with these fires. Kenora District Fire Number 24 started from a pile of wood chips burning near the Caribou Falls generating station and Hydro personnel did initial attack on the fire. It was declared out in the early afternoon. Kenora District Fire Number 25 was on an island in Lake of the Woods caused by lightning and received air attack and heli-cat out of Dryden District. The fire was also declared out by the afternoon. Kenora Fire Number 26 was near Werner Lake and the cause is under investigation. No problems were reported with any of these fires.

Sioux Lookout Fires number 17 and 20 showed no appreciable spread today. Continuous waterbomber was carried out in support ground crews in controlling hot spots from Highway 599 to Fault Lake. Favourable weather is allowing suppression actions to progress today.

Sioux Lookout Fire Number 16 adjacent to the Bearskin Lake community has had additional crews deployed to assist in the firefighting effort along the west flank of the fire. Other suppression containment continues to proceed north. With this deployment this will contain approximately 8 km of fire perimeter along the west flank. Bearskin Lake Category 2 Auxiliary firefighters were deployed to the fire and will continue to consolidate hose line to reduce the potential of any fire spread toward the Community Centre and community values. These actions will continue to provide excellent security to the community and the airport site from further fire encroachment.

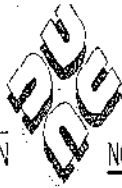
An EMERGENCY AREA ORDER has been declared for areas extending from the east, west and south shore of Lake Nipigon, and around two large forest fires in that area. This means that the Ministry of Natural Resources has the authority to close roads or stop the movement of people into the fire areas. It also means that people may be asked to leave an area if fire management staff feel the public is at risk from the threat of fire, or fire suppression activity.

Winnipeg Chosen as City for APTN Presentation Centre

Tuesday, May 4, 1999, Ottawa, Ont.—At an APTN (Aboriginal Peoples Television Network) Board of Directors meeting today, a final decision was made to establish a presentation and uplink centre for the network in Winnipeg, Manitoba.

"The Board reviewed a number of studies in making their final decision. They looked at available technical infrastructure, cost of office space, aboriginal population and human resources. With less than four months before the launch of the network on September 1, it was imperative that a decision was made," said Abraham Tagalik, APTN Chief Operating Officer.

The particular site within Winnipeg has not yet been determined. A number of locations are being considered and will be evaluated by the APTN Management Committee over the next month before a final decision is made.

"The support from Winnipeg was overwhelming," said Mr. Tagalik, "from the mayor's office, to the aboriginal community, to the local media, and I believe that had a positive influence on the decision."

The uplink and presentation centre will house the news studio for APTN and will be the primary location for receiving and disseminating APTN programming. APTN also plans to retain an administrative office in Ottawa, Ontario and the northern presentation centre in Yellowknife, NWT and continue to use existing uplinks in Whitehorse, Yukon and Iqaluit, Nunavut.

The Aboriginal Peoples Television Network (APTN), is a CRTC-licensed television network. APTN will broadcast programming by and about aboriginal people from all regions of Canada, in English, French and aboriginal languages. APTN will launch in September and will be available on basic cable (in areas where there are more than 2,000 subscribers) as well as direct-to-home distribution undertakings. APTN is a network that has grown out of Television Northern Canada, an aboriginal television network in the North that has been broadcasting since 1991.

MEMORANDUM

To: All Ontario Chiefs and First Nation Membership
From: Regional Chief Tom Brousseau
Date: May 18, 1999
Re: Upcoming Provincial Election

Please be advised of the upcoming Provincial Election slated for June 8, 1999

I am forwarding a personal request for you and your First Nation membership to consider participating in the upcoming Provincial election by casting your vote.

Many of you, like myself, have never participated in previous elections because we felt either we were "surrendering" our rights as Native peoples and complying with *white* government protocol and procedures. Or we felt that voting is a *useless* tactic in terms of establishing leadership partnerships with those who would not acknowledge and respect our Aboriginal inherited rights.

This will be my first time voting in a provincial election and this is my personal choice to do so. I believe our Native Veterans risked and gave their lives for each of us to have the option to vote should we decide to. My decision to vote is my personal attempt to ensure we as Native peoples have a provincial government who will support and work with us as we move towards our goals of self-determination and building a strong economic base for our future generations.

We should all realize that we have had no success with the current provincial government. My opinion of the current provincial government is a negative one, for very good reasons which would include: the action by the P.C. government on the Lauds for Life initiative without our consultation and participation, the shooting of Dudley George and savage beating of Bernard George during the Camp Ipperwash crisis and critical cuts to health care which has created a crisis situation for our people in the north. There are many more examples of Mike Harris' "leadership", far too numerous to mention in this memorandum.

Ultimately, it is *your* decision to vote or not to vote and who you will vote for. I am only forwarding this request for you to consider your *options* as leaders for our future as we enter in to a new millennium and what type of provincial government we will be attempting to create a positive and productive relationship with. Regardless of if you support voting or not, we must accept the reality that the provincial government does impact our agendas. One prime example of this is Ontario Works. This provincial initiative was implemented in spite of our protests and concerns.

Thank you for considering my request and I'm looking forward to meeting with you at the upcoming All Ontario Chiefs' Conference in mid-June.

POLICE

Press Release - April, 1999

The enforcement of traffic rules and regulations is just one of many ways the Tyendinaga Police promote Traffic Safety. Enforcement places the onus on Police to assist people to understand these principles and their importance in regard to safety. Therefore Traffic Education is essential when maintaining a high level of safety for the Citizens of Tyendinaga Territory.

Council is now in the process of reviewing a new approach to Traffic Safety on the Tyendinaga Territory. The Driver Safety Course will be administered by the Tyendinaga Police to violators found committing certain traffic offences on Tyendinaga roadways. This approach is designed to formally correct poor driving habits without costing demerit points or a severe fine. A driver will only be eligible to take the Driver Safety Course once per year and again this will only be available if the driver has not been involved in a collision and the offence is in the category listed.

A) DRIVER SAFETY COURSE NOTICE shall not be given for the following offences:

- involving motor vehicle collisions
- involving class L, G1, G2, M1 or M2 drivers
- of Careless Driving
- of exceeding the Speed Limit by 20 Km/h or more
- involving a School Bus
- equipment on commercial vehicles

- involving drivers licenses or permits

DESIGN

This is a **voluntary** program that is a formal extension of the warning system now in use by our officers engaged in traffic enforcement duties on the Territory. The added "fee for service" driver education feature is designed to assist drivers in understanding the principles and realities of failing to adhere to rules of the road.

Under the existing process an offender may receive a warning or be issued an offence notice. The offender receiving an offence notice may select one of three options;

- pay the fine,
- attend a Justice of the Peace office and give an explanation to their guilty plea,
- or set a court date for a trial.
- under the proposed process a fourth option would be available to the driver as follows;

Officers would issue a DRIVER SAFETY COURSE Information sheet with an explanation of this option and the listed \$55.00 fee.

Driver Safety Course (D.S.C.)

Under the Driver Safety Course (D.S.C.) program, offenders are

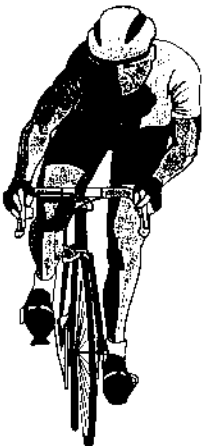
given the option to attend OUR course and educate themselves as a means to correcting poor driving habits. After attending the Tyendinaga Police Office (within 5 days of receiving their D.S.C. Notice) and completing the course (usually 30-40 minutes in length), they leave more aware of the consequences of poor driving habits and without receiving a Provincial Offence Notice or any demerit points on their licence.

Benefits of the Driver Safety Course Program

1. Increased Traffic Enforcement.
2. Increased Morale.
3. Reduced time spent in court.
4. Increased officer patrol time.
5. Program is self sustaining.
6. Revenue is generated for budget deficit reduction.
7. Program can be expanded into other areas (modules).

Any person issued a DRIVER SAFETY COURSE NOTICE may, within 120 hours (5 days) of the date of such issuance (not including date of issuance), participate in the DRIVER SAFETY COURSE by; reporting to the Front Desk of a Tyendinaga Police Service Station, providing the information requested, paying the required fee of \$55.00 and spending the time necessary to read the appropriate DRIVER SAFETY COURSE Module and correctly complete the compliance questions. No Officer shall accept payment of the \$55.00 fee at the time of delivery of the DRIVER SAFETY COURSE Notice.

YOUTH FOCUS



Communities have different rules about cycling on the sidewalk. In general, when children have developed the necessary skills (age nine and up), the safest place to ride in their neighborhood is on the road, where motorists can see them.

Crossing the street takes practice. Children need help to understand when it is safe to cross the road. Crossing the road can mean crossing at the corner, crossing at crosswalk or crossing in the middle of the block.

Children should walk across the street. They should learn to check left, check right then left again before deciding if it is safe to cross the street. They should not cycle across because then they will have too many things to think about to check properly for traffic.

Children younger than seven should not cross any street alone. Children younger than nine should not cross busy streets alone. You must walk your bike when crossing the street at a crosswalk. In Ontario it is the law.

Children should learn to make their own decisions. If a child is cycling with friends he or she may just follow the cyclist in front. This is dangerous. Traffic is changing all the time. And breaking the law, like riding through a stop sign, is still wrong even if a friend did it first.

Help children learn that they are responsible for the own vehicles and must make good and safe decisions for themselves.

Never make a turn without looking behind you first. When cyclist are riding on the road or on a bike trail, they must always look over their shoulder first before signaling and turning. Children may have been taught their signals, but they usually do not know to make a shoulder check. It can be a lifesaver. Cyclists must check to see if the way is clear to make the turn safely.

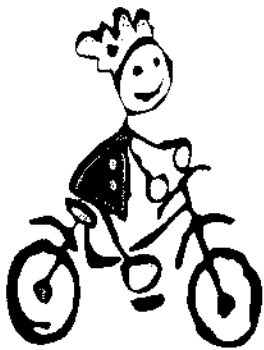
If there is traffic, a child should stop by the side of the road and wait for a gap.

Consider enrolling you and your children in a safe cycling skills course.

SAFE CYCLING



For children, cycling is freedom and adventure. They get to go fast under their own power. They can expand how far they can go. They feel good on their bikes. Children from the age of nine are gaining their independence, they are also beginning to develop the physical and mental skills needed to make safe decisions consistently on the road as an operator of a vehicle.

Cycling is a life-long activity. When children learn good cycling habits early, they can stay safe. You have an important role to play in helping your child learn good cycling habits.

- * Be a good role model!
- * Make sure your child has safe equipment (bike and helmet).
- * Have clear rules.
- * Discuss good cycling habits with your children.
- * Unlike adults, children are responsible for 80% of their own accidents - mostly because they don't know any better. The most common causes of collisions are:
 - * Riding on the sidewalk.
 - * Running a stop sign.
 - * Darting out of a driveway without looking.
 - * Running red lights.
 - * Turning left without yielding
 - * Falling

Help your child cycle safely

The bicycle is a vehicle: The rules of the road are for you. It does not matter what age the cyclist. The cyclist must obey the rules of the road and all the traffic signs. Obeying the rules of the road means you can stay safe.

- * Stop at all stop signs and red lights.
- * Ride on the right hand side of the road.
- * **Ride a bike that fits.** Make sure that your child is riding a bike that fits and is in good working order. A bike that is too big cannot be controlled properly and can be dangerous. It is not safe to buy a big bike with the idea that the child will grow into it.

A child should have both feet flat on the ground when standing straddling the top tube of the bike. The child should be able to touch the ground with the toes of one foot while sitting on the seat, without leaning the bike.

A bell or horn is required by law, and so is red reflector and a front white light if you cycle at night. Make sure the wheels are on tight and that the brakes work.

Wear a bike helmet. In Ontario, wearing a bike helmet is the law and can save you and your child from serious injury or death. Wearing a bike helmet reduces the risk of brain injury by 88%. Your children may never have a collision with a car, but they will probably fall off their bikes at some point. Even at low speeds, if the head hits the ground brain damage can occur.

Children under age nine should be supervised when they cycle. Children learn new skills as they grow. Before age nine most children do not have the skills to cycle safely on the road. Learning to balance a bike is only the first step. Understanding how traffic works takes time and experience. Before age nine children need help to make good choices and should cycle with responsible adults.

Driveways can be dangerous. Many children are hurt and some are killed every year because they cycle down the driveway and into the street without looking. They get hit by a car that has no chance of stopping in time.

A driveway is an intersection. Teach your children to:

- * Stop before entering the road.
- * Look left, then right then left again.
- * If there is no traffic, then they can go.

Practice these steps with your children.

Riding on the sidewalk is not always safe. For young cyclists the sidewalk may be the best to cycle. Children need help from their parents to stay safe when they ride on the sidewalk.

There are driveways and alleys that cross the sidewalk. Cars can turn into a driveway quickly and the driver may not see a young cyclist. Driveway, alleys, doorways and paths are all intersections. Conflict can happen and people can get hurt.

Sometimes sidewalks are bumpy and children can lose control of their bikes and fall. Pedestrians and pets are also on the sidewalk and are often unpredictable. Pedestrians have the right of way on the sidewalk and they do not expect cyclists to be there too.

At the end of the block the sidewalk ends and the road begins. Will your child be able to stop in time

- * Be with your child as he or she cycles on the sidewalk.
- * Help them to stop to check possible danger spots.
- * Help children respect pedestrians on the sidewalk.

I am writing in regard your request in September 1998 to purchase and install a new telephone system for the Tyendingaga Police Service facility. Subsequent to receipt of your request a systems coordinator conducted an on site need assessment resulting in the information that the telephone system at the Tyendingaga Police Service was dated, dilapidated and subject to failure. In December 1998 I wrote to you expressing support for a replacement however stated that fiscal constraints prevented further consideration until the new fiscal year.

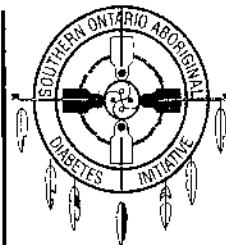
On March 25, 1999 your telephone situation was tabled for discussion at the Ontario First Nations Police Commission meeting. As a result, I am pleased to advise the Commissioner's unanimously agreed to commit \$6500 toward the purchase and installation of a new system. Funding for this initiative is available immediately and as such I ask that you contact Sergeant Pierre Chamberland direct at (705) 329-6210 for further detail.

Before closing, I believe it important to point out that the source of \$6,500, for this initiative comes not from First Nation Policing Section but rather the Ontario First Nations Police Commission. The availability of funds is as a result of the Commission's diligent effort to secure proceeds gleaned from the resale of program vehicles. It is evident that had it not been for the patience and perseverance of the Commission working on behalf of the communities they serve, your request for financial support may not have been realized.

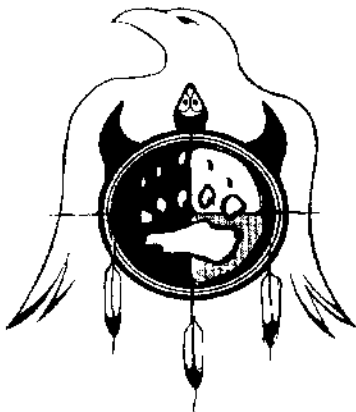

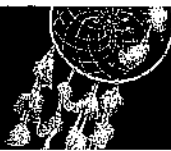

PROTECTING YOUR FAMILY FROM UV RAYS



With the summer weather approaching and the kids taking advantage of the weather please remember to protect your family from the sun.

The UVB rays are the strongest between 11:00 A.M. AND 4:00 P.M.

Unless children are protected from the sun, with proper clothing and sunscreen keep them out of the sun during those hours. HEALTH HAZARD ALERT -- COWBOY'S CAVIAR BEEF STIX

Ottawa, May 18, 1999 -- The Canadian Food Inspection Agency is warning the public not to eat *Cowboy's Caviar Beef Stix* summer sausage manufactured by Hub Meat Market Ltd., of Moose Jaw, Sask. The sausage is sold in vacuum-packed 40g packages and is not properly preserved to control the spread of pathogenic bacteria.

The product may contain the bacteria responsible for botulism in humans. Botulism is a life-threatening illness caused by the build-up of toxins produced by *Clostridium botulinum* bacteria. Food contaminated with *C. botulinum* bacteria may not look or smell spoiled. Consumers should dispose of remaining product immediately. The product should not be consumed by humans or animals.

Irvan Berg, the product distributor, also of Moose Jaw, is recalling the affected packages from the marketplace. The product was distributed only in Saskatchewan.

IKEA Canada Announces Voluntary Recall of Wooden Stacking Ring Toys to Replace Top Red Ball Pieces

Burlington, ON (May 11, 1999) - IKEA Canada Inc. of Burlington, ON is voluntarily replacing the red ball pieces on top of the wooden stacking rings on approximately 14,500 stacking ring toys. Despite meeting all Canadian toy/small parts safety standards, the red ball presents a potential choking hazard to young children.

IKEA has received one report of a 4 1/4 year old child in Europe reportedly choking to death on the top ball portion of the stacking ring toy. The article also fulfills current European Toy Safety Standards. Despite this, this ball-shaped object is viewed by IKEA as dangerous for children. This has prompted a recall of the product on all markets. To date, no other injuries or complaints have been reported.

The stacking ring toy called "MULA" is an 8 1/2-inch high wooden stacking toy consisting of 10 brightly colored pieces, including the top ball piece plus the pedestal base and stacking rod. When all of the pieces are stacked in order, the toy resembles an inverted cone with the top red ball capping it. There is a sticker on the base printed with the words "Design and Quality, IKEA of Sweden, ". The toy is packaged in either a cardboard box or shrink wrapped with the word "MULA" and "Stacking rings", printed on the outside.

IKEA stores nationwide sold the MULA stacking toy from 1991 through April 1999, most recently for \$9.95. The item is manufactured in Thailand and to date approximately 333,000 pieces have been sold around the world.

Consumers should take the top red ball away from children immediately. Consumers can return the red ball to any IKEA store and receive a redesigned top piece, in the shape of a cube, or receive a full refund of the purchase price. An ozone generator is a machine that:

- plugs into the wall or runs on batteries, and
- puts ozone into the air.

Ozone generators are sold as home air cleaners. They may have an ozone detector built-in.

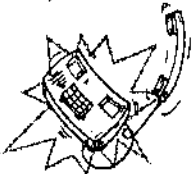
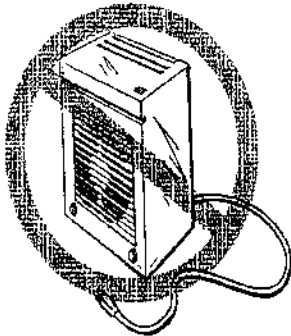
But beware! This kind of air cleaner puts a harmful gas called ozone into the air you breathe. Ozone can cause headaches, sore throats and coughs. Ozone can hurt your lungs.

The Canadian Standards Association (CSA) no longer approves ozone generators for use in homes.

Most of the ozone generators that are in homes were sold door-to-door across Canada. They were not sold in stores.

Safety Tips

- If you have an ozone generator in your home, stop using it.
- An ozone generator made for business (or commercial) use should NOT be used in your home.

PREVENTION STEPS

Many women live in fear of being sexually assaulted and are, therefore, forced to make special arrangements to protect their personal safety

- If you feel uncomfortable in a situation, trust your instincts and act on them.
- Learn to identify dangerous behaviour such as not listening or responding when you say "no".
- Always let someone know who you are with and where you are going.
- Take a self-defense course.
- Talk to other women about sexual assault. Understand what sexual assault is and why it happens.

REMEMBER: YOU ARE NEVER TO BLAME FOR A SEXUAL ASSAULT.

WHAT TO DO IF YOU ARE ASSAULTED

All people suffer pain and trauma from a sexual assault, even many years later. They may show this in different ways, or not show it at all. It helps to talk about it.

You might choose to tell someone you trust, such as a close friend or relative or contact:

- a sexual assault centre
- a local counselling service
- a teacher or guidance counsellor
- a health care worker or your doctor

MYTH:

The way women dress or behave can be the reason for the sexual assault.

FACT:

Age, appearance, social standing and marital status are not barriers to being assaulted.

MYTH:

Sexual assault only happens at the hands of a stranger in a dark alley.

FACT:

In approximately 69% of cases, the perpetrator was known to the victim. Most victims are sexually assaulted in their own homes.

Many women are raped by their husbands. Marital rape was not included in Canada's Criminal Code until 1983.

Many teenage girls are sexually assaulted on dates.

Many children have sexual acts forced upon them by trusted family members. This includes cousins, uncles, stepfathers, brothers and fathers etc. and occasionally mothers and sisters, etc. This is called incest. Many women and men do not remember their experiences of child sexual abuse until many years later.

MYTH:

The rapist is motivated by sexual desire.

FACT:

Sexual assault is a crime of violence not a crime of passion.

The attacker acts out of a need to have control over someone and/or to express anger.

Assaults are usually planned.

Men can control their sexual impulses.

Some men hear a clearly spoken "no" as an invitation to use force.

MYTH:

Victims should or could have done something to prevent a sexual assault and that they are to blame.

FACT:

Victims are not to blame. Verbal threats or intimidation may cause the victim to submit.

Victims are often afraid of being killed or seriously injured.

IF YOU ARE SEXUALLY ASSAULTED - THIS IS A CRIME - YOUR FREEDOM OF CHOICE HAS BEEN REMOVED. REMEMBER, THE OFFENDER MADE THE DECISION TO COMMIT THE CRIME AND CARRIED IT OUT. THE VICTIM IS NOT TO BLAME.

Facts About Sexual Harassment

Unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature constitutes sexual harassment when submission to or rejection of this conduct explicitly or implicitly affects an individual's employment, unreasonably interferes with an individual's work performance or creates an intimidating, hostile or offensive work environment.

Sexual harassment can occur in a variety of circumstances, including but not limited to the following:

- The victim as well as the harasser may be a woman or a man. The victim does not have to be of the opposite sex.
- The harasser can be the victim's supervisor, an agent of the employer, a supervisor in another area, a co-worker, or a non-employee.
- The victim does not have to be the person harassed but could be anyone affected by the offensive conduct.
- Unlawful sexual harassment may occur without economic injury to or discharge of the victim.
- The harasser's conduct must be unwelcome.

It is helpful for the victim to directly inform the harasser that the conduct is unwelcome and must stop. The victim should use any employer complaint mechanism or grievance system available.

When investigating allegations of sexual harassment, EEOC looks at the whole record: the circumstances, such as the nature of the sexual advances, and the context in which the alleged incidents occurred. A determination on the allegations is made from the facts on a case-by-case basis.

Prevention is the best tool to eliminate sexual harassment in the workplace. Employers are encouraged to take steps necessary to prevent sexual harassment from occurring. They should clearly communicate to employees that sexual harassment will not be tolerated. They can do so by establishing an effective complaint or grievance process and taking immediate and appropriate action when an employee complains.

These are some examples of behaviors that could be defined as sexual harassment:

- pressure for sexual activity
- asking about a person's sexual fantasies, sexual preferences, or sexual activities
- unwelcome patting, hugging, or touching of a person's body, hair, or clothing
- repeatedly asking for a date after the person has expressed disinterest
- sexual innuendoes, jokes, or comments
- making sexual gestures with hands or through body movements
- disparaging remarks to a person about his/her gender or body
- making suggestive facial expressions such as licking lips or wiggling tongue
- sexual graffiti or visuals

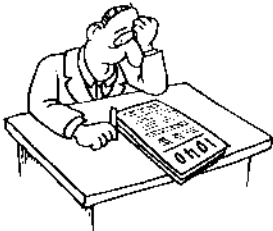

Global Television Network 1999-2000 Aboriginal Peoples' Internship Award

This annual Internship Award offers an Aboriginal Canadian a challenging opportunity to work in private television, in pursuit of a career in broadcasting. The Award, valued at up to \$10,000, places the Award Recipient in a 4-month internship program at any one of our Global Television stations located in: Toronto, Ontario; Halifax, Nova Scotia; Vancouver, British Columbia; Winnipeg, Manitoba; or Regina/Saskatoon, Saskatchewan where the Award Recipient will be paid on a salary basis for the summer of 2000. In addition, the Award covers transportation, hotel and attendance expenses at the Canadian Association of Broadcasters annual convention in November 1999, where the Award will be presented.

ELIGIBILITY CRITERIA:

- Aboriginal Canadian;
- secondary school graduate;
- interest in, and aptitude for, a career in the broadcasting industry;
- strong English language communication skills.

INTERNSHIP GUIDELINES:

- Award Recipient must be willing and able to relocate to any one of the Global stations listed above for the summer of 2000. Assignment of Internship location will be determined by the judging committee, in consultation with management from Global Television stations;
- If Award Recipient must relocate, Global Television will offer reimbursement of transportation and accommodation expenses of up to \$1,500 for the duration of the Internship period;
- Award Recipient will intern in an entry level position, within an area determined by Global Television. Internship will be designed by Global Television, based upon the abilities and interests of the Award Recipient and the requirements of the selected Global Television station;
- Award Recipient will be paid on a gross salary basis, subject to applicable taxes, for four months, May through August.

















