### NOTICE PROCEDURE FOR CONTACTING PIERCE ANIMAL CONTROL SERVICES

Residents can call (613) 966-4483 leave your name and phone number so that they can contact you.

**They are available 24 hours for emergencies.** An emergency would be a dog that is injured and the owner is unknown, a dog that is harassing livestock, a dog endangering the public or an animal suspected of having rabies. If a resident would like to log a complaint or inform them of a dog running at large they can do so by calling Monday to Friday between the hours of 8:00 a.m. and 4:30 p.m.

They are not available to pick up strays running at large on weekends or statutory holidays. All animals that are picked up are taken to the **Quinte Humane Society** and their hours are 12:00 noon to 5:00 p.m. Monday to Saturday and 1:00 p.m. to 4:00 p.m. Sunday. The Quinte Humane Society is also closed on statutory holidays.

The Quinte Humane Society is located on Avonlough Road which is at the west end of Belleville off of Dundas St. west (Hwy #2). Their number is (613) 968-4673.

It would be best if your pet has been picked up that you call ahead to the Humane Society to confirm the cost involved in redeeming your pet.

#### EXPIRY DATE ON STATUS CARDS

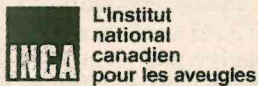
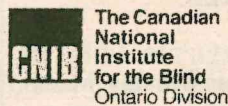
Our First Nation members have been inquiring why there is an "expiry date" on our status cards. I e-mailed Indian Affairs to inquire about the expiry dates. Here is their answer:

Our INAC policy is that the cards need to be renewed every 3 years for children under 18 yrs of age (because their appearances change quite a bit while growing up). For the adults the cards need to be renewed every 5 years as they also change, but not as quickly. These expiry dates are also implemented as they will be keeping in line with other government issued type of documents/cards such as health cards, drivers licenses, passports, etc. Plus once the new card comes into effect (we do not know when yet) these dates will be automatically system generated on the cards. This will help to ensure for INAC and First Nations that there are less fraudulent cards in circulation. My only advice would be to alert the First Nation members to renew their cards before the expiry date, so that they will not experience difficulties when travelling/shopping.

Thank you for voicing your concerns and I will certainly let our headquarters people know the dilemma the expiry date puts on First Nation members.

A special meeting of Council was held to review the quarterly performance report of February 11, 2005 from the Bank of Montreal Nesbitt Burns on the Casino Rama Investment portfolio.

Portfolio returns in 2004 were slightly below the target of 5-6% with an annual return of 4.75%. Continued low interest rates limited bond returns. The equity markets outperformed bonds on a currency adjusted basis and the rapid rise in the Canadian dollar has muted equity returns.

Historic return of 5.43% continues within our targeted range since the inception of the investment portfolios.

We can anticipate similar returns in 2005 with stable interest rates and marginal growth in equity markets contributing to steady returns.

BMO Nesbitt Burns Recommendations

It is anticipated the equity markets for next couple of years would be considered a prudent investment to reduce the foreign exchange risk at this time. It is anticipated the Canadian dollar will be in the range of \$0.85 over the next 13 months.

Recommendation #1

Jeff Curtis recommended the equity manager Seamark Asset Management be changed to a total BMO Nesbitt Burns Canadian Blue Print portfolio due to exchange risk and to save on investment fees.

Recommendation #2

Jeff Curtis recommended that the \$150,000 invested in a cashable GIC which is pledged to the Band of Montreal to support loan advance for economic development loans for businesses be invested in a BMO Capital Deposit Note to improve the interest rate earned.

The west side of West Creek will cost \$980,000.00. The road will cost \$760,000 and \$220,000.00 for utilities.

Paul Miller will have to complete a boundary plan, legal survey and place surveyor stakes in the ground. Jewell Engineering will complete final design.

It was recommended that Paul Miller complete legal survey and design the road at a cost of approximately \$60,000.00.

The storm water will go into a storm water management pond with natural attenuation in a two-bay pond.

Wells require treatment systems in the Industrial Park.

Mohawks of the Bay of Quinte stated that there will be enough funds to pay retroactive pay for teachers and teacher assistants but there will be shortfall in funding in 2006-2007.

### Special Education

Kathy Knott stated that special education funding lapses if it is not spent. Kathleen Manderville ensures funds are spent. Funds are reported to INAC according to the INAC reporting handbook. There are no lapsing funds for special education. Funds for retrofit can be carried over. The Tyendinaga Education Committee is funded at \$2,000.00.

### Staff Salaries & Benefits

MBQ sent a package to INAC but is still waiting for additional funding for Band employee benefits. If INAC does not respond, a significant portion is for educational salaries for 2004/05 in the amount of \$44,700.00. Kathy requested the letter be sent to her that was sent to Charles Nadiwon and Ron Hanley. The retroactive pay is for teachers, teacher aides and the secretary. The amount is \$53,980.00.

Students are funded on student enrollment - \$4,614.00 per student plus adjustment factors, school size, and English as a second language.

There is a special part of funding for teacher salary enhancement. There continues to be shortage of funding in teachers salary enhancement funding but not in Quinte Mohawk School.

Additional staff was provided regarding language and Cultural programs.

There is parity in funding to First Nations equivalent to that provided by Ontario.

Indian Affairs wants Chiefs of Ontario to identify what is the unique First Nations cost identifier and cost drivers.

Tim Thompson and a representation are on the Nation Board Operation formula committee.

Health and Safety training will be occurring to update training.

Chief Maracle questioned what is in the federal capital plan regarding Quinte Mohawk School. Kathy Knott will provide an update on INAC Education Capital Plan. Kathy Knott commented that the community support for Quinte Mohawk School is fantastic. Parental and grandparent involvement is uplifting.

### Nominal Roll – 333 FTE

Nominal Roll is based on residency and INAC does not fund children who lived on leased land.

Authority package and Nominal roll package will be forwarded to MBQ by Kathy Knott.

Velma questioned if there is a need for text books. Kathleen stated that grade 2 and under do not have a lot of hard covered texts in print but after grade 2 on there are hard covered texts and the students have a copy.

### Quinte Mohawk School Evaluation

The Committee has met and drafted terms of reference. MBQ needs to tender the school evaluation and request funding from INAC. The evaluation is not an evaluation of teachers.

### Parental Choice

Personal choice can be accommodated through local control of education.

Chief Maracle questioned parental choice where parents want their children educated in a religious or Mohawk language emersion school.

INAC policy is that students at Tyendinaga can be educated at the Quinte Mohawk Federal School.

Mohawk Language Immersion Schools must be registered as a credit granting institution with the Province. Province can approve private school status.

Ohahase can be funded through the Mohawks of the Bay of Quinte Contribution Agreement with Council. The Hastings County Tuition Agreement will be reviewed.



# MEETING MINUTES

It is proposed that we have a meeting the last week of May 2005.

Chief Maracle questioned the status of FNTI funding from INAC. Kathy Knott confirmed that FNTI has been forwarded \$500,000 from ISSP funding. An application is pending for \$500,000 from New Paths and additional information is required. It may be possible to receive an additional \$500,000 from the Indian Management Development Program. The total funding from INAC Region could be 1.5 million dollars.

A presentation was made by Charles Nadjiwon from Indian and Northern Affairs Canada on multi-year funding agreements. The multi-year funding agreement is transferred responsibility for all program delivery elements to the Tyendinaga Mohawk Council.

There are new terms in the multi-year core and non-core funding.

Core is also referred to as Block Funding. Non-core is usually a one-time funding request usually application based for a specific purpose and is non on-going funding. Non-core is also referred to as targeted program.

Core funding is set at the beginning for the five year term and is adjusted annually on a formula basis.

INAC will enter discussions without requiring the Mohawks of the Bay of Quinte to assume control of education as a band-operated school.

Operation & Maintenance and ancillary funding are formula based for education.

There are three considerations: budgets, risk factors, and does Chief and Council have willingness to take over budgets and design of the programs.

Council determines priorities of spending between programs.

Two-thirds of MBQ budget is for core activities.

Funding can be moved from core to non-core activity as confirmed by Charles Nadjiwon.

Non-Core budget is the same in Comprehensive Contribution and multi-year funding agreements.

Post Secondary is part of core-budget. Adjustments of funding for education is not available if MBQ were under a multi-year agreement.

Core funding surpluses are not recoverable by INAC.

MBQ population is increasing at an approximate rate of 120 people each year.

INAC determines when demographics change and when it is to be considered for exceptional circumstance funding.

There is a minimum standard of delivery for programs under both the comprehensive and multi-year agreements.

Special Education has been transferred to a non-core activity. There is no negotiation on establishing initial core budget. INAC would only ensure MBQ is getting maximum entitlement.

Under multi-year funding agreements, First Nation Councils must ensure minimum program delivery standards are met.

A meeting of the Tyendinaga Mohawk Council was held on Monday, May 9, 2005 at 9:00 a.m. in the Council Chambers for Local Business.

Christine Claus and Erma Gray attended Council on behalf of the Tyendinaga Native Women's Association to request the rental fees for the Community Centre be waived for lying corn for community events and funerals and for craft night. The Native Women's Association was also requesting to have the fees waived for their regular meetings and executive meetings; however, Christine informed Council that the request was now for the Association's regular meetings only.

Hill, seconded by Blaine Loft that this Council approve a budget from Brighter Futures/Building Healthy Communities for the cost of the Community Centre rental fees for the Tyendinaga Native Women's Association for lying corn and craft night in the amount of \$2,400. Christine Claus stated she will waive the honourarium, but would request reimbursement for mileage for three (3) meetings per month for ten (10) months. The Board did not meet in July or August 2004. Christine Claus pointed out that the Board representative on all Boards have been paid with the exception of the representative on the Hastings Children's Aid Society which was implemented when she was appointed to the Board.

Larry Hay, Police Chief, Tyendinaga Mohawk Police Services, informed Tyendinaga Mohawk Council that Ontario Provincial Police (OPP) Sergeant Grant Hobson informed the delegation at Walpole Island on April 28-29, 2005, that the Government of Ontario and Government of Canada have decided to not fund the Association of Iroquois and Allied Indians Regional Policing Model where Tyendinaga would receive 12 officers. Larry believes Tyendinaga would receive only two (2) additional officers.

Larry Hay proposes that the Tyendinaga Mohawk Council request funding for community consultation for a Community Policing Model. The method of providing policing levels will be the OPP deployment model and Tyendinaga would lively receive only two (2) additional officers.

Why is the OPP holding the funds formally allocated for the Indian Commission of Ontario?

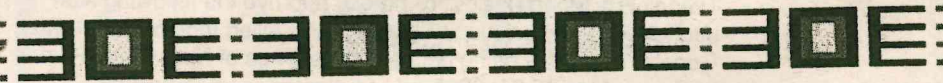

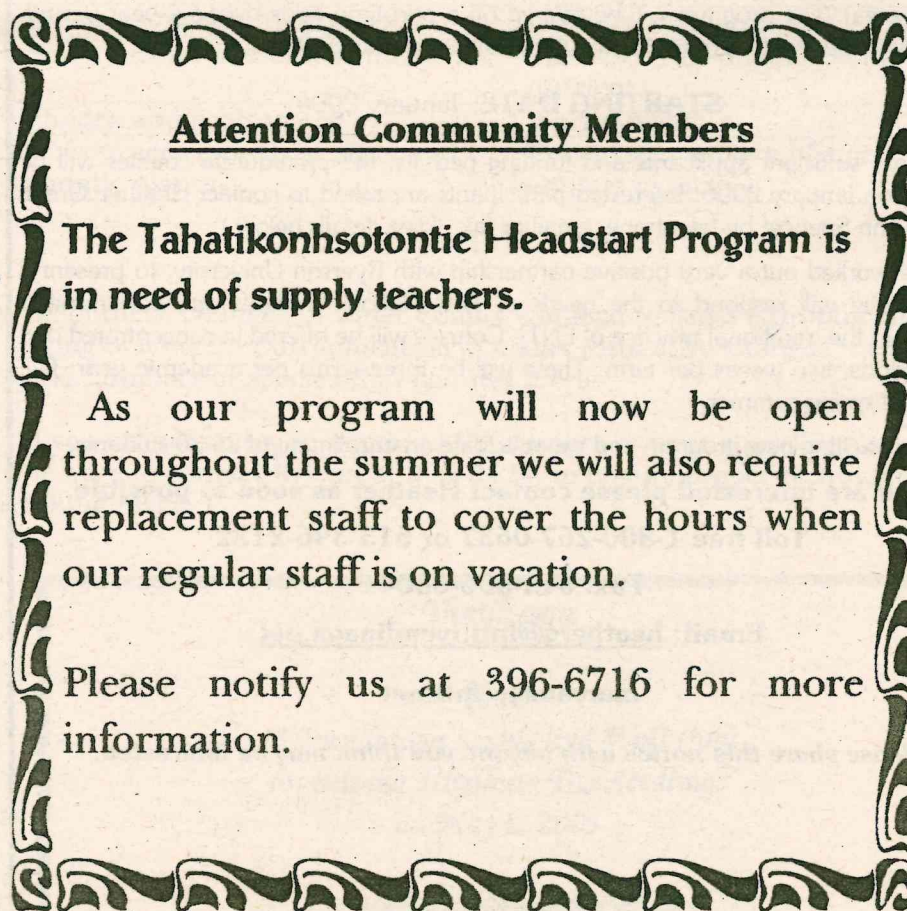

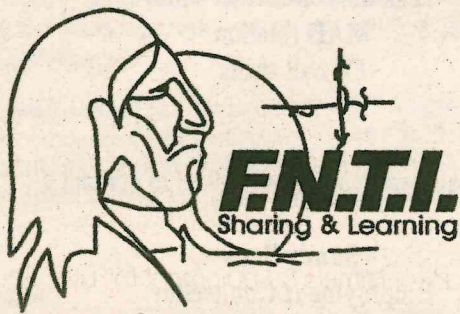
The Annual General Meeting for the Ontario Public School Board will take place June 9th to the 12th, 2005.

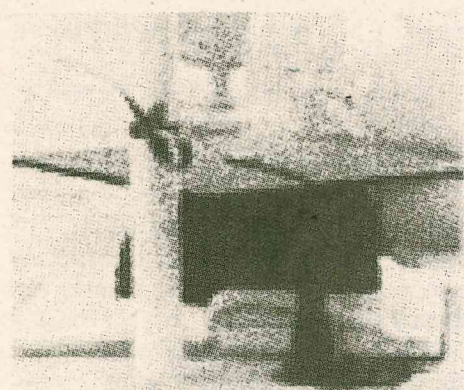

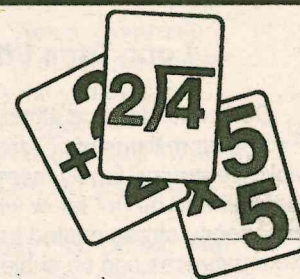

HELP - Helmets & Equipment for Little People

Dear Parents / Guardians

Prior to the completion of the 2005 school year, students of Quinte Mohawk School will be receiving a Bicycle Safety lecture delivered by the Tyendinaga Police Service. The lecture is designed to enhance personal safety and encourage compliance with applicable laws.

Statistics acquired from the Ontario Brain Injury Association and the Canadian Medical Association © report:

- 2001 - 2002 / 462 children, under 16 years of age, were hospitalized in Ontario due to bicycle related injuries
- annually, approximately 50 children & adolescents across Canada are killed as a direct result of bicycle related injuries
- head injuries account for 75% of all bicycle related deaths and use of an approved bicycle helmet can reduce this risk as much as 85%

It is the goal of the Tyendinaga Police Service, in partnership with, Canadian Tire - Belleville, Mohawks of the Bay of Quinte Band Council and the Tyendinaga Health Centre to ensure that all children on the Tyendinaga Mohawk Territory have an approved bicycle helmet available for use.

Canadian Tire has traditionally assisted with community programs concerned with the welfare of children and this is yet another example of their continuous support. Until June 30<sup>th</sup> 2005 Canadian Tire - Belleville is offering Mohawks of the Bay of Quinte Band Members the opportunity to purchase an approved bicycle helmet at a reduced price of \$9.99. This offer is restricted to product numbers beginning at 73-0460 and ending 73-0465. To access this program it will be necessary to produce a Mohawks of the Bay of Quinte Status Card, at the time of purchase, to the Customer Service Desk. A limited number of helmets have been acquired to assist those Members requiring financial aid, and can be accessed through Patricia Brant - Social Services Administrator Tyendinaga Health Centre.

## Long Term Effects of Woman Abuse on Children

Domestic violence affects children from every income level, race and religion. Each year millions of children witness violence in their homes. Seeing or hearing violence among family members hurts children in many ways. Even if you think that children do not know what is going on, think again. Even in utero, babies experience stress related to Domestic Violence. Babies born under these circumstances can be subject to many problems during birth and after.

**Remember, children do not have to be hit to feel the pain of violence!**

The majority of children from violent homes observe the violence inflicted by their fathers or male guardian upon their mothers. Most research suggests as many as 90% of children from violent homes witness the battering of their mothers. Children witnessing the violence inflicted on their mothers showed behavioral or emotional problems similar to those experienced by physically abused children demonstrating behavior that can be destructive not only to themselves but to others as well.

**In children of all ages look for the following warning signs of Long Term Effects:**

### Infants

- Disruption in eating and sleeping routines
- Fearful reactions to loud noises
- Excessive crying
- Physical neglect
- Delays in Development

### Preschool Children

- Low self-esteem
- Frequent illness such as headaches, or stomachaches
- Frequent crying
- Stuttering
- Poor concentration
- Eating and sleep disturbances
- Post-traumatic stress
- Fear
- Separation anxiety
- Anger and aggression and misread social cues from others
- Clinging
- Withdrawing
- Hitting, biting or kicking
- Unusual knowledge of sex or violence for their age
- Cruelty to animals
- Destruction of property
- Problems in pre-school/day care
- Pleasing behaviour
- Regressive behaviour (thumb sucking, bed wetting)
- Wanting to be held all the time or stiffening when held

### Elementary School Age 5-12 Years

- Low self-esteem
- Frequent illness such as headaches, or stomachaches
- Poor concentration
- Eating and sleep disturbances
- Post-traumatic stress
- Fear
- Difficulty trusting in or being comforted by a teacher
- Anxiety and tension

- Low self-esteem
- Frequent illness such as headaches, or stomachaches
- Poor concentration and distractibility

- Difficulty trusting in or being comforted by a teacher
- Anxiety and tension
- Anger and aggression and misread social cues from others
- Bullying
- Being abused or becoming abusive
- Depression
- Alcohol/drug use
- Self-harm
- Suicidal behaviour
- Inappropriate sexual behaviour
- Perfectionism
- Running away from home
- Pleasing behaviour
- Problems in school or dropping out of school
- Peer relationship problems
- Disrespect for females
- Feeling over-responsible
- Joining a gang, committing crimes, using weapons
- STD's (sexually transmitted diseases)
- Use of profanity and other violent words

Post-traumatic stress: Symptoms include nightmares, intrusive thoughts or images, flashbacks, fear, anxiety, tension, hyper-alert, easily startled, irritability, outbursts of anger and aggression.

All too often children who witness violence are also abused. They may suffer physical abuse (hitting, burning, etc.), Sexual Abuse (such as incest or sexual assault), emotional abuse (threats, put-downs, rejection, etc.) or neglect (such as lack of healthy food, clean clothes or health care). Thousands of children end up seriously injured or killed.

**Warning signs that differ for Male and Female children include:**

- Girls may act passively and withdraw from others
- Boys may act aggressively and lash out at others

Children may also suffer long-term effects. For example, they may grow up to become:

- Victims of more abuse
- Abusers – or they may commit other violent crimes

Some children are traumatized directly after witnessing violent altercations; others may exhibit symptoms of long-term effects. It is important to remember that not all child witnesses are traumatized by exposure to domestic violence, and resiliency studies identify certain protective factors that may assist children in developing healthy coping techniques. Nevertheless, most children exposed to domestic violence are affected, and living in an unsafe, unhealthy environment can result in negative consequences for children in adulthood.



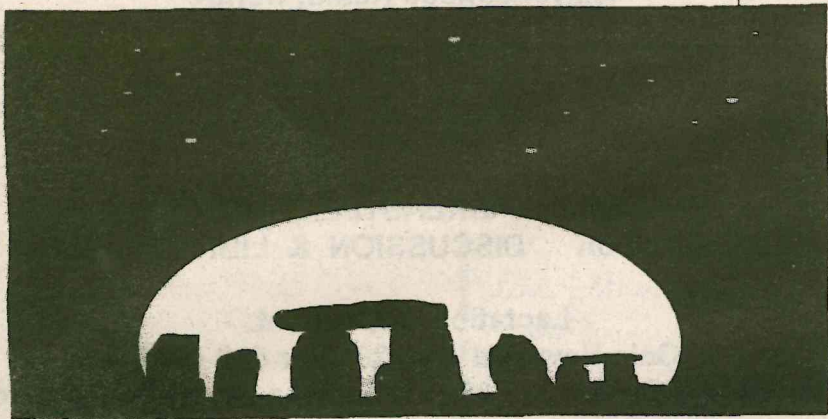

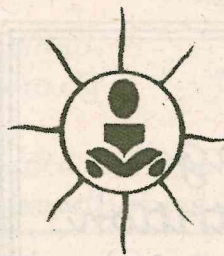

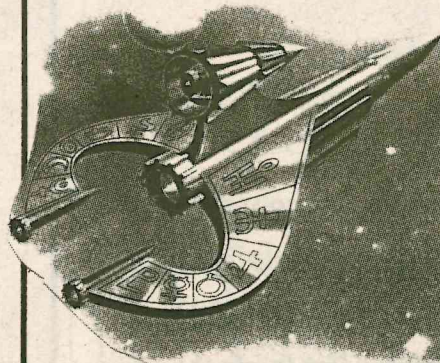

*"I have found a lot of breastfeeding informaton in books, magazines and on the internet. How do I decide whether the information I have found is accurate, reliable and supportive?"*

#### IMPORTANT THINGS TO CONSIDER ABOUT ANY BREASTFEEDING INFORMATION:

##### WHO IS PROVIDING THE INFORMATION?

BEWARE OF BIASES.

For example:

- **SOMEONE'S PERSONAL WEB PAGE.**  
This information may not be reliable but could have useful experiences from breastfeeding mothers
- **FORMULA COMPANIES**  
Promoting breastfeeding is not the goal of formula companies
- **ONLINE STORES SELLING PREGNANCY, BREASTFEEDING / BOTTLE FEEDING SUPPLIES**  
Although some have very good information, be careful. Providing breastfeeding information is also not the main purpose of the site.
- **LOCAL DOCTORS OFFICES, HEALTH CENTRES, HOSPITALS, CLINICS**  
Be cautious. Some do not realize that the info and magazines they are passing out contain outdated information and advertising propaganda which undermine breastfeeding.

##### WHERE IS THE INFORMATION COMING FROM? IS IT ACCURATE?

- Who funded the research? Is there a conflict of interest?
- Have the studies been published in respected journals, or only in newspapers or on the internet?

##### RE: INFORMATION YOU ARE UNSURE OF:

- **DOES IT MAKE SENSE TO YOU?** Don't practise anything you don't fully understand or feel comfortable with.
- **CHECK WITH A BREASTFEEDING PROFESSIONAL.**
- **DO MORE RESEARCH.** If you find a piece of information that looks to be of value, check around other web sites, mothers who have tried it, and non-internet resources.

#### What are the Symptoms

- ⌘ Unusual thirst
- ⌘ Urinating (pee) more than usual
- ⌘ Weight change (gain or loss)
- ⌘ Tired a lot or lack of energy
- ⌘ Blurred vision
- ⌘ Frequent infections
- ⌘ Cuts or bruises slow to heal
- ⌘ Tingling and numbness in the hands and feet
- ⌘ Trouble getting and keeping an erection

It is important to recognize that many people who have Type 2 Diabetes may have NO SYMPTOMS.

#### How do you know if you have diabetes?

Early diagnosis is extremely important! Steps can be taken to manage the diabetes and prevent or delay complications.

Screening should begin every year at the age of 40 or younger if there is family risk factors.

#### Can you prevent diabetes?

Scientists believe that lifestyle and Type 2 diabetes are closely linked. This means that lifestyle is one area that YOU can focus on to help prevent or delay the onset of diabetes. A healthy mealplan, weight reduction, physical activity and stress reduction are important prevention steps.

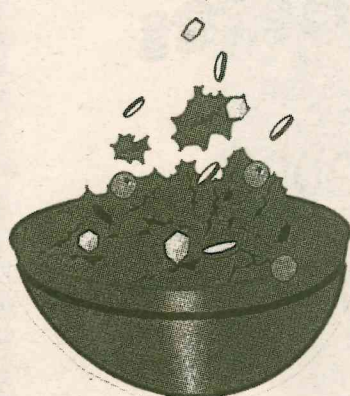

- add a low-fat salad dressing of your choice

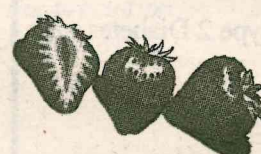

Strawberries are packed full of powerful antioxidants which can reduce the risk of cancer. They are also loaded with fibre, folate, potassium and vitamin C.

Strawberries were also one of the first medicines of our people and have many different uses in traditional medicine

They are delicious enjoyed fresh on their own for a snack or dessert, or can be incorporated into many desserts, jams, jellies, chutneys, salads, baked goods, frozen treats, etc.



### Strawberry-Spinach Salad

- 2 cups spinach, chopped
- ½ cup strawberries, sliced
- 1 tbsp chopped
- 1 ½ tbsp raspberry vinaigrette

- toss spinach, strawberries and walnuts
- drizzle vinaigrette over salad

### Frosty Strawberry Pops

- 2 cups strawberries, chopped
- 1 can (5 ounces) evaporated milk
- 3 tbsp frozen orange, cranberry or pineapple juice concentrate

- in a blender, blend all ingredients until smooth (about 1 min)
- pour into small wax-coated paper cups
- insert wooden popsicle sticks
- place in freezer until firm ( about 4 hours)

### Strawberry Smoothie

- 1 cup skim milk or vanilla soy milk
- 3 tbsp wheat germ (optional)
- ¾ cup sliced strawberries
- 1 small banana
- 4 ice cubes

- clean, peel & slice fruit
- add all ingredients to blender and blend until smooth

### Strawberry Tips



- pick your own berries at a local farm
- fresh strawberries can be frozen and enjoyed year round
- when buying packaged berries look for completely red, firm berries free of mold
- to avoid browning, berries should not be left at room temperature for more than a few hours

### Coleslaw with Apples and Raisins

- 1 medium carrot, diced
- 1/3 cup red onion, finely chopped
- 1 ½ cups white cabbage, thinly sliced
- 1 ½ cups red cabbage, thinly sliced
- 1/3 cup apple, diced (unpeeled)
- 1/3 cup raisins

#### Dressing

- ¼ cup light mayo
- 2 tbsp 2% yogurt (plain)
- 2 tbsp lemon juice
- 1 ½ tsp honey

- combine carrot, onion, cabbage, apple and raisins
- in a separate bowl mix together dressing ingredients
- pour dressing over salad and toss gently

### Broccoli, Snow Pea and Baby Corn Salad

- 2 cups broccoli, chopped
- 1 cup snow peas, cut into pieces
- ½ cup red onion, sliced
- half sweet red pepper, sliced
- 3 cups romaine lettuce, torn
- ¾ cup mandarin oranges
- ½ cup sliced water chestnuts
- 8 drained canned baby corn cobs
- 1 tbsp raisins
- 1 tbsp chopped walnuts

#### Dressing

- 3tbsp olive oil
- 3tbsp frozen orange juice concentrate, thawed
- 1 ½ tsp red wine vinegar
- ½ tsp crushed garlic
- 4 tsp lemon juice
- 1 tsp granulated sugar

- steam or microwave broccoli and peas just until tender-crisp. Drain, rinse and pat dry
- mix in other ingredients
- in separate bowl mix together dressing ingredients
- pour dressing over salad and toss

## NATIVE INSTITUTION WOUNDED BY GOVERNMENT'S MISTAKE

Despite federal government promises to improve post-secondary education for aboriginals, one of Ontario's leading aboriginal education institutions was dealt a severe blow recently forcing major cuts and layoffs.

To compensate for a 44 per cent cut in funding from Indian and Northern Affairs (INAC), First Nations Technical Institute (FNTI), located near Belleville, Ont., has slashed its operational budget. A 20 per cent salary cut to all 65 employees starts in June. In addition, as many as eight staff members will face temporary lay-offs for the rest of the fiscal year. Ironically, FNTI is celebrating its 20th anniversary of exemplary educational service this year.

The cause of the cuts is the belated (auditor general-induced) discovery by the government in 2003 that it had been funding \$2.2 million of FNTI's longstanding \$2.7 million INAC contribution from the wrong funding envelope. INAC initially indicated that FNTI would have to find another source for the entire \$2.2 million. Last year Minister of Indian Affairs Andy Mitchell and INAC staff cobbled together a temporary solution. However, this year, after considerable anxious discussion with Minister of Indian Affairs Andy Scott, the department has indicated that while it can't find all the lost funds they have agreed to provide an additional \$1million. FNTI is still \$1.2 million short.

The Institute has been very successful in generating its own revenues. In 1985, when FNTI opened its doors, 90 per cent of its funding came from Indian Affairs. Today, before the cuts, INAC funding comprises just over 40 per cent of the total operating budget, comparable to government funding afforded to mainstream colleges and universities.

Auditor General Sheila Fraser exposed serious issues of lack of accountability and authority in the handling of aboriginal education by INAC, yet FNTI has filed clean independent audits annually from its inception and had not been asked to change its practices prior to the withdrawal of funds.

"FNTI is renowned as the only native-governed flight-training program in North America, and as an international leader in culturally sensitive prior learning assessment," said FNTI vice president Richard Johnston, the recently retired President of Centennial College in Toronto, member of the Rae Review Panel and a past Chair of the Ontario Council of Regents. FNTI is currently running a program in Chile. "Its graduation, employment and student satisfaction are the envy of mainstream institutions," said Johnston.

Graduates of the public administration degree program have gone on to become elected leaders in their communities, while the welfare administration offices of virtually all the First Nations communities in Ontario are sprinkled with FNTI grads. It is hard for the institute to believe that the government would jeopardize this capacity-building record by downloading its mistake onto the institution.

"We are proud of our graduates and our mission to provide respectful, holistic learning opportunities and experiences that enhance the capacity of First Nations people to regain control over their social, political, cultural and economic future," said FNTI board chair Mark Green. Green said FNTI is both willing and able to take up the Prime Minister's challenge and be part of the new collaborative policy making his government has promised.

The institute wants its traditional funding levels returned until the outcomes of the Aboriginal-Canada Roundtable on life-long learning are implemented. It needs this multi-year commitment because many of its students take four years or more to complete their programs and they need to be sure of the continuity of the programs they are in. The delivery is sufficiently unique that it would be virtually impossible for most of them to transfer to mainstream institutions even if that were their choice.

Without aboriginal institutions like FNTI, Johnston said many students who wish to pursue higher education will not have the opportunity. "Some students may lack the marks to compete for a spot at a mainstream college or university. These students are often screened out in the application process." Johnston said that many aboriginal students seeking higher education prefer to attend an aboriginal institution that incorporates aboriginal culture and uses aboriginal instructors. "The present federal approach is to focus on putting money into the pockets of the students, but there is little understanding of the value that aboriginal institutions offer in contributing to success in the post-secondary education of aboriginals," Johnston added.

Last year, when the issue was first raised, the money was eventually found and reinvested, but not until 17 people suffered through an extended lay-off. "It is very hard on the staff to go through this for a second year and very unsettling for students. The uncertainty will also have a negative impact on applications," he said.

FNTI is the second largest employer in the Tyendinaga Mohawk community creating 65 jobs and injecting approximately \$6-million annually into the local Quinte area economy.

"We have had very cordial conversations with the Minister and regional INAC leaders," said vice-president, Richard Johnston. "Minister Scott, in particular seems to understand that it is illogical to damage the capacity of one of Canada's oldest and pre-eminent aboriginal institutions at the very point that he and the Prime Minister have been preparing for a nation-wide investment in aboriginal learning," he added. "They just seem incapable or unwilling to solve the problem they have created."

FNTI calls on the government to take responsibility for its mistake and to not place the consequences of its error onto the backs of the institution and its students.

Erica (15 yrs) wrote a myth for her Grade 10 academic English. Her teacher, Mr Watson submitted the whole class's writings.

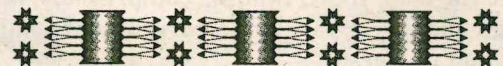

### POSTCARDS FROM THE VISION QUEST

#### Assessing Native Life in the 21<sup>st</sup> Century

For me, "Episode VI – Return of the Jedi" was the first of the three Star Wars movies that I saw. I watched it twice in the movie theater the summer it was released. It was with the summer camp that was at the council house that I watched the show the first time (do they still do that there?); then, again with my family only a few weeks later.

A quick Internet search reveals the movie came out in 1983 which means, given it was early summer, I was about to turn 7 years old. That's really young. In fact, as I sit here, I find myself re-evaluating parts of my personal history from that time. Anyway.

An irony for me, and perhaps a lot of people, is that we can't go back to the 1980s when the first trio of films came out and bring with us the wonderment of those first viewings.

The fact that my imagination was piqued with 'Return of the Jedi' cannot be erased. Popular opinion suggests "Episode V – the Empire Strikes Back" was the best of the entire series but, again, I feel I was too swept away by '...the Jedi' that, when I eventually saw '...the Empire' I could only be let down.

In a sense, then, the brand new 'Revenge of the Sith' has far too much to live up to. As far as I'm concerned, the cards were stacked against it long before the film was made (and long before I ever knew why).

Something similar happens when a singer remakes an old song. It's Sunday morning right now in Nashville. We've been hitting 80 degrees for the past couple weeks and my almost thirty year old Canadian bones aren't ready for it; I'm still well padded for another month of winter and spring. In the other room, on the radio I'm listening to one of those country music countdown shows, something I've done for about 15 years now.

One of the songs is a remake of an old Conway Twitty song called, "Goodbye Time." It's been re-done by Blake Shelton (who an old friend of mine dated a year or so before he became a star, incidentally). It's a beautiful song. Always has been, but it doesn't matter how often the radio stations play the new version, my mind will always drift back to summer 1988. I listen now and pick out every difference between the original and the remake.

There's nothing wrong with the new version. In fact, it's great just to hear it on the radio again, regardless to who's performing it. Makes me wonder just what we're supposed to appreciate from the past, what we're supposed to leave behind, and what we should really hold onto and bring with us.

Lately I've been totally intrigued by a new book called, "The World is Flat: A Brief History of the 21<sup>st</sup> Century" by Tom Friedman. Well ... hang on just a sec.

For a more detailed history, check out Friedman's "The Lexus & the Olive Tree: Understanding Globalization." First published about five years ago, it defines the globalization movement in a way that's accessible to everyone:

"Half the world was lusting after those Lexuses (the car), or at least the brilliant technology that made them possible, and the other half was fighting over who owned which olive tree."

As the foreign-affairs columnist for the New York Times, Friedman was essentially saying that globalization (everything made in China, sent to Wal-Mart, then sold around the world) is the organizing principle of the post-cold-war world; but that individuals and nations resist by holding onto what has traditionally mattered to them – the "olive tree." (Credit: amazon.com for that summary)

Hi. We're a bunch of Native North American Indians and that kettle is black.

The new book, "The World is Flat" expands on that thesis with more powerful examples. A bulk of the service industry, which only a few years ago was hyped as the new economic focus of the West, has now been outsourced to India, for example. The world is flat, he says, because people don't have to move to America or, simply, away from home to be productive and successful; technology and the digital revolution has made doing business with billions of people possible for all of us.

Isn't this borderless world what Native people have always longed for? Is this the point where we step up to the plate like we've been threatening to for the past 200 years?

What should we be doing to capitalize on this? In a sense, a lot of us – if we're too caught up in our own plans, or nailed down by our old mistakes – may feel as though we should just watch this train pass. I don't think we should.

I watched a TV interview with Friedman that aired last weekend. He pointed out that at the dawn of the industrial age people had to attend high school in order to advance from the agricultural age. We're at a point now where everyone in this society must attend some form of post-secondary institution to survive (not in the dying industrial age) but the global, digital one.

Isn't it obvious now, historically, to see the reasons why Native people didn't jump on board that whole progression from the agriculture society into the industrial one?

Friedman suggests high school students consider a bachelors degree in Engineering and a Masters in business. With the exception of luxuried 500-channels-and-nothing-on North Americans, young people in other countries are being educated in these industries at an amazing pace.

There are other cultural issues to contend with. Americans aren't terribly receptive to religions beyond Christianity. This is, of course, similar with Middle East Muslims. But you know what? That's the exact same situation we face as Native people in North America: we're just as misunderstood and, therefore, relegated to the sidelines economically. What this new flat world does is level the playing field for ALL of us; not just Indians from India. "Indians" from here, too.

If people from other countries, like India, can take their culture with them when they go away for education – to lands, like America, where they are a great minority – and take it all back to their homelands after graduation, why can't Native people?

There's a lot to think about here and I don't quite think I'm done with this topic. I mean: there are reasons people move off the rez and reasons why sometimes they move back and reasons why many don't move away in the first place, right?

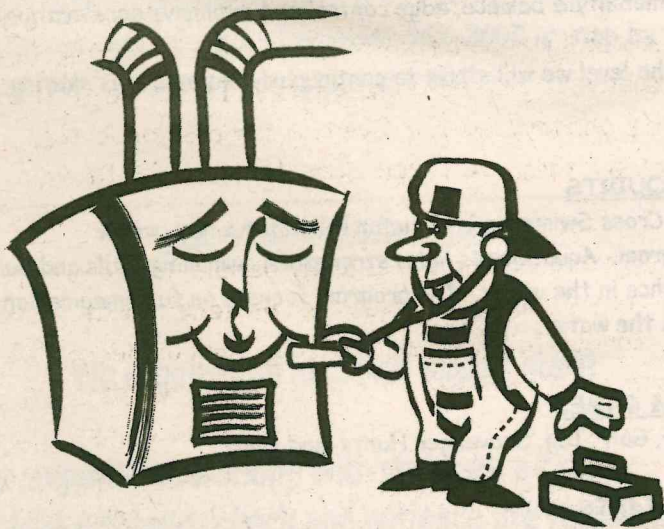

PRESERVING AND RESTORING NATURAL SHORELINES

Natural vegetation along the shoreline of lakes and rivers plays a crucial role in protecting water quality, preventing soil erosion and preserving the ecological balance of aquatic environments. However, much of the natural vegetation around Ontario lakes and rivers has been cleared or replaced with non-native species, resulting in the loss of wildlife habitat and reduced water quality.

Ninety per cent of all lake life is born, raised and fed in the area where land and water meet. The shallow water and the first 10 to 15 metres of shoreland forms a ribbon of life around lakes and rivers that is essential to the survival of many species. This rich and complex habitat supports plants, micro-organisms, insects, amphibians, birds, mammals and fish.

Unaware of the importance of shoreline vegetation, many landowners clear their shorelines and transform them into urban landscapes. They destroy the cattails, bulrushes and other native species, and replace them with lawns, and non-native species. They also build retaining walls, docks and boathouses. These changes destroy the balance of the aquatic and shoreline ecosystems. They also alter the wildlife habitat, natural beauty and character of our lakes and rivers.

Natural shoreline vegetation plays an important role in preventing soil erosions. Plant roots anchor the soil, preventing shoreland from being washed away by currents, waves and rain. The roots of mature trees reach down to the upper levels of the water table. Dogwood and meadowsweet roots form a web that extends a half-metre downward, these native species are far more effective in protecting properties from erosion than the roots of grasses, which only reach eight centimeters below the surface.

By preventing erosion and run-off, natural shoreline vegetation also improves water quality. When soil and excess nutrients are washed into the water, fish spawning beds can be destroyed, dissolved oxygen is depleted and the growth of algae and aquatic plants is encouraged. Shoreline vegetation also improves water quality by shading and cooling shallow water.

NATURAL SHORELINE VEGETATION	NO SHORELINE VEGETATION
Provides shelter and food for wildlife	Does not provide shelter and food for wildlife
Supports spawning beds for fish	Degrades spawning beds for fish
Enhances water quality	Decreases water quality
Traps run-off and excess nutrients	Increases run-off and excess nutrients
Shades and cools water	Warms water
Discourages growth of algae and aquatic plants	Encourages growth of algae and aquatic plants

All of these changes in water quality can lead to rapid eutrophication (the aging of a lake). Eutrophication of a lake ultimately changes the kinds and numbers of species that can live there.

- If you are unable to bring a food item for the picnic, you and your family are still welcome to attend, as there will be plenty of food for everyone

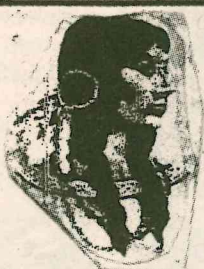

# RECYCLING

## Recycling Update

### Mohawks of the Bay of Quinte

Waste Reduction is a way of life both at home and work. One tonne of recycled paper saves 19 trees, 3.3 cubic yards of landfill and 4100 kW hours of electricity (enough to heat a home for 6 months or run a television for 31 hours!)

Please Recycle



#### #1- Plastic and Metal Containers

Please deposit these items in the blue totes.

##### Metal Food and Beverage Cans

Empty cans and lightly rinse. Place metal lids from cans (and glass jars) inside the can and pinch the top to trap the lid inside. Please do not place pop cans inside of food cans. DO NOT include, metal pots, butter wrappers or scrap metal.

&



##### Rigid and Foam Plastic Containers

Empty and lightly rinse your containers. Discard the lids. All plastics with the numbers 1 to 6 on the bottom are OK. Include plastic containers for soft drinks, detergent, bleach, juice, shampoo, yogurt, ice cream, Styrofoam coffee cups, trays and packaging. DO NOT include drink boxes, medicine bottles, toys, parts, or blister/bubble pack.

&



##### Empty Aerosol and Paint Cans and Aluminum Trays & Foil

Please make sure that aerosol cans and paint tins are empty and dry (remove the lids from empty paint cans and let them dry out before recycling. Aluminum trays and foil such as pie plates, fast food trays and clean aluminum foil. DO NOT include propane tanks, any paint cans that have product in them or if larger than 1 gallon or, any hazardous product.

#### #2 Clear Glass & Coloured Glass

Please separate your clear and coloured glass and deposit it in the steel drums at the depot.

##### Clear and Coloured Glass Bottles and Jars

Separate your clear glass from your coloured glass. There are Blue Boxes for each type at the depot. You can recycle the metal caps with your Metal Cans. DO NOT include anything that is not a glass beverage or food bottle or jar. NO ceramics, dishes, cups, window glass, light bulbs, mirrors, Pyrex, drinking glasses or special coated liquor bottles.

#### #3 Mixed Household Paper

Please deposit all household and office paper in the blue totes.



##### Mixed Household Paper

This includes junk mail, paper bags, egg cartons, paper tubes, sugar and flour bags, rinsed milk or juice cartons, cereal, detergent and snack boxes, books, computer paper, Newspapers, Magazines, Telephone Books and other paper items. Please remove any food or liners and flatten boxes. DO NOT include, soiled boxes, serviettes, Kleenex or paper towels.

#### #4 Film Plastic

Please deposit empty bags in the blue totes.

##### Plastic Bags, Pallet Wrap or Film Plastic

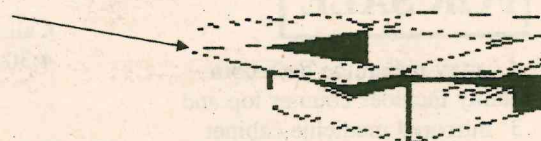
Fill a plastic bag with plastic grocery bag, rinsed milk and vegetable bags, bread newspaper, parts and dry cleaning bags. Outer film wrap from toilet paper, cases of pop and produce are OK too. DO NOT include dirty or soiled material, chip/snack bags, meat or cheese wrap, saran wrap, candy wrap, vinyl or rubber products. Please remove any food, crumbs or paper receipts. Tie your full bag shut and place it inside the depot container.

#### #5 Old Corrugated Cardboard

Please break down your cardboard boxes and place inside large cardboard boxes.

##### Cardboard Boxes

This is the type of box or case used for shipping packing larger items such as furniture, appliances and computers. The boxes have three layers with a wavy section in the middle. Please flatten your cardboard boxes down and place in the large Gaylord boxes in the corner. DO NOT include coated or waxed boxes or dirty pizza boxes.
