Ontario Well Water Study Information Sheet

Safe drinking water is important for everyone. In Ontario, about 90% of all drinking water samples that test positive for bacteria are from private drinking water sources such as wells. Some of the bacteria in well water, including certain kinds of bacteria called *Escherichia coli* (*E. coli*), can be resistant to a number of the antibiotics used to treat infections. There are many unanswered questions about how antibiotic resistance develops; some scientists think that antibiotic resistant *E. coli* in water may be one source of antibiotic resistant infections in people.

From May 2005 to December 2006, a group of doctors and scientists from the University of Western Ontario and the University of Toronto will be studying how drinking or using contaminated well water affects people. This study will determine possible factors (e.g. type of farm, soil, or well) that could contaminate private wells with antibiotic resistant bacteria. It will also determine whether antibiotic resistant bacteria in drinking water might be a source of antibiotic resistant bacteria in humans.

Since you have submitted a water sample for testing, you may be telephoned a few weeks after your water sample is tested to ask if you would be willing to take part in the study. The researchers need to talk to some people with water that tested positive for *coli* and some people whose water tested negative. Only a small fraction of people will be selected at random, will be telephoned. If you do receive a call, it will be from a member of the Safe Water Unit at the Ministry of Health and Long-Term Care. That person will ask permission to give your phone number to the researchers. You do not have to take part in the study if you do not want to. If you consent to participate in the study, the Ministry of Health and Long-Term Care will disclose your contact information to the researchers. The researchers will then contact you to arrange an interview. If you decide not to participate in the study, the Ministry of Health and Long-Term Care will not disclose your contact information to the researchers. Whether you decide to take part in the study will not affect future water testing in any way.

REMOVAL OF MATERIALS FROM TERRITORY

Are you removing soil, gravel, sand or timber from the Territory for sale in the surrounding municipalities?

Did you know that these activities are in violation of s. 93 of the Indian Act?

Section 93 of the Indian Act is outlined as follows:

93. Removal of material from reserves - A person who, without the written permission of the Minister or his duly authorized representative,

- a) removes or permits anyone to remove from a reserve
 - i. minerals, stone, sand, gravel, clay or soil or
 - ii. trees, saplings, shrubs, underbrush, timber, cordwood or hay or
- b) has in his possession anything removed from a reserve contrary to this section,

is guilty of an offence and liable on summary conviction to a fine not exceeding five hundred dollars or to imprisonment for a term not exceeding three months or to both.

TYENDINAGA MOHAWK COUNCIL MINUTES APRIL 6, 2006

A special meeting of the Tyendinaga Mohawk Council was held on Thursday, April 6, 2006 at 10:30 a.m. in the Council Chambers to review Capital Plan.

Present: Chief R. Donald Maracle
Councillors: Barry Brant, Trevor Lewis, Roy C. Maracle and Blaine Loft arrived at 11:00 a.m.
Staff: Rod Jeffries, CAO

The Capital Plan meeting discussion started at 11:35 a.m. with Peter Brant and Todd Kring attending following a private session with community members.

Airport Water System

Council discussed a D & K Manufacturing proposal for a water treatment facility to serve the Mohawk Airport area.

Shannonville Industrial Park

Peter questioned what is Council going to do for infrastructure and Barry Brant's concept about leasing land in the industrial Park.

Barry reported to Council that Ian Hilton formerly an ONAS employee, (now Ministry of Aboriginal Affairs) is a knowledgeable person regarding economic development grants for industrial parks development and that a lot of money was available for this purpose a few years ago.

The development costs for infrastructure development is \$477,500 plus engineering costs for Phase One, 19 lots.

Peter Brant and Todd Kring will conduct research on potential funding for development costs.

Council is interested in a new contractual arrangement to protect the environment.

Wastewater Peat Land System

Need to lobby INAC for peat land system for new submission. Lobby package will be for design dollars. Document completed by F.N. Engineers.

Landfill Closure

Council reviewed March 31, 2006 document from XCG Environmental Consultants regarding the Tyendinaga Landfill Site. Option No. 5 is being pursued - bin system haulage by Nibourg to LaFlesche Landfill Site at Moose Creek. MBQ will need \$496,694.00 capital funding from INAC to implement the plan.

All numbers are using a 4% growth rate for the community.

An operating budget of \$133,777.00 is needed for Option 5.

Fire Hall

Calvin Brant designed the new Fire hall concept and requires \$18,400 to update the costs for the new Fire hall. Council was requested to approve to go to tender to determine the cost of construction of the new Fire hall.

Council requested investigation for funding sources for new Fire hall to cover design engineering and construction costs for Fire hall.

Administration Building

Three options were developed by staff on a new administration building. Staff has consulted with some community members on the concept design. Council reviewed a turtle shaped sketch design. Some community members thought the building should look more Native.

ADMINISTRATION

Step One

Know who you're dealing with

Good contractors have satisfied customers. Ask contractors to provide customer references for projects similar to yours. Then take the time to call these homeowners and ask if the work was done properly, on time, and on budget. Find out if any follow-up work was needed and if this was done satisfactorily. Also ask if they would hire the contractor again.

If a contractor is unwilling to provide references, don't hire them.

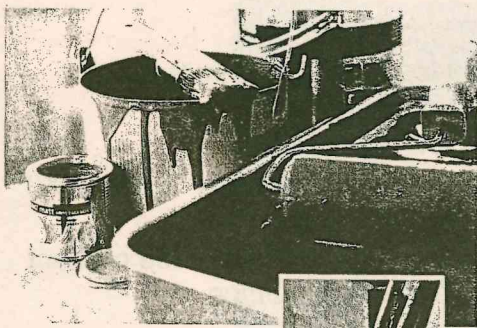
Step Two

Make sure you're protected from risks

When a contractor works on your home, you need to be protected from a number of risks. These risks exist whether you are hiring someone for a simple home repair, a large renovation project, the construction of a new home or cottage, or to work on a rental property you own.

Here are some things you should know:

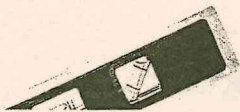
- A contractor's **business liability insurance** can protect you if your home is damaged through your contractor's fault, or if the contractor causes damage or injury to third parties, like your neighbours.
- Most contractors are required by law to have **Workers' Compensation** coverage. If you hire a contractor who does not have this coverage, you face an increased risk of claims or financial loss if a worker is injured on your project.
- A contractor's valid **Business Number** or **GST/HST number** tells you that they are registered with the Government of Canada.
- The **lien regulations** in your province specify how much money you must hold back from payments. This protects you if your contractor fails to pay suppliers or subcontractors.
- A contractor's **written warranty** specifies what is covered and for how long. When you hire a contractor to build a new home on land that you own, insist on coverage under a **new home warranty program** in your province.
- **Written receipts** for all deposits and payments you make to a contractor provides proof that you have paid.



It's also important that your project complies with local **building codes**. Any change to the structure of your home, even something very minor, requires a **building permit**. Home-

owners are responsible for obtaining a building permit; however, your contractor can usually get the permit on your behalf.

Inform your **home insurance** company before any work begins. Some homeowner policies don't cover construction-related risks or theft of building materials from the work site. Call your home insurance representative to make sure that you have adequate coverage.

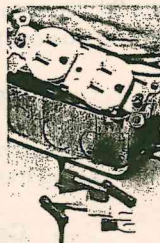


Step Three

Get it in Writing!

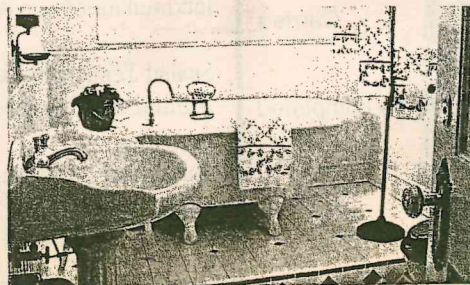
Having a written contract is essential. It helps protect you from the nightmare of lawsuits that can result from accidents, work-related injuries, or damages to third parties. Even for small projects, it's important to make sure you're protected. **The size of the job does not limit the liability you face if an accident occurs.** And accidents can happen even with the simplest home repairs.

A written contract also helps protect you from many other potential problems. Without a contract, you could lose any deposit or advance payment given to the contractor, or find yourself charged far more than you expected. Also, there is little you can do about poor quality or incomplete work. And you have little assurance that you will get warranty coverage and after-sales service.



A contract doesn't have to be complicated. For simple home repairs, it could be only a page long. For bigger projects, you'll need more information such as drawings and a specification list. Although the following list is not comprehensive, it provides examples of the information that should be in all contracts:

- The name, address and telephone number of the contractor



- A full description of the work and the material and products to be used
- When the work will start and be completed
- How much you will be charged for the work and when you will have to pay
- The amount of payment you will hold back as required by the lien legislation in your province
- The contractor's warranty detailing what is covered and for how long
- A certificate from an insurance company proving that the contractor carries business liability insurance
- A letter of clearance from your province's workers' compensation program confirming the contractor is registered
- The contractor's Business Number or GST/HST number and
- The contractor's business license number (where required by the municipality)

Most often, the contractor will draw up a contract for you to review. Don't sign it unless you are satisfied that it includes all the necessary information and accurately represents what you have agreed to.

Professional contractors always work with a proper, written contract. Their price includes protection you need in case something goes wrong or an accident occurs. This is a valuable part of the service you're paying for.

What to do when you hire a contractor

How to find a good contractor



- Ask friends, family and neighbours about contractors they have hired to work on their homes.
- Contact your local Home Builders' Association or other trade association for a list of professional contractors in your community.
- Ask your local building materials store if it has a list of recommended contractors.
- Ask your utility company if it has a list of recommended contractors.
- Check with your local Better Business Bureau to find out if a contractor is a member.

Many experienced and reliable contractors work in your community—highly skilled professionals who do business the right way.



Unfortunately not all contractors play by the same rules. Some cut corners to offer lower prices. They promise you a "good deal" as long as nothing is written down and you pay in cash.

These cash deals can mean a lot of risk for you. Contractors who don't do business properly don't protect you from accidents or their mistakes. If there is a work-related injury or damage to your home, you could face lawsuits and financial loss. You could be responsible for your contractor's unpaid bills. And you could be stuck with work that is incomplete or badly done.

While serious, these risks are easy to avoid. Before you agree to let anyone work on your home, take these three simple steps: know who you're dealing with, make sure you're protected from risks, and always **Get it in Writing!**

Monthly Trustee Report : May 2006

While the HPEDSB is preparing for final year end activities for staff, schools, programs and budgets another year is already beginning with the cycle to be repeated for next school year.

I mentioned in last months newsletter that I would list some of the areas that I have responsibility for in serving as Trustee for Tyendinaga First Nations. I have taken much of this information from the Handbook for Trustees, School Boards and Communities entitled EDUCATING TOGETHER which is coordinated by Ontario Public School Boards Association and four other sponsoring organizations including the Ministry of Education for Ontario. This booklet covers many areas including the Role of Native Representatives.

The role of all Trustees is to help create the vision and set strategic direction that will guide the Board and its schools. As the representative of the First Nations Students, I am in the unique position to insure that the Native Culture is part of that vision and that the strategic direction of the board includes the interests of the First Nations Community.

I am also responsible for:

- monitoring the negotiation of the tuition agreement;
- ensuring that the actions of the board reflect the tuition agreement;
- ensuring that both parties of the agreement are fulfilling their obligations;
- ensuring that mechanisms are in place for effective accountability to the First Nations Community;
- ensuring that racism and harassment are not part of the Native students experience at school;

I am in a position to encourage the involvement of the parents and the First Nations Community in the Native students education. One of the recommendations of the Report of the Royal Commission of Aboriginal Peoples is that all schools serving Aboriginal children adopt policies that welcome the involvement of Aboriginal parents, elders and families in the life of the school - for example, by establishing advisory or parent committees, introducing teaching by elders in the classroom, and involving parents in school activities.

I feel that my years of experience in education has also put me in a position where I can listen and advise students, parents and Band Council on issues that present problems, or just to work for improving the quality of education on our Territory.

I also set on the following committees of the Board

- operations and finance committee;
- suspension/ expulsion appeal committee;
- supervised alternative learning for excused pupils;
- equity and diversity policy steering committee;
- as well as attend all committee of the whole and regular public Board meetings.

ARTS ACCESS 2005 -2008 by Bernadette Wabie

After three years of discussion and research the Art Gallery of Ontario, the Thunder Bay Art Gallery, the Woodland Cultural Centre and our new partner the Kitchener-Waterloo Art Gallery is launching a three year Provincial Art Education Initiative entitled "ARTS ACCESS".

PRESS RELEASE (Toronto: September 12, 2005):

This fall the Art Gallery of Ontario (AGO) will launch Arts Access, a three-year interregional arts education and outreach program, in conjunction with the City of Toronto Culture Division, Museums & Heritage Services, the MacLaren Art Centre, the Multicultural History Society of Ontario, the Thunder Bay Art Gallery, the Toronto District School Board and the Woodland Cultural Centre.

This initiative was recently awarded \$637,700 by the Ontario Trillium Foundation's province-wide program, \$306,800 from the Virtual Museum of Canada and \$75,000 from The Salamander Foundation. The combined total of \$1,019,500 enables Arts Access to engage community members in cultural activities through artist-led workshops for all ages across the city and province.

Over 50,000 participants in Toronto, Thunder Bay, Barrie and Brantford will explore their local identities and the future of their communities by working in galleries, schools, community centres, festivals, and public spaces. Individual and collaborative responses to the project will result in exhibitions, theatre projects, community murals and new curriculum. The projects will be interconnected and shared in Collection X, an eclectic citizen-generated on-line archive that brings images, oral narrative and artworks by community participants in all four regions together with the collections of art galleries and other public institutions.

WHAT IS ARTS ACCESS?

Arts Access is an opportunity for community members from Six Nations, Wahta, Tyendinaga and Brantford to interact with three First Nations Artists who will host workshops at the Woodland Cultural Centre and in communities. Participants will have the opportunity to discuss and create art as it pertains to the theme of "Home". As well the Artists and participants will have a chance to explore the Woodland Cultural Centre's collection to see how the "Home" theme is represented within the collection. Selected art from the workshops will be exhibited within the

Cultural Centre and virtually on the Collection X web site.

Collection X will enable participants to comment on institutional collections, and add their own mementos, artworks and writing to create stories, tours and albums from the database's vast holdings. Collection X allows for increased access to collections and demonstrates the importance of community involvement in museum processes, including collecting, curating and interpretation.

The website component of Arts Access will be piloted in the Spring of 2006. Participants will be able to create their own art gallery by selecting and commenting on the images they like from the large database contributions from each Art Gallery.

WOODLAND CULTURAL CENTRE'S ROLE:

The Woodland Cultural Centre will be providing access to the Artist lead workshops at the Centre and in the communities. Artists will have the opportunity to explore the Centre's collection to identify works of art that reflect the "Home" theme. Workshops will be developed based on the selected pieces. Artists and participants will then interpret those items and create their own art.

The Woodland Cultural Centre will also be working with the other Arts Access Partners to discuss how the project is evolving in the other communities. We will be assisting with curriculum development and creating opportunities for artist and participant discussions among the partners.

WORKSHOPS:

The Cultural Centre will be hosting over fifty workshops in Year One and over two-hundred workshops in Year Two and Three.

The following is a breakdown of the participant group workshops we would like to engage throughout this project: 24 public workshops with approximately 5000 participants; 175 school workshops with 30 students per group; 11 community workshops with 30 participants per group, 10 youth workshops with 20 participants per group, 8 teacher workshops with 15 participants per group.

Secondary School Programs

Description

Ohahase Education Centre is operated by First Nations Technical Institute to provide programs for students seeking to achieve an Ontario Secondary School Diploma (O.S.S.D.). Ohahase means "new road" in the Mohawk Language and that is why we say it is "Your Future Path to Success"! Ohahase is a Private Secondary School that is inspected and licensed by the Ontario Ministry of Education. Each year our curriculum and guidelines are inspected and the Principal is granted a license to operate and grant credits. Ohahase currently offers two programs; a full-time day program for youth and an adult program of correspondence and night school.

Program Mission

Ohahase....

Is a centre for excellence, providing holistic and respectful learning rooted in Mohawk language and cultural practices; and

Will facilitate a multigenerational community that fosters belonging through encouragement, motivation and laughter – striving for the goals of self-sufficiency and biculturalism.

Learning Programs

Full-time Day Program for Youth

This program is a Private Secondary School program currently for grade nine and ten students. There is no tuition charge or fees for status Native students or community residents as the school is funded by Indian and Northern Affairs Canada. The program consists of regular semester periods in which students take a maximum of four classes per day in each semester. We offer a unique and challenging curriculum that meets Ontario guidelines and includes aspects of Mohawk language and culture. Students of all ages and levels of ability are welcomed as we are able to provide a small teacher-student ratio. We have been in operation three years and will expand to include grade eleven and twelve in the immediate future.

Courses/Program Requirements

Students are required to earn 30 credits to achieve an O.S.S.D. (18 compulsory and 12 optional credits). Our grade 9 and 10 programs in the past have included the following courses:

Adult Education Program

This program is designed as a self-directed learning program with a support system. Adults are offered correspondence courses from the Independent Learning Centre that are approved by the Ministry of Education. Students may work at their own pace and staff at the school, are available to provide assistance when required. The length of the program varies depending on the number of credits required for graduation.

Courses/Program Requirements

O.S.S.D (Ontario Secondary School Diploma) requires students to earn 30 credits. Credits may be earned from high school subjects, maturity credits or equivalency credits. At least 4 credits must be senior credits (grade 11 or 12) and a senior English credit must be included.

Maturity Credits – the Ministry of education grants up to 12 mature credits to adults returning to school. These credits apply to adult students who started high school in the Province of Ontario before September 1999.

Equivalency Credits – some non-post secondary courses that adult students have taken qualify for credits, i.e. apprenticeship training, community college upgrading, etc.

All courses are divided into 20 lessons. Each course is 1 credit unless otherwise stated. Courses are offered at various levels of learning to accommodate educational goals related to work, attending College or University. There is no fee for community members to take a course through correspondence, as the initial registration fees are subsidized by local community service organizations.

Night school is offered periodically and in the past we have offered courses in English, Presentations and Public Speaking Skills, Computers, Math and Mohawk language. Other non-credit workshop courses are available periodically such as leather crafts (moccasins).

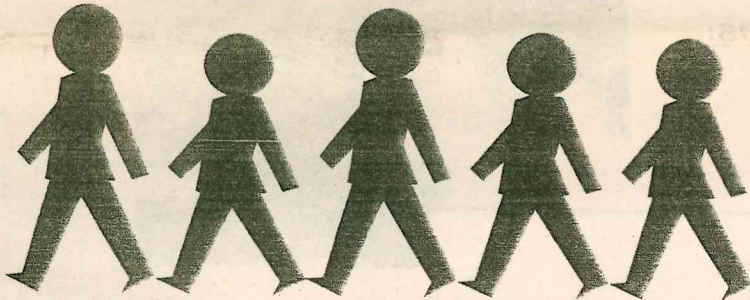
Dear Community,

As of the above date, you will be directly responsible for the costs you incur for bottled water. The Thayendanega Health Centre will not be accepting any receipts for financial reimbursement.

The Mohawks of the Bay of Quinte submitted a proposal in January 2006 to Indian and Northern Affairs for the continuation of the program without successful results. We will continue to advocate on behalf of the community to secure funding for this program, however, in the interim we must discontinue the service due to depleted financial resources.

Meals on Wheels Programs: A hot nutritious meal is delivered every Tuesday and Friday between 11:30am and 12:30pm. Meals are \$3.00 each. Frozen meals are also available monthly. They are delivered the beginning of every month. (Prices vary)

Diner's Club Program: Every second and fourth Wednesday of each month a delicious meal is prepared and served at the Elders Lodge at 12pm. Cost is \$3.50.

Transportation Program: The Mohawk Handivan is used to transport seniors living in the community to Home Support programs and community activities. Regular monthly runs to Deseronto, Belleville, Diner's Club at the Lodge as well as Deseronto and bowling.

Home Maintenance Program: Assistance is provided for household tasks beyond the individuals capability. Examples of this service would include: grass cutting, painting, window washing. Cost is \$3.00 an hour.

Social & Recreational Programs: Provides supervised activities for seniors in a group setting. Examples of this service include: ceramic classes, bowling, monthly grocery shopping and special pre-arranged outings. (Cost varies).

Friendly Visiting: Provides "friendly visits" to seniors in their homes. Visits are made by staff and volunteers under agency supervision.

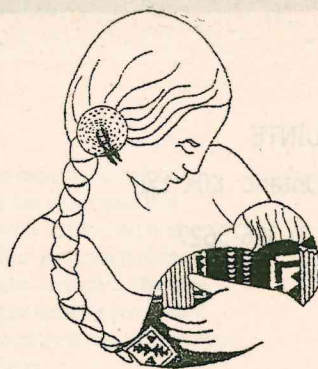

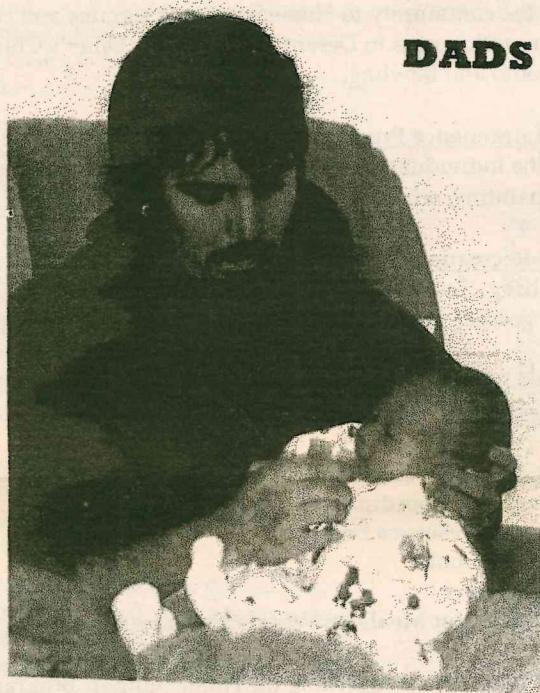

Please Recycle



#1- Plastic and Metal Containers

Please deposit these items in the blue toters.

Metal Food and Beverage Cans

Empty cans and lightly rinse. Place metal lids from cans (and glass jars) inside the can and pinch the top to trap the lid inside. Please do not place pop cans inside of food cans. DO NOT include, metal pots, butter wrappers or scrap metal.

&



Rigid and Foam Plastic Containers

Empty and lightly rinse your containers. Discard the lids. All plastics with the numbers 1 to 6 on the bottom are OK. Include plastic containers for soft drinks, detergent, bleach, juice, shampoo, yogurt, ice cream, Styrofoam coffee cups, trays and packaging. DO NOT include drink boxes, medicine bottles, toys, parts, or blister/bubble pack.

&

Empty Aerosol and Paint Cans and Aluminum Trays & Foil

Please make sure that aerosol cans and paint tins are empty and dry (remove the lids from empty paint cans and let them dry out before recycling. Aluminum trays and foil such as pie plates, fast food trays and clean aluminum foil. DO NOT include propane tanks, any paint cans that have product in them or if larger than 1 gallon or, any hazardous product.

#2 Clear Glass & Coloured Glass

Please separate your clear and coloured glass and deposit it in the steel drums at the depot.

Clear and Coloured Glass Bottles and Jars

Separate your clear glass from your coloured glass. There are Blue Boxes for each type at the depot. You can recycle the metal caps with your Metal Cans. DO NOT include anything that is not a glass beverage or food bottle or jar. NO ceramics, dishes, cups, window glass, light bulbs, mirrors, Pyrex, drinking glasses or special coated liquor bottles.

#3 Mixed Household Paper

Please deposit all household and office paper in the blue toters.

Mixed Household Paper

This includes junk mail, paper bags, egg cartons, paper tubes, sugar and flour bags, rinsed milk or juice cartons, cereal, detergent and snack boxes, books, computer paper, Newspapers, Magazines, Telephone Books and other paper items. Please remove any food or liners and flatten boxes. DO NOT include, soiled boxes, serviettes, Kleenex or paper towels.

#4 Film Plastic

Please deposit empty bags in the blue toters.

Plastic Bags, Pallet Wrap or Film Plastic

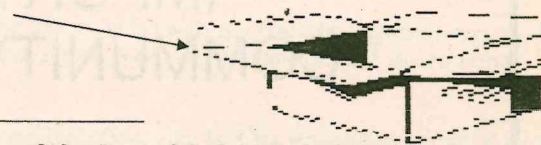
Fill a plastic bag with plastic grocery bag, *rinsed* milk and vegetable bags, bread newspaper, parts and dry cleaning bags. Outer film wrap from toilet paper, cases of pop and produce are OK too. DO NOT include dirty or soiled material, chip/snack bags, meat or cheese wrap, saran wrap, candy wrap, vinyl or rubber products. Please remove any food, crumbs or paper receipts. Tie your full bag shut and place it inside the depot container.

#5 Old Corrugated Cardboard

Please break down your cardboard boxes and place inside large cardboard boxes.

Cardboard Boxes

This is the type of box or case used for shipping packing larger items such as furniture, appliances and computers. The boxes have three layers with a wavy section in the middle. Please flatten your cardboard boxes down and place in the large Gaylord boxes in the corner. DO NOT include coated or waxed boxes or dirty pizza boxes.

NOTICE PROCEDURE FOR CONTACTING PIERCE ANIMAL CONTROL SERVICES

Residents can call (613) 966-4483 leave your name and phone number so that they can contact you.

They are available 24 hours for emergencies. An emergency would be a dog that is injured and the owner is unknown, a dog that is harassing livestock, a dog endangering the public or an animal suspected of having rabies. If a resident would like to log a complaint or inform them of a dog running at large they can do so by calling Monday to Friday between the hours of 8:00 a.m. and 4:30 p.m.

They are not available to pick up strays running at large on weekends or statutory holidays. All animals that are picked up are taken to the **Quinte Humane Society** and their hours are 12:00 noon to 5:00 p.m. Monday to Saturday and 1:00 p.m. to 4:00 p.m. Sunday. The Quinte Humane Society is also closed on statutory holidays.

The Quinte Humane Society is located on Avonlough Road which is at the west end of Belleville off of Dundas St. west (Hwy #2). Their number is (613) 968-4673.

It would be best if your pet has been picked up that you call ahead to the Humane Society to confirm the cost involved in redeeming your pet.

POSTCARDS FROM THE VISION QUEST

The view from down here

The worst part about everything you're reading here is that it may all be grossly out of date by now.

As I write this, the barricades at Caledonia are being taken down and the media is trying to assess the impact of the entire ordeal for us. Both the Toronto Star and the Globe and Mail seem to be on the ball, tackling those "on the ground" moments, finding and interviewing individuals who can share their experience on either side of the divide.

And because everyone has an opinion, the stories are multiple. One from the Star begins this way: "The barricades are gone from the main street of this small town. The bitterness is not." Just one of a plethora of articles the paper has devoted to this standoff, it suggests media and government and law enforcement seemed to have taken more interest in the grievances of the Natives and not considered any interest the non-Native people may have, those innocent ones who believe in European style rule of law and felt inconvenienced.

The Globe and Mail, in a column written by Christie Blatchford titled "Victory for the common man," appears to attribute the dismantling of the Native barricade and the recently-posted non-Native barricade to a shared interest to suddenly just be peaceful, from both sides.

I don't know much about this Caledonia thing and, from all the way in Tennessee, I'd be a fool to think I would. I do know about media, though, and it seems we've been dealt an okay hand in this one.

First of all, this was not international news. Perhaps there is some bureaucrat out there who'll be briefed on this someday and it may serve us well sometime in the future. But as far as the populace outside Canada is concerned: nothing.

There was a small article written back in April in the New York Times about this. Ironically, what prompted it was the railway stoppage in Marysville. No local quotes, though. Absolutely no other mention of it at all since.

And it seems you can have a standoff for as long as you want but, unless there is some newsworthy aspect of it every single day, it will fall off the radar. Daily newspapers and television news broadcasts only look back over the past 24 hours for news, so if nothing's happening at Caledonia, there's no reason to say "Still nothing happening at the standoff" (as much as we might want daily, up-to-the-minute reportage).

In fact, my favorite photo came from the Toronto Star, I think. It was one of those picture galleries where you click the "next" button and there's like 10 or 15 pictures you go through, each one with its own caption, detailing what we're looking at.

In this shot, a young woman sits just beyond the main blockade, dressed in a standard issue black coat (though what appears to be a light brown scarf is eye-catching). Her chin—nearly half her face—is resting in her hand, as she slouches in a seated position, scanning whatever is in front of her.

It's the caption that I love: "A native protester guards the main blockade ... (blah, blah, blah)." Maybe you have to look at this picture to understand me, but the last thing I'd consider this sister doing is "guarding" anything.

While perhaps not so for many non-Native people, that one picture humanized the entire situation for me. Here was somebody I could relate to.

Getting back to my point: it is an article written by the Globe and Mail political affairs columnist John Ibbitson, called "Broken promises, downed barricades and an uneasy peace," that seems to strike the summary note this situation needs at this point.

"What is Caledonia?" he asks. "It's a fault line." He says, "These confrontations are going to multiply and escalate. And there is nothing that can be done to stop them."

In a very well reasoned column, Ibbitson articulates the current history of Native land claims: that our land has long been far removed from urban areas and now that the suburbanization of the world is encroaching upon us, suddenly Canadian governments don't have decades upon decades to figure out some resolution to these outstanding land claims.

It would be nice for those who are meeting now to set some kind of precedent that could eliminate the need for another Caledonia or Oka or by whatever neighboring non-Native community the next showdown will be labeled. But, as the writer says, it's unlikely, because all land claims—while seemingly similar—are all unique. And it all depends on whose interpretation of history we're dealing with.

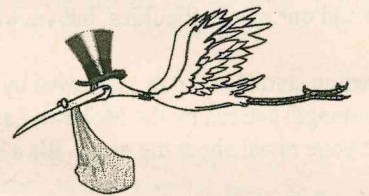
As of right now, today, though, it's a good day to be indigenous. From what I've read, the Natives at Caledonia relied on history and allowed it to lead them this time. There were no visible weapons to provoke non-Native authorities. There was always the claim that they were leading a peaceful protest.

Oka and Dudley George taught everyone valuable lessons. It may not necessarily have to be an internationally recognized event to make the Canadian government want to resolve these land claims as much as we do. But the feeling is that they're getting there.

And the national media, it seems, wants to contribute when it can.

Ottawa, May 9, 2006 – The Canada Council for the Arts has launched a new pilot program that will help young Aboriginal artists learn from Elders. The Elder/Youth Legacy pilot program will give Elders the opportunity to pass on the many art forms they practice to the next generation.

The deadline for applications to this program is June 15.

"The Elder/Youth Legacy initiative is an exciting new development at Canada Council," said Louise Profeit-Leblanc, the Council's Aboriginal Arts Coordinator. "This new component of the Aboriginal Peoples Collaborative Exchange program has been sought by Aboriginal artists and organizations to ensure succession of artistic practice and to transfer knowledge to future generations."

The Elder/Youth Legacy pilot program funds Aboriginal arts organizations that wish to work with these two groups on a project basis. This program is not limited to traditional art forms but encompasses all forms of the arts.

Through this program, Aboriginal arts organizations can choose the Elder who will work with youth. The Elder will help decide the number of young people with whom he or she will work and will help select them. The organizations can apply for a grant worth up to \$20,000.

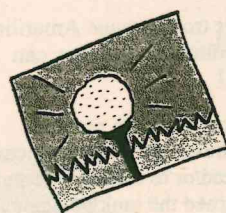



About the Kwahadi Dancers

The Kwahadi Dancers are a Scout Group from Amarillo, Texas. Their first dance was a one-shot presentation at a campfire in 1944. Shortly after this first dance, they started getting invitations to perform for other groups. Besides a short period in the 1950s when the drums fell silent, the Kwahadis have continued to dance and tour around the United States and overseas.

Every member of the Kwahadis is an active Scout with another troop around Amarillo. The Scouts make their own costumes and carefully learn the culture so that they can accurately honour the dances and the native people.

The Kwahadis are a fellowship of Scouting families who work together to provide leadership and educational experiences for our youth through travel and performances. The great goal for all Kwahadis is to become an Eagle Scout and/or to earn the Venture Ranger Award. Two-hundred-seventy-three Kwahadis have earned the rank of Eagle Scout.

Over 1600 boys and girls have earned the right to perform in the Kwahadi show since the first dance in 1944. Over the years, the Kwahadis have presented over 3700 performances in 46 states and overseas. The crew often travels 20,000 miles a year coast-to-coast in their bus to perform and sightsee. They have been honored with the Youth Award for Excellence by the Texas Commission for the Arts and were selected to represent the United States, along with Up With People, and the Brigham Young University Choir, at the International Festival of the Arts in Amman, Jordan.

The Kwahadis perform for community events, fundraisers, and entertainment coast to coast throughout the year. During spring break and during the summer, the Kwahadis are on the road for 10-24 days presenting performances and enjoying educational experiences. The Kwahadis traveled to Hawaii in the summer of 2004, and presented 80 performances in 2005, including 14 performances on a 4000 mile tour across the Midwest and eastward to Montreal. In 2006 the group will tour across the Southern United States in the spring, and will travel to Canada for a series of shows between Montreal and Toronto in late July. Plans call for a west coast tour in 2007.
