#### Duties & Responsibilities:

1. To assist Band Council and individual Band members in job creation by:
  - Planning, submitting, implementing, co-ordinating, monitoring and reporting for all Job Creation Programs as directed by Tyendinaga Mohawk Council;
  - Providing technical assistance for business development projects, up to and including preparation of funding submissions to financial institutions or funding agencies and making appropriate recommendations;
  - Establishing contacts with off-reserve employers, co-ordinating employment programs for individuals that are available from CEIC and Indian Affairs and generally assisting in off-reserve job placements as requested by individuals or Band Council;
  - Co-ordinating Career Days for the benefit of Reserve students;
  - Co-ordinating Job Preparation Workshops for the benefit of Band members.
  
2. Assist Band Council and government agencies in planning for employment by:
  - Providing Work Force Reports and Community Profiles as requested by the District Office of Indian Affairs;
  - Providing program Quarterly Reports as requested by the District Office of Indian Affairs;
  - Providing inventories and resumes of Band members seriously looking for employment or to further their careers;

- Providing input as required by Band Council in the Comprehensive Community Planning program:
- Developing Employment Strategies for consideration by Band Council after the District Office of Indian Affairs develops appropriate guidelines.

3. Enhance personal skills in order to provide better service to Band by:

- Attending all workshops provided by District Office of Indian Affairs for the benefit of Band Development Officers;
- Attending other workshops, seminars as may seem desirable by Band Council;
- Taking further training as may seem desirable to Band Council or as negotiated between Band Council and the District Office of Indian Affairs.

Qualifications:

- High School graduation with experience in management;
- Applicants must be highly motivated and able to work well on their own;
- Applicants must have excellent communication skills both verbal and written.

Management is defined as an activity where the incumbent has authority over both human and financial resources and is personally responsible for achievement of goals and objectives.


The use of electric arc welders to thaw frozen water pipes is no longer recognized as acceptable by Ontario Hydro for safety reasons.

Please find enclosed, the following letters related to this subject:

- May 20/86 - Ontario Municipal Water Association
- May 27/86 - Ontario Hydro
- June 18/86 - Fire Marshall

Kindly advise any local personnel who thaw frozen waterlines of the availability of CSA certified electrical pipe thawing equipment.

The use of electrical arc welders for thawing pipes should be discontinued because of the fire hazard, and the effect it may have on liability insurance coverage.

RE: THAWING OF FROZEN WATERMANS AND SERVICES

In July 1983 interim special permission was granted by Ontario Hydro for the continued use of electrical arc welders to thaw frozen watermains and service connections. This interim special permission was granted in recognition of the fact that there was no CSA Certified electrical pipe thawing equipment available on the market in Ontario.

CSA Certified electrical pipe thawing equipment is now available. This certification of electrical pipe thawing equipment by CSA in effect, nullifies the special permission granted by Ontario Hydro respecting the use of electrical arc welders for the thawing of frozen watermains and service connections. The continued use of electrical arc welders for thawing may have an affect upon a municipality's/utility's liability insurance.

In view of preceding it is the recommendation of the Ministry of the Environment, the American Water Works Association - Ontario Section and the Ontario Municipal Waterworks Association that all municipal waterworks authorities and utilities in Ontario begin immediately to re-evaluate their current practices respecting thawing with arc welders and amend same to meet current requirements. In addition, we would recommend that all waterworks operating authorities advise their consumers and any local contractors who thaw frozen services/watermains of this change. This advise could be through utility bills, municipal tax notices, or the local press etc.

We would also recommend that all waterworks authorities and utilities re-evaluate their current standards for freeze protection/depth of bury of watermains and service connections. The technology associated with the protection


of watermains and service connections from freezing is greatly improved and when properly applied will reduce costs and virtually eliminate the freezing of watermains and services.

Attached you will find a copy of a letter sent by the Office of the Fire Marshall to all fire chiefs in Ontario which should be read in conjunction with this letter.



Subject: Pipe Thawing

DISTRIBUTION: ELECTRICAL INSPECTION SUPERINTENDENTS

The subject of pipe thawing has been discussed by the OMWA/AWWA-MOE Liaison Committee, representatives of the Ontario Hydro Electrical Inspection Department and the Ontario Fire Marshal's Office.

At the meeting it was determined:

- there is now approved electrical water pipe thawing equipment;
- there are alternatives to using electrical water pipe thawing equipment; and
- fires associated with the use of unapproved electrical equipment for water pipe thawing are continuing to occur.

Because of the foregoing, we feel that utilities and contractors who have been using welders to thaw pipes should be aware that:

- (a) Pipe thawing with electrical equipment not approved for the purpose can and does damage the electrical installation. This is contrary to Rules 2-032 and 2-034 of the Electrical Safety Code and may lead to prosecution under The Power Corporation Act; and
- (b) For thawing water pipes using electrical equipment, only machines which are specifically CSA certified as pipe thawing machines are acceptable, and then when used in accordance with all the manufacturers' instructions.

This memorandum is being sent to all water works authorities in the Province. Memorandum AM-32-83 on this subject is cancelled.

Re: Pipe Thawing

In my memorandum of October 27th, 1982, I pointed out that the use of electric arc welding equipment for the thawing of frozen water pipes was a known and frequent cause of fire, and only equipment certified by Canadian Standards Association specifically for the purpose of pipe thawing should be used. This information was based on an Ontario Hydro bulletin dated October 18th, 1982, File No. AM-45-82, giving similar information to their electrical inspection superintendents.

At that time suitable equipment had not been tested and listed by CSA, and Ontario Hydro published a second memorandum, dated October 29th, 1983, File No. AM-32-83, which gave interim permission to use electric arc welding equipment for the thawing of frozen water pipes, provided specific procedures were followed.

Suitable safe electrical pipe thawing equipment has now been certified by CSA. Ontario Hydro has issued a new bulletin dated May 27th, 1986, withdrawing special permission to use arc welding equipment on an interim basis.

We recommend that your councils or public utilities commissions be informed of the hazards of using arc welding equipment for pipe thawing, and urge your municipality to use approved equipment. You might

wish to point out that, where fires occur as a result of using unapproved pipe thawing equipment by the municipality, civil or criminal liability could result; your council might also wish to consult with its public liability insurer and its legal department.

Because of circumstances beyond our control we have very little time to make a success of this endeavor.

We will be running for a total of six (6) hours. Starting time is 9:00a.m. and the run finishes at 3:00 p.m. Our relay team consists of ten (10) runners? There's no question about the number of runners, the question is the quality of runners. Knowing our abilities we will probably cover anywhere between 45-55 miles. A pledge of .10¢ per mile at 50 miles covered comes to a total of only \$5.00. The same 50 miles covered with a pledge of .25¢ per mile equals \$12.50.
