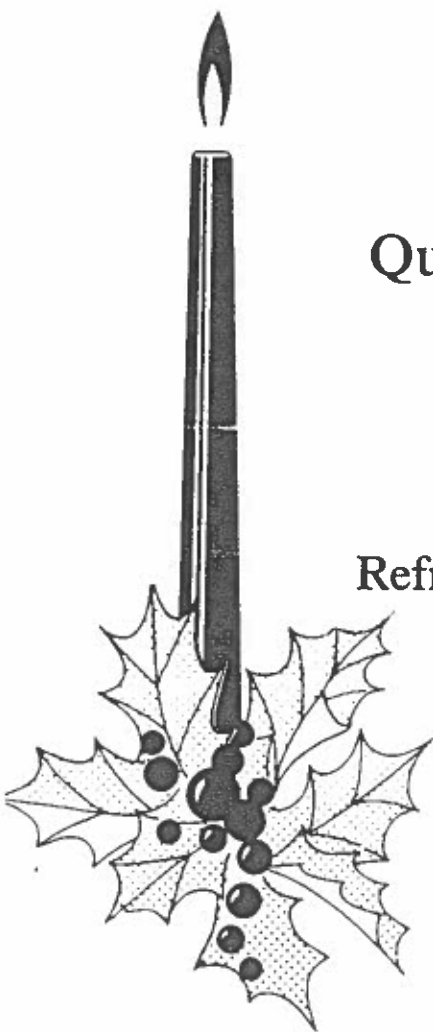

RESULTS OF WATER SURVEY

During the months of July and August, Bev Hill and Lynn Brant conducted a water survey on Tyendinaga Reserve. This survey excluded the Bayshore Road residents due to departmental negotiations.

The survey consisted of going to each home to collect data and water samples. The results of the collection has been assessed and compiled and presented to Chief and Council.

Results are as follows:

Residences and public buildings	346
Samples from residences	273
Samples from public buildings	15
Vacant buildings and no water on location	32
Residents unavailable-3 call backs	26
Shortage of water reported	73
Homes without inside facilities	22

Results from water samples taken-see interpretation


Faecal count	97 samples
Coliform 10	176 samples
Coliform 10	92 samples
Overgrowth	19 samples

As a follow-up to this survey each resident will receive a copy of the results of the sample taken from their water supply. If there is a high coliform or faecal value, instructions for chlorinating your water system will be included. After the resident has chlorinated his/her water system they can contact Bev. Hill at the Band Office (396-3424) and a retest will be done.

If you have any questions regarding well construction or water samples, please contact Ron Brant or Bev. Hill at the Band Office.
