I hope that this report finds you in good health and that you are enjoying the fall season.

SPECIFIC CLAIMS RESOLUTION ACT - BILL C-6

Bill C-6 is in the final days of the debate in the Senate. A motion was made by aboriginal Senators Watt and Gill to refer the Bill C-6 to the Legal and Constitutional Affairs Committee to review the Bill in light of the Metis Powley Supreme Court Decision of September 19, 2003. The Powley Decision is an Ontario court case that confirmed the Metis People have an aboriginal right to hunt.

The Senate compromised with Senators Watt and Gill and requested that Bill C-6 be reviewed by a different Senate Committee called the Senate Aboriginal Peoples Committee. This committee is comprised of Senators. The Aboriginal Peoples Committee was given a deadline of October 7, 2003 to review the Bill and had the first hearing of witnesses on September 30, 2003.

I am enclosing a copy of my lobby letter to Senator Chalifoux concerning Bill C-6 indicating my support of Senator Charles Watt's motion.

Two witnesses appeared before the Aboriginal Peoples Committee. Audrey Stewart and Robert Winogron represented Indian Affairs and advised that Bill C-6 is about the resolution of specific land claims and is not about recognition of aboriginal rights as is the case of the Powley Supreme Court Decision. The Specific Claims Bill applies to Indians and not Metis people according to Indian Affairs.

Ralph Goodale is the Minister responsible for Metis issues. Alan MacDonald from the Privacy Council office endorsed the position of Indian Affairs. Mr. MacDonald stated that it was too early to decide the impact of the Powley Decision on Bill C-6 and that the provinces were responsible for Metis people and that there would have to be Federal/Provincial discussion on the issue.

Metis law professor, Larry Chartrand, was not given time to testify when Conservative Senator Pat Carney made a motion to send Bill C-6 back to the senate without amendments. Senator Gill was very upset with the decision and thought that the October 7, 2003 deadline would be respected.

Senators Watt and Gill are concerned that Bill C-6 is being rammed through without careful thought about the impact of the Powley Decision and the concerns raised by the aboriginal leaders. Both Senators believe that Bill C-6 needs more study.

It is unclear if the Senate will reconsider continuing the hearings on Bill C-6. The Assembly of First Nations have been silent on the issue, however, there was an AFN staff person auditing the hearings.

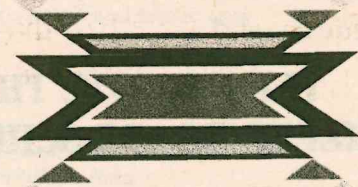
Aboriginal leaders remain concerned about the inadequacies of Bill C-6. There is too much Ministerial control of the appointments to the Tribunal. The amendment to raise the cap on claims to 10 million dollars is too low. The Federal Government remains unaccountable for excessive delays in responding to specific land claims that have been filed.

I was in attendance at the Senate on September 23, 2003 in Ottawa to hear the deliberation on Bill C-6. Chief Roberta Jamieson, Chief Greg Cowie and Chief Sharon Stinson were also present. I had the opportunity to discuss our position with some of the Senators.

FIRST NATIONS GOVERNANCE ACT - BILL C-7

There is no overwhelming momentum to bring Bill C-7 forward. There is a possibility that Parliament may recess on November 7, 2003 and not reconvene until February 2004 pending the Liberal convention. If this happens, no Bills are introduced or legislation enacted, and question period in the House of Commons will not take place.

The Chiefs attendance at the Aboriginal Affairs Committee of the House of Commons sent a strong message to the Government of Canada that First Nations were opposed to the legislation.

FIRST NATIONS FISCAL AND STATISTICAL MANAGEMENT ACT – BILL C-19

The clause by clause review of Bill C-19 by the House of Commons Aboriginal Affairs Committee was completed on September 22, 2003. Bill C-19 was tabled in the House of Commons on September 23, 2003.

There minor cosmetic changes to Bill C-19 in the proposed amendments. The only significant amendment was the inclusion of a non-derogation clause on Aboriginal and Treaty rights. This means that Bill C-19 cannot be interpreted as infringing on Treaty and Aboriginal rights.

Chiefs believe that the premise on which the Bill is founded is wrong, and that Bill C-19 does undermine aboriginal and treaty rights and the right to self-determination. The Federal Government is attempting in this Bill to off-load Canada's constitutional, fiduciary, and fiscal obligations to First Nations Councils. The Bill proposes to finance capital projects by acquiring loans and repaying them from revenue streams which include a property tax collection scheme.

The Chiefs remain concerned that there is too much Ministerial control over the appointments to the Commissions.

The window of opportunity is quickly closing. I have written numerous letter to Members of Parliament and Senators requesting that they oppose this Bill. MP, Pat Martin has been a strong voice for Aboriginal people opposition to the Bill at the House of Commons Aboriginal Affairs Committee hearings. I am enclosing a copy of my letter of September 18, 2003 for you perusal.

UPPER GAP ANCESTRAL BURIAL SITE

In 1995, the Ontario Ministry of Transportation archaeologist discovered an ancestral Iroquiosan settlement and burial site during the preparations for the reconstruction of Highway 33 between Bath and Conway, Ontario.

The Upper Gap archaeological site is situated on the northern shoreline of Lake Ontario overlooking the open channel, or Upper Gap, between Amherst Island and Cressy Point in Prince Edward County. Archaeologists excavating the site in 1996 and 1997 found segments of five longhouses and an extensive refuse midden, and identified three main periods of occupation spanning the years between A.D. 700 and A.D. 1400.

There will be plaques erected in the Mohawk, English and French languages to commemorate this site. The plaques will be unveiled on October 2, 2003 at 11 a.m. at the Mohawk Community Centre.

TURTON PENN HIGHWAY

The Tyendinaga Mohawk Council had substantial discussions with the Federal and Provincial representatives on September 18, 2003 regarding a potential settlement.

Any acceptance of any offer must be voted on and approved by the membership. Pending legal advice, Council hopes to be in a position to inform the community of the details in the near future.

GAS SPILL - SHANNONVILLE

Efforts are continuing to address the source, impacts and remediation measures concerning the gasoline spill entering the catch basin along Highway #2 west of Shannonville, Ontario.

I have been in contact with a number of regulatory bodies and safety authorities. The Mohawks of the Bay of Quinte have contracted XCG Environmental Consultants and All-Pro Contracting to advise Council on this matter. I am enclosing a press release which provides further information.

I would like to extend my sincere thanks to Marlene Brant-Castellano for serving as our Trustee on the Hastings and Prince Edward County School Board. PRESS RELEASE

EFFORTS TO ADDRESS FUEL SPILL CONTINUE

In a press release issued today by the Mohawks of the Bay of Quinte, Chief R. Donald Maracle stated that efforts are continuing to address the impacts of the fuel spill that occurred on Highway 2, approximately 1 km west of Shannonville.

"The fuel spill first came to our attention on September 4, and we immediately notified the Ministry of the Environment Spills Action Centre, Environment Canada, and Health Canada," said Chief Maracle. "These regulatory authorities and a number of others responded to the scene," stated Chief Maracle, "but because of jurisdictional issues, relating to the fact that the land is part of the Tyendinaga Mohawk Territory, no one provincial or federal regulatory authority took charge of the situation."

Environment Canada took samples from the catch basin on September 5 and initial results were not received until September 22. However, Environment Canada was unable to determine if the product was gasoline.

"In an effort to ensure that appropriate action was taken," said Chief Maracle, "we have remained in frequent contact with all of the following agencies that have been involved in this: the Ontario Ministry of the Environment, Environment Canada, Health Canada, Indian and Northern Affairs Canada, the County of Hastings, the Ministry of Labour, the Human Resources and Development Canada Occupational Health and Safety Group, the Technical Standards and Safety Authority, the Electrical Safety Authority, the Mohawk Fire Department, the Tyendinaga Police, GD Jewell Engineering, and Quinte-Eco Consultants."

"Jewell Engineering and Quinte-Eco are working for the County of Hastings and have been responsible for ongoing measures to contain the spill since September 18," stated Chief Maracle. Quinte-Eco Consultants took samples on September 19 and test results confirmed and reported that it was gasoline on September 24. "Due to the jurisdictional issues, no concrete action was taken by any of the parties involved to find the source of the spill," added Chief Maracle.

"Because of the seriousness of the situation," said Chief Maracle, "we decided to take matters into our own hands and on September 24 we hired XCG Consultants, an environmental consulting firm, to undertake an investigation to determine the source of the leak and the extent of the environmental impact, and provide direction on how to resolve the situation."

"Investigations conducted this past weekend by XCG and All Pro General Contracting at two gas stations--Jumpin' Johnnie's and Mohawk Liquidation--identified problems that resulted in orders to close both stations," said Chief Maracle. "Jumpin' Johnnie's was ordered closed on September 27 and Mohawk Liquidation was ordered closed on September 28," added Chief Maracle.

"More investigations are required at both stations before we will be satisfied that all existing problems have been identified," stated Chief Maracle. "We are making every effort to complete these investigations as quickly as possible in order to minimize disruption of these businesses," he added.

"The gas stations will not resume operations until the problems identified have been corrected, the equipment at each facility passes an inspection by the TSSA, and remedial action plans to address the environmental damage have been prepared to the satisfaction of all of the parties involved," said Chief Maracle.

"Thorough environmental investigations are required, and are already in progress, to determine the full extent of the environmental impact from the fuel spill," stated Chief Maracle. "The public will be kept informed as additional information becomes available," he added.

The Mohawks of the Bay of Quinte intend to recover all costs relating to the investigation and remediation from the responsible parties.

Dear Senator Chalifoux:

In the last days of Senate debates prior to the summer recess, the Report of the Committee on Aboriginal Peoples regarding Bill C-6, the Specific Claims Resolution Act, was tabled for Third Reading in the Senate. The Report recommended five amendments to the Bill.

Senator Charles Watt then moved that the Report and Bill be referred to the Standing Senate Committee on Legal and Constitutional Affairs because of the material question which had been raised during the hearings. The Senate recessed for the summer with Senator Watt's motion left on the order paper.

As the Senate resumes sittings on September 16, it is important that the significant questions implicit in Senator Watt's resolution receive favourable consideration. The amendments only partially address the issues raised in the hearings both by witnesses and Senators themselves. We believe the Committee is the appropriate forum to address the issues, rather than through debate in the Senate on the amendments. Should that be necessary, however, we intend to ask Senators to allot substantial time for debate on the amendments.

The Assembly of First Nations most recent resolutions on this subject maintain the Bill cannot be salvaged by amendments. We see nothing in the amendments proposed which would change that position. The approach recommended by the Joint Task Force, which included government and AFN representatives, is an acceptable route, which can be adopted, in a fresh Bill, which the government should bring forward.

We look forward to your support for Senator Watt's motion to refer the Report of the Standing Committee on Aboriginal and C-6 to the Standing Senate Committee on Legal and Aboriginal Affairs.

RE: Bill C-19 – First Nations Fiscal & Statistical Management Act (FNFSMA)

The purpose of this letter is to reaffirm First Nation opposition to Bill C-19, currently before your committee in clause-by-clause review. It is imperative that Parliament recognize the First Nation's opposition to this flawed legislation and respect the position of the First Nation Constituents.

Pursuant to the two (2) resolutions passed by Ontario Chiefs, our position against Bill C-19 remains firm and strong. Resolution 03/27 passed June 2003 during All Ontario Chiefs Conference in Whitefish Lake First Nation territory calls for reasonable measures against Bill C-19 as it violates our Inherent Rights and do nothing to improve the economic prospects of our people. Resolution 01-3 First Nations Financial Institution Act, which was unanimously endorsed by the All Ontario chiefs Conference in June 2001 states "to reject the First Nations Financial Institution Act, based on its content and current process, which violate the constitutional standard of fair and reasonable consultation". Further, it calls on AFN to reconsider its entire approach to the fiscal relations issue, which should be based on First Nations rights, and not the Indian Affairs agenda of taxation, own source revenue, and external accountability.

Bill C-19 is consistent with the federal agenda that is behind the FNGA agenda. It appears Canada does not want to deal with Aboriginal rights, especially the inherent right. The FNFSMA, like the FNGA, promotes on-reserve revenue collection (through taxation and own source revenue) and the imposition of restrictive financial management rules. There is no mention of increased fiscal transfers or resource revenue sharing which is key for economic self-sufficiency for First Nations.

The Mohawks of the Bay of Quinte First Nation request your support of our concerns and opposition to the passage of C-19. I respectfully urge you to convey our position to your party leader and your colleagues.

RE: ONTARIO REGIONAL CHIEF'S RESPONSE TO BILL C-19 – FIRST NATIONS FISCAL AND STATISTICAL MANAGEMENT ACT (FNFSMA)

As you are aware, the Standing Committee on Aboriginal Affairs (SCAA) has completed it's clause by clause review of Bill C-19. The SCAA Chair, Ray Bonin, ruled 120 clauses and 30 amendments out of order and prevented any debate on these submissions, based on his ruling that Bill C-19 has nothing to do with inherent rights.

As Ontario Regional Chief, I have maintained the position that this bill is a flawed document that undermines our rights by delegating federal powers and does not recognize our inherent governance jurisdiction. As the Ontario Vice Chief, I have called upon the Assembly of First Nations to reconsider its approach to the fiscal relations issue. The Resolutions confirmed the mandates of the Chiefs in Ontario to take all reasonable measures to stop Bill C-19. Based on these resolutions and the confirmation of this mandate, I have continued to oppose this legislation and have called upon the National Chief to uphold the national resolutions that mandate him to do the same.

The Chiefs of Ontario resolution 03/27, clearly accommodates First Nations that want to proceed in developing their own local/regional agreements on financial institutions, but not in the context of national legislation. I respect the autonomy and the right First Nations have to pursue such agreements. Clearly, the right and autonomy of the Ontario Chiefs must also be respected and mandated activities must be actioned.

I encourage you to lobby your member of parliament, as directed by resolution 03/27, with the message that First Nations will oppose the passage of Bill C-19, and if passed will be the subject of court challenge.

As Bill C-19 progresses through the parliamentary process, I will continue to uphold the mandate you have set for me and will be calling upon you to assist in this endeavor.

Dear Chief:

We have recently completed our examination of the systems and records of Mohawks of the Bay of Quinte for the year ended March 31, 2003.

In general we found the overall quality of accounting records and timeliness of information provided by your staff has increased substantially over prior years. This has allowed for a condensed period of time required to complete the current year's audited financial statements.

As a result of our audit testing, we did not encounter any significant weaknesses in the organization's internal controls, systems, or accounting procedures.

We would however like to provide some general comments and recommendations with the intent to improving the overall operations of the band.

We would also like to take this opportunity to thank Ms. Sue Maracle and the Finance Department for the professional manner and co-operation extended to us throughout the performance of our duties.

Schedule of Unadjusted Differences

During the course of our year end testing we noted expenditures of approximately \$50,000 relating to the construction of a bus parking lot were recorded as prepaid expenses. These costs were recorded in this fashion to match the expenditures to the 2003-2004 minor capital budget.

Canadian Generally Accepted Accounting Principles applicable to First Nations require that amounts expended in a period are recorded in the Statement of Revenues & Expenditures and accordingly, we have recorded these prepaid amounts as a current period unadjusted difference.

However we do not feel that this item in itself materially misstates the overall statement presentation, and we have therefore issued our unqualified opinion on the current year's financial statements.

Marketable Securities

At year end, the market value of securities was approximately \$369,000 less than the carrying value in the financial statements.

The Band's accounting policy for marketable securities has been expanded to include more detail on the valuation of marketable securities in the financial statements. Specifically, marketable securities will be written down to market value where the decline in value below cost is considered to be other than temporary in nature.

Subsequent to year end, overall market conditions and the Bands investment portfolio has improved significantly. The ability to carry these investments at an amount in excess of market value is predicated on your belief the decline is temporary in nature, and that the ultimate proceeds on sale of the investments will exceed original cost.

You should consider the expected requirements for use of these funds in order to ensure that an appropriate time period exists for the market value of these securities to exceed original cost.

Allowance For Doubtful Accounts

During the course of our audit we noted a substantial increase in rental arrears over the previous two fiscal years.

We understand council has taken steps to address this problem via the recently implemented rental incentive program.

However, the allowance for doubtful accounts has not been increased in the current year despite the dramatic increase in these rental arrear balances.

Every avenue should be explored to ensure these receivable balances are collected. However, we would suggest that you consider the probability these balances will be collected on an on-going basis and adjust your allowance for doubtful accounts accordingly.

Housing Loans/Insurance Requirements

Through discussions with staff, we noted that a band member's home was recently destroyed by fire. Aggravating this unfortunate situation was the fact that the individual did not have any insurance on the property.

It is our understanding that the Finance Department is currently implementing procedures to ensure band member's with housing loans maintain adequate insurance on their property.

It is however imperative that the Band is a named insured under the policy. This will require the insurance provider to advise the Band of any lapse in coverage so that appropriate steps may be taken to ensure protection.

We hope you find our suggestions useful to your operations. We would be pleased to discuss these or any other matters in greater detail at your convenience.




The section of York Road between Norway's Road and Wyman's Road is currently being rehabilitated with the contractor having a completion time in 40 days, without any delays (weather, etc.). The contractor started this section of road September 22nd, 2003.

The minor resurfacing sections of Beach Road, Mowbray's Road, Wyman's Road and Lower Slash Road, along with the full reconstruction sections of Upper Slash Road and Norway's Road are also in process, with the contractor having a completion date in 77 days without any delays (weather, utilities, etc.). The contractor has started the minor resurfacing sections of road September 16th, 2003, with the work on Upper Slash Road and Norway's Road starting after the utility (Hydro and Bell) relocations have been completed.

The contractor will be working hard to complete the above-mentioned sections of road before the snow fall, by utilizing heavy equipment, labourers, flag people, etc. Please note that the contractor could also work on the weekends and holidays to keep the project on schedule. RE: LEACHATE ANALYSIS OF EXCAVATED ROADBED MATERIAL

Dear Todd:

As outlined in our faxed proposal dated July 30, 2003, XCG Consultants Ltd. (XCG) undertook sampling of excavated roadbed material, presently on site at the Tyendinaga Landfill site. This letter report provides a summary of the fieldwork and analytical results.

On August 8, 2003, Mr. Gary Hughes, Field Technician of XCG, collected two composite samples from the two areas where the excavated roadbed material was deposited. One sample (TY-Fill-A) was taken from the smaller pile (Pile A) in the northwest area. This pile appeared relatively well mixed, and consisted of various types of excavated material (gravels, asphalt and clay). The second sample (TY-Fill-B) was taken from the pile of excavated material located in the southeastern portion of the landfill area (Pile B). This pile was significantly larger than Pile A and consisted of one area of dumped tandem loads and one area that appeared to be well mixed.

In order to provide "worst-case" results, both composite samples included material obtained from "hot spot" areas within the piles. "Hot spot" areas within Pile B consisted of visible traces of oils and/or staining from tar and asphalt. "Hot spot" areas in Pile A were not as well defined but were included in the initial sampling.

Shovelfuls of material were collected from several locations within each pile, then mixed and quartered. Two of the quarters were removed and mixed again until an appropriate sample size was obtained. The samples were transferred to soil sample jars and transported in coolers to the laboratory. The samples were submitted to Caduceon Laboratories in Kingston, a C.A.E.A.L. accredited lab, on the same day for solid leachate analysis including metals, semi-volatile organic compounds (SVOCs), volatile organic compounds (VOCs), and flash point. In addition, one of the samples was analyzed for polychlorinated biphenyls (PCBs) and dioxins and furans.

The analytical results are summarized in Tables 1 through 6 below. The laboratory certificates of analysis have been appended to this report.

As shown in Table 1 (Metals), barium, boron, chromium, lead, and selenium were detectable but well below the leachate criteria. Arsenic, cadmium, mercury and silver were not detected. Calcium and sodium were present in the leachate, however there are no guidelines for these elements.

Table 2 summarizes the results of the flashpoint analysis for both samples. Both samples had flashpoint values above the 65°C criteria. None of the parameters listed in Tables 3 (VOCs), 4 (SVOCs) or 5 (PCBs) were found at concentrations above the laboratory method detection limit.

Dioxins and furans (Table 6) were found to be in the sample submitted from Pile B at a concentration of 0.7 pg/L, which is well below the leachate criteria of 1500 pg/L.



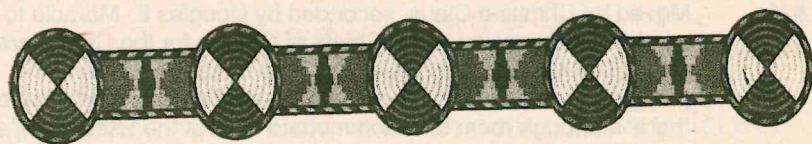

Carl Hennum attended Council to provide a report on the funding request for the York Road.

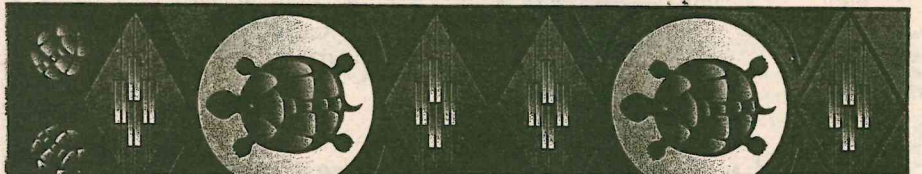
I have read the letter reports of August 28 and September 5, 2003 from XCG Consultants Ltd, your consultants on the above-referenced project. I earlier provided comments via e-mail on the first letter report but will combine comments on both reports in this letter.

The sample results provided in both letter reports clearly indicate that the material is neither leachate toxic nor does it contain elevated levels of dioxins or furans. It is safe to be landfilled at your landfill site.

As I indicated in my e-mail, The Ontario Ministry of the Environment much prefers that this type of material be recycled whenever possible but that position is a policy not a regulation.

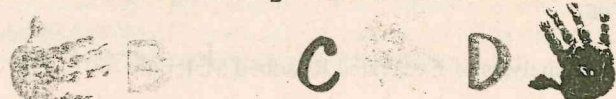

TEEN DATING VIOLENCE

What is Dating Violence?

Dating violence is the physical, emotional and/or verbal abuse of one partner by the other partner in a current or former dating relationship. Abusive behaviour is any act carried out by one partner aimed at hurting or controlling the other. Dating violence happens in male/female relationships as well as in lesbian and gay relationships.

A violent relationship means more than being hit by the person who claims to love or care about you. Violence is about power and control. When someone uses abuse and violence against you, it is always part of a larger pattern to try and control you.

Even though most people think that violence in relationships happens only between married persons, the same kind of violence also happens between people who are dating regardless of their sexual orientation. Even if you are not being hurt physically, verbal and emotional abuse are just as painful and often lead to physical violence.

Types of Dating Violence

Emotional Abuse – harms the person's self esteem or causes shame.

Examples:

- Repeated lies, broken promises, withholding affection
- Jealousy so extreme that it keeps a partner away from friends or interests
- Insults and put-downs
- Threats against a person's safety
- Controlling a person's every move, including how to dress, what to eat, where to go

Physical Abuse – causes physical pain or injury

Examples:

- Shaking, pushing or grabbing hard enough to cause discomfort
- Attacking with a knife, gun or other weapon
- Any physical act that is unwanted or hurtful – even tickling or hugging if it is unwanted

Sexual Abuse – is any kind of unwanted sexual advance or contact. It can include everything from unwelcome sexual comments to kissing to intercourse. Forced sexual intercourse between two people who know each other is called "date rape".

Effects of Dating Violence

Dating violence can range from broken bones and bruised self-esteem to permanent injury and even death. Victims may also come to view abuse as a normal part of their relationships. Dating violence can prevent a young person from growing and learning from healthy relationships.

Some of the effects are:

- Loss of appetite
- Shame
- Mistrust
- Depression
- Fear
- Terror
- Self-blame
- Sadness
- Confusion
- Anxiety
- Guilt
- Suicide
- Death

Build Healthy Relationships

- Communicate clearly
- Avoid dangerous situations
- Be in control
- Be selective
- Trust your instincts

In an Unhealthy Relationship?

If you're involved in an unhealthy relationship:

- Get help
- Get out

Dating someone is never worth being hurt or feeling afraid.

Breaking Up is Hard to Do

No matter what type of relationship you are in, breaking up can be a difficult task. We are often being tugged in different directions by our emotions. Here are some of the reasons why it's hard to break-up:

Love – Abusers are not always hurtful. Many abusers have a likable and loving side that makes their victims wish only that the abuse would stop. Many victims think they can change the abuser's behaviour.

Fear – Many times a date/partner will threaten to hurt him or herself if the other decides to leave. Many times the abuser will threaten to hurt the victim if she/he decides to leave. Abusers often threaten that the violence will get worse if the partner decides to leave.

Doubt – It's not always easy to admit that the relationship you are in is abusive. If your date is popular at school (athletics, academics, etc) you may be concerned about losing social status with your peers.

Embarrassment – Teens who ask for help (especially from parents) may perceive themselves to be failures. Some teenagers believe that their parents will react violently if they are aware of the abuse.

- Support the person
- Suggest options

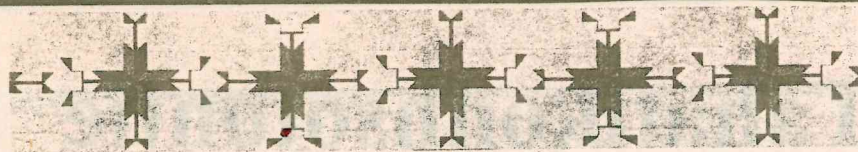

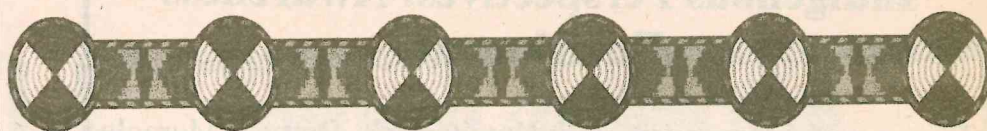

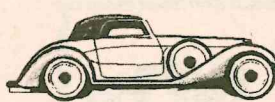

Halloween XXVIII: Curse of the Mute Indian

It's October and that means three things to me: 1) practically every member of my family will celebrate Thanksgiving while I wait another month for the same holiday; 2) Christmas is coming up so mad wild fast that my bank account and credit cards can already taste it; and 3) I'll have to explain, yet again, why I hate Halloween.

What follows is only one example of the latter...

Only one year after I moved here, a friend of mine invited me out with her for Halloween. She knew I hated it and figured I'd enjoy her way of marking the occasion. She said, "We're going out to a farm. Everyone from my church will be there. You'll like them. They have hayrides and grill hot dogs and hamburgers."

I thought to myself, Uh Muh Gawd. This is the real Tennessee! I'm gonna be out in the bush with a bunch of Christians where we'll go for hayrides and eat hamburgers.

We get out there and, like every church event I've ever attended, everybody was incredibly, deliriously happy. Becky (my friend) and I wandered around and spoke with some of the people she knew. There was a ton of kids there and not even one of them was dressed up.

When I say there were a ton of kids, I mean there were, like, a million of them. They monopolized the hayride wagon, and ran around and around and smiled too often. Like their parents. None of them whined or cried or anything.

Later, after the sun went down and I had my fill of both the hamburgers and hot dogs, potato salad made with mustard, and potato chips, everybody gathered around the bonfire where this very kind, very friendly lady who had one or two or seven kids of her own starts telling this story. I thought, Oh how fun and family-friendly this is! She's gonna tell a little kid version of a ghost story!

Becky and I and three hundred children and their parents leaned in while this lady told us that Halloween is the devil's holiday and all the evil spirits were alive that night and they wanted to steal our souls so we had to pray to God to protect us, and all of the people of the world who "celebrate" this occasion.

Everybody put their heads down and then they prayed to God.

When they were done, I looked at my friend, Becky, and I said, "Are you ready to go?"

I had one of those goofy smirks on my face, the kind you get when you're the only person who knows that a rug has been pulled out from under you.

She said all of her goodbyes while I politely smiled. I remained silent until we got in the car. I said, "That was INSANE!! On Halloween where I come from, little kids get dressed up and they go door-to-door and get candy ... and that's all! I mean, I can't stress this enough ... there's nothing more to it!"

"That's what most people do," she said, and tried to convince me of all that I'd just heard - it was not a joke, not a scary story, believe me - and we went on our way and tried to forget about the whole thing.

For me, it was just another reason to hate Halloween. Because I always have! Even when I was young I didn't like it. You can ask my mom, though she might deny it. I just cannot think of a time when it made sense to me. Yeah, I got the candy part, I got the "trick-or-treat" part, I got the you-have-to-dress-up part but I could never understand the fact that we were all in on it.

As a matter of routine, my family car would drive to a house, my brother and I would climb out of the car, walk to the door, knock, and then wonder who in the world this person answering the door was - I'm talking about the rez so, of course, our parents knew them. He or she would ask who our parents are, we'd answer, then he or she would smile and look out to the driveway, wave to them, and finally drop some candy into our bags. We'd say thank you and run away. We were kids, of course, so we may not have said thank you.

We'd end up back at home, emptying the bags and, at this point, I only have one memory. On this particular Halloween night, my mom was excited for all of us. She "helped" us navigate our collection of candy.

"Ooh, I like these," she'd say, her eyes aglow.

"So do we," my brother and I would respond.

Another random memory: the Fall Guy was on TV when we arrived at home from trick-or-treating. The episode was one where some bad guys kidnapped the girl - the one who would've been Daisy Duke had it been the *Dukes of Hazzard* - and they locked her in this windowless room where the wallpaper was so real, it appeared as though there was a window in the room, so when she tried to climb out of it, she couldn't. So she cried.

Why do I remember that so vividly? I mean, really. Sometimes I forget my phone number. (I say that like I pass out my phone number all the time!)

When I worked at Wildhorse, I hated Halloween. Everyone would dress up and I wouldn't. At my job now, most people dress up and I don't. Just walking down 2nd Avenue, back when I worked at the bar, walking out to my car to go back home provided all the proof I needed. Halloween makes the average person go crazy, because you can dress up and pretend you're something, or someone, that you're not. So if the average person is allowed to go crazy, then guess where the already-crazy people get to go?

They get to go mad and I'm just not comfortable with that.

I've always been the kind of person who searches for truth and authenticity in everything I do. Pretension makes me ill; clichés make me dry heave. As well, I'm a naturally quiet person, so going crazy is not easy for me. If you're from Tyendinaga and you're about my age (or older or younger, for that matter), then you know exactly what I'm talking about.

As Native people, we can be dead silent people. When I'm around other Native people, though, there are no problems. I'm so much more relaxed and free speaking than usual. But when I'm around non-Native people (meaning: 95% of the time), the silence can be deafening. I'm better than I used to be, mind you. The trick, I've found, is to just let the conversation fall off topic over and over and over. Unless you're dealing with bright people, then it shouldn't be hard.

It's not that we have nothing to say. I, for one, have much to say but it has to have its context and, perhaps it's that non-Native people don't know our context that makes communicating so elusive. Do I want to educate everyone about my perspective before I make my point? No. Does that mean I shouldn't say anything? No, too.

Philosophically speaking, I wonder if maybe we've been trained by each generation to not trust non-Native people (which is all the more reason to be half-Mohawk, by the way; notice how they're more talkative?) so, perhaps subconsciously, we just end up saying as little as possible. Does having a millenniums-long history of little complexity make it difficult to speak in today's world where legality and technicality rules, and our words can be twisted to meet other means?

Just 'looking stoic' can benefit us in that people may assume we're deep thinking and intelligent. It does not benefit us in that 1) it can also make us appear dumb, and 2) if we are bright and intelligent, we're sharing it with nobody, so we all lose.

It's been a lifelong struggle for me. At the beginning of a new semester back when I was in college, I'd tell myself, If I have something to say, I'll just say it.

And then I wouldn't do it. On top of that, the first time someone else in the class said something wrong, I'd laugh until it hurt. Why in the world do we do *that*? Again, if you're from Tyendinaga (or are Native in any way), you cannot deny that you just flat-out laugh when someone trips, falls, mispronounces a word or says something you know to be dumb. Admittedly, it is raw hilarious but I, for one, have learned how inhibiting it can be. Traditionally, our people did chastise their kids and each other when they stepped out of line - especially in social situations. We can hopefully all agree, though, that it hasn't made us a better people.

Where to go from here? I not sure, but I can tell you this much: if you're ever in Nashville, don't come 'round my place looking for candy. 'Cuz I'll just go crazy.

I bumped into TWO Native people in the past week! EEE!! (I squeal with delight.) Maybe I'll tell you more about them next time, along with the other two I've met in my eight years here. Comments: mohawkvisionquest@canada.com

Aboriginal media students win U.S. scholarships

Two journalism learners in the Aboriginal Media Program at First Nations Technical Institute have each won prestigious scholarships of \$1,500 U.S.

It is the first time that students from FNTI have been awarded Native American Journalists Association scholarships. The Aboriginal Media Program is designed to increase the number of Native journalists in Canadian newsrooms, as well as to help Native people learn to tell their own stories. It is the only journalism diploma program for Aboriginal people in Canada.

Jeremy Brascoupe from Toronto and Ann Hanson from Peepceekiasis First Nation, Sask., were given the awards during the association's 19th annual convention in Green Bay, Wisconsin.

Ron Walters, NAJA's executive director, said of the awards going north, "We don't choose the recipients by region. We give scholarships out based on the talent behind it. We at NAJA are happy to help out any Native student pursuing an education in journalism."

Brant Bardy, coordinator of the Aboriginal Media Program, said, "I think that there is opportunity south of the border for our learners... It's good to see the issue of the invisible border doesn't really matter. Nation to Nation dealings continue without that division and it's good to see that continue with these awards."

"The fact that scholarships like this are being won by Aboriginal journalism students from Canada emphasizes the global nature of the Aboriginal community," Bardy added.

Daimler/Chrysler underwrote the scholarship for Brascoupe. "This award is going to help me out, traveling to FNTI and back again, as well as all the other expenses of being a student. I am glad NAJA has these scholarships. They are definitely needed."

The New York Times underwrote Hanson's scholarship. In her essay applying to NAJA she wrote, "I spent most of my youth searching for a voice... now I have one."

Over 530,000 in NAJA scholarships were awarded to Native students to continue journalism education. The Mohawks of the Bay of Quinte own First Nations Technical Institute on Tyendinaga Mohawk Territory east of Belleville, Ont. Since 1985 they have offered diploma and degree programs in partnership with several Ontario colleges and universities.

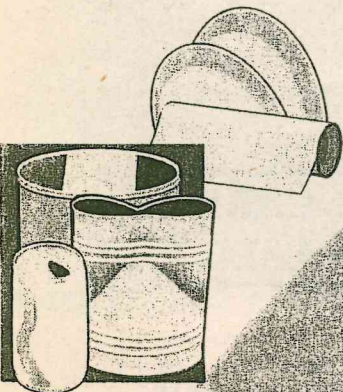


RECYCLING



A Recycling Reminder

Hang this on your wall!



Metal Cans & Foil

Rinse cans. Place lids in a can, pinch closed and put loose in blue bin. Do not put aluminum cans inside tin ones. Include clean aluminum foil and pie plates. *Flattened cans save space!* **No** pots, cigarette or butter wrappers or scrap metal. Avoid putting pop cans inside other cans.

Bring these items to your depot



Empty Aerosol and Paint Cans

Make sure metal containers are empty. Take lids off the paint cans to let them dry, and place in the blue bin — *don't bag them.* **No** containers with product, paint cans larger than 4 litres (1 gallon), plastic paint cans, propane cylinders or other hazardous waste.



Plastic Containers

Discard tops and rinse containers for soft drinks, detergents, juice, bleach, shampoo, dairy products as well as clear and foam plastic cups, trays and packaging. Flatten soft drink containers and replace lids. All plastics with the numbers 1 to 6 on the bottom are OK. **No** blister or bubblepacks, prescription bottles or toys.



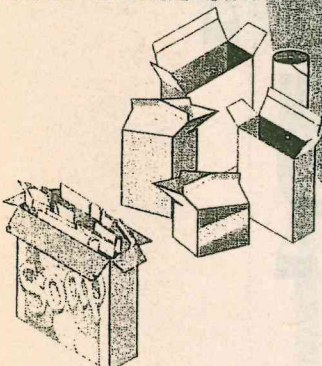
Bottles & Jars

Remove and rinse caps and lids. Metal lids can be recycled with cans. Leave loose in the blue bin. *Don't bag them.* **No** other types of glass such as kitchenware, ceramics, dishes, drinking glasses, window glass, light bulbs or mirrors.

Place in appropriately labelled bins.

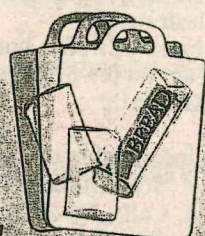
Boxboard and Mixed Paper

Bundle junk mail and office paper separately from Boxboard. Flatten and stuff **boxboard** into a large box. **Boxboard** includes cereal, shoe and detergent boxes as well as rinsed milk and juice cartons, paper bags, sugar & flour bags, cardboard tubes, books (hard-cover & paperback), egg cartons and other clean paper packaging. **No** drink boxes, tissue, paper towel or laminated paper. Do not put paper loose in blue bin.



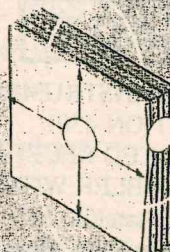
Plastic Bags

Stuff clean, dry plastic bags into a plastic bag and tie handles. Include rinsed milk pouches, grocery, bread, dry cleaning, frozen vegetable and blue newspaper bags as well as outer wrapper from toilet and hand tissues. Remove food residue, stickers and receipts. **No** meat, cheese or stretch wrap, cereal box liners or chip bags.



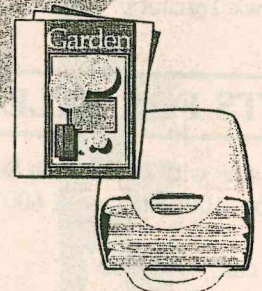
Corrugated Cardboard

Flatten and bundle corrugated cardboard boxes into a maximum size of 30" x 30" x 8" bundles. Only broken down and bundled boxes will be collected. **No** waxed boxes, soiled pizza boxes.



Newspapers & Magazines

Place newspapers, inserts, phone books, magazines and catalogues in a plastic bag next to your blue bin. **No** soiled newspapers. Keep boxboard and mixed paper separate, not mixed with newspaper and magazines.

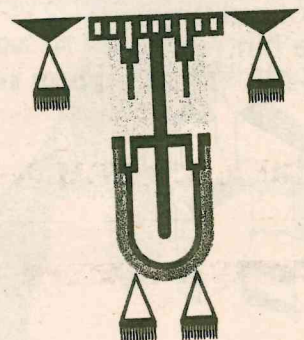



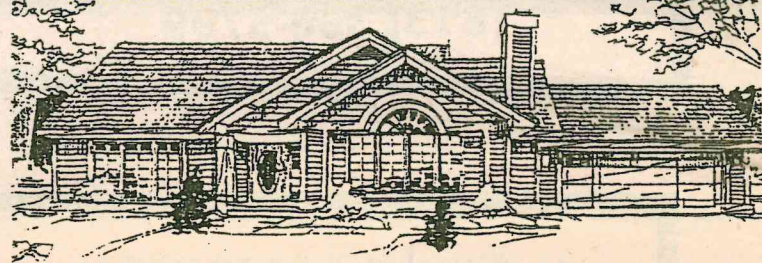
