

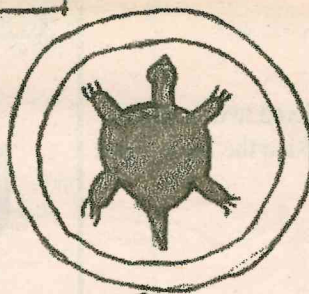
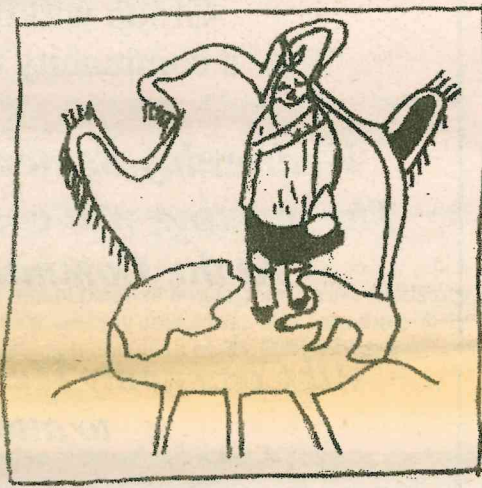

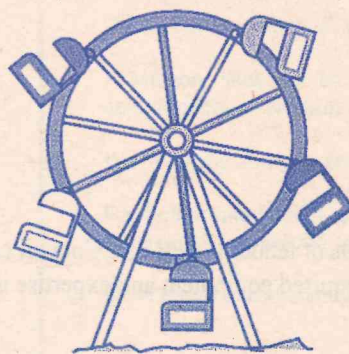

Tyendinaga Mohawk Council recently publicly advertised and tendered two contracts, Landfill Closure and Transfer Station that closed on May 30, 2007, and the Ridge Road Reconstruction that closed on July 16, 2007.

CULBERTSON TRACT CLAIM UPDATE

Below is a general summary of the information that was provided at the community meeting on August 22, 2007.

During the last set of negotiation meetings, MBQ and Canada have agreed to further explore a process of partial settlement whereby third party interests could be addressed and the land returned to the control of the Mohawks of the Bay of Quinte.

The Mapping Study that was conducted by Ron Stewart for MBQ to determine the exact boundaries of the Culbertson Tract has been formally accepted by Canada. Canada has agreed to the boundaries as defined in the study.

Working Groups have been set up to address Communications, Third Party Acquisition, and Loss of Use of the land since 1837.

MBQ has retained an economist to provide expertise on methods of assessing Loss of Use as part of a claim settlement to assess the loss of economic benefit of the land since 1837.

On June 25, 2007 the Ministry of Natural Resources and the Ministry of the Environment conducted a joint investigation of the Thurlow Aggregates quarry on Deseronto Road after environmental concerns were forwarded to the Ministry of Natural Resources two months prior.

On August 9th, MBQ staff met with MNR and MOE officials to review the results. While there were several concerns noted in the MNR and MOE reports, there was deemed to be no serious infractions of the provincial Aggregate Resources Act that would warrant canceling the license. The Tyendinaga Mohawk Council will continue to pursue the cancellation of the license through other means.

The MBQ negotiation team would like to thank those community members in attendance who came to learn and share firsthand their perspectives with regard to the Culbertson Tract claim. And we look forward to continued community participation as negotiations proceed. There have been rumours, gossip, and false information circulating in our community regarding the Culbertson Tract. This type of activity doesn't contribute to a positive climate for negotiations.

To those who have participated in the Hydrogeological Study

The Hydrogeological Study has been on-going by XCG Consultants since summer of 2004.

The study is finally coming to a successful end with the last part of the study being a pumping/monitoring test of the aquifers.

Those who agreed to participate in the pumping test gave up using their water anywhere from 6-24 hours for XCG to monitor the water levels. We understand how frustrating this was especially in the winter season.

Our sincere appreciation goes out to you and your families.

XCG Consultants will be compiling all data collected and have the final report for early March 2005.

Helpful Water Hints

(TO HELP MAINTAIN POTABLE WATER)

FAQ: Bacteria such as e.coli and total coliform can grow inside your screened taps. To prevent bacteria growth, soak your aerators in javex and remove all debris from the inside of the screen.

FAQ: Water storage tanks/cisterns can become contaminated. You should have your water tested to ensure its safety. Instructions can be provided to help you clean your tanks/cisterns if required.

FAQ: Used or soiled dish clothes can contain bacteria. You should never wrap a used dish cloth around your tap or have it near the aerator. This can cause the bacteria to spread into your tap.

FAQ: Animals that have access to drink the water directly from the taps can also cause bacteria growth in a faucet. Never allow an animal to drink directly from taps or sinks.

FAQ: If you are reusing drinking water containers, disinfection is essential. Bacteria could potentially build up if containers are not cleaned frequently with pure javex.

FAQ: Water coolers should also be cleaned with javex at least twice a year to prevent bacteria growth. Instructions can be mailed to you if requested.

WHEREAS on April 1, 1793, Treaty No. 3 ½ ("the treaty"), also known as the Simcoe Deed, formally granted the Mohawk Tract to the "Chiefs, Warriors, Women and People of the ... Six nations and their Heirs for ever, free from "all manner of Rents, Fines or Services whatsoever;"
AND WHEREAS the purpose of the Treaty was to provide a territory for the Six Nations, in gratitude and recognition of their services to the Crown as allies in the recently concluded American Revolutionary War;

AND WHEREAS research conducted by the Mohawks of the Bay of Quinte has revealed many examples of losses of land within the Mohawk Tract in circumstances that are breaches by the Crown of its fiduciary duties to protect and preserve the Mohawk Tract; AND WHEREAS the Culbertson Tract consists of approximately 923.4 acres of land now within the Town of Deseronto and the Township of Tyendinaga, and is within the original Mohawk Tract granted to and reserved for the Six Nations by the Simcoe Deed, also known as Treaty 3 ½ in 1793; AND WHEREAS no surrender of the Culbertson Tract was ever sought by the Crown nor given as required by the mandatory provisions of the Treaty and the Royal Proclamation of 1763, resulting in its alienation to third parties and the loss of enjoyment of that Tract to the Mohawks of the Bay of Quinte; AND WHEREAS the Culbertson Tract Claim was submitted to the Government of Canada and the Province of Ontario in November 1995 and accepted for negotiation by the Government of Canada in November 2003; AND WHEREAS the 1837 Letters Patent issued to John Culbertson created a one chain shore allowance by "... Reserving all Public allowances for Road within the same and an allowance of One Chain for a Road on the Bank of the Bay."; AND WHEREAS the Shore Road Allowance was a direct product of the Culbertson Patent, in that no action by the Crown to reserve the Shore Road Allowance took place prior to its issuance; AND WHEREAS no surrender of the Shore Road Allowance was ever sought by the Crown nor given by the Mohawks of the Bay of Quinte, as required by the mandatory provisions of the Simcoe Deed and the common law; THEREFORE BE IT RESOLVED that the Shoreline Road Allowance Land Claim be formally presented to the Honorable Jim Prentice, Minister of Indian Affairs and Northern Development, Canada and to the Honorable David Ramsey, Minister of Aboriginal Affairs and Minister of Natural Resources, Ontario; AND THEREFORE BE IT FURTHER RESOLVED that the Mohawks of the Bay of Quinte seek to have this claim joined with the Culbertson Tract Claim and negotiated as a priority within the ongoing Culbertson Tract negotiations. M.C.R. #2007/08-030



Whereas the duly elected Councils of Kahnawá:ke, Kanéhsatá:ke, Akwesasne, Tyendinaga, Six Nations of the Grand River, Wahta and Oneida of the Thames:
Recognize that they are communities of the Haudenosaunee Confederacy and that they are one People who share a common identity, common responsibilities and our own system of Law and government;
Have come together in a forum known as the Iroquois Caucus in order to speak with a unified voice on common issues and to render aid and assistance when necessary;
Have responsibility to protect the rights, land and resources of their people;

MEETING MINUTES

Recognize that many of the issues affecting our people require us to look to our original rights, our own system of Law and the historical relationships and agreements;
Agree to seek a working relationship with the Haudenosaunee Confederacy;
Have agreed to promote and protect the Iroquois languages, culture and autonomy;
And have agreed to work in unison to re-build our Nation(s);
Therefore Be It Resolved that the Tyendinaga Mohawk Council will allocate the resources required for its delegates to participate in the Iroquois Caucus and to adequately address issues;
Further Be It Resolved that the Tyendinaga Mohawk Council agree to provide feedback and input on all Iroquois Caucus issues as needed;
Finally Be It Resolved that the Tyendinaga Mohawk Council agrees with and confirms these statements. M.C.R. #2007/08-031

Lunch to Go! Food Safety Tips Preventing foodborne illness

Three quick & easy steps to making a safe lunch

1. Get off to a CLEAN start!

- Hand washing is one of the best ways to prevent the spread of foodborne illness. Wash your hands for at least 20 seconds with soap and warm water before and after handling food.
- Sanitizing kills bacteria and can prevent foodborne illness. Don't forget to sanitize your counter tops and lunch bags every time you use them.

TIPS

Bleach Sanitizer – combine 5 ml (1tsp) of bleach with 750 ml (3 Cups) of water in a labeled spray bottle. After cleaning, spray sanitizer on the surface/utensil and let stand briefly. Rinse with lots of clean water, and air dry (or use towels)
Also raw fruits and vegetables can be contaminated with bacteria, viruses and parasites, wash them thoroughly with clean, safe water before you prepare and eat them. Use a brush to scrub produce with firm rough surfaces, such as oranges, cantaloupes and carrots.

2. Keep cold food cold

- Perishable food like meat, chicken, seafood, eggs, mayonnaise, dairy products and all leftovers must stay cold to stay safe. Use frozen packs to keep your food at or below 4 Celsius.

TIPS

Frozen juice boxes act like extra freezer packs and you'll love the icy juice when they thaw. Pack them between foods that need to stay cold. Use an insulated lunch box. Keep it out of direct sunlight and away from radiators and other heat sources. You can refrigerate or freeze lunchbox items such as juice the night before, to get your lunch box off to a cool start. Add a freezer pack to keep food properly chilled.

3. Keep hot food hot

- To be safe, hot food like soup, chili and stew must stay hot or above 60 Celsius. Use insulated containers and keep the containers closed until lunchtime. Or, if you have a microwave available, take your food cold and reheat it at lunchtime.

TIPS

Preheat your insulated container by filling it with boiling water and letting it stand for a couple of minutes. Pour out the water and fill container with your hot food right away.

Secondary School Programs

Description

Ohahase Education Centre is operated by First Nations Technical Institute to provide programs for students seeking to achieve an Ontario Secondary School Diploma (O.S.S.D.). Ohahase means "new road" in the Mohawk Language and that is why we say it is "Your Future Path to Success"! Ohahase is a Private Secondary School that is inspected and licensed by the Ontario Ministry of Education. Each year our curriculum and guidelines are inspected and the Principal is granted a license to operate and grant credits. Ohahase currently offers two programs; a full-time day program for youth and an adult program of correspondence and night school.

Program Mission

Ohahase....

Is a centre for excellence, providing holistic and respectful learning rooted in Mohawk language and cultural practices; and

Will facilitate a multigenerational community that fosters belonging through encouragement, motivation and laughter – striving for the goals of self-sufficiency and biculturalism.

Learning Programs

Full-time Day Program for Youth

This program is a Private Secondary School program currently for grade nine and ten students. There is no tuition charge or fees for status Native students or community residents as the school is funded by Indian and Northern Affairs Canada. The program consists of regular semester periods in which students take a maximum of four classes per day in each semester. We offer a unique and challenging curriculum that meets Ontario guidelines and includes aspects of Mohawk language and culture. Students of all ages and levels of ability are welcomed as we are able to provide a small teacher-student ratio. We have been in operation three years and will expand to include grade eleven and twelve in the immediate future.

Courses/Program Requirements

Students are required to earn 30 credits to achieve an O.S.S.D. (18 compulsory and 12 optional credits). Our grade 9 and 10 programs in the past have included the following courses:

Adult Education Program

This program is designed as a self-directed learning program with a support system. Adults are offered correspondence courses from the Independent Learning Centre that are approved by the Ministry of Education. Students may work at their own pace and staff at the school, are available to provide assistance when required. The length of the program varies depending on the number of credits required for graduation.

Courses/Program Requirements

O.S.S.D (Ontario Secondary School Diploma) requires students to earn 30 credits. Credits may be earned from high school subjects, maturity credits or equivalency credits. At least 4 credits must be senior credits (grade 11 or 12) and a senior English credit must be included. Maturity Credits – the Ministry of education grants up to 12 mature credits to adults returning to school. These credits apply to adult students who started high school in the Province of Ontario before September 1999.

Equivalency Credits – some non-post secondary courses that adult students have taken qualify for credits, i.e. apprenticeship training, community college upgrading, etc.

All courses are divided into 20 lessons. Each course is 1 credit unless otherwise stated. Courses are offered at various levels of learning to accommodate educational goals related to work, attending College or University. There is no fee for community members to take a course through correspondence, as the initial registration fees are subsidized by local community service organizations. Night school is offered periodically and in the past we have offered courses in English, Presentations and Public Speaking Skills, Computers, Math and Mohawk language. Other non-credit workshop courses are available periodically such as leather crafts (moccasins).

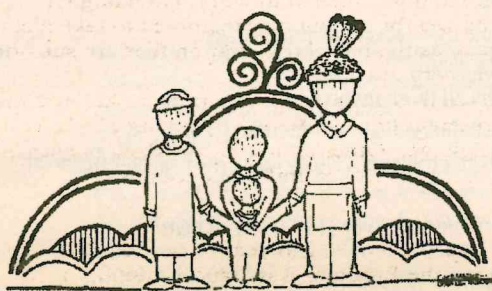

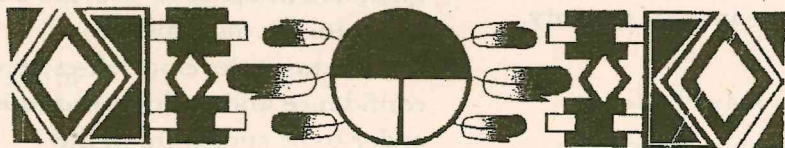

I am excited about my new position, and I am thankful to have the opportunity to contribute to the community.



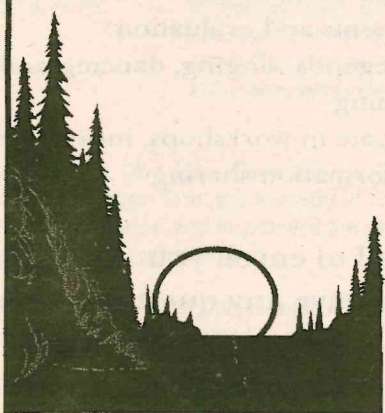

Alcohol Linked to Violence

Charlotte A. Watson, executive director of the New York State Office for the Prevention of Domestic Violence, said "It's not alcohol which causes violence. There are men who batter sober, there are men at the other end, who batter when under the influence. Domestic violence has a lot to do with the notion of power and control, and who's got power and who's obeying."

Although they are not always found together, there is a definite connection between substance abuse and violence. Research shows that people that abuse do so because they can and want to, and that alcohol does not need to be consumed in order for violence to occur. In many cases, alcohol just makes it easier for them as it allows them to feel less inhibited.

According to the National Clearinghouse on Family Violence, a branch of the Public Health Agency of Canada

Family violence and substance abuse:

- are constant social and health problems that are found in all demographics areas
- can be life-threatening
- may be intergenerational
- tend to worsen or become more severe as time passes
- affect all members of the family
- usually involve denial by all those involved
- result in isolation for both individuals and families
- often lead to other kinds of problems such as legal, medical and financial

The national Violence Against Women Survey (1993) shows that:

- Women that live with regular drinkers (at least 4 times/week) are three times more likely to experience a violent partnership than those who never drank.
- Women were at six times the risk of violence if their partners drank five or more drinks at one time, compared to those who never drank.

PLEASE NOTE: Although research shows that there is a correlation between alcohol and violence, sufficient study has not been completed. Further study is required to better understand the complexities of alcohol induced violence, as well as how personality, setting, context and social and economical status figure into these situations.

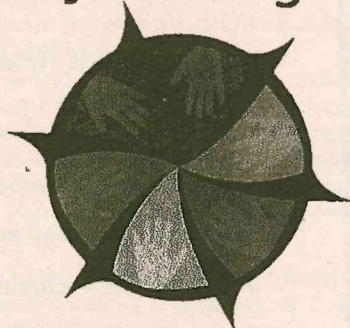

TYENDINAGA HOME SUPPORT HOME MAINTENANCE PROGRAM



The Tyendinaga Home Maintenance program offers assistance around the home and yard to seniors 55+ and physically disabled 18+ who are unable to perform the task themselves and have no family members in area to assist with the task.

Our Home Maintenance workers can perform essential tasks like: grass cutting, weed eating and raking. If time is available after essential services we can cover some other tasks like: flower beds, painting decks, washing walls/cupboards/ceilings and snow removal from steps/decks/walkways and ramps.

Clients are to provide all necessary supplies and tools to complete the job.

*We cannot do household chores like vacuuming, dishes, sweeping, laundry, etc.

*Any jobs that require professional services cannot be done by our program, i.e. plumbing, indoor painting, landscaping, construction. We do not cover costs for professional services.

*All work must be set up through the Home Support Office and client must be home while task is being done.

While a worker is at your home performing a task, please ensure that all animals are properly restrained until the job is done for the workers safety and comfort.



Client Intervention & Assistance



The goal of this service is to provide support and crisis intervention in critical situations, stabilize and put a plan in place for the longer term. Activities may include intervention and support for people facing homelessness, a critical or impending change in life situation (i.e. death of a family member, long term care placement, or moving) or abuse and isolation.

Emergency Response Program



This program provides information, referrals and assistance with medical alarms. The goal of this program is to provide clients with the security and confidence to continue to live independently.

Security & Reassurance Program



This program ensures the well being and safety of our clients. This service is provided by a phone call or brief visit as little as once a month or as often as once a day.

Friendly Visiting



Provides "friendly visits" to seniors in their homes. Visits are made by staff and volunteers under agency supervision.

MCGUINITY GOVERNMENT PUTS BRAKES ON DANGEROUS DRIVING *More OPP Officers, New Plane And Stiff Penalties For Extreme Speeders To Improve Road Safety*

MARKHAM — The McGuinty government is taking another step forward in its plan to make Ontario roads and highways safer by toughening penalties for extreme speeders and investing in more OPP officers, a new airplane and sophisticated surveillance equipment, announced Premier Dalton McGuinty.

"Working with police over the last four years, we've made real progress when it comes to curbing dangerous driving," said Premier McGuinty. "Today, we're moving forward, together. And we're being clear — if you're reckless on our roads, if you choose to break the law, we consider you a threat to our public safety and you're going to face stiff penalties."

In June, the McGuinty government strengthened penalties for street racers and drunk drivers with its Safer Roads for a Safer Ontario Act. This landmark legislation increased fines for convicted street racers — up to \$10,000, the highest street racing fine in Canada.

Today, the Premier announced the next step in the government's plan to target dangerous driving with a new package of initiatives, including:

- Putting 55 more OPP officers on the roads to fight extreme speeding
- Funding a new OPP plane with high-tech surveillance equipment
- Treating drivers going 50 kilometres or more over the speed limit the same as street racers — including issuing an immediate seven-day driver's

The Premier joined OPP Commissioner Julian Fantino, Minister of Community Safety and Correctional Services Monte Kwinter, Transportation Minister Donna Cansfield and OPP officers for today's announcement.

"The addition of these new officers will help us make Ontario's highways safer by enabling us to clear crash scenes more quickly while safeguarding both officers and the public," said Fantino. "By adding aerial traffic support we will be able to target aggressive drivers and street racers."

"Ontarians have the right to travel safely on our roads and we're giving the Ontario Provincial Police a whole new toolkit to crack down on those who threaten public safety," Kwinter said. "Today marks the beginning of a concerted new effort to take those who endanger innocent citizens off our roads."

"Excessive speeding on our roads will not be tolerated. Today's announcement further demonstrates the McGuinty government's commitment to road safety in Ontario," said Cansfield. "With these tougher measures, our government continues to protect those who obey the law from those who choose to break it."

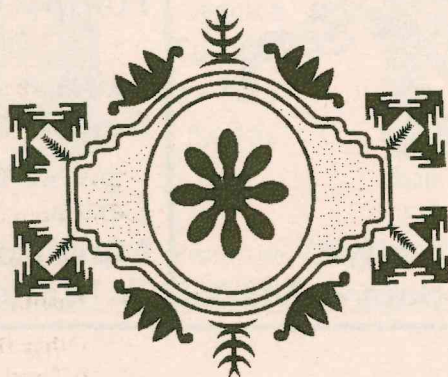
