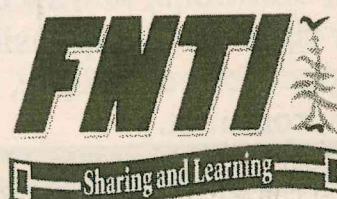

MOHAWK FIRE DEPARTMENT

The Mohawk Firefighters in August responded to 10 calls:

- 2 - Motor Vehicle Accidents
- 1 - Medical
- 1 - Police Assist
- 3 - Auto Alarms
- 2 - Tanker Assists
- 1 - Hay Fire

This brings our total to 62 calls for the year 2008

This is a continuation of the Minutes of 1800. In September 1800 there was a Council Meeting held in the community that spanned 8 days. This meeting was held to try to come to some resolution of the troubles that had been dividing the community at that time.

Reprinted in this edition of the newsletter is the proceedings of the meeting held on September 9th.

Proceedings of a Council held at the Bay of Quinte beginning on the 2nd and ending on the 10th of September 1800, in the Mohawk Village

9th September

The Council held at Captain John's House.

Present as before.

Captain Claus informed Captain John and his people the same as he had done to Captain Isaac's party yesterday.

Captain John then spoke as follows:

Now, Brother, the Great Spirit has allowed us to assemble here in a very good cause. You have been greatly fatigued to make up this sad business between us; nor did we expect you should ever have had so much trouble or to come this great distance to reconcile our differences, and I hope it never will happen again. I am very happy to hear the good things that passed in Council yesterday after we left it, and if you will allow us a few minutes we will consult on the business among ourselves. We will go out and endeavour for the best and return immediately.

They then withdrew.

On their return:

Captain John said:

Now, Brother, you have called upon us for our opinion on this business and to know our minds. When you first came here, we

were at a loss what you meant to so, as you spoke to Captain Isaac first as soon as you arrived and also yesterday when we were desired to withdraw. I think, Brother, you was rather too mild with Captain Isaac and his party, and I think also that Mr. Stuart said too much in Captain Isaac's favor; and it does not appear to me that Mr. Stuart's advice would correspond with the General's intention. Mr. Stuart is very ignorant of the situation of this place as he only comes here once a year, and as his business is of a different kind I never wish to trouble him with what concerns the Village. Now Brother, we find the reason of you having seperated us yesterday was from a good cause, and we are very happy to find it so. We have very little more to say as everything seems to be settled and I shall say but a few words more.

You heard, Brother, what Captain Isaac said to you, that he would not in future stir up any more disturbances, and I suppose he is now very happy, as he was very fearful before the business came to be heard. He studies nothing, and knows nothing and is very obstinate and knows not what honesty is. He will make fair promises and never will be as good as his word. We shall never credit him but upon proof of his future good behaviour. Sir John Johnson and Colonel Claus always instructed me to keep in the strait path and I have always followed their advice: and what can I say more? I know the Great Spirit is ever looking at us and that is the reason I strive to do for the best. We, therefore, cannot think of shaking hands until we see whether he will stick to his promises. For the crime has been so great I cannot think of making up the matter in this manner, and General Hunter said that those who were in the fault should be sent out of the place.

Now, Brother, you have heard what I have said and the Village will never be in peace until those people who have made this disturbance are sent out of this place. When that is done the Village will be peaceable, and in future when they are gone, every person who misbehaves as they have done will be served in the same manner. But before anything more can be done these people must be sent out of this place. Now, Brother, you will take this into consideration. Which do you think, Brother would be the best; To send me and my people from off this Land, or those who have been guilty of so great a crime? We would not think it a great hardship to set off and leave the King's land if required, because we know we have behaved well, but by being with bad people for some time it causes a great deal of trouble. You may depend that Captain Isaac will never keep his promises, and when your backs are turned he will go on as before, as he is possessed with a Devil. Captain Isaac, Paulus, the Frenchman, and Thomas, the fiddler, are the men who make all the disturbances. Isaac says he will never be guilty of such conduct again; let him Pay all the Deceased's debts and go through the Custom of covering the Dead, and then we may expect he will abide by his Promises. We shall now let the matter rest as it is until we hear General Hunter's opinion of the matter. I hope we shall never be guilty of such a Crime as Captain Isaac's party have, as I always give good advice to my people. You see, Brother, when the white people come among us there is always mischief and misunderstanding. Sir William Johnson told me in the year 1760 to let all the prisoners go or they would ruin the Indians, particularly the french people for they are bad Birds, and that after they were all sent away we would have peace and quietness. These thoughts struck me when our disturbances began here. You white people made Christians of us on which account you have been applied to, to do us justice.

Now, Brother, this is all I have to say. You have the whole in writing before you and we hope you will do us all the service that lays in your power. As to taking Isaac and his party by the Hand, that is out of the question at present; time and experience of his future good Conduct may make us friends.

In the meantime, I shall conduct myself with quietness and regularity to all his party.

After some conversation with Captain John and the Widow Laurence, and after Captain John's consulting his people again, he returned and spoke as follows.

ADMINISTRATION

Brother, there is one thing still which you request. You wish all these disturbances and everything which has passed to be put under ground. We see clearly you wish us well. We are Christians and as such are not hard to be persuaded. Therefore, we agree to your request, as we must all die some time or other. When Captain Isaac repeats before us what he has said to you, that he will have nothing more to say in the Village, we will be satisfied; and it is expected that Thomas, the fiddler, Little Peter, Nicholas Crawford and Ab. Hill will also come forward and make the same declaration, and also all those who were concerned in the Murder. I will then take Isaac by the Hand, and I hope, Brother, you will not be bashful, but speak sharply to them, as it may have a good Effect. I heartily thank all the Gentlemen for their long attendance and attention to this unhappy business.

Adjourned till tomorrow noon.

Summary Description:

Under the direction of the Executive Director, oversees all operations in connection with financial matters within the Chiefs of Ontario, including accounts receivable and payables, payroll, and auditing; trains and supervises department staff; develops and initiates systems, policies, and procedures for transacting financial matters; ensures that the financial system is accurate, efficient and in accordance with professional accounting practices and government regulations.

Duties and Responsibilities:

Develops and implements the Finance Department's goals, projects, policies, procedures, methods and controls; directs the general accounting activities including the maintenance of general ledgers, analysis of computer printouts, and review of payroll records; prepares monthly, quarterly reports and close-out reports as required by federal and provincial regulations and agreements; profit and loss statements, annual corporate tax returns, and special financial reports, studies and analysis; develops and maintains internal audit control system; develop and administers the accounting management system within authority of the position. Constantly prepares and monitors for year-end audit and audit trail.

Provides data, reports, and other information to assist in the preparation of the annual budget; forecasts revenue, expenditures, and year-end balances; plan, designs, implements, and modifies the data process system; prepares and revises the fiscal operations procedure manual; coordinates with other departments concerning short and long-range fiscal needs and plans; responds to requests for information; supervises daily accounting operations, including the preparation of payroll for verification and sign-off of payroll and benefits, cash disbursements; selects, trains, supervises and evaluates finance staff.

Knowledge:

Principles, practices and methods of modern accounting and auditing; principles and practices of financial administration including budgeting and reporting/monitoring; modern office practices, procedures, methods and equipment; modern principles and practices in operations procedures and data processing; application of data process in the maintenance of accounting records and financial administration; budget preparation, program analysis, and revenue forecasting; principles and practices of organization, administration, budget and management; reports accounting practices required by federal and provincial regulations and agreements.

Exceptional knowledge and experience in the use of computerized accounting systems (ACCPAC Windows) and spreadsheet software (Excel).

Skills:

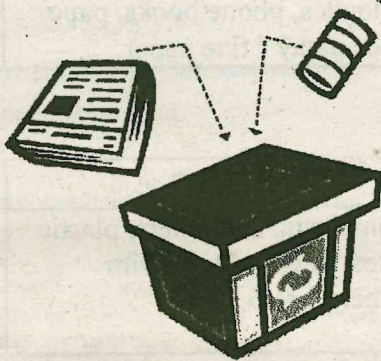


Imagine going to school everyday and not throwing anything into the garbage can. Its possible, start with packing a LITTERLESS LUNCH!

- Use a lunch box- instead of brown paper, or plastic bags.

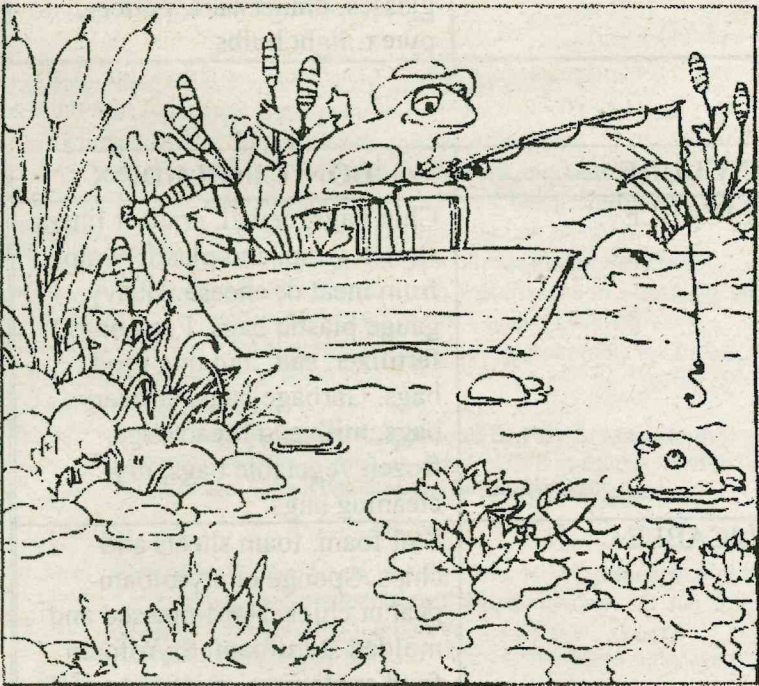

Let's Stop Bullying in our Schools

What is Bullying?

Bullying is a serious problem for those who engage in it, for its victims, and for the communities in which it takes place. It is not a normal part of growing up. It can make children feel frightened, sick, lonely and unhappy. Bullying is a common form of abuse. It has been identified that Bullying is the assertion of power through aggression. Its forms can frequently change with age: school playground bullying, sexual harassment, gang attacks, date violence, assault, marital violence, child abuse, workplace harassment and elder abuse.

The basic elements of bullying are:

- **Unequal power:** One person has more power than the other person (or at least it seems that way to the people involved)
- **Hurtful actions:** Physically or psychologically harmful behaviour takes place
- **Direct and indirect actions:** The behaviour may be face-to-face or behind one's back
- **Repetitive behaviour:** The hurtful actions keep happening so the person being hurt finds it more and more difficult to escape

Who are the Victims?

Boys and girls alike are equally likely to be victimized as a result of bullying. Children can become victimized for many different reasons - there is not a single victim type. For some children, the following characteristics are present before bullying occurs; for others, they develop as a result of bullying. Victims of bullying will also often display symptoms of depression, such as sadness, and loss of interest in activities.

Who are the Bullies?

While there is no research to show distinctive groups of children to be more frequently involved in bullying, it has been said that bullies tend to bully in many different ways - there is not a single type of bully. Bullies are generally aggressive toward their peers, teachers, parents, and siblings. They also tend to be assertive and easily provoked. They are attracted to situations with aggressive content and have positive attitudes about aggression often display a lack of empathy and sympathy for their victims with little remorse displayed for their actions.

What to do if you suspect a child is being bullied?

Ask

It is often not easy for children to tell, so it's important to ask the child about bullying. Let them know that they can tell you if they have a problem.

Listen

Listen to what the child tells you. If a child feels that he or she is being bullied, acknowledge this

Talk

Discuss the problem with the child and how it might be resolved. Victims of bullying should not be encouraged to retaliate, as there may be a risk of injury.

Get Help

Identify the places where the bullying is happening. If the bullying is school related, talk to the class teacher and/or school principal. It may help to make an appointment. It is important to have your facts straight before raising the issue with the school. If the bullying is related to a club or activity the child attends, talk to the group leader. Explain to the teacher or group leader what has been happening and how the child feels. Discuss with them how you might work together to stop the bullying.

Just a reminder that the **Children's Oral Health Initiative** will be starting again soon at QMS and Daycare

Children's Oral Health Initiative or COHI is a dental initiative that was introduced in January 2006 and is designed to prevent and control tooth decay in young First Nations and Inuit Children and to set the stage for a lifetime of healthy teeth.

Goals of COHI:

- Improve oral health for children and, in doing so, improve their overall general health
- Teach parents and caregivers how to prevent dental diseases for themselves and their children
- Prevent tooth decay in babies and young children and to avoid the need for unpleasant dental treatment
- Introduce babies and young children to dentistry that is successful, painless and fun

Why This Initiative?

- First Nation children have high rates of early childhood tooth decay
 - Rotten teeth are painful for children
 - Too many children under the age of six need to have dental surgery in a hospital and have general anesthetic (be put to sleep) to have their teeth fixed
 - Having general anesthesia can be dangerous and may increase overall medical risks
- By the age of three, some children have been hospitalized many times to have their teeth fixed.

Who is Eligible for COHI?

- Children ages 0 – 7, new babies included
- Pregnant women, parents and caregivers of children aged 0 to 7

What are COHI Services:

- COHI Screening by a Dental Hygienist who checks for signs of tooth decay
- Fluoride Varnish Application, which is a safe
- COHI Screening by a Dental Hygienist who checks for signs of tooth decay
- Fluoride Varnish Application, which is a safe substance that is painted on all the visible surfaces of the teeth. Fluoride Varnish protects and strengthens the teeth making it more difficult for tooth decay to begin or get worse. Sealants are a thin, clear, or white, plastic coating placed on the surfaces of teeth to help prevent tooth decay. A tooth surface has many grooves and pits where food and bacteria can lodge itself leaving the area very susceptible to decay. Sealants prevent the acids which cause tooth decay from getting into the grooves and pits. Sealants are usually placed on first permanent molars only.

These services that are free of charge, are not meant to replace your dentist, but to add more preventative care to lessen tooth decay in our children. We at the Health Centre hope this will help you, the parents and caregivers, in making an informed decision on signing the permission form for the CHILDRENS ORAL HEALTH INITIATIVE.

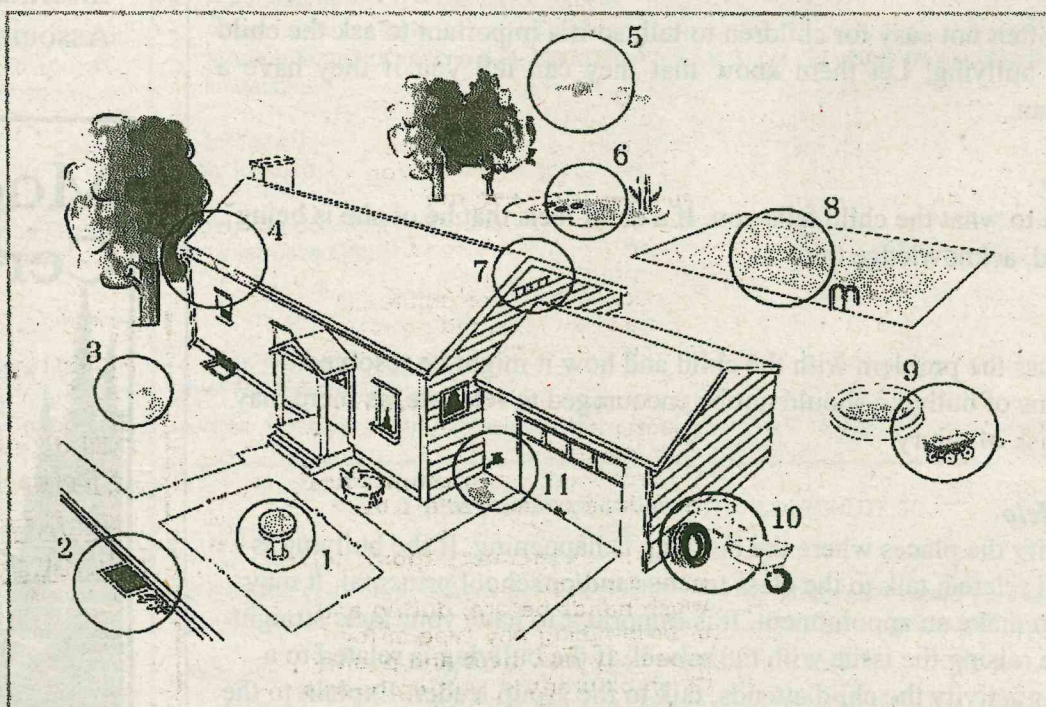

FOOD SAFETY FACTS ON *LISTERIA*

Main Page - Listeria Investigation and Recall

What is foodborne illness?

Foodborne illness occurs when a person consumes food contaminated with pathogenic bacteria, viruses or parasites. This condition is often called "food poisoning". Many cases of foodborne illness go unreported because their symptoms often resemble flu symptoms. The most common symptoms of foodborne illness may include stomach cramps, nausea, vomiting, diarrhea and fever.

What are *Listeria monocytogenes* and listeriosis?

- *Listeria monocytogenes* is a bacterium. It is often found in the environment, particularly in soil, vegetation, animal feed, and in human and animal feces.
- Eating food contaminated with *Listeria* may lead to the development of a disease called listeriosis.

What are the symptoms?

- Symptoms include: flu-like symptoms, nausea, vomiting, cramps, diarrhea, headache, constipation and persistent fever. Symptoms usually appear within 2 to 30 days and up to 70 days after consuming contaminated food.
- The very young, elderly or those with poorly functioning immune systems are the most

Where could I come in contact with *Listeria monocytogenes*?

- *Listeria monocytogenes* can be found in a variety of dairy products, vegetables, fish and meat products.
- *Listeria monocytogenes*, unlike most other harmful bacteria, will grow slowly on foods stored in a refrigerator.
- *Listeria monocytogenes* can also be spread by contact with an infected product or surface, such as hands or counter tops, during food preparation.

How can I protect myself and my family?

- Keep foods out of the temperature danger zone (between 4°C and 60°C or 40°F and 140°F). Keep the refrigerator at 4°C (40°F) or colder. Refrigerate food promptly.
- Thoroughly cook or boil foods such as hot dogs and poultry products until they are steaming hot.
- Avoid raw, unpasteurised milk or foods made from it such as raw milk cheese.
- Purchase only as much product as will be consumed in 1 to 2 days.
- Wash raw vegetables thoroughly before eating.
- Wash hands before, during and after handling any type of food, especially raw meat and poultry.
- Clean all utensils, cutting boards and work surfaces with a mild bleach solution (5 ml/1 tsp. bleach per 750 ml/3 cups water) before and after using.
- Separate utensils for raw and cooked foods.
- Follow "use by" dates especially on packaged goods with a long shelf life.

If you are pregnant or have a weakened immune system

- Avoid soft cheeses such as Brie, Camembert, feta and queso blanco fresco. Other dairy products such as hard cheese, processed cheese, cream cheese, cottage cheese, or yogurt can be freely consumed during pregnancy.
- Avoid refrigerated pâtés.
- Although the risk of listeriosis associated with foods from deli counters, such as sliced packaged meat and poultry products, is relatively low, pregnant women and immunosuppressed persons may choose to avoid these foods.
- Avoid refrigerated smoked fish products unless you have cooked them, for example, in a casserole.

What are producers and processors doing to protect consumers?

- From the farm to the retail store, efforts are being made to reduce the risks associated with *Listeria monocytogenes* throughout the food production process.
- Individual companies and industry associations are working to develop systems that will further enhance the safety of their product.

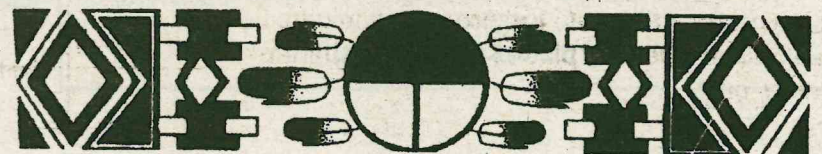
How does the Canadian Food Inspection Agency (CFIA) protect consumers?

- The CFIA administers and enforces 12 Acts governing food safety and food inspection within Canada and at our borders.
- CFIA inspectors monitor food processing in federally registered slaughtering and processing establishments.
- CFIA inspectors also check packaging dates and labels in retail stores.
- CFIA laboratories continue to develop quick, cost-effective tests to better detect new and existing pathogens in foods and food manufacturing processes.
- In cooperation with industry, the CFIA is moving towards a modernized, science-based inspection system.

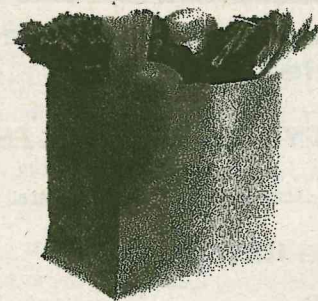

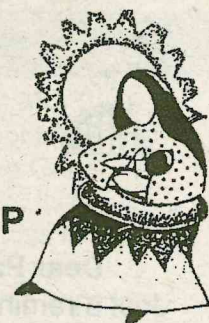

Just a reminder that the **Children's Oral Health Initiative** will be starting again soon at QMS and Daycare

Children's Oral Health Initiative or COHI is a dental initiative that was introduced in January 2006 and is designed to prevent and control tooth decay in young First Nations and Inuit Children and to set the stage for a lifetime of healthy teeth.

Goals of COHI:

- Improve oral health for children and, in doing so, improve their overall general health
- Teach parents and caregivers how to prevent dental diseases for themselves and their children
- Prevent tooth decay in babies and young children and to avoid the need for unpleasant dental treatment
- Introduce babies and young children to dentistry that is successful, painless and fun

Why This Initiative?

- First Nation children have high rates of early childhood tooth decay
 - Rotten teeth are painful for children
 - Too many children under the age of six need to have dental surgery in a hospital and have general anesthetic (be put to sleep) to have their teeth fixed
 - Having general anesthesia can be dangerous and may increase overall medical risks
- By the age of three, some children have been hospitalized many times to have their teeth fixed.

Who is Eligible for COHI?

- Children ages 0 – 7, new babies included
- Pregnant women, parents and caregivers of children aged 0 to 7

What are COHI Services:

- COHI Screening by a Dental Hygienist who checks for signs of tooth decay
- Fluoride Varnish Application, which is a safe
- COHI Screening by a Dental Hygienist who checks for signs of tooth decay
- Fluoride Varnish Application, which is a safe substance that is painted on all the visible surfaces of the teeth. Fluoride Varnish protects and strengthens the teeth making it more difficult for tooth decay to begin or get worse. Sealants are a thin, clear, or white, plastic coating placed on the surfaces of teeth to help prevent tooth decay. A tooth surface has many grooves and pits where food and bacteria can lodge itself leaving the area very susceptible to decay. Sealants prevent the acids which cause tooth decay from getting into the grooves and pits. Sealants are usually placed on first permanent molars only.

These services that are free of charge, are not meant to replace your dentist, but to add more preventative care to lessen tooth decay in our children. We at the Health Centre hope this will help you, the parents and caregivers, in making an informed decision on signing the permission form for the CHILDRENS ORAL HEALTH INITIATIVE.

What can I do to reduce my chances of getting bit by a mosquito carrying West Nile Virus?

- 1) When you spend time outdoors:
 - use a mosquito repellent that contains DEET or other approved ingredients
 - wear light-coloured clothing, a long-sleeved shirt, long pants and a hat
- 2) Make sure window and door screens are in good repair
- 3) Get rid of standing water around your home:
 - drain pool covers, old tires, rain barrel lids, flower pots and children's toys
 - store upside down any items that could collect rain water
 - replace water in bird baths and outdoor pet dishes at least twice a week

WALK4JUSTICE. NEEDS YOUR SUPPORT

Setting out on June 21, the "Walk4Justice" is now working its way toward Ottawa where they will present a petition and demand a full public inquiry into the "scandal" of missing and murdered women in Canada.

Over the past 40 years, at least 3000 women have been murdered or reported missing. That's roughly one woman for each kilometer the Walk4Justice will complete in their two month march.

The Women and Men Walkers will be walking to Parliament Hill to address Prime Minister Steven Harper and Indian Affairs Minister Chuck Strahl about all the missing and murdered Aboriginal women, children and men.

They want to demand justice and closure for our people who have lost their loved ones over the past four decades. The Women and Men Walkers will gather in unity and speak out for those who can no longer do so. They would like to gather true numbers of exactly how many are missing, murdered, raped, beaten and overall violated by this system.

The Walk4Justice want to honour the women, men and children and the families of the ones who have disappeared over the last four decades. We want to speak out for them and for the children who were left behind. Our demands will be very simple. We want justice, closure, equality and accountability!

Please show your support by welcoming these women into our community on Sept 4-8.

WALK4JUSTICE

This very powerful journey has taken 18 Women and Men Walkers across the country in honour of the missing and murdered women of the Highway of Tears in British Columbia. The journey began on June 19th from BC and will end with a full day session at Parliament Hill which will include a presentation of their petition.

THE WALKERS WILL BE ARRIVING IN TYENDINAGA, ON THURSDAY, SEPTEMBER 4, 2008.

SCHEDULE OF EVENTS:

- Sept 4 The Women and Men Walkers will arrive in Tyendinaga in the late afternoon. We will greet them at the edge of the Territory in Shannonville (near Smoking Joe's) and then escort them to Red Cedars Shelter. A greeting ceremony will be held before we take them to their accommodations at the bible college. At this time we will have supper. **Everyone is welcome!**
- Sept 5 Breakfast will be held for the Women and Men Walkers at the Orange Lodge and is open to all community members and off-Territory agencies. A representative from Chief and Council will welcome the women. After breakfast there will be a tour of Tyendinaga returning to the Orange Lodge for lunch. We will provide therapeutic massage in the afternoon from 2:00 - 4:00 for all the women.
- Sept 6 At 5:00 pm at the Stone Longhouse, there will be a Community Potluck Social and a blanket dance to honour our guests and to help support them on the rest of their journey.
- Sept 8 The Women and Men Walkers leave to start the last leg of their journey to Ottawa. We ask that people from the community and other agencies walk with the women to Napanee and if possible, gather sponsors to help them with monetary donations. Sponsor sheets can be picked up at FNTI. A bus will be provided to bring walkers back from Napanee to Tyendinaga.

School Lunch Advice for Kids at Every Age

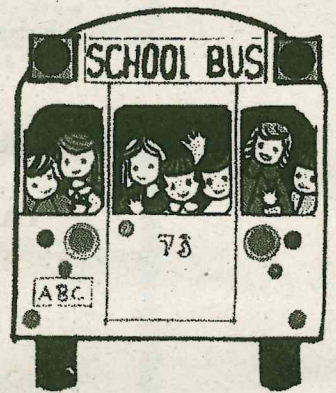
Try the tips below to make your child's lunch healthy AND worth looking forward to.

For home-packed lunches:

Avoid the morning rush by preparing lunch the night before and chilling it in the refrigerator.

- Put slices of tomatoes in a separate bag or container so they don't make sandwiches soggy.
- Instead potato or corn chips, pack a healthier alternative like veggie chips, bagel rounds, or baked tortilla crisps.
- Round out the meal with kid-sized veggies-baby carrots, celery sticks, or broccoli florets-and low-fat or fat-free dip.
- Low-fat, high fiber mini muffins make a great dessert alternative to cupcakes or high-fat cookies.
- Use a cookie cutter to transform a plain square sandwich into something unique.
- Turn a container of low-fat yogurt into a complete meal by sending along some stir-ins like granola, trail mix, unsalted chopped nuts, or whole grain cereal.
- Consider alternatives to sandwich bread like burger buns, pita rounds, soft tortillas, and large lettuce leaves (for a no-sog wrap for savory fillings).

* Remember no nuts of any sort if your school is peanut free*



Puzzle Box

1. Take an old shoe box with a lid and have a friend place a "mystery object" inside.
2. Tape the lid closed and try to figure out what's inside by sliding it back and forth, shining a light in it, tapping on it with a pencil, etc.
3. The only thing you can't do is open it up and look inside!
4. Take turns trying different objects (removable painter's tape would make it easier to open and close the box).



The Importance of Stretching

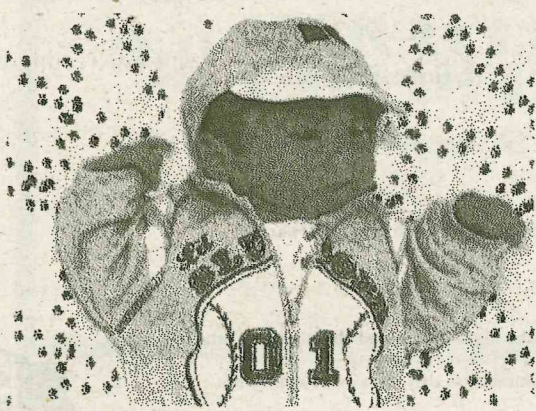

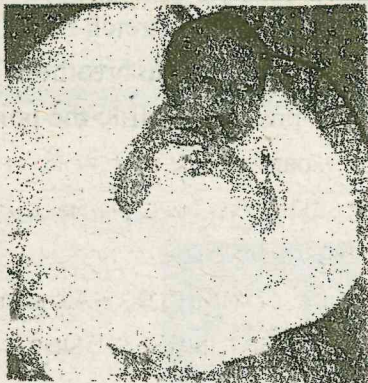

Celebrated Native Writer Pens Poignant Memoir About His Path to Emotional Recovery

In 2005, award-winning writer Richard Wagamese moved with his partner to a cabin outside Kamloops, B.C. In the crisp mountain air Wagamese felt a peace he'd seldom known before. Abused and abandoned as a kid, he'd grown up feeling there was nowhere he belonged. For years, only alcohol and moving from town to town seemed to ease the pain.

In *One Native Life*, Wagamese looks back down the road he has travelled in reclaiming his identity and talks about the things he has learned as a human being, a man and an Ojibway in his fifty-two years. Whether he's writing about playing baseball, running away with the circus, attending a sacred bundle ceremony or meeting Pierre Trudeau, he tells these stories in a healing spirit. Through them, Wagamese celebrates the learning journey his life has been.

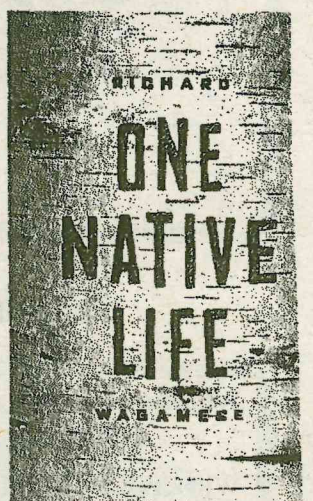
Free of rhetoric and anger despite the horrors he has faced, Wagamese's prose resonates with a peace that has come from acceptance. Acceptance is an Aboriginal principle, and he has come to see that we are all neighbours here. *One Native Life* is his tribute to the people, the places and the events that have allowed him to stand in the sunshine and celebrate being alive.

RICHARD WAGAMESE is an Ojibway from the Wabasseemoong First Nation in Ontario. He is the author of three novels—*Keeper'n Me*, *A Quality of Light* and the award-winning *Dream Wheels*—and the autobiography *For Joshua*.
