COMMUNITY GENERAL SUPPORT:

Whereas the community of Mohawks of the Bay of Quinte will support this Emergency First Response Team by providing (not limited to):

- 1. Adequate training facility
- 2. 24-hr access to a heated, secure storage facility for team supplies (i.e.: patient care equipment) and should the Team have a first response vehicle it would be housed in an appropriate heated building
- Support a Team Coordinator with its administration role (i.e.: fax, telephone, mail,) and should that Coordinator be changed, to inform the Regional Training Coordinator and Emergency Health Services (EHPMDB)
- 4. Maintain a good relationship with the representatives from Emergency Health Services (EHPMDB) and the Regional Training Program
- 5. Provide local transportation, lodging and general support to Emergency Health Services (EHPMDB) and Regional Training Program representatives in their quest to support this said First Response Team.
- 6. Ensure that all call reports are mailed to Regional Training Coordinator monthly.
- 7. Ensure that ALL team members have the time off to complete the required training and retraining
- 8. To be able to do calls even if they are working should the need arise.

PROVINCIAL GENERAL SUPPORT:

Whereas the Emergency Health Services (EHPMDB), through the Regional Training Program will:

- 1. On a continuous basis, provide MANDATORY training in Standard First Aid, Cardiopulmonary Resuscitation (CPR) level (BLS), Emergency First Response program and Compassion Fatigue training with its appropriate deliver methods and patient care equipment to this community.
- 2. Maintain the appropriate level of patient care equipment.
- 3. Via its internal administration process Emergency Health Services (EHPMDB) is to maintain call reports
- 4. In the case of poor community support or the delivery of inappropriate patient care the Emergency Health Services (EHPMDB) retains its ability to end its support to this said community.

Therefore Be It Resolved that the mutual agreement is to be implemented without any financial remuneration from any parties. M.C.R. #2022/23-011.

AND WHEREAS certain plaintiffs commenced a court action styled Tataskweyak Cree Nation and Chief Doreen Spence on her own behalf and on behalf of all members of Tataskweyak Cree Nation v Attorney General of Canada, Court File No. CI-19-01-24661, in the Manitoba Court of Queen's Bench on November 20, 2019 (the "Manitoba Action", and together with the Federal Action, the "Actions");

AND WHEREAS the Actions were certified by the respective courts as class proceedings;

AND WHEREAS the Attorney General of Canada and the plaintiffs in the Actions have negotiated a settlement agreement (the "**Settlement Agreement**") in respect of the Actions;

AND WHEREAS the Settlement Agreement provides that a First Nation that is a member of the class described in the Actions (the "Class") may provide the administrator appointed by the courts under the Settlement Agreement (the "Administrator") with notice of acceptance by that First Nation of the Settlement Agreement and thereby become entitled to certain compensation and benefits under the Settlement Agreement available to First Nation Class members;

AND WHEREAS the Mohawks of the Bay of Quinte is a member of the Class and the Tyendinaga Mohawk Council (the "**Council**") wishes to confirm and approve the acceptance of the Settlement Agreement by the Mohawks of the Bay of Quinte by passing this Band Council Resolution at a properly constituted meeting called for this purpose;

BE IT HEREBY RESOLVED THAT:

1. The Council hereby directs and authorizes Chief R. Donald Maracle, on behalf of the Mohawks of the Bay of Quinte, to approve and accept the Settlement Agreement, a copy of which was reviewed by the signatories below on behalf of the Council, and the Council hereby further directs and authorizes such signing authority to deliver an executed copy of this Band Council Resolution to the

- Administrator to confirm acceptance of the Settlement Agreement by the Mohawks of the Bay of Quinte. The Council hereby acknowledges and confirms that no further actions are required by Council to accept the Settlement Agreement.
- 2. The Council hereby directs and authorizes the Chief, on behalf of the Mohawks of the Bay of Quinte, from time to time, to execute and deliver these resolutions and such further documents and instruments and do all acts and things as may be reasonably necessary to carry out and give effect to the Settlement Agreement, including, if the Chief determines appropriate, a confirmation of the individual class members resident on the Mohawks of the Bay of Quinte reserve while a long-term drinking water advisory was in force on that reserve during the period applicable to the Settlement Agreement.
- **3.** These resolutions may be signed by the Chief and Council members in as many counterparts as may be necessary, in original or electronic form, each of which so signed shall be deemed to be an original, and such counterparts together shall constitute one and the same resolution.
